

## AMENDMENTS TO SENATE BILL NO. 801

1 Amend Bill, page 1, line 5, by inserting after "thereto,"  
2 in certification of teachers, further providing for teacher  
3 support in the structured literacy program; and

6 Section 1. Section 1205.8(a), (b), (c) and (g) of the act of  
7 March 10, 1949 (P.L.30, No.14), known as the Public School Code  
8 of 1949, added July 8, 2022 (P.L.620, No.55), are amended to  
9 read:

10 Section 1205.8. [Teacher] Educator Support in the Structured  
11 Literacy Program.--(a) (1) It is the intent of the General  
12 Assembly that [teachers] educators be equipped to facilitate  
13 high-quality reading instruction grounded in structured literacy  
14 and intervention services to address student reading needs.

15 (2) The program provided in this section will assist  
16 [participating] school entities in providing professional  
17 development for [teachers] educators in foundational skills and  
18 instructional interventions based on structured literacy and  
19 providing opportunities for school personnel to serve as reading  
20 coaches to support [teachers] educators in delivering high-  
21 quality reading instruction.

22 (b) (1) Beginning with the 2022-2023 school year, the  
23 department shall establish a program of professional development  
24 and applied practice in structured literacy for school personnel  
25 that includes in-class demonstration, modeling and coaching  
26 support to improve reading and literacy outcomes.

27 (2) School personnel selected by the [participating] school  
28 entity to serve as professional coaches for this program must  
29 have at least five years of experience in teaching of reading  
30 and be able to demonstrate their skills in the instruction of  
31 and intervention with students, including those with dyslexia  
32 and other language-related disabilities.

33 (3) The department may contract with multiple service  
34 providers, including school entities and institutions of higher  
35 education with demonstrated experience in structured literacy,  
36 to develop and implement the program so that experienced support  
37 is available locally.

1 (4) A service provider, including a school entity or  
2 approved educator preparation program that demonstrates  
3 successful implementation of literacy outcomes, is eligible to  
4 provide professional development and onsite demonstration and  
5 coaching support in the program.

6 (5) A [participating] school entity shall adopt high-quality  
7 instructional materials grounded in [scientific-based reading  
8 research] evidence-based reading instruction in accordance with  
9 the State academic standards approved by the State Board of  
10 Education.

11 (c) (1) The continuing professional education plan of each  
12 school entity shall satisfy the continuing education  
13 requirements of 22 Pa. Code § 49.17 (relating to continuing  
14 professional education), including training in structured  
15 literacy for professional employees who hold instructional  
16 certificates in early childhood, elementary-middle level,  
17 Special Education-PK-12, English as a second language and  
18 reading specialist. To ensure that school personnel have the  
19 knowledge and skill to teach all students to read, including  
20 students with dyslexia and other language-based learning  
21 disabilities, training shall address, but shall not be limited  
22 to:

23 (i) Evidence-based intervention practices on structured  
24 literacy.

25 (ii) Explicit and systematic instruction in phonological and  
26 phonemic awareness.

27 (iii) The alphabetic principle, decoding and encoding,  
28 fluency and vocabulary.

29 (iv) Reading comprehension and building content knowledge.

30 (2) School employees required to undergo continuing  
31 professional education under section 1205.1, 1205.2 or 1205.5  
32 shall receive credit toward the school employee's continuing  
33 professional education requirements [if the training program has  
34 been approved by the department].

36 (g) As used in this section, the following words and phrases  
37 shall have the meanings given to them in this subsection unless  
38 the context clearly indicates otherwise:

39 "Approved educator preparation program." A sequence of  
40 courses and experiences offered by a preparing institution or  
41 alternative provider that is reviewed and approved by the  
42 department.

43 "Chief school administrator." The superintendent of a school  
44 district, executive director of an intermediate unit,  
45 administrative director of an area career and technical school  
46 or chief executive officer of a charter school, cyber charter  
47 school or regional charter school.

48 "Department." The Department of Education of the  
49 Commonwealth.

50 "Educator." As defined in section 1501-N.

51 "Evidence-based reading instruction." As defined in section

1 1501-N.

2 ["Participating school entity." A school entity that elects  
3 to take part in the Structured Literacy Program.]

4 "School entity." A school district, intermediate unit, area  
5 career and technical school, charter school, cyber charter  
6 school or regional charter school.

7 "Structured literacy." Systemic, explicit instruction that:

8 (1) provides a strong core of foundational skills in the  
9 language systems of English;

10 (2) integrates listening, speaking, reading, spelling and  
11 writing; and

12 (3) emphasizes the structure of language across the speech  
13 sound system, the writing system, the structure of sentences,  
14 the meaningful parts of words, the relationship among words and  
15 the organization of spoken and written discourse.

16 Section 2. The act is amended by adding an article to read:

39 as provided in section 1205.8.

(4) The department shall provide a process through which a school entity can submit an application for additional curriculum that meets the requirements under paragraph (2) for inclusion on the list developed and maintained by the department under paragraph (2).

establish a reading leadership council that shall advise the department on the development and maintenance of the list of reading instruction curricula required under paragraph (2), the list of universal reading screeners and the list of structured literacy intervention approaches required under section 1503-N(d)(1). The following shall apply:

(i) The council shall have 20 members appointed by the department who have expertise in structured literacy and shall include public school elementary school staff, including the following:

(A) Primary classroom teachers in kindergarten through third grade.

(B) Reading specialists.

(C) Literacy coaches.

(D) Elementary special education teachers.

(E) A learning support employee with experience working with subgroups as defined in the Every Student Succeeds Act (Public Law 114-95, 129 Stat. 1802).

(ii) Membership on the council shall reflect geographic representation of school districts, including diversity of district types, including rural, urban and suburban.

(iii) The council shall meet at least once every two months at dates and times determined by the department.

(iv) In performing its work, the council may consult with other professionals and nonprofit organizations with expertise in structured literacy.

(6) This subsection shall expire five years from the effective date of this paragraph.
