He was known as an expert on the state's tax laws and, as an expert pilot, he also gained expertise on aviation issues. He authored a local tax reform package, designed to eliminate local nuisance taxes and reduce reliance on real property taxes to finance school districts and local government operations. He was an outspoken leader in the effort to reduce the Philadelphia Wage Tax on suburban commuters, the only legislator to get a bill passed to reduce the tax; now therefore be it
