The Senate met at 1 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Mark S. Schweiker) in the Chair.

GENERAL COMMUNICATION

APPLICATION OF THE COMMISSION ON CRIME AND DELINQUENCY FOR FUNDS PROVIDED UNDER THE ANTI-DRUG ABUSE ACT OF 1988

The PRESIDENT laid before the Senate the following communication, which was read by the Clerk as follows:

Dear Senator Jubelirer:

On behalf of the Pennsylvania Commission on Crime and Delinquency (PCCD), I am pleased to forward to you a copy of our final federal FY-1996 state application for funds provided through the Drug Control and System Improvement Formula Grant Program established by the Anti-Drug Abuse Act of 1988. Under the Act, all state applications are to be submitted for legislative review, but shall be deemed to be reviewed if the state Legislature does not comment on the application within 30 days. Our interim federal FY-1996 application which was required this year because of the federal government operating under a series of continuing resolutions was provided to you on February 23, 1996.

The Drug Control and System Improvement Formula Grant Program provides assistance to states and units of local government for the purpose of enforcing state and local drug laws, and to improve the functioning of the criminal justice system with emphasis on violent crime and serious offenders. PCCD was designated by the Governor as the state office to apply for and administer these funds. Pennsylvania's total FY-1996 allotment is approximately \$19.8 million.

PCCD will utilize the funds to continue state and local projects begun with the federal Drug Control and System Improvement Formula Grant Program FY-1993, 1994 and 1995 allocations. The enclosed application, which has been submitted to the federal Bureau of Justice Assistance, is consistent with the Governor's Executive Budget for 1996-97.

I will be pleased to answer any questions you may have concerning this application.

SB 589 (Pr. No. 2005) (Amended)

An Act relating to the rights of purchasers and lessees of defective new motor vehicles; creating a motor vehicle arbitration board; imposing obligations, duties of refund and replacement; making an appropriation; and making a repeal.

HB 1855 (Pr. No. 3548) (Amended)

An Act amending the act of May 1, 1933 (P.L.216, No.76), known as The Dental Law, further providing for the general powers of the State Board of Dentistry.

HB 2446 (Pr. No. 3411)

An Act amending Title 66 (Public Utilities) of the Pennsylvania Consolidated Statutes, affirming the opportunity for an electric public utility to restructure, buy down or buy out a nonutility generation contract from which such utility has an obligation to purchase electricity and affirming rate recovery of certain electric utility payments for such purposes.

Senator BELL, from the Committee on Consumer Protection and Professional Licensure, also reports Final Form Regulations 57-157 and 16A-572 have been reported to the IRRC without objections and that the committee supports implementation of the 1996-97 Philadelphia taxicab budget request.

Senator GREENLEAF, from the Committee on Judiciary, reports the following bills:

SB 853 (Pr. No. 2010) (Amended)

An Act amending Titles 18 (Crimes and Offenses) and 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, providing for sexual offenses by psychotherapists and practitioners of the healing arts.

SB 1398 (Pr. No. 2011) (Amended)

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, prohibiting the operation of clubs and businesses patronized primarily for the purpose of engaging in sexual activity.

SB 1469 (Pr. No. 2012) (Amended)

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, further providing for restitution.

SB 1470 (Pr. No. 1879)

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, providing for priority of restitution.

SB 1508 (Pr. No. 2013) (Amended)

An Act amending the act of April 9, 1929 (P. L. 177, No. 175), entitled "The Administrative Code of 1929," further providing for definitions, for powers and duties of the Bureau of Victims Services and for determination of claims, awards and responsibilities of employers; and making a repeal.

SB 1509 (Pr. No. 1929)

An Act amending the act of November 22, 1978 (P. L. 1166, No. 274), entitled "Pennsylvania Commission on Crime and Delinquency Law," further providing for composition of the commission.

HB 1182 (Pr. No. 3561) (Amended)

An Act amending Titles 18 (Crimes and Offenses) and 75 (Vehicles) of the Pennsylvania Consolidated Statutes, authorizing police officers to record certain oral communications; providing for authority to purchase surveillance devices; and providing for windshield obstructions and wipers.

HB 2379 (Pr. No. 3562) (Amended)

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, further providing for credit card fraud; defining the offense of unlawful device-making equipment; and providing penalties.

The PRESIDENT pro tempore. Mr. President, I have the distinct honor of introducing a group of young adults who are here with their coaches to be recognized by the Members of the Senate of Pennsylvania for once again winning the Class AAAA Girls Basketball Championship in Hershey. They defeated a team from Northampton County, if I am not mistaken. I hear a laugh from my back, so I guess that must be the one.

The Altoona Area High School Lady Lions are with us today, Mr. President, and I am so very proud of this particular group of people. They are here with their coaches, Art Taneyhill, Amy Palfey, and Jennyfer Moran. I think it would be fitting to recognize that this team has a distinguished history which would be worth mentioning at this time. They are not only outstanding athletes, they are outstanding students, and the seniors are all going on to further their education at the college level with scholarships because of their tremendous athletic abilities and the fact that they are academically well suited to that environment.

(4) Class M—A Class M license shall be issued to those persons who have demonstrated their qualifications to operate a motorcycle, including successful completion by persons 16 or 17 years of age of the program under section 7911 (relating to motorcycle safety education program). A Class M license accompanied by an endorsement shall be issued to those persons who have demonstrated their qualifications to operate a motor-driven cycle. If a person is qualified to operate only a motorcycle or motor-driven cycle, he shall be issued only a Class M license or a Class M license with an endorsement, as applicable.

§ 1505. Learners' permits.

* * *

(c) Operation of motorcycle.—A motorcycle learner's permit entitles the person to whom it is issued to operate a motorcycle only between sunrise and sunset and, except for a driver licensed to drive another class of vehicle, only while under the instruction and immediate supervision of a licensed motorcycle operator. Motorcycle learners shall not carry any passenger other than an instructor properly licensed to operate a motorcycle. <u>A motorcycle learner's permit shall</u> not be issued to a person 16 or 17 years of age who has not successfully completed the program under section 7911 (relating to motorcycle safety education program).

Senator MELLOW. Mr. President, this is not an agreed-to amendment. We have not even seen the amendment May we be at ease?

Senator MELLOW. Mr. President, I would like to go at ease for a moment.

The PRESIDENT pro tempore. The Senate will be at ease. (The Senate was at ease.)

AMENDMENT WITHDRAWN

The PRESIDENT. The Chair recognizes the gentleman from Lancaster, Senator Armstrong.

Senator ARMSTRONG. Mr. President, I withdraw my amendment A2760.

The PRESIDENT. Senator Armstrong has withdrawn his amendment.

And the question recurring, Will the Senate agree to the bill on third consideration? It was agreed to.

On the question, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentleman from Centre, Senator Corman.

Senator CORMAN. Mr. President, on this bill, the gentleman from Bucks, Senator Heckler, who is chairman of the Committee on Aging and Youth, and I, as chairman of the Committee on Transportation, held public hearings last fall in Philadelphia and in State College, and we took testimony from local police, from people from PennDOT, physicians, the district attorney of Philadelphia, the coroner from Blair County, senior citizens, and the Penn State transportation study team to try to find ways to make certain that everybody could be driving their cars as long as they possibly can, because in rural Pennsylvania it takes a car to get around. Many ideas were put forth and we are working on many of those ideas, but while we are working on those we came up with a change in the law that seems to be appropriate to take those people who are truly disabled to the point that they cannot drive a car and are dangerous to themselves and to others on the highway, and that is what this bill, Senate Bill No. 1332, proposes to do.

Each year, Mr. President, all physicians and other persons authorized to diagnose or treat disorders dealing with lapse of consciousness or other mental or physical problems affecting their ability to drive are required to report that to the Pennsylvania Department of Transportation, and each year physicians report about 40,000 Pennsylvanians they believe have some kind of difficulty. The police report another 2,000, and through accidents and family letters, we come up with another 500 people.

What happens when PennDOT receives that information? Well, some of the people they believe the information is faulty after they talk to the people on the phone and gather other information and they dismiss it. Some of the people, however, they believe have significant problems and ought to have their license immediately recalled, and these people are so notified to have their license recalled. If you receive notice that your license should be recalled, you are certainly entitled to have a public hearing. What we have found, Mr. President, is at these public hearings people who are badly disabled and cannot really drive did not appear at the hearing but had their attorneys represent them, and almost 100 percent of the hearings were granted so the people could continue to have their driver's license and continue to use it for another period of time until maybe they would finally be tested or have some doctors write a statement that they cannot drive a car.

What this bill would do is require the person to personally appear in front of the judge when the judge is granting this appeal of the recall of their license so the judge can see the condition of this person, and if the person's condition is quite evident that an appeal should not be granted, that appeal then would be denied at that time. Further, the bill would state that whenever PennDOT asked people to surrender their license or in fact come in to be retested or have a physical, with today's law, if this is ignored, we really cannot do anything about obtaining their license until the end of the period of time that it has been granted, and that may be nearly 4 years. Before then, PennDOT can refuse to just renew the license. So we are attempting to, in Senate Bill No. 1332, address that as well by saying if you ignore the notice from the Department of Transportation, they can then issue a recall and you can appeal the recall and prove that you ought not have the license taken from you. This bill has the support of senior citizen organizations, and I would encourage all my colleagues to pass it at this time.

I believe that the gentleman from Bucks, Senator Heckler, also has some comments, as he was co-chair of the committee that worked on this particular problem.

The PRESIDENT. The Chair recognizes the gentleman from Bucks, Senator Heckler.

Senator HECKLER. Mr. President, very briefly, this is good commonsense legislation, as the gentleman from Centre, Senator Corman, has pointed out. It just makes sure that those who have been properly identified to PennDOT as having some impairment, and as I believe the Senator pointed out, more than half of those people are under 45 years of age, so we are certainly not singling out any age class in our Commonwealth, but once either the police or medical personnel who are mandated reporters provide PennDOT with the information that there may be a problem with this person's driving ability, we simply make sure that they will respond to appropriate requests for either retaking a test or having a medical exam. And if they do not, their license will be suspended, and we make sure that where such a suspension occurs, the gambit which is presently used of filing an appeal, getting an automatic stay, and stretching out, depending on the court calendar of the particular county, stretching out that period of driving for some very extended period of time before a court even takes a look at the underlying merits of the appeal will no longer occur. This is good legislation, and we certainly urge its adoption.

And the question recurring, Shall the bill pass finally?
