SUMMARY: Amends Title 75 (Vehicle Code) Provides for yellow and white lights for tow trucks, red lights for vehicles used by probation officers in the First Judicial District of Philadelphia, internal blue lights for privately-owned vehicles used in answering emergency calls, yellow strobe lights for solid waste collection vehicles, internally mounted lights in certain fire police vehicles, and red lights for privately-owned SERT vehicles. This legislation would take effect in 60 days.

ANALYSIS: This legislation makes the following amendments to the Vehicle Code:

§102 (Definitions): 'Emergency vehicle' is amended to include a vehicle owned by a city of the first class and operated by first judicial district certified armed probation officers. These vehicles are now authorized to be equipped with one or more revolving or flashing red lights and an audible warning system, granted under §4571 (Visual and audible signals on emergency vehicles). Vehicles used by police officers who are members of a county or regional special emergency response team (SERT) are also added to the definition of "emergency vehicle."

Police officers who are members of a county or regional SERT are also added to the definition of "emergency responder."

'Solid waste collection vehicle' is defined as a vehicle used for the curbside collection of municipal solid waste or recyclables.

§4571 (Visual and audible signals on emergency vehicles): The existing section is amended to extend the use of flashing or revolving internal lights in vehicles used in answering emergency calls to fire police captains or fire police lieutenants that comply with PennDOT's regulations. This section is also amended to authorize police officers who are members of a county or regional SERT to have their privately-owned vehicle equipped with flashing or revolving red lights.

§4572 (Visual signals on authorized vehicles): The existing section is amended to state that PennDOT may not prohibit the use of flashing or revolving blue lights mounted internally in the passenger compartment of a privately-owned vehicle used in answering an emergency call that otherwise comply with PennDOT regulations.

§4572.1 (Flashing or revolving yellow and white lights): This newly established section states that tow trucks are authorized to be equipped with yellow and white flashing or revolving lights. Limitations on the usage of those lights are listed, and they shall not be operated when:

- Not engaged in the act of towing a vehicle;
- Brake lights, turn signals and operating lights are visible from the rear and not obstructed;
- The vehicle being towed does not trail behind the tow truck and is securely positioned on the flatbed of the tow truck with no parts of the towed vehicle overhanging.

The penalty for misuse under the section is a \$50 fine.

§4572.2 (Solid waste collection vehicles): This newly established section authorizes solid waste collection vehicles to use a bright yellow strobe, visible from all directions, and provides requirements that the yellow strobe must be active when stopped upon a street and while engaged in the collection of garbage, solid waste, recyclables and refuse while moving between stops at a speed not greater than 10 miles per hour.

General rules of the road for the motoring public when interacting with solid waste collection vehicles are also prescribed. An approaching vehicle shall:

- Make a lane change into a lane not adjacent to the solid waste collection, if possible;
- If the above is impossible, prohibited by law or unsafe, reduce speed of the motor vehicle to a reasonable and proper speed for the existing road and traffic conditions, which shall be less than the posted speed limit, and be prepared to stop.

FISCAL IMPACT: This legislation would have no adverse fiscal impact on Commonwealth or local funds.
