**SUMMARY:** HB 613 PN 3479 provides funding for the state-related universities (Penn State, Pitt, Temple, and Lincoln), funding for the University of Pennsylvania for the university's veterinary school and authorizes appropriations of moneys in the restricted account within the Agricultural College Land Scrip Fund to Penn State University. This legislation would take effect immediately.

**ANALYSIS & FISCAL IMPACT:** This legislation makes a number of appropriations to the Commonwealth's state-related universities (Penn State, Pitt, Temple, and Lincoln) and the University of Pennsylvania. Additionally, the bill authorizes appropriation of moneys in the restricted account within the Agricultural Land Scrip Fund to Penn State University. Lastly, the bill provides for restrictions.

\*Legislation appropriates funding for the University of Pennsylvania for the university's veterinary activities for both the 2023/24 and 2024/25 fiscal years, as the General Assembly did not enact appropriations for 2023/24.

## Agricultural College Land Scrip Fund

Each year, the General Appropriation Act (GAA) includes a transfer appropriation from the General Fund in the Department of Agriculture's budget to the Agricultural College Land Scrip Fund. In 2023/24, the amount appropriated was \$57.7 million. These funds support agriculture research in the College of Agriculture and the county cooperative extension offices, which Penn State runs as the commonwealth's land grant institution.

# **University of Pittsburg restrictions**

Legislation also places restrictions on the use of appropriations by the university:

- Funds may not be used for personnel and operating costs of an environmental law clinic
- Funds shall only be used for costs directly related to providing of instruction for graduate and undergraduate students and costs incurred in providing student related services and community outreach services, consistent with the existing laws of the commonwealth

### University of Pennsylvania restrictions

Legislation further requires money appropriated to the University of Pennsylvania to be "conditioned on continuing authority for inclusion on the Board of Trustees of the University of Pennsylvania" of four persons who are not elected officials and who are appointed by:

- President Pro Tempore of the Senate
- Minority leader of the Senate
- Speaker of the House of Representatives
- Minority leader of the House of Representatives
