DESCRIPTION AND PURPOSE OF BILL

Senate Bill 1086 amends Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in registration of vehicles, further providing for display of registration plate and for surrender of registration plates and cards upon suspension or revocation and providing for suspension of registration upon unpaid tolls and, in fees, further providing for reinstatement of operating privilege or vehicle registration.

This legislation authorizes the Pennsylvania Department of Transportation (Department) to suspend the vehicle registration of a motorist that evades or fails to pay a toll on the Pennsylvania Turnpike or another tolling entity.

The legislation does the following:

- Expands §1332 (relating to display of registration plate) to make it unlawful to display on any vehicle a registration plate which:
 - 1) Inhibits the proper operation of an automated enforcement system authorized by this title or an electronic toll collection system as authorized under 74 Pa.C.S §8117 (relating to toll collection); or,
 - 2) Is obscured, covered or otherwise obstructed in a manner which inhibits the visibility of the issuing jurisdiction at a reasonable distance.
- Updates §1376 (relating to surrender of registration plates and cards upon suspension or revocation) to provide for immediate seizure of registration plates and cards when a suspension is imposed pursuant to §1380 until all tolls, administrative fees and costs have been paid, dismissed, reversed on appeal or cancelled or if the owner or registrant enters into an agreement with the tolling entity to make installment payments.

- Adds a new section, §1380 (relating to suspension of registration upon unpaid tolls) that clarifies the process of suspending a vehicle registration for evading and/or failing to pay a toll to a "tolling entity." Additionally, this new section establishes certain procedures that shall be followed in order for a vehicle registration to qualify for suspension. A "tolling entity" is defined as follows:
 - 1) The Pennsylvania Turnpike Commission (PTC); and
 - 2) An entity, or its authorized agent, authorized to impose and collect tolls in accordance with the laws of this Commonwealth, the laws of another state, or the terms of an interstate compact or agreement.
- Provides for reciprocal collection agreements with other states;
- Implements a 3-year statute of limitations on imposing a vehicle registration suspension for evading or failure to pay a toll; and
- Amends §1960 (relating to reinstatement of operating privilege or vehicle registration) requiring the Department to charge a fee of \$88, to restore a person's vehicle registration, as a result of a violation of §1380.

The definition for a "tolling entity" was amended with the intention of making it broad enough to capture the Delaware River Port Authority (DRPA) and the Delaware River Joint Toll Bridge Commission (DRJTBC).

This act shall take effect in nine months.

FISCAL IMPACT:

Currently, tolling entities have no effective enforcement authority to collect tolls that were evaded and/or not paid at the time of exit. Uncollected tolls can only be placed with a collection agency and cannot be reported to credit reporting agencies, unlike other state agencies and authorities in the Commonwealth that have penalties in place for violators. A violator cannot have their driver's license and/or vehicle registration suspended and cannot be charged with any offense under Title 75.

Of the \$766 million in E-ZPass revenue collected during the PTC's last fiscal year (ending May 31, 2016), approximately \$5.4 million, or 0.7%, was considered "uncollectible" violation revenues that were written off after all collection efforts or adjusted charges were exhausted.
