## AN ACT

- Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An 1
- act to consolidate, editorially revise, and codify the public welfare laws of the Commonwealth, providing for unlicensed 2
- residential habilitation waiver services and reimbursement. 4
- 5 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows: 6
- The act of June 13, 1967 (P.L.31, No.21), known 7 Section 1.
- as the Public Welfare Code, is amended by adding a section to 8
- 9 read:
- Section 211.1. Unlicensed Residential Habilitation Waiver 10
- Services. -- Subject to Federal approval of such amendments as may 11
- 12 be necessary to the Commonwealth's approved Title XIX State
- 13 plan, the department shall do all of the following:
- 14 (1) Permit a relative or legal quardian of an individual
- 15 with an intellectual disability to provide unlicensed
- residential habilitation waiver services to the individual in a 16
- 17 residential setting approved by the department. A residential
- setting may include the private home of an individual with an 18

- 1 intellectual disability and the private home of a relative or
- 2 <u>legal quardian of an individual with an intellectual disability</u>.
- 3 (2) Promulgate regulations that establish the process and
- 4 criteria to be used to determine eligibility for a relative or
- 5 legal quardian of an individual with an intellectual disability
- 6 to provide unlicensed residential habilitation waiver services
- 7 to the individual in residential settings approved by the
- 8 department. The relative or legal quardian must meet the
- 9 qualifications criteria for providers of residential
- 10 habilitation waiver services set forth by the department as of
- 11 the effective date of this section.
- 12 (3) Establish reimbursement rates for eliqible relatives or
- 13 legal quardians providing unlicensed residential habilitation
- 14 waiver services.
- 15 Section 2. Within 90 days of the effective date of this
- 16 section, the Department of Public Welfare shall submit to the
- 17 appropriate Federal agency a request for necessary waivers of
- 18 Federal law and regulations and for any other approvals by the
- 19 Federal Government necessary for the implementation of the
- 20 changes and additions made by the addition of section 211.1 of
- 21 the act. It is the obligation of the department to enter into
- 22 good faith negotiations with the appropriate Federal authorities
- 23 and to make every effort to obtain the necessary Federal waivers
- 24 and approvals.
- 25 Section 3. This act shall take effect immediately.
