AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto, " providing for school police and
- security officer training.
- 7 The General Assembly finds and declares as follows:
- 8 (1) School security officers and security guards
- 9 employed by school districts across this Commonwealth are
- 10 entrusted with securing our school buildings, property and
- the safety of our students, staff, administration and all
- related support staff employed in the educational setting.
- 13 These security officers and quards are to ensure that the
- 14 youth of this Commonwealth have a safe learning environment.
- 15 (2) The purpose of this act is to provide for the
- 16 education, training and certification of school security
- 17 personnel as a basis of their employment and to prescribe a
- 18 course of instruction to obtain certification.
- 19 The General Assembly of the Commonwealth of Pennsylvania

- 1 hereby enacts as follows:
- 2 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 3 as the Public School Code of 1949, is amended by adding a
- 4 section to read:
- 5 <u>Section 778.1. Training Requirements for School Security</u>
- 6 Officers.--(a) Education and training requirements for security
- 7 officers are as follows:
- 8 (1) A security officer hired by a school district on or
- 9 after the effective date of this section must complete a
- 10 mandated training course within one year of being hired.
- 11 (2) A security officer hired by a school district prior to
- 12 the effective date of this section shall have a reasonable
- 13 amount of time, as determined by the board of directors of the
- 14 school district, to either give cause to the board's
- 15 satisfaction as to why the training should be waived or to
- 16 <u>complete the mandated training course.</u>
- 17 (3) An approved training course must include the following
- 18 topics:
- 19 (i) Professionalism.
- 20 (ii) Authority as a security officer.
- 21 (iii) Report writing.
- 22 (iv) Self-defense and dealing with unruly students and
- 23 adults.
- 24 (v) Search and seizure on school property.
- 25 (vi) Testifying in court.
- 26 (vii) Working with State and local police agencies.
- 27 (viii) Lockdown and crisis procedures.
- 28 (ix) Interviewing witnesses.
- 29 (x) Preserving evidence.
- 30 (xi) The relevant provisions of this act.

- 1 (xii) Basic computer skills.
- 2 (xiii) Custody issues specific to schools.
- 3 (xiv) Crowd control.
- 4 (xv) Special events security.
- 5 (xvi) Drug identification.
- 6 (xvii) Truancy and related issues.
- 7 (4) In addition, a security officer must be certified in
- 8 basic first aid, cardiopulmonary resuscitation (CPR) and
- 9 <u>automated external defibrillator (AED)</u> usage.
- 10 (5) An approved training course must include at least sixty
- 11 (60) hours of instruction.
- 12 (6) Instructors for the required course material must be
- 13 <u>accredited through one of the following:</u>
- 14 (i) The department.
- 15 (ii) The Pennsylvania Commission on Crime and Delinquency.
- 16 (iii) The provisions of 53 Pa.C.S. Ch. 21 Subch. D (relating
- 17 to municipal police education and training).
- 18 (iv) The Pennsylvania State Police.
- 19 (7) Instructors for any additional course material must be
- 20 approved by a board of directors of a school district.
- 21 (b) The board of directors of a school district shall have
- 22 the duty to:
- 23 (1) Adopt curriculum that is in compliance with this
- 24 section.
- 25 (2) Pay costs of certification and recertification, but not
- 26 for qualification for training.
- 27 (3) Set the date and location of the certification and
- 28 recertification courses.
- 29 (4) Maintain and file with the department a list of all
- 30 <u>certified security officers</u> in the school district.

- 1 (c) The department shall have the duty to approve all school
- 2 board-adopted policies and the authority to promulgate rules and
- 3 regulations consistent with this section and to issue
- 4 certification or recertification upon successful completion of
- 5 the mandated and approved training course.
- 6 (d) A person who is certified under 53 Pa.C.S. § 2167
- 7 (relating to police training), 2168 (relating to automatic
- 8 <u>certification</u>) or 2169 (relating to in-service training by
- 9 <u>existing personnel</u>) shall be automatically certified by the
- 10 board of directors of a school district.
- 11 (e) To qualify for admission into a training course, the
- 12 <u>individual</u> must meet all the following:
- 13 (1) Be eighteen (18) years of age or older.
- 14 (2) Have a physician attest to the individual's physical
- 15 ability to perform the duties of a security officer.
- 16 (3) Have on file with both the board of directors of a
- 17 <u>school</u> district and the department the following:
- 18 (i) A Federal Bureau of Investigation (FBI) clearance.
- 19 (ii) A completed background check under section 111.
- 20 (iii) Clearance under 23 Pa.C.S. Ch. 63 Subch. C.2 (relating
- 21 to background checks for employment in schools).
- 22 (f) The department shall issue a certification to the
- 23 <u>individual upon successful completion of the required training</u>
- 24 course. Certification may be renewed annually upon successful
- 25 completion of twenty (20) hours of continuing education
- 26 consisting of updates to the basic curriculum or specialized
- 27 areas that a board of directors of a school district deems
- 28 <u>necessary</u>.
- 29 (q) Nothing in this section shall require or prohibit a
- 30 centralized training or recertification course.

- 1 (h) As used in this section:
- 2 <u>"Department." The Department of Education of the</u>
- 3 <u>Commonwealth.</u>
- 4 "Security officer." A person employed by a school district
- 5 for the purpose of maintaining the security of the school. The
- 6 term shall include school police officers hired under section
- 7 778.
- 8 Section 2. This act shall take effect in 60 days.
