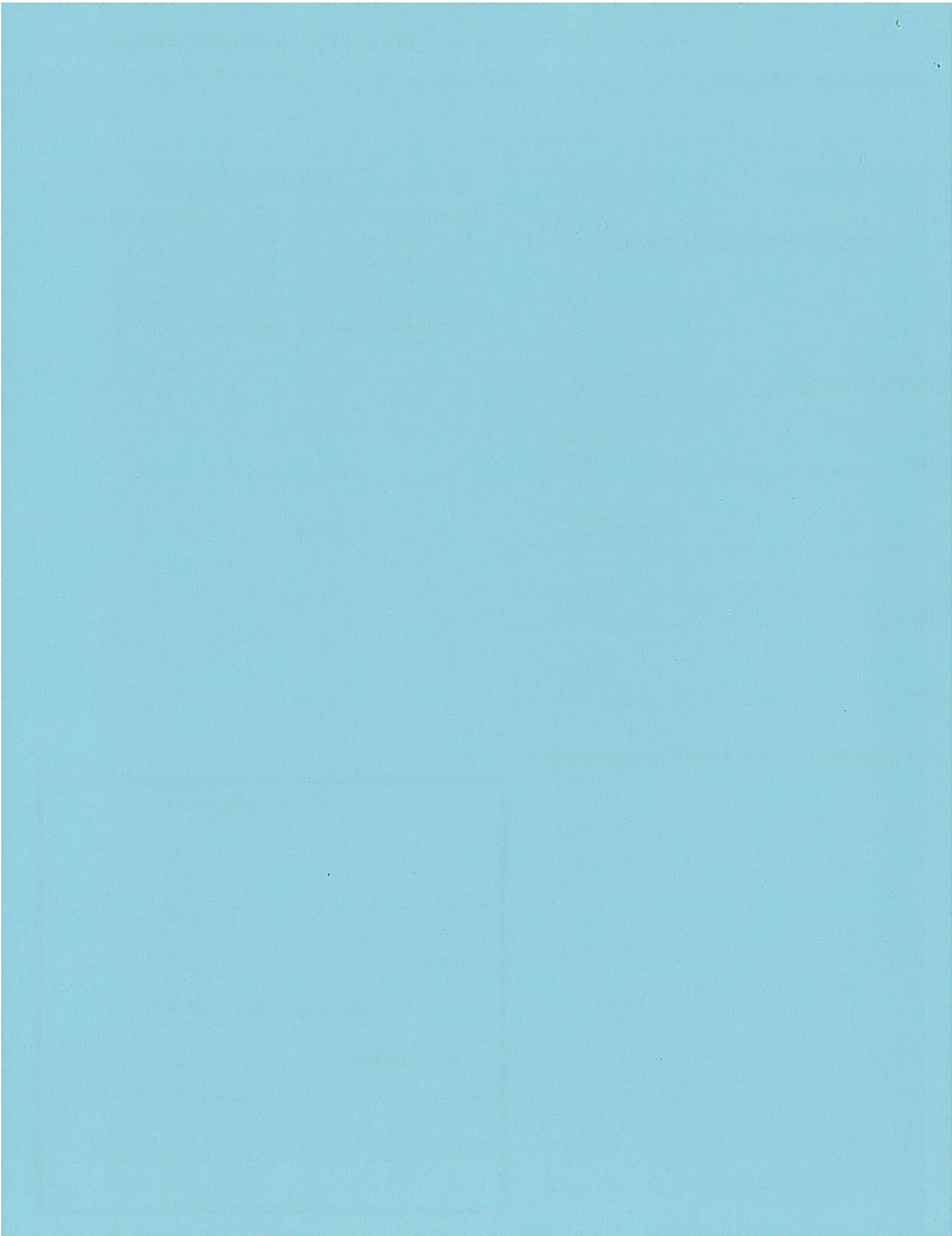

A JOINT RESOLUTION

1 Proposing separate and distinct amendments to the Constitution
2 of the Commonwealth of Pennsylvania, further providing for
3 terms of members and for the Legislative Reapportionment
4 Commission.

5 The General Assembly of the Commonwealth of Pennsylvania
6 hereby resolves as follows:

7 Section 1. The following separate and distinct amendments to
8 the Constitution of Pennsylvania are proposed in accordance with
9 Article XI:

10 (1) That section 3 of Article II be amended to read:

11 § 3. Terms of members.

12 [Senators shall be elected for the term of four years and
13 Representatives for the term of two years.]

14 (a) Senators shall be elected for the term of six years. No
15 person shall hold the office of Senator for a period of longer
16 than two successive terms of six years. Terms of Senators shall
17 be considered successive unless separated by a period of six or

1 more years. Representatives shall be elected for the term of
2 four years. No person shall hold the office of Representative
3 for a period longer than three successive terms of four years.
4 Terms of Representatives shall be considered successive unless
5 separated by a period of four or more years.

6 (b) In determining the eligibility of an individual to hold
7 office in accordance with subsection (a):

8 (1) Time spent in office in fulfillment of a term to which
9 another person was first elected shall not be considered,
10 provided that a period of at least six years for Senators and at
11 least four years for Representatives passed between the time, if
12 any, the individual previously held that office and the time the
13 individual is elected to fulfill the unexpired term.

14 (2) A person who is elected to office in a regularly
15 scheduled general election and resigns prior to the completion
16 of the term for which the person was elected shall be considered
17 to have served the full term in that office.

18 (c) Senators elected at the general election in 2014 and
19 thereafter shall serve a six-year term. Senators now elected and
20 those whose terms are unexpired shall represent the districts in
21 which they reside until the end of the terms for which they were
22 elected.

23 (d) Representatives in odd-numbered districts elected at the
24 general election in 2014 shall serve a four-year term, and
25 Representatives in even-numbered districts elected at the
26 general election in 2014 shall serve a two-year term.
27 Representatives in even-numbered districts elected at the
28 general election in 2016 shall serve a four-year term.

29 (2) That section 17(f) of Article II be amended to read:

30 § 17. Legislative Reapportionment Commission.

1 * * *

2 (f) Any district which does not include the residence from
3 which a member of the Senate or House of Representatives was
4 elected whether or not scheduled for election at the next
5 general election shall elect a Senator or Representative at such
6 election.

7 * * *

8 Section 2. The provisions of this resolution apply only to
9 terms served by members of the General Assembly after the first
10 election cycle following the ratification of this constitutional
11 amendment and thereafter.

12 Section 3. (a) Upon the first passage by the General
13 Assembly of these proposed constitutional amendments, the
14 Secretary of the Commonwealth shall proceed immediately to
15 comply with the advertising requirements of section 1 of Article
16 XI of the Constitution of Pennsylvania and shall transmit the
17 required advertisements to two newspapers in every county in
18 which such newspapers are published in sufficient time after
19 passage of these proposed constitutional amendments.

20 (b) Upon the second passage by the General Assembly of these
21 proposed constitutional amendments, the Secretary of the
22 Commonwealth shall proceed immediately to comply with the
23 advertising requirements of section 1 of Article XI of the
24 Constitution of Pennsylvania and shall transmit the required
25 advertisements to two newspapers in every county in which such
26 newspapers are published in sufficient time after passage of
27 these proposed constitutional amendments. The Secretary of the
28 Commonwealth shall submit the proposed constitutional amendment
29 under section 1(1) to the qualified electors of this
30 Commonwealth as a ballot question and the proposed

1 constitutional amendment under section 1(2) to the electors of
2 this Commonwealth as a separate ballot question at the first
3 primary, general or municipal election which meets the
4 requirements of and is in conformance with section 1 of Article
5 XI of the Constitution of Pennsylvania and which occurs at least
6 three months after the proposed constitutional amendments are
7 passed by the General Assembly.
