- 10 § 6120. Limitation on the regulation of firearms and

- 13 Relief. -- A person adversely affected by an ordinance, (a.2)
- a resolution, regulation, rule, practice or any other action 14
- promulgated or enforced by a county, municipality or township 15
- 16 prohibited under subsection (a) or 53 Pa.C.S. § 2962(g)
- (relating to limitation on municipal powers) may seek 17
- declaratory or injunctive relief and actual damages in an 18

- 1 appropriate court.
- 2 (a.3) Reasonable expenses.--[A] <u>If a person adversely</u>
- 3 affected provided 60 days' prior written notice of his intention
- 4 to file an action pursuant to subsection (a.2) to the defendant,
- 5 the court shall award reasonable expenses to [a] the person
- 6 adversely affected in an action under subsection (a.2) for any
- 7 of the following:
- 8 (1) A final determination by the court is granted in
- 9 favor of the person adversely affected.
- 10 (2) The regulation in question is rescinded, repealed or
- 11 otherwise abrogated after suit has been filed under
- 12 subsection (a.2) but before the final determination by the
- 13 court.
- 14 (b) Definitions.--As used in this section, the following
- 15 words and phrases shall have the meanings given to them in this
- 16 subsection:
- 17 "Dealer." The term shall include any person engaged in the
- 18 business of selling at wholesale or retail a firearm or
- 19 ammunition.
- 20 "Firearms." This term shall have the meaning given to it in
- 21 section 5515 (relating to prohibiting of paramilitary training)
- 22 but shall not include air rifles as that term is defined in
- 23 section 6304 (relating to sale and use of air rifles).
- "Person adversely affected." Any of the following:
- 25 (1) A resident of this Commonwealth who may legally
- 26 possess a firearm under Federal and State law.
- 27 (2) A person who otherwise has standing under the laws
- of this Commonwealth to bring an action under subsection
- 29 (a.2).
- 30 (3) A membership organization, in which a member is a 2017D00650 2 -

- person described under paragraph (1) or (2).
- 2 "Political subdivision." The term shall include any home
- 3 rule charter municipality, county, city, borough, incorporated
- 4 town, township or school district.
- 5 "Reasonable expenses." The term includes, but is not limited
- 6 to, attorney fees, expert witness fees, court costs and
- 7 compensation for loss of income.
- 8 Section 2. This act shall take effect in 60 days.
