

7	The General Assembly of the Commonwealth of Pennsylvania
8	hereby enacts as follows:
9	Section 1. Section 778 of the act of March 10, 1949 (P.L.30,
10	No.14), known as the Public School Code of 1949, is amended by
11	adding subsections to read:
12	Section 778. School Police Officers* * *
13	(b.2) Every school police officer, school resource officer,
14	or school security officer shall successfully complete training
15	designed to facilitate working with children and adolescents,
16	including those with mental health and behavioral health needs
17	due to a disability. Training shall be completed within 120 days
18	of the officer's commission or placement with a school district
19	or on a school campus, or within 120 days of the adoption of the

curriculum, whichever applies.

(1) The Municipal Police Officers Education Training 2

Commission shall develop, adopt or otherwise make available an 3

appropriate training curriculum related specifically to children 4

and adolescents that includes the following topics: 5

(i) Child and adolescent development and psychology. 6

(ii) Mental health, trauma and behavioral health needs of 7

children with disabilities, including crisis intervention 8

9 techniques especially suited to those children.

(iii) Positive behavioral interventions and supports, 10

conflict resolution techniques and restorative justice 11

12 practices.

(iv) De-escalation techniques and methods for limiting the 13

use of force, including the use of physical, mechanical and 14

15 chemical restraints.

(v) Emergency planning considerations and age-appropriate 16

safety instruction training, including for students with mental 17

health, disabilities or other behavioral health needs. 18

(2) The curriculum shall be made available within six months 19

of the effective date of this section. Before adopting the 20

curriculum, the commission shall provide a thirty (30) day 21

22 period for public comment.

23 (3) The commission shall review the curriculum developed and

adopted under this section and update the subject matter as 24

needed at least once every three years. 25

(4) A school police officer, school security officer or 26

school resource officer who has completed the Basic School 27

Resource Officer Course conducted by the National Association of 28

School Resource Officers within the last three years, or a 29

training course equivalent as accepted by the commission, shall 30

3	(b.3) (1) School security officers who carry a firearm as a
4	requirement of such employment shall complete firearm
5	recertification every two years.
