## AN ACT

1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated  
2 Statutes, in licensing of drivers, further providing for  
3 issuance and content of driver's license.

4 The General Assembly of the Commonwealth of Pennsylvania  
5 hereby enacts as follows:

6 Section 1. Section 1510 of Title 75 of the Pennsylvania  
7 Consolidated Statutes is amended by adding subsections to read:  
8 § 1510. Issuance and content of driver's license.

9 \* \* \*

10 (b.1) Reduced-cost identification card for a homeless  
11 individual.--The department shall issue an identification card  
12 at a reduced cost to an individual who is ten years of age or  
13 older, who is homeless and who has made application for the  
14 identification card in the manner as the department shall  
15 prescribe. The following apply:

16 (1) The reduced cost of the identification card shall be  
17 one-half of the full cost of an identification card as  
18 prescribed by the department in the year in which the

1 applicant has applied for the identification card.

2 (2) The department may require additional documentation  
3 to verify the homeless status of an applicant.

4 (3) For the purposes of this subsection, the term  
5 "homeless" shall have the meaning given to it in section 103  
6 of the McKinney-Vento Homeless Assistance Act (Public Law  
7 100-77, 42 U.S.C. § 11302).

8 (b.2) Reduced-cost identification card for an individual in  
9 poverty.--The department shall issue an identification card at a  
10 reduced cost to an individual who is ten years of age or older,  
11 who is a member of a household in poverty and who has made  
12 application for the identification card in the manner as the  
13 department shall prescribe. The following shall apply:

14 (1) The reduced cost of the identification card shall be  
15 one-half of the full cost of an identification card as  
16 prescribed by the department in the year in which the  
17 applicant has applied for the identification card.

18 (2) The department may require additional documentation  
19 to verify an applicant's poverty status.

20 (3) For the purposes of this subsection, the term  
21 "poverty" shall mean a household with total income at or  
22 below the poverty guideline, adjusted for household size, as  
23 published annually by the United States Department of Health  
24 and Human Services in the Federal Register.

25 (b.3) Reduced-cost identification card for a disabled  
26 individual.--The department shall issue an identification card  
27 at a reduced cost to an individual who is ten years of age or  
28 older, who is considered disabled as described in section  
29 1338(a) (relating to person with disability plate and placard)  
30 and who has made application for the identification card in the

1 manner as the department shall prescribe. The following shall  
2 apply:

3 (1) The reduced cost of the identification card shall be  
4 one-half of the full cost of an identification card as  
5 prescribed by the department in the year in which the  
6 applicant has applied for the identification card.

7 (2) The department may require a health care provider's  
8 statement as described in section 1338(c) to verify an  
9 applicant's disabled status.

10 (b.4) Reduced-cost identification card for senior  
11 citizens.--The department shall issue an identification card at  
12 a reduced cost to a senior citizen who has made application for  
13 the identification card in the manner as the department shall  
14 prescribe. The following shall apply:

15 (1) The reduced cost of the identification card shall be  
16 one-half of the full cost of an identification card as  
17 prescribed by the department in the year in which the  
18 applicant has applied for the identification card.

19 (2) The department may require additional documentation  
20 to verify an applicant's status as a senior citizen.

21 (3) For the purposes of this subsection, the term  
22 "senior citizen" shall have the meaning given to it in 74  
23 Pa.C.S. § 1503 (relating to definitions).

24 (b.5) Reduced-cost identification card for veterans.--The  
25 department shall issue an identification card at a reduced cost  
26 to a veteran who has made application for the identification  
27 card in the manner as the department shall prescribe. The  
28 following shall apply:

29 (1) The reduced cost of the identification card shall be  
30 one-half of the full cost of an identification card as

1 prescribed by the department in the year in which the  
2 applicant has applied for the identification card.

3 (2) The department may require additional documentation  
4 to verify an applicant's status as a veteran.

5 (3) For the purposes of this subsection, the term  
6 "veteran" shall have the meaning given to it in 51 Pa.C.S. §  
7 7202 (relating to definitions).

9 Section 2. This act shall take effect in 60 days.
