A RESOLUTION

- 1 Urging the Trump Administration to not include a citizenship question in the 2020 decennial census.
- 3 WHEREAS, The Founding Fathers understood the importance of
- 4 keeping an accurate recording of the country's population by
- 5 including it as a constitutional requirement; and
- 6 WHEREAS, Article I, Section 2, Clause 3 of the United States
- 7 Constitution, known as the Enumeration Clause, confers on
- 8 Congress the power to conduct an actual enumeration every 10
- 9 years; and
- 10 WHEREAS, Since the adoption of the 14th Amendment, the United
- 11 States Constitution has mandated that all persons, regardless of
- 12 race, citizenship or legal status, be included in the decennial
- 13 census count; and
- 14 WHEREAS, The indisputable fact that all persons, including
- 15 the nonvoting classes, have a vital interest in the conduct of
- 16 the government is just as true today as it was in 1866; and
- 17 WHEREAS, When the 39th Congress debated the wording for the

- 1 14th Amendment, options including "voters" and "citizens" were
- 2 considered and expressly rejected, before the language "whole
- 3 number of persons" was decided upon; and
- 4 WHEREAS, Congress delegated the responsibility of conducting
- 5 the actual enumeration of the population through the Census Act
- 6 to the Secretary of Commerce who may delegate authority for
- 7 establishing procedures to conduct the census to the Census
- 8 Bureau; and
- 9 WHEREAS, The fundamental constitutional and statutory purpose
- 10 of the Census Bureau in conducting the decennial census is to
- 11 acquire an accurate and actual enumeration of the population;
- 12 and
- WHEREAS, Federal law requires the Secretary of Commerce to
- 14 advise Congress as to the questions, which are typically
- 15 thoroughly developed and tested, to be included on the decennial
- 16 census; and
- WHEREAS, The report transmitted by the Secretary of Commerce
- 18 advising Congress of the questions to be incorporated in the
- 19 2020 decennial census included a demand for information
- 20 regarding the citizenship status of every person in the country;
- 21 and
- 22 WHEREAS, By including the demand for citizenship information
- 23 in the 2020 questionnaire, the Census Bureau deviated from its
- 24 adopted standards and practices for ensuring the accuracy of the
- 25 decennial census and violated the requirements of the
- 26 Information Quality Act; and
- 27 WHEREAS, For decades, the Census Bureau has acknowledged and
- 28 expressed the public opinion that the inclusion of questions on
- 29 citizenship or immigration status would deter census
- 30 participation and in turn impair population count accuracy; and

- 1 WHEREAS, During litigation seeking to compel the Census
- 2 Bureau to demand disclosure of immigration status in 1980, the
- 3 Census Bureau argued that "any effort to ascertain citizenship
- 4 will inevitably jeopardize the overall accuracy of the
- 5 population count." Federation for American Immigration Reform v.
- 6 Klutznick, 486 F. Supp. 564 (D.D.C. 1980); and
- 7 WHEREAS, The Census Bureau further explained that:
- 8 "[o]btaining the cooperation of a suspicious and fearful
- 9 population would be impossible if the group being counted
- 10 perceived any possibility of the information being used
- against them. Questions as to citizenship are
- 12 particularly sensitive in minority communities and would
- inevitably trigger hostility, resentment and refusal to
- 14 cooperate." Id.;
- 15 and
- 16 WHEREAS, The position of the Census Bureau regarding the
- 17 detrimental effects of a citizenship or immigration status
- 18 question on the accuracy of the decennial census has remained
- 19 unwavering regardless of the administration or political party;
- 20 and
- 21 WHEREAS, Even without a citizenship demand, minority and
- 22 immigrant populations have historically been some of the hardest
- 23 groups to count accurately in the decennial census; and
- 24 WHEREAS, Statistically, the 2010 census failed to count more
- 25 than 1.5 million minorities, and the Hispanic population was
- 26 undercounted by 1.54% in 2010, by 0.71% in 2000 and by 4.99% in
- 27 1990; and
- WHEREAS, Immigrants account for 6.8% of Pennsylvania's
- 29 population, and in 2014, more than one in five immigrants in
- 30 Pennsylvania were undocumented; and

- 1 WHEREAS, Immigrants account for 13.1% of Philadelphia's
- 2 population, and in 2014, an estimated 50,000 undocumented
- 3 immigrants lived in Philadelphia; and
- WHEREAS, Immigrants account for 8.5% of Pittsburgh's
- 5 population, and in 2014, an estimated 18% of those immigrants
- 6 were undocumented; and
- WHEREAS, In addition to participation and accuracy concerns,
- 8 population data from the census is used to apportion
- 9 representatives to Congress, draw state and local legislative
- 10 districts, allocate electors to the electoral college and
- 11 distribute billions of dollars in Federal funding; and
- WHEREAS, Approximately \$800 billion is annually distributed
- 13 to nearly 300 different Federal programs based on census counts,
- 14 and a citizenship question could deprive a state or municipality
- 15 of its statutory fair share of Federal funding due to inaccurate
- 16 counts; and
- WHEREAS, Some of the biggest line items in the Federal budget
- 18 that rely, at least in part, on census data, include health
- 19 programs such as Medicaid, the Supplemental Nutrition Assistance
- 20 Program (SNAP), education programs, infrastructure plans and
- 21 highway planning and construction programs; and
- WHEREAS, Pennsylvania received more than \$1.67 billion in
- 23 Highway Trust Fund grants in 2015, which is funding allocated on
- 24 the basis of local population estimates collected through the
- 25 decennial census, for road construction and other surface
- 26 transportation programs; and
- WHEREAS, Pennsylvania received nearly \$183 million in
- 28 urbanized area formula grants for planning, operating and
- 29 improving transportation; and
- 30 WHEREAS, The Child Care and Development Fund allocates

- 1 funding based on census information of the number of children
- 2 under 13 years of age, of which Pennsylvania received more than
- 3 \$116 million in grants in 2015; and
- 4 WHEREAS, The Medicaid Program relies on per capita income
- 5 information calculated with decennial census data to determine
- 6 the amount to reimburse each state for medical assistance
- 7 payments on behalf of low-income individuals, and, in 2015,
- 8 Pennsylvania received \$11.2 billion in reimbursement under the
- 9 Medicaid program; and
- 10 WHEREAS, If Pennsylvania had even a 1% undercount on the 2010
- 11 decennial census, the Commonwealth would have lost nearly \$222
- 12 million in Federal funding as reimbursement under the Medicaid
- 13 program in one year; and
- 14 WHEREAS, Undercounts of both citizens and noncitizens alike
- 15 in immigrant communities due to the addition of a citizenship
- 16 question will inhibit a state's representational interests and
- 17 its ability to meet constitutional requirements in creating
- 18 congressional and state legislative districts; and
- 19 WHEREAS, Each state relies on the accuracy of the decennial
- 20 census in order to comply with the 14th Amendment's one-person,
- 21 one-vote requirement, which requires that a legislative district
- 22 be as close to equal population as practicable and that
- 23 congressional apportionment be based on total population; and
- 24 WHEREAS, The decision to include a citizenship question in
- 25 the 2020 decennial census is so detrimental to our democracy
- 26 that the Commonwealth of Pennsylvania joined a coalition of 17
- 27 other attorneys general, several cities and the bipartisan
- 28 United States Conference of Mayors in filing a lawsuit to block
- 29 the collection of the information; and
- 30 WHEREAS, The well-documented concerns and risks surrounding a

- 1 citizenship question on the census are heightened in the current
- 2 political climate given the President's anti-immigrant rhetoric
- 3 and the current administration's pattern of actions and policies
- 4 targeting immigrant and minority communities; and
- 5 WHEREAS, These actions and policies include the rescission of
- 6 the Deferred Action for Childhood Arrivals (DACA) program, the
- 7 rhetoric and efforts for a physical wall along the border
- 8 between the United States and Mexico, the increased detention of
- 9 undocumented immigrants, efforts to suspend or terminate Federal
- 10 funding to sanctuary cities, the travel ban from several Muslim-
- 11 majority countries, the suspension of refugee admissions into
- 12 the United States and the termination of special protections
- 13 from removal for migrants from nations experiencing war and
- 14 natural disasters, among other actions; and
- 15 WHEREAS, The decennial enumeration of the population is one
- 16 of the most critical functions our Federal Government performs;
- 17 and
- 18 WHEREAS, The decennial census, although not perfect, should
- 19 and must be apolitical in both its execution and its application
- 20 to ensure a full, fair and accurate count; therefore be it
- 21 RESOLVED, That the House of Representatives of the
- 22 Commonwealth of Pennsylvania urge the Trump Administration to
- 23 not include a citizenship question in the 2020 decennial census;
- 24 and be it further
- 25 RESOLVED, That copies of this resolution be sent to the
- 26 President of the United States, the Secretary of Commerce, the
- 27 Director of the United States Census Bureau, the presiding
- 28 officers of each house of Congress and each member of Congress
- 29 from Pennsylvania.
