## AN ACT

- 1 Amending Titles 30 (Fish), 34 (Game) and 63 (Professions and
- Occupations (State Licensed)) of the Pennsylvania
- 3 Consolidated Statutes, in Pennsylvania Fish and Boat
- 4 Commission, providing for organ and tissue donation; in
- 5 Pennsylvania Game Commission, further providing for powers
- and duties of commission; and, in powers and duties,
- 7 providing for organ and tissue donation.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. Title 30 of the Pennsylvania Consolidated
- 11 Statutes is amended by adding a section to read:
- 12 § 322.2. Organ and tissue donation.
- 13 (a) Application. -- The commission shall ensure that the
- 14 application system for licenses issued under this title
- 15 processes requests by applicants to consent to organ or tissue
- 16 donation and include the following statement on all
- 17 <u>applications:</u>
- 18 Anyone can save and heal lives. Yes, I would like to
- 19 <u>register as an organ and tissue donor.</u>
- 20 (b) Electronic submission. -- The statement under subsection

- 1 (a) shall include a box that an applicant may check to request
- 2 <u>inclusion in the national donate life registry. If the box is</u>
- 3 <u>checked</u>, the commission shall automatically electronically
- 4 <u>submit the information for inclusion in the national donate life</u>
- 5 <u>registry.</u>
- 6 (c) Definitions. -- As used in this section, the following

- (i) Ensure that the application system for licenses
- 25 issued under this title processes requests by applicants
- 26 to consent to organ or tissue donation and include the
- 27 <u>following statement on all applications:</u>

- 30 <u>(ii) The statement under subparagraph (i) shall</u>

- include a box that an applicant may check to request

- 16 (a) Application. -- The bureau shall ensure that the

- 18 by applicants to consent to organ or tissue donation and include
- 19 the following statement on all applications:
- 20 Anyone can save and heal lives. Yes, I would like to
- 21 register as an organ and tissue donor.
- 22 (b) Electronic submission. -- The statement under subsection
- 23 (a) shall include a box that an applicant may check to request
- 24 inclusion in the national donate life registry, the bureau shall
- 25 automatically electronically submit the information for
- 26 inclusion in the national donate life registry.
- 27 <u>(c) Definitions.--As used in this section, the following</u>

- 5 Section 4. This act shall take effect in 60 days.
