A RESOLUTION

- Designating the month of September 2024 as "Life Insurance Awareness Month" in Pennsylvania.
- 3 WHEREAS, Six million Pennsylvania residents have life
- 4 insurance coverage with an average benefit of \$148,000; and
- 5 WHEREAS, According to the American Council of Life Insurers,
- 6 the life insurance industry in Pennsylvania paid \$11.7 billion
- 7 to beneficiaries in 2024, providing a tremendous source of
- 8 financial relief and security to families that experienced the
- 9 loss of a loved one; and
- 10 WHEREAS, Life insurers pay out \$31.9 million a day to
- 11 Pennsylvanians in life insurance and annuities; and
- 12 WHEREAS, Despite the importance individuals place on life
- 13 insurance and the peace of mind it brings to millions of
- 14 Pennsylvania families, there are still too many Pennsylvanians
- 15 who lack adequate coverage; and
- 16 WHEREAS, The reality is that approximately one in five
- 17 Pennsylvania residents are under 18 years of age and typically

- 1 financially dependent on a loved one or caregiver; and
- 2 WHEREAS, During times like these when so many families
- 3 continue to struggle, life insurance coverage is more important
- 4 than ever because individuals have fewer financial resources to
- 5 fall back on, increasing their financial vulnerability; and
- 6 WHEREAS, The nonprofit organization Life Happens, the
- 7 National Association of Insurance and Financial Advisors and a
- 8 coalition representing hundreds of leading life insurance
- 9 companies and organizations have designated September as "Life
- 10 Insurance Awareness Month" to encourage consumers to think about
- 11 their need for life insurance protection, seek advice from a
- 12 qualified insurance professional and take the actions necessary
- 13 to achieve a financially secure future for their loved ones;
- 14 therefore be it
- 15 RESOLVED, That the Senate designate the month of September
- 16 2024 as "Life Insurance Awareness Month" in Pennsylvania; and be
