Many of them mothers who gave their sons in the last world crisis that we might live.

I, of course, am aware of the committee appointed pursuant to a resolution adopted by this House last week to make an investigation as to who was correct regarding W. P. A. grants, our Governor or Col. Matthews, but my friends I am not concerned just now as to who is right or who is wrong. I am and I know you are, concerned about these unfortunate women of our State. Our Federal Government contemplates spending twenty-five billion dollars for defense, and rightly so, but yet some one will quibble about a few paltry dollars when the welfare of twelve thousand women is at stake.

I call upon you Mr. Speaker to keep this House in session until we have solved this humanitarian problem.

HOUSE BILL No. 1.

An Act to further amend paragraphs six and nineteen, and to eliminate paragraph seven, of section twelve hundred ten of the act, approved the eighteenth day of May, one thousand nine hundred eleven (P. L. 309), en-

titled "An act to establish a public school system in the Commonwealth of Pennsylvania, together with the provisions by which it shall be administered, and prescribing penalties for the violation thereof; providing revenue to establish and maintain the same, and the method of collecting such revenue; and repealing all laws, general, special or local, or any parts thereof, that are or may be inconsistent therewith, "fixing the minimum annual salary and increments of members of the teaching and supervisory staff in school districts of the fourth class; increasing the percentage of state-aid for all districts; and providing additional state-aid through an equalization fund created by this act to be maintained from state appropriations.

HOUSE BILL No. 2.

An Act authorizing cities, boroughs, towns and townships to construct, acquire, own, operate, control, sell and lease facilities for the production, generation, transmission, distribution or furnishing of natural or artificial gas, electricity, steam or water, or the collection, disposition or treatment of sewage and to furnish or render such services to the public within or beyond their corporate limits, or both; conferring the power of eminent domain, conferring certain powers and imposing certain duties on such municipalities, and the controller or auditors thereof, providing for and authorizing the incorporation and election of a board of directors to operate and manage such works and defining its powers and duties, conferring certain powers and imposing certain duties on the Pennsylvania Public Utility Commission, and prescribing penalties.

HOUSE BILL No. 3.

An Act to further amend section one of the act, approved the eighth day of April, one thousand eight hundred and sixty-eight (P. L. 73), entitled "An act to authorize the recorder of deeds in the several counties of this Commonwealth to record the discharges of all honorably discharged officers and soldiers," extending the same to discharges of honorably discharged members of the Civilian Conservation Corps; and increasing the fee payable by the county therefor.

L. 364), entitled "An act relating to business corporations; defining and providing for the organization, merger, consolidation, reorganization, winding up and dissolution of such corporations; conferring certain rights, powers, duties and immunities upon them and their officers and shareholders; prescribing the conditions on which such corporations may exercise their powers; providing for the inclusion of certain existing corporations of the second class within the provisions of this act; prescribing the terms and conditions upon which foreign business corporations may be admitted, or may continue, to do business within the Commonwealth; confirming powers and imposing duties on the courts of common pleas, and certain State departments, commissions, and officers; authorizing certain State departments, boards, commissions, or officers to collect fees for services required to be rendered by this act; imposing penalties; and repealing certain acts and parts of acts relating to corporations" by requiring the recording of all certificates of incorporation and copies of articles attached thereto, heretofore or hereafter issued under the provisions of said act; and prescribing penalties; to be collected by the Department of Justice.

HOUSE BILL No. 5.

An Act authorizing all counties, cities, boroughs, incorporated towns, townships and institution districts, to place their respective officers and employes in the State Employes' Retirement Association; prescribing the procedure to be followed; and authorizing a special tax to pay the expenses incident thereto; placing certain duties upon the State Treasurer, and the fiscal officers of the said municipal units; prohibiting the future establishment of local pension or retirement systems; and providing in certain cases for the discontinuance of existing ones.

HOUSE BILL No. 9.

An Act to amend section four as amended, and section seventeen of the act, approved the twenty-first day of May, one thousand nine hundred and thirty-one (P. L. 149), entitled "An act imposing a State tax, payable by those herein defined as distributors, on liquid fuels used or sold and delivered within the Commonwealth, which are ordinarily, practically, and commercially usable in internal combustion engines for the generation of power; providing for the collection and lien of the tax, and the distribution and use of the proceeds thereof; requiring such distributors to secure permits, to file corporate surety bonds and reports, and to retain certain records; imposing duties on retail dealers, common carriers, county commissioners, and such distributors; providing for rewards; imposing certain costs on counties; conferring powers and imposing duties on certain State officers and depart-

ments; providing for refunds; imposing penalties; and making an appropriation," by exempting from such tax liquid fuels used for the operation of stationary engines and the operation of tractors and machinery used other than on the highways, and providing refunds of taxes paid on such liquid fuel.

An Act to facilitate vehicular traffic between the eastern and western sections of the Commonwealth by providing for the construction, operation and maintenance of a turnpike from a point at Irwin in Westmoreland County, the western terminus of the turnpike heretefore constructed by said commission, to a point on the boundary line between the Commonwealth of Pennsylvania and the State of Ohio; and conferring powers and imposing duties on the Pennsylvania Turnpike Commission; authorizing the issuance of turnpike revenue bonds of the Commonwealth, payable solely from tolls, to pay the cost of such turnpike; providing that no debt of the Commonwealth shall be incurred in the exercise of any of the powers

granted by this act; providing for the collection of tolls for the payment of such bonds and for the cost of maintenance, operation and repair of the turnpike; making such turnpike bonds exempt from taxation; constituting such bonds legal investments in certain instances; requiring suits against the commission to be brought in Dauphin County; prescribing conditions upon which such turnpike shall become free; providing for grade separations, grade changes and relocation and restoration of public roads and State Highways affected by the turnpike; providing for condemnation; granting certain powers and authority to municipal subdivisions and agencies of the Commonwealth to cooperate with the commission; and authorizing the issuance of turnpike revenue refunding bonds.
