RESOLUTIONS INTRODUCED AND REFERRED

By Mr. SARGE. (Concurrent) RESOLUTION No. 75.

In the House of Representatives, April 8, 1941.

The vast number of bills introduced during a legislative session which are never reported to the House or Senate

session which are never reported to the Fouse or Senate by the committee to which they were assigned has added tremendously to the cost of a legislative session. During the session of 1935 three thousand five hundred and thirteen jills were introduced and only five hundred and eighty-seven were finally passed; during the 1937 session two thousand nine hundred and ninety-nine were introduced and only seven hundred and fifty-six were

passed; and during the 1939 session two thousand and seventy-three were introduced and five hundred and fortynine were passed.

It often happens that at one session a half dozen bills bearing on the same subject and seeking the same remedy are introduced, which practice aids materially in increasing the number of bills that remain in committee.

During the past three regular sessions a total of eight thousand five hundred and eighty-five bills were in-troduced and one thousand eight hundred and eighty-two wore passed.

This situation demands a remedy in order to cut down the useless cost of printing bills, and eliminates waste oc-casioned by the handling and filing of bills that should not have been introduced and printed.

In order to arrive at some remedy for this waste of money and work, a special study should be made of the condition by a commission charged with no other duty; therefore be it

Resolved (if the Senate concur), That a committee of three members of the House of Representatives to be ap-pointed by the Speaker of the House, three Snators to be appointed by the President pro tempore of the Senate, and three persons to be appointed by the Governor, is hereby created whose duty it shall be to make a study of the question of the introduction of bills in the legislature and endeavor to arrive at some method which could effectively be used in reducing the number of bills introduced and printed and to report its findings to the regular session of the legislature to be convened in January, one thousand nine hundred forty-three.

The said committee shall organize immediately after its appointment and elect a chairman and a secretary from its membership and appoint any clerks or stenographers necessary to carry out the purpose of this resolution.

The members of the commission shall receive no compensation but shall be reimbursed for any necessary traveling and living expenses actually incurred in the performance of the duties hereby imposed.

An item of five thousand dollars shall be inserted in the general appropriation bill for the purpose of paying such expenses and the salaries of such clerks and steno-graphers, appointed by the committee.

RESOLUTION No. 76.

In the House of Representatives, April 9, 1941.

Whereas, Music is the agency that synchronizes and soothes the feelings of mankind, and, at the same time, creates an emotional reaction that brings ease to the mind and solace to the soul; and

Whereas, Music, from time immemorial, has been in-tended by mankind to create an emotional response which is fitting and proper for particular occasions in man's life; and

Whereas, Music can be best appreciated when it is performed under proper circumstances; and

Whereas, The commercialism of today, and the resultant swing or jazz arrangements of certain music, is in absolute derogation of the composer's or creator's expression of

Whereas, The songs known as spirituals and foll: songs have meant a great deal in the development of the American negro, and have been a great cultural contribution by him to the development of American music; and

Whereas, Spirituals are symbolic of the deep religious devotion of the American negro to his God and creator; and

Whereas, Today negro spirituals are being used by leading orchestras throughout the country in jazz and swing arrangements, which are nothing but ribald desecrations of such beautiful music; therefore be it

And said bill having been read at length the second time and agreed to,

Ordered, To be transcribed for a third reading.

PERMISSION TO ADDRESS HOUSE

Mr. WOODSIDE asked and obtained unanimous consent to address the House.

Mr. Speaker, I notice that the Members have been introducing amendments generally without sending a corbon copy to the floor leaders. It would be well to follow the practice which was adopted at the last session, and which I think was meant to be followed at this session, of giving copies of the amendments to the floor leaders. Otherwise, the floor leaders may find it necessary to hold up the reading of the amendments until those interested in the bill have a chance to write them down. It will greatly delay the proceedings of the House. If the Legislative Reference Bureau, the Attorney General's office or whatever other places are preparing amendments do not furnish enough copies, arrangements ought to be made to supply sufficient copies to the members so that one copy can be furnished to each of the floor leaders, and each floor leader in turn can give it to the Members on his side of the House who are interested in the particular bill.

I call this to the attention of all of the Members of the House because from now on I think the House is going to be busy, and it would be bad practice for the House to take time to read and study the amendments from the desk. The work of the House will be carried on a lot easier if extra copies are prepared.

The SPEAKER. The Chair appreciat's the remarks of the gentleman from Dauphin concer. ng amendments offered without the knowledge of the por leaders. The Chair requests Members offering amendments to give a copy to each floor leader before they are considered. If you do not have a sufficient number of copies, request them from the Legislative Reference Bureau. The Desk requires four copies. The Reference Bureau can easily furnish six copies.

BILLS PASSED OVER

There being no objection House Bill No. 854, Printer's No. 253 was passed over at the request of Mr. ACHTER-MAN.

There being no objection House Bill No. 236, Printer's No. 126, was passed over at the request of Mr. HARKINS.

BILL ON THIRD READING

Agreeably to order,

The House proceeded to the third reading and consideration of House Bill No. 1092, as follows: An Act making an appropriation for the expenses of the committee of the House of Representatives created by House Resolution Serial Number forty-nine adopted the nineteenth day of February one thousand nine hundred forty-one

The General Assembly of the Commonwealth of Penn-sylvania hereby enacts as follows

Section 1 The sum of ten thousand dollars (\$10,000) or so much thereof as may be necessary is hereby specifically appropriated to the committee created by House Resolution Serial Number forty-nine adopted the nineteenth day of February one thousand nine hundred fortyone and authorized thereby to make an investigation of the causes and reasons for gas main explosions in the city and county of Philadelphia for the payment of the expenses of such investigation by the committee including the cost of subpoenas witnesses witness fees stenographic service the wages or other compensation of necessary clerical assistants and any other expenses of every kind and description which may be authorized by a majority of the committee in connection with the conduct of its work

Section 2 This act shall become effective immediately upon final enactment

On the question,

Will the House agree to the bill on third reading?

It was agreed to.

On the question,

Shall the bill pass finally?

Mr. D'ORTONA. Mr. Speaker and members of the House, As Chairman of a Committee of this House, appointed to investigate a terrible catastrophe in South Philadelphia, which resulted in the death of five persons by explosion and burning, in injury to more than sixty persons, and vast destruction of property, I rise to ask support of this House for the appropriation requested by the Committee.

The Committee has proceeded with the investigation thoroughly and expeditiously. After organization we selected James F. Masterson, as counsel for the Committee, and sought expert engineering and chemical advice. We requested Mr. Wm. H. Gravell, an eminent engineer, and Dr. Louis Gershenfeld, professor of chemistry at the Philadelphia College of Pharmacy and Science to co-operate with the Committee. We explained to these gentlemen that no appropriation had been granted the Committee, but that we felt that this body would make an appropriation to compensate them for such services as would become necessary in making the investigation.

Our counsel and engineers have spent days and nights on this investigation. We held three all day public hearings and two public night hearings lasting until 11 P. M. We held these hearings during both the day and evenings to give the public an opportunity to be heard. We have heard every citizen we could locate or who volunteered who could throw any light on the subject matter under investigation. We gave the City of Philadelphia the same opportunity, and we have heard from responsible employes and officials who were in a position to know the true conditions. The testimony taken up to the present time covers approximately six hundred pages. We are now affording the Philadelphia Gas Works Company the same opportunity to produce whatever records or facts it has in its possession to show the cause of this frightful tragedy.

We have learned many things with respect to the conditions of the water system of the City of Philadelphia, and the gas main system of the Philadelphia Gas Works Company.

From the beginning of this investigation the Committee

has had in mind the idea that if at all possible such tragedies should be prevented in the future, and it is our purpose when the investigation is completed to recommend to this House legislation which may eliminate some of the fundamental, underlying causes which led to these explosions.

The 20th Century Fox Film Corporation took about six hundred feet of film of the scene, but most of it was so gruesome that the negative was not printed. However, the company agreed to show the negative to the Committee and when the Committee saw it, it was determined to have the negative printed and to purchase a copy so that it can be shown to this House when the report of this committee is made.

Our counsel and engineers have worked day and night in preparing the testimony which has been produced before the Committee, and that which remains to be heard. A great deal of physical investigation has been done including chemical analysis of the soil, physical examination of the scene, buildings, pipes, and investigations into the records of the City of Philadelphia with respect to alleged breaks in the water and sewer systems.

The members of the Committee having to be in Harrisburg in connection with their duties here, the work of preparation for the hearings naturally devolved upon our counsel and the engineers, and these men devoted practically all of their time from Fobruary 20th to April 4th to matters affecting this investigation.

It is believed that additional experts will have to be obtained upon the conclusion of the testimony of the Philadelphia Gas Works Company, as we propose upon the completion of the testimony to seek the advice of eminent gas engineers to see if improvements could be made in the manner of gas and water distribution, and what precautions can or should be taken to avoid any such future catastrophe.

It certainly requires no argument on my part to convince the members of this House, and without prejudging the investigation, that gas mains and water pipes laid 50 to 75 years ago cannot be in good condition, and the Committee intends to seek the advice of the best engineers available on the subject in order to protect, if possible, by law the lives and properties of the citizens against any recurrence of such a frightful tragedy.

In these days of safety drives to protect the lives and limbs of citizens from the operators of automobiles, railroads, industrial accidents, etc., it seems to this Committee that there should be some way of requiring by law, measures which science has developed to protect and guard the lives and properties of our people from damage and injury caused by pipes carrying gas and water under city streets, and into the homes of our people, who have elected us to provide laws for their safety.

I would, therefore, request that the House pass the appropriation bill as recommended by the Committee.

On the question recurring,

Shall the bill pass finally?

Agreeably to the provisions of the Constitution the yeas and nays were taken and were as follows, viz:
