The SPEAKER. The Chair recognizes the gentleman from Northampton, Mr. Kowalyshyn.

Mr. KOWALYSHYN. Mr. Speaker, the amendment being offered to HR 150, in keeping with the concern expressed in the resolution as to the skyrocketing increase in automobile insurance policy premiums, is directed to the order of the Pennsylvania Insurance Commissioners of November 23, 1977, approving a 32-percent increase for premiums in the Pennsylvania automobile insurance plan commonly known as the assigned-risk plan.

The Insurance Committee is to investigate two things as to the assigned risk plan—why such a large increase in premiums and why so many licensed drivers are being forced into the assigned-risk plan, particularly so-called clean risks; that is, persons who have had no accidents or moving violations within the past 3 years.

I recommend that this amendment be approved and I want to assure the members of the House that an independent study will be made of the assigned-risk plan and the circumstances surrounding the approval order of November 23, 1977.

In making our study, if we find it necessary in order to accomplish an independent product, the Insurance Committee may endeavor to secure the services of our own actuary.

On the question,

Will the House adopt the resolution as amended?

The SPEAKER. The Chair recognizes the gentleman from Northampton, Mr. Kowalyshyn.

Mr. KOWALYSHYN. Mr. Speaker, I would like to make a few comments at this time about the serious problems that now exist as to automobile insurance in Pennsylvania. By the way, I asked to have the latest figures as to the number of registered vehicles in Pennsylvania and as to the number of licensed drivers in Pennsylvania, and these are the figures: As of now, there are 9,832,753 registered automobile vehicles in Pennsylvania, 9.8 million; there are 7,342,362 licensed drivers in Pennsylvania, 7.3 million.

I am sure all of the members of the Insurance Committee welcome having this resolution acted upon by the members of the House, because when the Insurance Committee was constituted 11 months ago, the members of the committee voted unani-

mously that the availability and the affordability of automobile insurance in Pennsylvania were top-priority problems. If the members of the House approve this resolution, you will enter on record your own imprimatur that the availability and the affordability of automobile insurance deserve immediate and careful legislative attention.

This resolution is timely because some of the products of committee action are on today's calendar. I point particularly to HB 1475, which proposes omnibus amendments to the No-fault Motor Vehicle Insurance Act of 1974. As you know, Pennsylvania now has a dual system of making reparations in cases of automobile accident damages. One part has recovery on the basis of fault, so-called tort liability, now modified by the principle of comparative negligence. The other part has recovery on the basis of no fault, where the first party in the insurance contract, the insured, receives payment of reparations from the second party in the insurance contract, his own insurer. The Insurance Committee has held hearings, taken testimony, and in its deliberations has reported out of committee bills which would for the first time change and improve the no-fault law based on 2 years of experience.

Now, just a few words by way of background about the skyrocketing increase in premiums mentioned in the resolution. Mention should be made that during the past 7 years, for example, the United States economy has experienced serious inflation, including double-digit inflation, and insurance companies have taken heavy losses in their investments. Despite underwriting losses and investment losses sustained by the insurance companies, Pennsylvania's Insurance Commissioner from January 1971 to March 1974, a period of 3 years and 2 months, allowed absolutely no rate increases. From March 1974 to July 1975, the successor Insurance Commissioner did allow some rate increases in all major automobile coverages for all major companies. In July 1975 when the No-fault Act went into effect, there was a 15-percent rollback in rates for 1 year as to no-fault coverages. Between July 1975 and July 1976, there were some rate increases as to other than no-fault coverages, namely, collision and comprehensive. From July 1976 to the present, there have been extensive requests for rate increases all along the line.

In 1974 the United States property and casualty insurance industry incurred underwriting and investment losses in excess of \$2 billion. In 1975 the United States property and casualty insurance industry had its worst year ever. It incurred underwriting and investment losses of \$3 billion.

I am giving you these facts because they should be considered as a background when you speak about rates and increases that are approved.

I request a vote in favor of this resolution.

Thank you.

The SPEAKER. The Chair recognizes the gentleman from Delaware, Mr. Zearfoss, on the resolution.

Mr. ZEARFOSS. Mr. Speaker, I do not think anyone argues with the need for a review of these matters by the Insurance Committee of the House.

I have a little concern about why we need a resolution or why

we have a resolution. The Insurance Committee has since the beginning of this session been looking into this matter. I think every member of the Insurance Committee, whether he be a Republican or a Democrat, is concerned about this and is ready to attend any hearings or meetings on this subject that may be called.

The only concern that I would have is that to adopt this resolution suggests that the committee is not interested in the subject. I would like to make it very clear to the House that the committee has been concerned about this, has been reviewing it already, and really the resolution does not give us any additional authority to subpoena anyone, does not gives us an appropriation to conduct additional hearings. I do not know why we need the resolution at all since we are doing what you are asking us to do at this time.

STATEMENT ON LEGISLATION INTRODUCED

The SPEAKER. The Chair recognizes the gentleman from Blair, Mr. Milliron.

Mr. MILLIRON. Thank you, Mr. Speaker.

I am introducing legislation today that will be on the table, if anybody would cosponsor it with me.

The current Banking Code, Mr. Speaker, says that the most that can be charged for a late payment is \$2.50. Under the Consumer Discount Company Act, instead of having a dollar figure, it has a 1½-percent late-charge penalty.

What this amounts to, Mr. Speaker, is on a \$3,000 loan, the interest which is the maximum is 1½ percent, or \$37.50 interest, and a late penalty charge of \$45. Thank heavens, most of the companies are not charging the full 1½-percent late penalty, but my bill would limit it to the same amount that the Banking Code states, and that is \$2.50.

I think their late-payment penalty clause is exorbitant and it should be eliminated.

Mr. DiCARLO. Mr. Speaker, I was held up in western Pennsylvania by bad weather, but had I been in my seat, I would have voted "yes" on the motion to recommit HB 552; I would have voted "aye" on SB 377 and SB 481; "no" on SB 402; I would have voted "aye" on SB 480; I would have voted "aye" on the motion to recommit SB 1038; I would have voted "aye" on SB 1048, HB 1630 and HB 1821.
