On the question,

Will the House agree to the amendments?

The SPEAKER. The Chair recognizes the gentleman from Perry, Mr. Noye.

Mr. NOYE. Mr. Speaker, this is an amendment to the Volunteer Firemen's Assistance Act.

A few years ago, when the act was originally drafted, we went to great lengths to make sure that the funds would not be available in the act for the refinancing of any outstanding loans that the fire company had at the time the act went into effect, primarily because we expected that the volunteer fire companies throughout Pennsylvania and ambulance companies and rescue squads would make a run on the \$10 million that we set aside for their use. That did not happen, and we still have almost \$6 million of that fund still available in that revolving account.

A couple years after the act went into effect, we did come back and place a period of time in the act where they could refinance if they took out a loan during that period of time, but anything prior to that—I think it was a 10-month or a 1-year period—still could not be refinanced.

My amendment would strike out from the act the prohibition of refinancing whenever it took place and would leave all fire companies the right to refinance any outstanding obligations that they presently have. I think the fund, financially, can take care of it without any problem.

The SPEAKER. The Chair recognizes the minority whip.

Mr. MANDERINO. Mr. Speaker, will the gentlemen, Mr. Noye, consent to interrogation?

The SPEAKER. The gentleman, Mr. Noye, indicates that he will, and the gentleman, Mr. Manderino, may proceed.

Mr. MANDERINO. Mr. Speaker, the Volunteer Fire Company Loan Act that is being amended puts certain limitations on how much can be originally borrowed for new equipment, for ambulances; for building limits they are different. Would the refinancing amendment that you are putting in here have to live within those limits? Is it structured in that manner?

Mr. NOYE. Yes.

Mr. MANDERINO. Thank you, Mr. Speaker.

REMARKS ON VOTES

The SPEAKER. The Chair recognizes the gentleman from Bucks, Mr. Burns.

Mr. BURNS. Mr. Speaker, I inadvertently voted the wrong way on the Noye amendment numbered A3127 to HB 948.

The SPEAKER. The Chair recognizes the gentleman from Bucks, Mr. Wilson.

Mr. WILSON. Mr. Speaker, I voted the wrong way on the Nove amendment numbered A3127 to HB 948.

The SPEAKER. The Chair thanks the gentlemen. Their remarks will be spread upon the record.

REQUEST TO RERUN VOTE

The SPEAKER. The Chair recognizes the gentleman from Lehigh, Mr. Zeller.

Mr. ZELLER. Mr. Speaker, because of the problem that I had last year with the so-called high and mighty in the corner, I was thinking that possibly, could you please—because this is a very vital issue and for these two gentlemen, I am sure there are some people who would try to use it against them. I know that we do not do this too often, but if you could please—rerun it, because I have been a victim of that gang and I wish that they could have a chance of not being victims.

On the question,

Will the House agree to the bill as amended on third consideration?

Mr. RYAN offered the following amendments:

Amend Sec. 1, page 1, line 16, by striking out "and (d)" and inserting, (d) and (g)

Amend Sec. 1 (Sec. 4), page 4, by inserting between lines 22 and 23

(g) A volunteer fire company, ambulance service and rescue squad shall be eligible for a loan under this act regardless of legal ownership in whole or part by any political subdivision of any facilities or apparatus equipment used by the volunteer fire company, volunteer ambulance and volunteer rescue squad. The credit of the political subdivision, by co-signing the application, may be used to satisfy the 20% requirements of subsection (a).

On the question,

Will the House agree to the amendments?

The SPEAKER. The Chair recognizes the majority whip.

Mr. S. E. HAYES. Mr. Speaker, it has become necessary for the majority leader to leave the floor for a moment, but he is today offering an amendment to HB 948.

As we all recall, we placed a stipulation in the loan provision that in order for a local volunteer fire company to participate in the loan program, that organization would have to provide a 20-percent down payment. Mr. Ryan would like to amend the statute which would allow the credit of the political subdivision by cosigning the application. It may be used to satisfy the 20-percent requirements of the law. I urge adoption of the amendment, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman from Columbia, Mr. Stuban.

Mr. STUBAN. Mr. Speaker, may I interrogate the man who is speaking for the man who is putting it in?

The SPEAKER. The gentleman, Mr. Hayes, indicates that he will stand for interrogation. The gentleman, Mr. Stuban, may proceed.

Mr. STUBAN. Mr. Speaker, the question that I would like to ask here concerns a political subdivision, like a borough, that is buying the equipment for a volunteer fire company and they pay for all of the equipment. Is it possible for them to get the money?

Mr. S. E. HAYES. There was some noise, Mr. Speaker. The last part of your statement I did not hear.

Mr. STUBAN. Okay. The question that I am asking is, if we have a little borough that furnishes the volunteer fire company with all of the equipment, would it be possible for them to get the \$7,500 on a building or a piece of new equipment?

Mr. S. E. HAYES. It is my understanding that they would.

Mr. STUBAN. If that is the case, then I rise to support the amendment.

The SPEAKER. The Chair recognizes the gentleman from Cambria, Mr. Stewart.

Mr. STEWART. Mr. Speaker, would the gentleman stand for interrogation?

The SPEAKER. The gentleman, Mr. Hayes, indicates that he will. The gentleman, Mr. Stewart, may proceed.

MR. STEWART. Mr. Speaker, do you know if there will be any conflict with this amendment? In the various codes of the townships and boroughs, et cetera, there are, I believe—and correct me if I am wrong—spending limits on what they are allowed to contribute to a volunteer fire company.

Mr. S. E. HAYES. It is my understanding that there is no conflict with this amendment, Mr. Speaker.

Mr. STEWART. Do you know if there are limits in the municipalities as to what they can contribute to their local fire companies?

Mr. S. E. HAYES. I know of no prohibition that would cause a conflict with this amendment.

Mr. STEWART. Okay. Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes the minority whip.

Mr. MANDERINO. Mr. Speaker, we have created in the Commonwealth of Pennsylvania what can be considered a very viable and productive low-interest loan program for volunteer firemen, and I have problems when we tamper with what we have already done unless we are absolutely sure that we are not going to, in some manner, detract from the good job that has been done in the past.

To that end, Mr. Speaker, I would like to ask the offerer of the amendment whether he will consent to interrogation.

Mr. S. E. HAYES. Yes.

The SPEAKER. The gentleman, Mr. Hayes, indicates that he will, and the minority whip may proceed.

Mr. MANDERINO. Mr. Speaker, if a volunteer fire comany—and I am not sure these limits will apply—is applying for a loan for building purposes—we began the program at \$35,000; we may be up to \$50,000 now, I am not sure—can that volunteer fire department, if this amendment were passed, borrow the

entire \$50,000 or \$35,000 without any local money being generated by that volunteer fire company?

Mr. S. E. HAYES. It is the intention of Mr. Ryan, where you have a fire company unable to generate that necessary down payment, to use the credit of that local political subdivision so it would be possible, even though there was an inability on the part of the fire organization to generate the money themselves, to make that down payment as required by law.

Mr. MANDERINO. Would it not then be changing the program where we would only finance at a 2-percent rate because of the 20-percent requirement? If we were only financing 80 percent of the costs of equipment or a building at a 2-percent rate, we could be financing the entire amount at 2 percent, if this amendment were passed?

Mr. S. E. HAYES. As I recall the General Assembly's intent, Mr. Speaker, we were trying to provide an opportunity for local volunteer fire services to provide a facility, to provide equipment which was necessary for them to carry out their purpose. Now it has been found subsequent to that enactment—and you kind of touched upon it yourself—that there are some local services unable to generate the necessary money to meet that 20-percent requirement. What Mr. Ryan would like to do, rather than telling that volunteer service that they cannot participate because they cannot generate the 20 percent, is to allow the municipality wherein they are located, if in fact that municipality wants to—this does not require them to but they may, through the Ryan amendment—to use the credit of their political subdivision as a way of satisfying the 20 percent.

Without any question, this General Assembly has to decide whether it wants to do that or not, but it has been found that there are some companies unable to generate the money and the local political subdivision is willing to make that commitment in lieu of the fire company.

Mr. MANDERINO, Let us take a for instance, Mr. Speaker. Let us take a for instance that community A wants to buy a building or put up a building for \$70,000 and this program as it presently exists allows them to borrow \$50,000 at 2 percent interest—I am not sure that those rates apply. They have \$20,000 local money. Would it not be advantageous for that local fire department to keep their \$20,000 in the bank and earn 7 percent, 8 percent, 9 percent interest, whatever the traffic will bear today, get their municipality to cosign the loan and come up here and get the full amount of money that they need for the building at 2 percent? I am bothered, I am not sure that that is what we are creating. I am afraid we are creating something that was not intended. Originally we wanted the initiative of volunteer fire companies to be maintained. We wanted them to have to raise that 20 percent themselves before they could get an easy 2-percent loan, and I think we are taking that initiative, the incentive for that initiative, away from them by this kind of an amendment.

Mr. S. E. HAYES. I do not know whether the gentleman's fears are well founded or not as to taking away initiative and volunteerism, but what we evidently are denying some companies is the opportunity to participate in the loan program because they themselves for whatever reason—it may not be a lack of volunteerism on their part—but nevertheless their

opportunity or their ability to generate these monies are impaired for some reason, and the gentleman, Mr. Ryan, would just like to expand the opportunity to participate by saying that the local subdivision may, if it wills, the local elected officials may, if they want to, place the credit of their subdivision on the line for this volunteer service, and we just have to make a "yes" or "no" decision in that regard, Mr. Speaker.

Mr. MANDERINO. I understand what he is trying to do. I have problems with the language with which he is trying to do that, because the 20-percent cash that most volunteer companies come up with at the present time—okay?—allows us to finance only a portion of the project at 2 percent, even though it may be 80 percent. I can see where we are going to be financing the entire project at 2 percent if this amendment passes. If the local community that wants to put up its credit wants to pay on that 20 percent the going rate of interest, then I think it would be fair. It would be fair for the local community that wants to put up 20 percent to pay the going rate on that 20 percent, and so that everybody is in the same boat, everybody pays 2 percent on the 80 percent. I can understand that.

I am also troubled by the fact that the credit of the political subdivision, simply by cosigning an application, satisfies the 20-percent requirement. I would like to see and I hope that what he means is not only the application but whatever note or promissory device or judgment device is used they also have to obligate themsleves on, besides endorsing the application of the volunteer fire company. If that is what he means, I think we ought to state it in a little better language and I think we ought to insure that we are only providing a 2-percent loan on 80 percent of the cost of that project, which is what we have always done in the past, because you would be penalizing those people who have gone out and raised their 20 percent if you would allow 2-percent financing simply because the municipality has signed on as a cosponsor. You know, I am not against in theory allowing those volunteer fire companies to substitute the credit of their community for the 20-percent down payment so long as the substitution is fair, and unless they are paying the going rate of interest on that first 20 percent, then it is not fair. Some companies have had to put up cash on which they could be earning 7 percent or 8 percent interest and just getting the balance financed at 2 percent.

REQUEST TO TABLE HB 948 AND AMENDMENTS

Mr. MANDERINO. I would ask, perhaps, Mr. Speaker, rather than a defeat of the amendment, unless there is some urgency with the bill at this time, that we hold this until we try to work out language that would be fair to everyone.

Mr. ZELLER. Mr. Speaker, maybe I can help him on this. Mr. Speaker, a point of order. I do not think you will have— The SPEAKER. Will the gentleman yield?

The minority whip, Mr. Manderino, asks that this amendment and the bill be held over until Mr. Ryan can be consulted on it. Is that correct?

The Chair hears no objection to that.

HB 948 AND AMENDMENTS TABLED

The SPEAKER. The Chair recognizes the majority whip.

Mr. S. E. HAYES. Mr. Speaker, I move that the bill and the amendments be laid on the table.

On the question,

Will the House agree to the motion?

Motion was agreed to.

The House proceeded to third consideration of **HB 1011**, **PN 2036**, entitled:

An Act amending the act of June 18, 1941 (P. L. 137, No. 74), entitled "An Act providing for the appointment, powers and control of members of volunteer fire companies as special police, *** in any city, borough, town and township," further providing for the powers of special fire police.

On the question,

Will the House agree to the bill on third consideration?

Mr. A. C. FOSTER offered the following amendments:

Amend Sec. 1 (Sec. 1), page 2, line 23, by striking out <u>"AND</u> CROWD" and inserting control and crowd control

Amend Sec. 1 (Sec. 1), page 2, line 24, by striking out <u>"requests"</u> and inserting request

Amend Sec. 1 (Sec. 1), page 2, line 30, by inserting after "employment." Fire police performing such duties shall be identifiable by, at minimum, the wearing of a distinctive arm band.

On the question,

Will the House agree to the amendments?

The SPEAKER. The Chair recognizes the gnetleman from York, Mr. Foster.

Mr. A. C. FOSTER. Mr. Speaker, the amendment is in three parts, two of which are completely editorial. The section referring to page 2, line 24, is simply to correct the omission of the word "control" which is in the bill before you, so that it will read "traffic control and crowd control". The second portion of the amendment is likewise editorial, on page 2, line 24, in which we make the word "requests" singular instead of plural.

The third part of the amendment simply stipulates that fire police shall wear some distinctive type uniform, distinguished by the wearing of at least an arm band.
