The SPEAKER. The prime sponsor of the bill, Representative Caltagirone, will you consent to interrogation? He accepts the interrogation. You may proceed.

Mr. DAVIES. Thank you, Mr. Speaker.

Mr. Speaker, on line 5 of the bill, does a "viewing screen" include TV viewing, such as cable, or any presentation of television that may appear in public, such as in a store window or in a bar that has cable TV or other television?

Mr. CALTAGIRONE. Mr. Speaker, I just could not hear the question.

The SPEAKER. The Chair is unable to help Representative Caltagirone hear the question without the assistance of the members of the House who insist on speaking when they have not been recognized on the floor of the House. The rules of the House require silence when you are sitting in your seats.

The House proceeded to third consideration of SB 727, PN 1013, entitled:

An Act amending the act of December 17, 1986 (P. I., 1685, No. 197), entitled "An act providing that recorders of deeds may make additional charges for accepting certain documents," regulating sizes of documents accepted for recording.

On the question,

Will the House agree to the bill on third consideration? Mr. RYAN offered the following amendment No. A2919:

Amend Sec. 1 (Sec. 1), page 1, lines 14 through 18; page 2, lines 1 through 8, by striking out all of said lines on said pages and inserting

Section 1. Size of documents accepted for recording.

The recorder of deeds may charge twice the ordinary fee for accepting any document for recording which is larger than 8 1/2 by [14] 11 inches in size. Subdivision maps, Department of Transportation highway and condemnation maps, other similar maps and plots or drawings required to be recorded in the recorder of deeds office shall be exempt from this requirement.

On the question,

Will the House agree to the amendment?

The SPEAKER. On the question of agreeing to the amendment, the Chair recognizes Representative Ryan.

Mr. RYAN, Thank you, Mr. Speaker.

Mr. Speaker, we have a provision in the law now that if a person wants to record a mortgage which is other than the size permitted, the recorder of deeds has a right to double the fee. The bill as it is before us does not have such a provision but rather permits a recorder of deeds to set the size of any mortgage, county by county, that he wants to set. This amendment would say that the recorder has to take a mortgage, but he has the right to charge more.

I understand that the gentleman, Mr. McCall, also had the same amendment that I had. This is really just bringing the law back around to where it was but with different sized instruments being recorded, and I think it makes some sense to pass this. I do not believe a recorder of deeds should say, we will not take that mortgage. Now, he should perhaps charge more because he has to go to some more trouble, but he should not be given the option of deciding what is or is not a legal document entitled to be recorded in the county. Thank you, Mr. Speaker.

The SPEAKER. The question is, will the House agree to the amendment? On that question, from Carbon County, Representative McCall is recognized.

Mr. McCALL. Thank you, Mr. Speaker.

The gentleman, Mr. Ryan, is absolutely correct. The chairman of the legislative committee for the recorders of deeds resides in my district, and it was their intent to have this language placed into the bill. The Recorders of Deeds Association does support it, and I support Mr. Ryan's amendment. Thank you, Mr. Speaker.

The SPEAKER. The question is, will the House agree to the amendment? On that question, from York County, Representative Bortner is recognized on the amendment.

Mr. BORTNER. May I interrogate the minority leader?

The SPEAKER. The Republican leader has consented to interrogation.

Mr. BORTNER. Mr. Speaker, I just have one question, and that concerns the size of the documents. I certainly agree that recorders ought to be able to charge more. I think it makes more sense for us to standardize it, because the practice now is that people are getting mortgages from banks not just across the State but across the country. My only question concerns whether the present law deals with 8 1/2 by 11 or 8 1/2 by 14 size.

Mr. RYAN. My understanding is the present law deals with 8 1/2 by 14, and this new bill would change that size to 8 1/2 by 11. Do not ask me why. I have no idea of the significance

of 8 1/2 by 11 versus 8 1/2 by 14. The only thing I am saying is, let them make up their own minds, according to their equipment, what should be the acceptable flat fee, no-extracharge size document, but do not tell me I cannot record something else if I am willing to pay for it. I do not understand why they are changing from 14 inches long to 11. Mr. McCall may.

The SPEAKER. For what purpose does the gentleman from Carbon, Mr. McCall, rise?

Mr. McCALL. To answer the gentleman, Mr. Bortner's question.

Mr. BORTNER. I would appreciate that, Mr. Speaker.

The SPEAKER. On the allowance of the person who has the floor, Mr. Bortner, you may answer the question.

Mr. McCALL. Thank you, Mr. Speaker.

The reason the recorders of deeds are trying to change it back to 8 1/2 by 11 is most of them are using microfilm. With the 8 1/2 by 11, they can get eight recording documents on one piece of microfilm, whereas on the 8 1/2 by 14, they can only get about four sheets onto the microfilm. So it is a cost savings for them with the film on the microfilm also. So that is why they want the 8 1/2 by 11; they are trying to standardize it statewide.

Mr. BORTNER. Thank you, Mr. Speaker. If I could just make a comment.

The SPEAKER. The gentleman is in order.

Mr. BORTNER. I am not sure that that is a good enough reason for me to change. I certainly do not think this is that controversial, but I think Mr. Ryan is absolutely right. Banks and mortgage companies ought to be able to know what is going to be a recordable instrument and what is not going to be. We really ought to standardize it, and I would support the amendment. Thank you.
