Will the House agree to the bill on third consideration?

Mr. TRELLO offered the following amendments No. A0222:

Amend Title, page 1, line 5, by removing the period after "wards" and inserting

; and further providing for certain building specifications.

Amend Bill, page 2, by inserting between lines 3 and 4

Section 2. Section 1805 of the act, amended December 22, 1981 (P.L.535, No.154), is amended to read:

Section 1805. Separate Specifications for Branches of Work.—In the preparation of specifications for the erection or alteration of any public building, when the entire cost of such work exceeds four thousand dollars, the architect, engineer, or person preparing such specifications [shall] may prepare separate specifications for the plumbing, heating, ventilating, and electrical work, and the township shall receive separate bids upon each of such branches of work, and award the contract for the same to the lowest responsible bidder.

Amend Sec. 2, page 2, line 4, by striking out "2" and inserting

3

On the question,

Will the House agree to the amendments?

The SPEAKER. On that question, the Chair recognizes the gentleman from Allegheny, Mr. Trello.

Mr. TRELLO. Mr. Speaker, what this amendment does is it amends the First Class Township Code.

Presently in any bids that are considered by a first-class township that involve a number of areas, they have to submit separate bids in each area to comply with the code. What this bill does, it is a "may" amendment that would allow them to accept one bid for the entire cost rather than having bids from the plumber, the electrician, and the contractor.

It conforms with the Borough Code, and it is a "may" bill. I would appreciate support.

On the question recurring,

Will the House agree to the amendments?

(A roll-call vote was taken.)

Mr. COWELL. Mr. Speaker?

The SPEAKER. For what purpose does the gentleman, Mr. Cowell, rise?

Mr. COWELL. Mr. Speaker, the number that was on the board indicated we were considering amendment 218. I believe that Representative Trello described amendment 222. If he could clarify that, please.

Mr. RYAN. Mr. Speaker?

The SPEAKER. Would the gentleman suspend?

In response to the gentleman's inquiry, we were considering amendment 0222, and the board was in error. The record will reflect that the amendment that was adopted was 0222.

The Chair recognizes the minority leader.

Mr. RYAN. Mr. Speaker, I intended to vote for amendment 218 and against 222, so I would appreciate it if you would rerun that particular amendment in that it was in error.

The SPEAKER. For purposes of the record, we will ask that the record as to that last vote be expunged in view of the error and the misleading nature of it, and we will now recognize the gentleman, Mr. Trello, who offers amendment A0222.

On the question recurring,

Will the House agree to the amendments?

The SPEAKER. The gentleman's explanation is in the record.

Is there anyone else seeking recognition?

Mr. REBER. Yes, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman from Montgomery, Mr. Reber.

Mr. REBER. Thank you, Mr. Speaker.

Mr. Speaker, for the record as well, I would like to note that I attempted to call the attention to the Chair that I did have some consideration in the way of interrogation on amendment 222, even though it was amendment 218 that was there, and I was wondering if Mr. Trello would stand for interrogation.

The SPEAKER. The gentleman indicates he will.

Mr. REBER. Mr. Speaker, in reading the amendment, I recall the explanation you gave, but as I read the amendment, I seem to think that there is some confusion in the way this amendment is drafted.

In light of the amendment language removing the mandatory "shall" language from the current First Class Township

Code as it currently exists, we would in essence be allowing a municipality to not necessarily spec out the separate plumbing, ventilation, and various other types of work - plumbing, heating, ventilation, and electrical work - but yet we still mandate and require that bids be received on each of the separate items.

Mr. Speaker, I was just wondering how it is going to be possible for people to bid on separate items if in fact they are not specced out separately as the current law requires. It would seem to me to provide for a paradoxical situation the way the amendment is drafted.

I have per se no particular problem with what you are attempting to do. I just think there is some confusion in the manner in which this is drafted, and I was wondering if you could clear up this concern.

Mr. TRELLO. Well, Mr. Speaker, this language is exactly what is in the Borough Code right now.

Now, as far as first-class townships are concerned, the architect shall make specifications for each entity - the plumbing, the electrical work, and so forth. What this does is change it from "shall" to "may," that he "may" do that. They can continue to do it the same way they are doing it now, but in no way does it mandate that. If the township wants to save money on their bidding process, rather than requiring separate bids, they can allow one contractor to bid on the whole project.

Mr. REBER. I understand that, Mr. Speaker. My only concern is, I do not see how a particular separate bid can be given for each of the independent areas of plumbing, heating, ventilation, or electrical work when in fact there may be a situation under this proposed amendment whereby the specifications would not be separately drawn to allow the mandatory separate bidding on those separate specifications. I can envision a scenario where there may be specifications prepared where it is all lumped together but it could not then be delineated as such to allow the separate ultimate awarding of the bid in bidding on that particular job.

Now, I understand you are saying that the Borough Code allows this identical language. I am taking your word on that; I do not have a copy of that in front of me. But if that is the case, I think there may be some confusion there. But I know there is going to be confusion on a first-class-township level if this particular concept, as drafted, would be implemented.

Again, I have no particular concern or problem with what you are attempting to do. I am just concerned that this may bring about some ambiguities in the ultimate request-for-a-proposal process and then the ultimate bidding-and-awarding process in a first-class township.

# AMENDMENTS WITHDRAWN

Mr. TRELLO. Mr. Speaker, I think the gentleman has a very good point. In reading the last two sentences of the bill, I have to agree with him. So at this time I am going to withdraw the amendment and have it redrafted. Thank you.

The SPEAKER. The Chair thanks the gentleman.

The amendment is withdrawn.

Mr. TRELLO offered the following amendments No. A0218:

Amend Title, page 1, line 2, by inserting after "Statute," further providing for payment of fees and taxes when applying for a certificate of title; and

Amend Sec. 1, page 1, line 6, by striking out "Section 1312" and inserting

Sections 1103(b) and (d) and 1312

Amend Sec. 1, page 1, line 7, by striking out "is" and inserting

Amend Sec. 1, page 1, by inserting between lines 7 and 8 § 1103. Application for certificate of title.

\* \* \*

- (b) Signing and filing of application.—Application for a certificate of title shall be made within ten days of the sale or transfer of a vehicle or its entry into this Commonwealth from another jurisdiction, whichever is later. The application shall be accompanied by the fee prescribed in this title, and any tax payable by the applicant under the laws of this Commonwealth in connection with the acquisition or use of a vehicle or evidence to show that the tax has been collected. The fee prescribed by this title and the tax due the Commonwealth shall each be paid by separate checks or other instruments drawn by the applicant or his lender payable to the order of the department. The application shall be signed and verified by oath or affirmation by the applicant if a natural person; in the case of an association or partnership, by a member or a partner; and in the case of a corporation, by an executive officer or some person specifically authorized by the corporation to sign the application.
- (d) Vehicles purchased from dealers.—If the application refers to a vehicle purchased from a dealer, the dealer shall mail or deliver the application to the department within ten days of the date of purchase. The application shall contain the names and addresses of any lienholders in order of priority, the amounts and the dates of the security agreements, and be assigned by the dealer to the owner and signed by the owner. Any dealer violating this subsection is guilty of a summary offense and shall, upon conviction, be sentenced to pay a fine of \$50 for each violation. The requirement that the dealer mail or deliver the application to the department does not apply to vehicles purchased by fleet owners or governmental or quasi-governmental agencies. Any dealer who collects taxes and fees due the Commonwealth as a part of the transaction and fails to remit the taxes and fees within the prescribed time shall be the party solely liable for the taxes and fees

due, and notwithstanding the provisions of section 1109 (relating to refusing issuance of certificate of title) such nonpayment shall not delay the issuance of the certificate of title to the purchaser.

Amend Bill, page 1, line 16, by striking out all of said line and inserting

Section 2. The amendments to section 1103(d) shall be retroactive to January 1, 1989.

Section 3. This act shall take effect as follows:

- (1) The amendment to section 1103(d) shall take effect immediately.
- (2) The remainder of this act shall take effect in 60 days.

On the question,

Will the House agree to the amendments?

The SPEAKER. On that question, the Chair recognizes the gentleman from Allegheny, Mr. Trello.

Mr. TRELLO. Mr. Speaker, this amendment does two things. There has been a problem throughout the Commonwealth, in the eastern part of the State and especially in my district and Elaine Farmer's and Huck Gamble's and Dave Mayernik's. We have a very serious problem - Nick Colafella; all of western Pennsylvania. It happens that two automobile dealers went out of business. They declared bankruptcy, and about 340 people to be exact, they are all recorded with the Attorney General's Office where the dealer did not forward the sales tax or the transfer fees on their titles to Harrisburg. In order for them to get their registrations renewed, they must repay the sales tax again. Well, it is my opinion that when somebody collects the sales tax, they become agents of the State, and there is no reason in the world why these people should be denied renewal of a registration.

The first thing this bill does is exonerate the people whose sales tax has not been forwarded, and it would mandate that the Department of Transportation renew their registration upon showing proof that they did pay the sales tax and the transfer fees on the automobile.

The other part of the amendment will prevent this from ever happening again, because it would mandate that in the future, when anybody buys a motor vehicle, two separate checks will be issued - one for the sales tax and the transfer fees and the other one for the cost of the vehicle.

I am sure that members all over the State had this same problem, and I would appreciate support for the amendment.

The SPEAKER. The Chair recognizes the gentleman from Allegheny, Mr. Markosek.

Mr. MARKOSEK. Thank you, Mr. Speaker.

Mr. Speaker, I have spoken with the gentleman, Representative Trello. He has explained the amendment to me. It sounds like a good amendment, and I recommend that we vote in the affirmative. Thank you.

The SPEAKER. The Chair recognizes the gentleman from York, Mr. Foster.

Mr. FOSTER. Thank you, Mr. Speaker.

I strongly support the Trello amendment. This has occurred in other areas of the State, and it is a problem, and I urge every member of the House to support the Trello amendment. The SPEAKER. The Chair recognizes the gentleman from Allegheny, Mr. Mayernik.

Mr. MAYERNIK. Thank you, Mr. Speaker.

I, too, ask for an affirmative vote on the Trello amendments.

I would just like to give the members of the House a little bit of background. In western Pennsylvania we have one dealership that has just gone bankrupt—two dealerships, and another one is ready to go bankrupt, from what we understand, but in regards to information for one of the dealerships, 166 people had paid their sales tax, title and registration fees, the amount of money adding up to \$96,000 just for one dealership that went bankrupt. There are 15 to 20 people who have paperwork that has not been received by PennDOT, and they are out in the cold.

The bond for these dealerships is only \$10,000. The Department of Transportation is presently in the process of a regulatory review and bringing the bond up to \$20,000. But it just seems unfair that these individuals who have paid the sales tax and the title and registration fees should once again have to pay it. By enacting Mr. Trello's amendments, we will not have this problem in the future.

I ask for an affirmative vote.

The SPEAKER. The Chair recognizes the gentleman from Crawford, Mr. Merry.

Mr. MERRY. Mr. Speaker, the maker of the amendment makes a good point as to the need for this type of legislation. I suggest that there should have been a different process before we saw it here today. I wish it had come up through a committee, because the problem has to be addressed.

I see no reason, however, why the Commonwealth is the one that loses these funds or has to ultimately become a creditor to the now defunct automobile dealership. When the purchaser of an automobile does all this paperwork, he in effect makes the dealer, in most cases, his agent to return those funds to the State for his title and for sales tax. I believe that this is where the problem lies in this process. Perhaps we should not let the purchaser of an automobile make that assignment to the dealer. Perhaps the purchaser should still be responsible as he is in true fact. As he purchases the automobile, he should make those funds paid directly to the Commonwealth, from the purchaser, and not let the dealer launder those funds through his own accounts and in many cases not turn it in.

So I am speaking against the amendment but not for the purpose that it intends to do. I would really like to have the maker of the amendment reflect on a better, more concise way to accomplish his purpose, if that is possible, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman from Indiana, Mr. Wass.

Mr. WASS. Mr. Speaker, may I interrogate Mr. Trello, please?

The SPEAKER. The gentleman, Mr. Trello, indicates that he is willing to be interrogated. The gentleman may proceed.

Mr. WASS. Mr. Speaker, thank you for a good amendment. I am totally in favor of it, and it is long overdue. But as

I considered the long overdue part, how far do you go back to make the car buyer whole as it relates to the sales tax that was not forwarded? How far do you go back?

Mr. TRELLO. January 1, 1989 - 1 year.

Mr. WASS. Thank you very much.

The SPEAKER. The Chair recognizes the gentleman from Allegheny, Mr. Gamble.

Mr. GAMBLE. Mr. Speaker, I rise to wholeheartedly support the Trello amendment. As he mentioned, there are several pieces of legislation being introduced which will not now be necessary, mine being one of them and Representative Mayernik's being another.

The two so-called tragedies happened in my district. The two automobile dealers went out of business, and people who paid their taxes in a good, honest fashion now are not getting credit for their taxes with the Department of Revenue, and there is something wrong with that. This will correct that and prevent that from happening in the future, and I ask your wholehearted support. Thank you.

The SPEAKER. The Chair recognizes the gentleman, Mr. Wass, for the second time.

Mr. WASS. Mr. Speaker, forgive me. Would Mr. Trello stand for interrogation just one more time?

The SPEAKER. The gentleman, Mr. Trello, indicates that he is willing to be interrogated.

Mr. WASS. Mr. Speaker, I want to be specific. In my case I have motorcycles, where it happened to about six motorcycles. Is that included in your definition of "vehicle"?

Mr. TRELLO. The definition in my amendment says all motor vehicles, which would include motorcycles.

Mr. WASS. Thank you very much.

Mr. BOWLEY. Thank you, Mr. Speaker.

Mr. Speaker, I would like to ask you if the intent of your amendment would cover those Pennsylvania residents who purchase vehicles from an out-of-State dealer and then that out-of-State dealer did not submit the sales tax to the Commonwealth of Pennsylvania. Would these people be eligible to receive their registration without an additional charge?

Mr. TRELLO. Well, it is the intention of the amendment to cover all motor vehicles that are licensed in Pennsylvania.

Mr. BOWLEY. Thank you, Mr. Speaker.

Mr. Speaker, may I make a comment on the amendment?

The SPEAKER. The gentleman is in order, and he is recognized and may proceed.

Mr. BOWLEY. Thank you, Mr. Speaker.

Mr. Speaker, I rise in support of the Trello amendment. I had a situation just very recently where a car dealer in New York State went out of business. A number of my constituents paid the sales tax to New York State. This particular dealer did not forward that money on to the Commonwealth of Pennsylvania, and my constituents then had to pay an additional sales tax in order to get their registration.

I ask for an affirmative vote on this amendment. Thank you.

The SPEAKER. The Chair recognizes the lady from Beaver, Mrs. Laughlin.

Mrs. LAUGHLIN. Mr. Speaker, I want to speak in favor of the Trello amendment. The circumstance did not happen in my district where the two car dealers went out of business, but many of my constituents were involved in that. So I believe that this much-needed amendment is favorable to the consumers, and I hope the members will vote in favor of it. Thank you.
