PENNSYLVANIA'S YOUNG WOMAN OF THE YEAR PRESENTED

The SPEAKER pro tempore. The Chair at this time is pleased to recognize the gentleman from Chester, Mr. Pitts, who has a distinct honor to introduce a very outstanding young woman to the House. At this time the Chair wishes to recognize Mr. Pitts.

Mr. PITTS. Thank you, Mr. Speaker.

Mr. Speaker, members of the House, it is an honor and privilege to introduce to you today one of the most talented young people that I have ever met. It is encouraging in this day to know when we hear so many negative news stories about young people that such an outstanding teenager can be found.

Carole Jane is a member of the National Honor Society, the honor roll, the marching band, varsity cross country, district band, district orchestra, district chorus, regional band, regional orchestra, State chorus, and alleastern orchestra. She was also in school musicals and earned distinction in the national mathematics merit testing.

Carole Jane plays over 20 different musical instruments. For her creative and performing arts presentation in the program, she played three instruments - the flute, saxophone, and the violin. She plans to pursue a career in medical research.

It now gives me great pleasure to recognize my friend and colleague from Allegheny County who serves as the chairman of the advisory board for the YMCA Youth and Government Committee, Representative Ron Cowell, who has a very pleasing responsibility to recognize a number of the young people who served in the YMCA Youth and Government Program.

At this time I am pleased to recognize Representative Cowell.

Mr. COWELL. Thank you, Mr. Speaker.

Mr. Speaker, last Wednesday the members of the House approved a resolution welcoming several hundred young people to our chamber. Those young people were to serve as participants in the 1990 YMCA Model Legislature program. They had a very successful program this past weekend. The Model Legislature program includes a House, a Senate, an executive branch, a lobbying corps, a newspaper corps, and a number of other support individuals.

First I want to thank all the members of our House of Representatives and the staff who helped to make that weekend very successful. It has become a tradition, and it has become an outstanding experience for several hundred young people each year.

Secondly, I would like to introduce to the members of the House several of the leaders of the Model Legislature program, and they are seated over to my left. First is the statewide adviser to the Model Legislature program, Mr. Larry Bock; secondly, a young man who served as the Youth Governor this past weekend, Jason Schwartz. Jason, thank you for being with us; and the gentleman who served as the Youth Lieutenant Governor, Matt Smyers. Matt, thank you for being here.

Finally, I would like to ask to come forward the young man who had the privilege to preside over a House of Representatives that was very attentive when he was presiding during the past 3 days, and I hope that our members will be just as attentive as the young people were and just as courteous as the young people were this past weekend when they were in session. I would like to introduce for some very brief remarks Mr. Michael Dunmyre. Michael.

Mr. DUNMYRE. Members of the House, this is a great honor.

I would like to tell you that 192 young high school students attended this weekend and this weekend occupied the seats you are occupying now. They undertook a great task. This task started at the beginning of the year when they started to research topics for their bills. They wrote these bills; they researched them. Some of you might have been approached by them for help. They brought these bills to the Capitol. These bills were then debated over the course of this weekend. My father used to tell me that experience is the best teacher. I cannot agree with him more after this weekend. This experience has taught me a lesson I will never ever forget.

I must say that I am in awe of the Speaker to be able to keep a body such as this under control. I do not know if any of you can see this, but this is the result of trying to keep this group under control - a half-shattered gavel. This was not due to the fact that the high school students involved were in any way discourteous; it was just the contrary. They were so involved, they were so seriously committed, they were so enthusiastic about trying to show that they could undertake this responsibility that it sometimes got ahead of them and they tried every trick in the book sometimes to get their bills and their thoughts onto the floor.

But 15 bills passed out of the House. Seven bills passed into law. You may be seeing some of these seven bills. They ranged everywhere from homosexual rights to drug enforcement.

The Representatives that occupied this House undertook their duties with the utmost of seriousness. I have to say that the experience of having these people doing what they were doing at such an early age and holding that responsibility was a great thrill for myself.

There are a lot of memories in this House for me over the past few days, and I will never forget the experience. It is all possible by the efforts of the YMCA Youth and Government Program. Without such, this program would be nothing of what it is. It would be nothing of what it is without your cooperation and letting us use your chambers for the weekend, of which we are greatly appreciative, and I am greatly appreciative of the Speaker for the use of his facilities. I would like to thank the organizer of this program, Mr. Larry Bock, for all the effort that he puts into it.

I would like to close with the fact that Youth and Government has made a definite change in my life. I started in the program 2 years ago not knowing where I was going, not knowing what I was going to do with the rest of my life. But through the past 2 years, last year I served on the administration and this year I served as the Speaker of the House, and I have to say I do know where my life is going now. I am enrolled in a political science and public service program in college, and I would greatly hope that someday I can come back to this chamber, maybe give a little back to the people who made it possible for me to be here this weekend.

I would like to thank you all again and hope that you would give your support again in the future to the Youth and Government Program. It is a great program, and it has made a very big - very, very big - experience in my life. Thank you very much.

The SPEAKER pro tempore. Michael, I would just like to say on behalf of myself and my colleagues in the House of Representatives, we were pleased to have you here this weekend. We are pleased to have the YMCA put on this program, and having witnessed a little bit of the program over the weekend, you did an outstanding job and you are to be commended.

Take care. We hope to see you again next year.

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, providing for sentencing requirements for police officers convicted of certain offenses relating to delivery of controlled substances.

Mr. DeLUCA offered the following amendment No. A1331:

Amend Sec. 1 (Sec. 9720), page 1, lines 11 through 15; page 2, lines 1 through 8, by striking out all of said lines on said pages and inserting

(a) General rule.—Any police officer who tests positive for, or is convicted of possession, possession with intent to deliver, or delivery of any controlled substance which is classified in Schedule I or Schedule II of the act of April 14, 1972 (P.L.233, No.64), known as The Controlled Substance, Drug, Device and Cosmetic Act, in addition to any other penalty imposed by law, shall lose the certification awarded by the Municipal Police Officers' Education and Training Commission pursuant to the act of June 18, 1974 (P.L.359, No.120), referred to as the Municipal Police Education and Training Law.

(b) Exception.—This section shall not apply to any police officer who had a valid prescription for such controlled substance.

On the question,

Will the House agree to the amendment?

The SPEAKER pro tempore. On that question, the Chair recognizes the gentleman from Allegheny, Mr. DeLuca.

Mr. DeLUCA. Thank you, Mr. Speaker.

Mr. Speaker, amendment 1331 helps strengthen HB 2034. What we are trying to do is give our law enforcement community out there another tool in the fight against the war on drugs. Any police officer who happens to be using drugs who tests positive - or is convicted of selling or possession should nowhere be tolerated on a police force. This has happened in some of our communities, and we certainly cannot tolerate people who are entrusted with enforcing the Commonwealth's laws out there pertaining to drugs breaking the law themselves.

In talking to a few of the police chiefs out there, they are in favor of this type of legislation, and I ask for an affirmative vote on the amendment. Thank you.

STATEMENT BY MR. NOYE

The SPEAKER pro tempore. The Chair now recognizes the gentleman, Mr. Noye, under unanimous consent. The Chair hears no objection.

Mr. NOYE. Thank you, Mr. Speaker.

Mr. Speaker, I would like to take this minute to bring something to the members' attention which I think particularly those of you who live in suburban and rural areas have a concern about, and that is a piece of legislation that we passed last year as it related to a 10-acre rule dealing with the onlot sewage problem that exists in this Commonwealth.

In your mail today you received a memo from Representative Lloyd, which I think all of you who have an interest in this area should pay heed to. It was my impression that the legislation that we passed last year, with clear intent from this legislature, has been completely muddled by the interpretation by the department.

At this time, Mr. Speaker, I would ask if Mr. Lloyd would consent to a very brief interrogation.

The SPEAKER pro tempore. The gentleman from Somerset consents to being interrogated. The gentleman from Perry may proceed.

Mr. NOYE. Mr. Speaker, under your memo, you outline, I think pretty clearly, the problem we face. Am I correct in assuming from this that you feel that our intent was thwarted with the legislation that we passed in the last session?

Mr. LLOYD. Yes. It was certainly my understanding that— To give you a hypothetical situation, there are a lot of farmers in my district who want to retire and build a house for themselves on the corner of the farm and turn the rest of the farm over to a son or a daughter and son-in-law. It was my assumption that that was going to be possible, and the Department of Environmental Resources has in essence said that we do not care if you had 300 acres; if you now cut 10

acres off and put a house and there was already a house on that 300 acres, you are subdividing and you have got to go through the planning module, and in effect, you have to prove the same thing you used to have to prove in order to get an onlot sewage permit. That is what I thought we were going to do away with, and that is an interpretation of the Department of Environmental Resources that my bill is designed to try to overturn.

I would also note that this issue is probably going to reach the courts in my county because of someone who feels the department has misinterpreted the law.

Mr. NOYE. Thank you, Mr. Speaker.

If I may, Mr. Speaker?

The SPEAKER pro tempore. The gentleman is in order and may proceed.

Mr. NOYE. Mr. Speaker, all of you who represent rural areas, I would encourage you to take a look at Mr. Lloyd's proposal and join as a cosponsor. This originated as a Bucks County problem originally where the legislation started and it spread throughout the Commonwealth, and I think this is one of the most blatant disregards of legislative intent that I have seen in the years that I have been in Harrisburg, and I will join Mr. Lloyd as a cosponsor of that bill.

The SPEAKER pro tempore. The Chair thanks the gentleman.
