Mr. PITTS offered the following amendments No. A1039:

Amend Title, page 1, line 26, by inserting after "appropriations"

and reducing appropriations

Amend Bill, page 2, by inserting between lines 19 and 20 Section 2. As much of the State appropriation for general obligation debt service in section 206 of the act is amended to read:

Section 206. Treasury Department.—The following amounts are appropriated to the Treasury Department:

For general obligation debt service or to pay all arbitrage rebates to the Federal Government required under section 148 of the Internal Revenue Code of 1986 (Public Law 99-514, 26 U.S.C. § 148).

Amend Sec. 3, page 3, line 7, by striking out "appropriation" and inserting

For the State mental hospitals and restoration center and the care of patients of such hospitals and center, including appropriate treatment and aftercare. This appropriation includes funds for the costs associated with all activities related to the closing of Woodville State Hospital.

On the question,

Will the House agree to the amendments?

The SPEAKER. On that question, the Chair recognizes Mr. Pitts.

Mr. PITTS. Thank you, Mr. Speaker.

Mr. Speaker, HB 2529 provides for supplemental appropriations totaling \$63 million without providing the source of revenue to pay for these added expenditures this fiscal year. If we fail to identify revenue sources, the Governor, in order to fund the bill, would have to lapse sufficient funds to cover these expenditures.

Now, the Governor has placed in budgetary reserve many programs that are important to the members of this House of Representatives. A total of \$403 million he has placed in budgetary reserve. I do not believe that the majority of the members of this House believe that the Governor should lapse funds for things such as small business development centers, for agriculture, for special education, and for the Human Services Development Fund or other potential targets that the Governor has identified with his list.

What my amendment does is to repeal \$63 million of previously approved expenditures that the Governor has placed in budgetary reserve. We have authorized this money; the Governor has placed it in budgetary reserve, and I believe we should be able to agree upon these items.

The Governor has indicated that \$60 million is available in our State mental hospitals line item as a result of increased Federal funding, which we have just authorized with the previous amendment, and he has indicated that the debt service line item contains \$15 million beyond what will be needed this year. What my amendment does is reduce these two line items by a total of \$63 million, which is needed to accommodate the appropriations in this supplemental bill, and I believe that it is the responsible way for us to budget for the needs of the Commonwealth for the balance of the fiscal year.

I urge the members to adopt the amendment. Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes Mr. Evans.

Mr. EVANS. Mr. Speaker, probably the most difficult thing to do here, Mr. Speaker, is to stand and oppose my good friend, Mr. Pitts, but this time there is a little difference between the minority chair of Appropriations and me, and let me express where the differences are.

The difference, Mr. Speaker, is that there are a number of categories that the administration should have the opportunity to review as we attempt to pay for this supplemental. As a matter of fact, Mr. Speaker, there are two items already in the Senate - HB 611 and HB 2216. One is equal to about \$9.5 million and the other one is worth \$15 million.

Mr. Speaker, there are also the categories of outpatient fees, MA (medical assistance), corrections, and general services that could be made available to pay for the supplemental. I do not believe, Mr. Speaker, that this particular amendment at this particular point would be advisable. I think, Mr. Speaker, that there needs to be flexibility available as the Governor considers the options that are open and available to him.

So I would ask, Mr. Speaker, that we oppose this particular amendment, because there are a number of categories that are available. We do not need, Mr. Speaker, to tie the hands of the Governor at this particular point. With knowing and understanding what our revenue situation looks like in this Commonwealth, with knowing that our numbers in the month of March are off, certainly if this amendment is passed, it can certainly tie the Governor's hands in terms of making the necessary decisions to deal with this fiscal situation as we have.

Thank you, Mr. Speaker. So I would oppose the amendment.

The SPEAKER. The Chair recognizes Mr. Ryan.

Mr. RYAN. Mr. Speaker, would the gentleman stand for a brief period of interrogation?

The SPEAKER. The gentleman indicates that he will. The gentleman may proceed.

Mr. RYAN. Mr. Speaker, would you be kind enough to tell us where you think this money will come from?

Mr. EVANS. Mr. Speaker, there are a number of categories. I mentioned to you HB 611, which is in the Senate. There is nothing we can do about that. That is worth about \$9.5 million. I mentioned to you HB 2216, which is in the Senate. That is \$15 million, which there is nothing we can do about

that. I mentioned to you corrections, MA-inpatient, general services—those are just some of the areas—and outpatient fees are available to us, Mr. Speaker.

Mr. RYAN. Mr. Speaker, the outpatient fees, by way of example - is that not money that has been at least morally committed?

Mr. EVANS. Yes, Mr. Speaker, that has been morally committed. That, as you recall in the budget negotiations, was at \$50 million, and thus far since February, we have spent about \$17 million of that, and there is a general commitment in that direction.

Mr. RYAN. All right. Now, there being a general commitment in that direction, to coin a snappy phrase, why should we run the risk of someone in the Governor's Office looking over this menu of money that he on his own, in contravention of commitments, has put in reserve when we could, by adopting these amendments, strike out that moment of doubt that we all must feel when we know he is going to reach down and grab some 60-plus millions of dollars? Why would we not want to say, Governor, we do not want to deprive you of this money, but you must take it out of moneys that are available that you do not need. For instance, you, Governor, told us you did not need all this debt service money. Is that right? He said he did not need the debt service money. Is that not correct? The Budget Secretary?

Did not your staff, Mr. Speaker, receive a letter from the Budget Secretary advising that he did not need all of the money that was set aside for debt service?

Mr. EVANS. Correct, Mr. Speaker. However, as you know, there are certain factors that change that we do not have control over. I think, Mr. Speaker, what we have been attempting to say is that we need to be as flexible as possible.

I want to go back to something, Mr. Speaker, when you mentioned the question of outpatient fees. Mr. Speaker, as you know, the fees were increased in February, first. Secondly, Mr. Speaker, we may not need that \$32 million at this particular point, and since we may not need that particular money, Mr. Speaker, at this point, we should be able to take advantage of that, and that is some flexibility, as you know, that we need to have available to us.

Mr. RYAN. That is right. We may or may not need it, but there are certain areas of finance where we do not have that doubt. We know we do not need it. We know we do not need it for debt service to the extent of some 15 millions of dollars.

We know that just a little while ago, you put some \$60 million into the State coffers from the Federal Government, and we have no need to keep that. We can take that out and use it, because the Governor said he does not need it. He was getting the Federal money.

The SPEAKER. The Chair reminds the gentleman, the purpose of interrogation is interrogation and not argumentation. The gentleman will frame his question.

Mr. RYAN. Do you agree?

Mr. EVANS. No, I do not, Mr. Speaker.

You know the amendment we just passed is for the purpose of authorizing, Mr. Speaker, and you know he does not neces-

sarily have to take advantage of those dollars fully of what we have authorized, first. Secondly, Mr. Speaker, you also know that because, again, of our fiscal situation, we do need the flexibility available to us. The only place we differ with you, Mr. Speaker, is the fact that you want to put this into law, and what we are saying, Mr. Speaker, is that we need this flexibility available.

Mr. RYAN. Mr. Speaker, is the gentleman saying, when he uses the term "we" need this flexibility, does he not really mean the Governor? He does not mean we the legislature, because we certainly do not need it, do we?

Mr. EVANS. Yes, Mr. Speaker. I was defining "we" as we the legislature and the executive branch because we are in this together as Pennsylvanians. So my view is, Mr. Speaker, I was roping us all in there together, knowing full well that you would agree that we cannot spend money we do not have and that we have to take advantage of these reserves so that we will not move into a deficit next year, Mr. Speaker.

Mr. RYAN. Mr. Speaker, are you familiar with the January 17 documents that came from the Budget Office indicating the list of reserves?

Mr. EVANS. Yes.

Mr. RYAN. And over on about I think it is page 4, under "PUBLIC WELFARE" we find, "State Mental Hospitals. \$60,000,000. Estimate of potential lapse due to additional Federal funding." Do you see that on your list?

Mr. EVANS. Yes, Mr. Speaker.

Mr. RYAN. Now, is that the \$60 million that you just appropriated in your last amendment?

Mr. EVANS. Repeat your question again, Mr. Speaker.

Mr. RYAN. The amendment that you just inserted into this bill, how does that relate to the \$60 million that is shown there as a potential lapse?

Mr. EVANS. That is the same one, Mr. Speaker. I repeat what I said to you before that we are not clear exactly what the cost would be and that the only thing we did is authorize the Governor to take that particular action.

Mr. RYAN. Mr. Speaker, now, without the lapse, would it not be true that there is \$120 million at this moment—assuming this bill becomes law, the bill that is before us—would there not be \$120 million available for the mental hospitals line under Welfare? You have got \$60 million in there now awaiting a lapse and you have just added \$60 million.

Mr. EVANS. I guess, Mr. Speaker, if you say theoretically, you could be correct. However—

Mr. RYAN. No. Not theoretically; actually.

Mr. EVANS. That is very hard to determine, Mr. Speaker, because of the question of, we do not know if we are going to get all of the Federal dollars, Mr. Speaker.

Mr. RYAN. Well, parenthetically we just appropriated those Federal dollars.

Now, go to your January 17 list from the Governor and move up a notch to "DEBT SERVICE," and this is money, again, that the Governor has put in his reserve column. As I look at it, you will see three items, two 15's and a 5,600,000, and the identification on my documents, Mr. Speaker, say of

one 15, "Estimate of potential lapse. Requires legislation"; the bottom one, 5.6 million, "Estimate of potential lapse. Requires legislation"; and the center, "Bond Refinancing. Estimate of potential lapse" does not require—I am saying this—does not require legislation. It is not identified as needing it. Why can we not take—it does not require legislation—why can we not take that \$15 million plus the other moneys that were mental health moneys the way Mr. Pitts is suggesting? This is money that is not going to be needed.

Mr. EVANS. Mr. Speaker, that is just the perfect example. One, interest rates have been going up, first. Secondly, Mr. Speaker, again, we are trying to make these kinds of decisions when the circumstances are changing every day and every week and every month, and I am sharing with you, Mr. Speaker, we need to have some flexibility as we try to make some of the decisions.

You also know, Mr. Speaker—and certainly Mr. Rosenstein can tell you—that our revenue numbers in the month of March, in the month of March, are off greatly, and as a result of those numbers being off, Mr. Speaker, we again need the flexibility as we attempt to deal with this. The \$400 million that the Governor set aside, Mr. Speaker, clearly we may have to take advantage and use all of that before the end of the year is up. Naturally, we hope we will not, but the fiscal situation and the recession drives us to such a point that we may have to do that, Mr. Speaker.

Mr. RYAN. Mr. Speaker, is it not true that the Governor, before he signs this bill—assuming it passes the House and the Senate—before he signs this bill, he is going to have to lapse money from somewhere. He is going to have to let the bunny out of the hat, is he not?

Mr. EVANS. Correct.

Mr. RYAN. Why can he not let the bunny out of the hat so we can see what is going on before he asks us to spend the money on the bunny?

Mr. EVANS. Mr. Speaker, as I indicated to you earlier and to members of this House, there are a number of areas that he has available to him. I mentioned to you HB 611, HB 2216, which are in the Senate, which there is nothing we can do about it. I mentioned to you MA-inpatient, corrections, general services, MH hospital, and outpatient fees, Mr. Speaker. I mentioned to you that all of those categories are available to make sure we take care of the purpose of the supplemental.

Mr. RYAN. I thank the gentleman.

Mr. Speaker, in connection with these amendments.

The SPEAKER. The gentleman is in order.

Mr. RYAN. I sincerely think that the members should vote to adopt these amendments. They are offered in good faith. If we were going to play games at this point—and neither side is above playing games from time to time—but if we were going to play games, we could have started with the budget and nickled and dimed lines out of general government that may be or would be embarrassing, out of public relations, and things that from time to time we have done and you have done trying to score some political points. We have not done that,

Mr. Speaker. We have gone right to those areas of the budget where you and I and everybody else know the lapse has got to come from. It has got to come from one of these areas that we have looked at.

It is our judgment that the least sensitive of all of the areas are those that we have put in the amendments that were offered by the gentleman, Mr. Pitts.

To simply ignore this type position—which we believe to be good government—to ignore it just because we—and I think the "we" stands for the Governor's Office—find it more convenient to have flexibility, I think is wrong. Every one of us knows he has got to lapse, he has got to lapse before he can sign a bill. Why not let us know where those lapses are coming from? That is all we have ever asked.

The SPEAKER. The Chair recognizes Mr. Evans.

Mr. EVANS. Mr. Speaker, I indicated, when Mr. Pitts stood and offered this amendment, that I said to you that it was somewhat difficult to oppose this particular amendment. I also said, Mr. Speaker, in terms of opposing this particular amendment, that I opposed it on the basis of understanding that there needed to be some form of flexibility available to us at this particular point. I expressed to you that I understand the intent of Mr. Pitts by offering this particular amendment, but I do not think, Mr. Speaker, that this would be acceptable at this particular point and that we should oppose this amendment. Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes Mr. Saurman.

Mr. SAURMAN. Thank you, Mr. Speaker.

Mr. Speaker, we are in a situation, all of us, I think, where we have to recognize that the general public has been extremely upset with how budgets have been adopted in an atmosphere of secrecy and a veil that keeps us from having the necessary information.

We are being asked, Mr. Speaker, to authorize \$63 million, which was not even considered at the time that the budget was adopted, because of a need, and that certainly can happen.

What is disturbing, Mr. Speaker, is that there is no roadmap as to where these dollars are going to be taken, from what source, what in fact would be lapsed, and we are back to that old adage "trust me." Mr. Speaker, this amendment lets everyone trust each other, because we know where the funds will come from.

I would certainly ask that everyone support this Pitts amendment so that we can take care of this problem but so that we also can control how we take care of it and we can explain to our constituents exactly where that money came from and do not have to say again we trusted someone, but in this case we know. Thank you, Mr. Speaker.

On the question recurring,

Will the House agree to the amendments?

(Members proceeded to vote.)

VOTES CHALLENGED

Mr. RYAN. Mr. Speaker, before you close the board, please.

The SPEAKER. Does the gentleman wish, before the Court—Before the Court.

Before the Chair records the vote, does the gentleman wish to challenge votes?

Mr. RYAN. Yes, Your Honor.

The SPEAKER. It was the gentleman's techniques of cross examination that unfortunately put the whole House in that mind.

The gentleman will proceed.

Mr. RYAN. Rieger?

The SPEAKER. The gentleman is not recorded.

Mr. RYAN. Maiale?

The SPEAKER. The gentleman is not recorded.

Mr. RYAN. McGeehan?

The SPEAKER. If the gentleman, Mr. McGeehan, is not presently in the House, his vote will be stricken. The gentleman's vote is stricken.

Mr. RYAN. Williams?

The SPEAKER. If the gentleman, Mr. Williams, is not presently in the House, his vote will be stricken.

Mr. RYAN. Thomas?

The SPEAKER. The same thing with the gentleman, Mr. Thomas.

Mr. RYAN. Butkovitz? I am sorry. They are not voted.

The SPEAKER. The gentleman is on leave.

Mr. RYAN. Steelman? Hughes?

The SPEAKER. The gentleman, Mr. Hughes, was observed by the Chair, but if he is not presently on the floor of the House, his vote will be stricken until he returns.

Mr. RYAN, Mrkonic?

The SPEAKER. If the gentleman, Mr. Mrkonic, is not on the floor, please strike his vote.

Mr. RYAN. Veon?

The SPEAKER. The gentleman is on leave.

Mr. RYAN. Levdansky?

The SPEAKER. The gentleman, Mr. Levdansky, is present.

Mr. RYAN. All right. I am sorry.

Josephs? I know Representative Josephs was here this morning. I do not see her on the floor now though.

The SPEAKER. If she is not presently on the floor, her vote will be stricken.

Mr. EVANS. Mr. Speaker, Mr. O'Brien?

The SPEAKER. Is the gentleman, Mr. O'Brien, in the hall of the House? If not, please strike his vote.

Mr. EVANS. Mr. Taylor?

The SPEAKER. Is the gentleman, Mr. Taylor, in the House? Please strike his vote.

Mr. EVANS, John Barley?

The SPEAKER. Is the gentleman, Mr. Barley, in the House? The gentleman is present.

Mr. EVANS. Tom Gannon?

The SPEAKER. Is the gentleman, Mr. Gannon, present? Please strike the gentleman, Mr. Gannon's vote.

Mr. EVANS. Strike the Gannon vote.

The SPEAKER. That has been done.

Mr. EVANS. Rick Cessar?

The SPEAKER. Is the gentleman, Mr. Cessar, in the House? Please strike the gentleman's vote.

Mr. EVANS. Can you take Mr. Cessar off, please?

The SPEAKER. The Chair would request that the gentleman, Mr. Gallen, if convenient, strike the gentleman, Mr. Cessar's vote until the gentleman— The Chair notes the presence of Mr. Cessar.

Mr. EVANS. Serafini?

The SPEAKER. Is the gentleman, Mr. Serafini, in the House? Please strike his vote.

Mr. EVANS. Pete Vroon?

The SPEAKER. Is the gentleman, Mr. Vroon, in the House? Please strike the gentleman's vote.

Mr. EVANS. Representative Stairs?

The SPEAKER. Is the gentleman, Mr. Stairs, in the House? Please strike the gentleman's vote. Please strike the gentleman, Mr. Stairs' vote. The Chair notes the presence of Mr. Stairs.

Mr. PITTS. Mr. Speaker, I urge the members to vote "no" on this bill. We are not identifying the revenue sources. This is not proper fiscal policy, and I urge the members, the same ones who voted on the amendment, I urge them to vote against the bill. Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes Mr. Evans.

Mr. EVANS. You know, Mr. Speaker, probably, again, the most difficult part about this position is that I understand the gentleman, Mr. Pitts' feelings about what just occurred, and I am certainly sorry that it occurred that particular way, but I would ask that the minority chair think carefully about recommending "no" on this supplemental, particularly when you start talking about the local school districts. Keep that in mind, that your local school districts project a shortfall, and particularly the long-term care, Mr. Speaker, in this Commonwealth. These are bills and debts that we have to pay, Mr. Speaker. These are payments that are due by April 20.

So I understand how the gentleman feels, and I do not agree sometimes with the way that the process is handled here, but the bottom line, Mr. Speaker, is I would think that this is a mistake for the gentleman to recommend that members vote "no" on bills that we owe in this Commonwealth, because if this should fail, Mr. Speaker, as usual, it will get caught up into the political muck and mire of what typically happens around here. So I would ask that the gentleman, I would hope, reconsider the recommendation that he has just made on bills that we owe and that we pay those bills.

So I would ask that all members on both sides of the aisle consider voting "yes" on this particular bill. Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes Mr. Snyder.

Mr. D. W. SNYDER. Thank you, Mr. Speaker.

Mr. Speaker, I think the chairman of our Appropriations Committee speaks for many of the members of our caucus. I think it is time that we as members take a position that the public can identify with. The public has said many times that we are here with a responsibility to watch the State treasury. Previously, during the amendment, Representative Saurman noted the question of "trust me" once more that the Democratic Appropriations chairman was asking the members of this floor to follow.

You know, we can always find excuses and reasons and political sensitivities to vote for more spending, but we can never find justification to say where that money is going to come from because we need, quote, "flexibility," unquote. The Governor, as we noted, has to find a reason to lapse moneys in order to sign this appropriation bill. We, as the legislature, have a responsibility to determine what programs get funded and, when there is only limited moneys, to find out what programs get reduced.

The amendment that passed was sound fiscal policy. It provided for reductions in areas where money is definitely not needed during this fiscal year. I think, Mr. Speaker, it is not a question of what we are funding but the process that we are going through, and I think a "yes" vote today is a vote for irresponsibility of State spending. Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes Mr. Saurman.

Mr. SAURMAN. Thank you, Mr. Speaker.

Mr. Speaker, it is pretty easy to just simply say that if you are not going to vote for this, it means you are not going to support your schools or medical assistance. Mr. Speaker, those votes to pass this would have been there if in fact we knew where the money was coming from. It is a two-way street. It is not just spending the money; it is accountability, and without that accountability some of us are just not going to support this spending of money in the dark. Thank you, Mr. Speaker.

On the question recurring,

Shall the bill pass finally?

The SPEAKER. Agreeable to the provisions of the Constitution, the year and nays will now be taken.
