# REMARKS SUBMITTED FOR THE RECORD

Mr. EVANS submitted the following remarks for the Legislative Journal:

There has been a lot of recent attention paid to the way in which the General Assembly performs its job. In some cases, more attention to the way than the what.

The bills we are about to consider say a little bit about each. While much of what they do is establish or refine process, they do it surrounding some major substance - the effectiveness of government-funded programs and the appropriation of money to carry them out.

These bills are not new to this chamber. In fact, we over-whelmingly approved them last session. They attack head-on what I believe is the most important thing people want from government, and that is that government works harder and performs better.

For those in the chamber who have wanted to continue to reform how things happen in Harrisburg, here it is. One of these bills sets up duties, responsibilities and deadlines and the penalties for failure to meet them. One of those penalties would be the loss of access to House and Senate operating accounts until appropriate action is taken.

Another would amend the State Constitution to permit the State Senate to initiate revenue-generating legislation. Currently only the House can do so.

A third would establish an independent revenue forecasting board, an effort to provide expert and independent insight into the business of projecting the State's revenue picture.

The fourth would establish a performance evaluation commission charged with assuring that all programs administered by State government undergo periodic performance evaluations. Right now there is not systemic, consistent evaluation process in place.

As a direct result of this year's budget hearings on accountability in State government, this legislation was amended in committee to require the development and implementation of a State employees' cost reduction incentive program to award State employees who propose ideas which reduce State expenditures or improve State operations, provided such ideas are put in place.

I urge all members to look beyond the short term, focus on the long term, and vote "yes" on these bills.

# DECISION OF CHAIR RESCINDED

The SPEAKER pro tempore. Without objection, the Chair rescinds its decision that HB 587 was agreed to for the third time.

On the question recurring,

Will the House agree to the bill on third consideration? Mr. GANNON offered the following amendments No. A0526:

Amend Title, page 1, lines 1 through 3, by striking out all of said lines and inserting

Proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, providing for special tax provisions for certain persons who have attained 65 years of age.

Amend Bill, page 1, lines 6 through 13, by striking out all of said lines and inserting

Section 1. The following amendment to the Constitution of Pennsylvania is proposed in accordance with Article XI:

That section 2(b) of Article VIII be amended by adding a clause to read:

- § 2. Exemptions and special provisions.
  - (b) The General Assembly may, by law:

(vi) Provide that, subject to income limitations established by act of the General Assembly, the amount of tax levied by a school district on the residence of a person shall not be increased after the person attains 65 years of age and, in the case where a person who has attained 65 years of age purchases a residence, that the amount of tax levied by a school district on the residence shall not be increased during the period the person owns the residence. The Commonwealth shall provide for the reimbursement of school districts by the Commonwealth for revenue losses resulting from this special tax provision.

Section 2. This proposed amendment shall be submitted by the Secretary of the Commonwealth to the qualified electors of this Commonwealth at the primary, general or municipal election next held after the advertising requirements of section 1 of Article XI of the Constitution of Pennsylvania have been satisfied.

On the question,

Will the House agree to the amendments?

The SPEAKER pro tempore. The Chair recognizes Mr. Gannon.

Mr. GANNON. Thank you, Mr. Speaker.

Mr. Speaker, I am not certain that this amendment has been circulated on the floor at this time. Oh, okay; it has. Thank you, Mr. Speaker.

Mr. Speaker, this is a very, what I feel is a very important and significant amendment, and it is something that the senior citizens of Pennsylvania have been asking for from this legislature for a number of years. This, I believe, is the first opportunity that we have had as a body to address this issue on the floor of the House. What it does, Mr. Speaker, it says to those folks who are 65 years and older that enough is enough; your property tax increases have to stop.

This proposal to the Constitution of Pennsylvania says that when you are 65 years and older, your property tax rates freeze. There will be no further increase in property taxes for senior citizens 65 years and older, and I know that many members of this legislature, including myself, have received numbers of petitions and letters and requests from senior citizens in our districts and throughout the Commonwealth for this type of local property tax relief.

I urge a "yes" vote on this amendment. Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Evans.

Mr. EVANS. Mr. Speaker, there are a number of things I would like to-

Mr. PICCOLA. Mr. Speaker, a point of personal privilege. The SPEAKER pro tempore. What is your point of personal privilege? Mr. PICCOLA. Mr. Speaker, these lights that have all of a sudden come on here in the chamber are quite distracting, and unless they are of extreme importance, I would request that they be turned off.

The SPEAKER pro tempore. I can appreciate the gentleman's remarks, but the lights are needed temporarily, and I can assure you that the problem will be taken care of in a very short period of time.

The Chair recognizes the gentleman, Mr. Evans.

Mr. EVANS. Mr. Speaker, there are a number of things I would like to say regarding this major amendment that Mr. Gannon is offering.

The first thing I would like to note is that we received this amendment at 12:45 today, and, Mr. Speaker, although we received it at 12:45 today, we were able to prepare a fiscal note, Mr. Speaker. I state that for the record so people can understand certainly the complexity of trying to put together a fiscal note. Even though we were able to put together a fiscal note, Mr. Speaker, there are some implications in this amendment that are far-reaching for the Commonwealth of Pennsylvania that could be extremely costly.

If you notice your fiscal note—and I hope that you have it on your desks—you will notice that this particular amendment says that school districts cannot increase resident property taxes on persons ages 65 and above. The Commonwealth, Mr. Speaker, must reimburse school districts for any revenue. Let me repeat that: School districts, as is stated, cannot increase resident property taxes on persons ages 65 and above. However, Mr. Speaker, that revenue has to be made up by someone. We need to understand in this House, Mr. Speaker, that these things are not done by magic. The reality of it is, Mr. Speaker, this Commonwealth will be responsible for reimbursing those school districts. I do not know, Mr. Speaker, where the maker of this particular amendment has an answer to that problem.

I would encourage you to vote "no" on this particular amendment, because in my view, Mr. Speaker, this again is an amendment that is not well thought out. If you are going to deal with this particular issue, Mr. Speaker, this needs to be dealt with in the context of tax reform for the Commonwealth of Pennsylvania and not just dealt with in a narrow way. So I stress to you, Mr. Speaker, that you need to read the fiscal note and understand the fiscal implications if this amendment should pass. Thank you.

The SPEAKER pro tempore. The Chair recognizes Mr. Preston from Allegheny County.

Mr. PRESTON. Thank you, Mr. Speaker.

Will the maker of the amendment stand for interrogation? Mr. GANNON. Yes, Mr. Speaker.

The SPEAKER pro tempore. The gentleman, Mr. Gannon, agrees that he will agree.

Mr. PRESTON. It is apparent that the Commonwealth would be responsible should your amendment pass. How and in what manner would you assess that the Commonwealth would be able and where will we get the funds to be able to pay for your amendment?

Mr. GANNON. Mr. Speaker, this amendment provides a very reasonable and simple mechanism for the Commonwealth o reimburse school districts. We already reimburse school districts for, in some instances, 50 to 40 to 60 percent of their educational costs.

This amendment only addresses the increase in property taxes, not the whole property tax that is now assessed against an individual 65 or older. And those revenues, Mr. Speaker, would come from the same source that all of our general revenues come from, and that would be our sales tax, our corporate net income taxes, our business taxes, and of course, our other income taxes.

Mr. PRESTON. Being that we currently are under a constitutional law of having a balanced budget, would you say then if we pass your amendment for the additional revenues, are you recommending that we would increase taxes, sir?

Mr. GANNON. No. Mr. Speaker, this amendment would not require any increase in taxes. That is obvious on its face.

#### POINT OF ORDER

Mr. MELIO. Point of order, Mr. Speaker.

The SPEAKER pro tempore. The gentleman will state his point of order.

Mr. MELIO. Mr. Speaker, there are some of us who do not have the fiscal note on our desks. None of us.

The SPEAKER pro tempore. The fiscal note is now being prepared and will be circulated in a few seconds. Will the House stay in order until the fiscal note is circulated.

#### POINT OF ORDER

Mr. PRESTON. A point of order also. A question of order, sir.

The SPEAKER pro tempore. The Chair recognizes Representative Preston. What is your point of order?

Mr. PRESTON. Was this amendment submitted within our rules context?

The SPEAKER pro tempore. Yes.

Mr. PRESTON. Okay. Thank you.

The SPEAKER pro tempore. The new rules are effective March 29.

Mr. STURLA. Mr. Speaker?
