- (c) Physician's statement.-
- (1) Any person applying for a special plate or parking placard for handicapped persons must present a statement, certified by a physician licensed to practice in this Commonwealth or in a contiguous state, that the handicapped person is handicapped as provided in subsection (a). A copy of the physician's certification may be displayed on the dashboard and shall serve as a temporary handicapped parking placard until a permanent placard is received from the department, but in no case for more than 45 days after the date of the physician's certification.
- (2) Any person applying for a renewal of registration of a special plate for handicapped persons must comply with this subsection. Once a handicapped person has been duly certified by a physician as being handicapped, as provided in subsection (a), the applicant need not submit a certification for subsequent renewals of registration for a special plate for handicapped persons. A person who was issued a handicapped plate under this section and no longer qualifies for one shall not be charged a replacement fee for a regular registration plate upon payment of the regular registration fee.
- (3) In lieu of a physician's statement, a person applying for a special plate or parking placard may present a statement from a police officer certifying that the person does not have full use of a leg, or both legs, or is blind.
- (4) The department shall phase out existing handicapped placards as soon as practicable and issue a new series to persons who comply with this section.

On the question,

Will the House agree to the amendment?

The SPEAKER pro tempore. On that question, the Chair recognizes the gentleman from Clearfield County, Mr. George.

Mr. GEORGE. Thank you, Mr. Speaker.

Mr. Speaker, I rise today to offer amendment A0544.

This amendment is designed to help handicapped motorists across the Commonwealth gain access to public places while waiting for the Department of Transportation to process their applications for a handicapped parking placard. Under this amendment, PennDOT will provide to the licensed physicians a certification form that can be displayed and used in lieu of a handicapped placard or a plate. The physician's certification form will be good for 45 days only or until the actual placard arrives, whichever comes first.

There have been and continue to be many instances when handicapped individuals cannot make use of special handicapped parking spaces because they are waiting for PennDOT to provide them with the proper materials. Instead of risking a stiff fine, these legitimately handicapped or injured people are left with few options when traveling to the stores or the malls, churches, and other public places. My amendment will help to rectify this situation by allowing licensed physicians who sign the normal and

existing applications, as is today, to provide the temporary relief to these individuals.

I ask for an affirmative vote.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Lycoming County, Mr. Dempsey.

Mr. DEMPSEY. Thank you, Mr. Speaker.

Mr. Speaker, I rise to oppose this amendment.

There is a method in place now for temporary handicapped plates. In discussing this amendment with PennDOT, their feeling is that this is not a needed amendment, so I would ask for a negative vote. Thank you.

The SPEAKER pro tempore. Does the gentleman, Mr. George, wish to be recognized for the second time?

Mr. GEORGE. Yes, I do, but I will wait.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Franklin County, Mr. Coy.

Mr. COY. Thank you, Mr. Speaker.

Just a moment of support for the amendment.

I can think of numerous times where individuals have come to district offices that I operate, and for one reason or another, the handicap that brought about the need for the application, for the placard, came about rather quickly; in other words, maybe a fall or something like that which might be a really quick situation where the person needs the placard. Not all handicaps come about over a long period of time or can be anticipated. Therefore, the idea that Representative George has I think helps to cut down on the bureaucracy that we have in place.

I think by having PennDOT establish a form and provide physicians and others who face firsthand the circumstance is a good idea. You know what we are faced with. A person comes into the district office and they need it badly, and then we have to go through the bureaucracy and make phone call after phone call to make sure that they get it back, and probably the best you can do is a couple days or a week anyhow.

This is a way to make the whole thing happen easier. It still requires the signature of the physician.

I think it is a well-thought-out idea. I commend Representative George for it, and I encourage an affirmative vote.

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. George, for the second time.

Mr. GEORGE. I thank you, Mr. Speaker.

Mr. Speaker, I am a little confused as to why a colleague from the rural area such as I come from would rise to insist that the system that is in place now is the system that is workable.

I look to my right. I see an individual now on crutches. Hopefully he will be off the crutches before 45 days.

I wonder how Mr. Dempsey, whether he uses some special consignment or delivery, can get away with the 3 or 4 days that it takes for his office to send it in to Harrisburg, the 6 or 7 days for it to be gone over, the 4 or 5 more days to come back. Pretty soon you have 2 or 3 weeks.

We are not doing anything more than what PennDOT did during the flood when they took these emergency places into the districts and said, you can get your licenses from A to Z; you can get the people who need these handicapped placards taken care of immediately, because they could be stamped right there.

It is beyond my comprehension to believe that anyone would want to vote against this amendment.

The SPEAKER pro tempore. The Chair recognizes the lady, Ms. Boscola.

Ms. BOSCOLA. Thank you, Mr. Speaker.

I support Representative George's amendment.

Personally, I have a brother who was in a diving accident and is a quadriplegic at this time. It took us forever to get a handicapped placard, which is very inconvenient, because we needed a van that had a lift on it in order to transport him. Without that handicapped placard, it was very, very difficult. It took four people in order to get him in and out of a car, at one point, for months.

I just think it would be very reasonable if everybody here thought about supporting this amendment. It is a very good amendment. Thank you.

Mr. Speaker, my bill, HB 2013, removes the definition of "motorized wheelchair" from the definition of a vehicle in the Motor Vehicle Code, but by doing that, we have to give it some designation. So amendment 6223 now designates a motorized wheelchair with the same responsibility as a pedestrian has. Thank you.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Allegheny County, Mr. Itkin.

Mr. ITKIN. Mr. Speaker, I have a copy of the amendment in front of me, and I have no objection to the amendment. I am just concerned that the members on the floor all do not have copies. I know that it is being distributed right now. Could we just postpone the vote until members are provided a copy?

The SPEAKER pro tempore. The Chair thanks the gentleman. The House will be at ease for a moment.

So that because of the change up higher on the page in the definition of "vehicle"— And, Mr. Speaker, your position is that designating these as "pedestrians" does not have any effect anyplace else in the code with regard to some other kind of offense – jaywalking or whatever it might be.

Mr. DEMPSEY. That is correct; that is correct. Yes; I would say yes.

Mr. LLOYD. So that the effect of your amendment is that anytime a pedestrian would be guilty of violating the code, someone on a self-propelled wheelchair would also be guilty of violating the code.

Mr. DEMPSEY. That is correct; that is correct.

CONSIDERATION OF HB 2205 CONTINUED

On the question recurring, Will the House agree to the motion?

The SPEAKER pro tempore. The question is on the motion that HB 2205, PN 2789, be recommitted to the Committee on Veterans Affairs and Emergency Preparedness.

On that question, the Chair recognizes the gentleman, Mr. Kukovich.

Mr. KUKOVICH. Thank you, Mr. Speaker.

I would like to oppose recommitting the bill to the Rules Committee. We did have this scheduled for a vote 3 weeks ago when we broke for the appropriations hearings. It was scheduled originally for a vote today. As I look at the sponsorship, there is a large number of members, both Republican and Democrat, who have cosponsored this bill; there are about 29 Republican sponsors on Representative O'Brien's bill—

The SPEAKER pro tempore. Will the gentleman suspend?

For the gentleman's information, the motion was to recommit it to the Committee on Veterans Affairs and Emergency Preparedness, not to Rules.

Mr. KUKOVICH. Thank you.

I would oppose any motion to recommit to any committee.

There are very few opportunities that we have in this chamber to accomplish this kind of policy. It is very important now, because fire departments across the Commonwealth are seeing their budgets stretched very thin, especially in light of the emergencies we have had over the winter.

Again, as I look at the various bills, the one I had introduced back in October and the bill that Representative O'Brien introduced a month later to provide some relief in grants, small grants from the State, I see widespread support. It is crucial that we try to do this now before the budget debate actually begins so we can try to provide funding in the very next fiscal year when the money is needed the most.

So I would ask for members to vote against recommittal. I am not even suggesting that we vote the bill on final passage today, although I would like to do that. My fear is that once this bill is taken off the table, we will tend to lose control of it. It will be buried in a committee until after a budget is passed, and we will lose that opportunity.

I understand, and I think the prime sponsor of the bill is very well intentioned; he is trying to negotiate with the administration, trying to work something out. I am suggesting that by keeping the bill on the calendar rather than recommitting it, we will be in a much stronger position to negotiate. We will be able to build up more support from fire departments across the Commonwealth and try to get something done in a timely way as soon as possible.

I would ask the members to vote against recommittal.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Philadelphia, Mr. O'Brien.

Mr. O'BRIEN. Thank you, Mr. Speaker.

For the information of the ladies and gentlemen of the House, as pointed out by Mr. Kukovich, I am the prime sponsor of this piece of legislation, and again for the information of the members of the House, this bill is being recommitted to the Veterans Affairs and Emergency Preparedness Committee, of which I am the chairman. It is not my intention to bury this legislation, but since its appearance on the floor of the House, there have been very substantive amendments that have been proposed that change the original intent significantly, and I am concerned about the chances of final passage and enactment into law of this piece of legislation.

The main intent of this legislation is to provide financial assistance to the volunteer fire and emergency service units throughout the Commonwealth. It is my intention, by recommittal, to work through these various issues and bring before the House a bill that will get that aid to those units.

I would ask the members to support me on the recommittal motion. Thank you.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Westmoreland County, Mr. Tangretti.

Mr. TANGRETTI. Thank you, Mr. Speaker.

Mr. Speaker, my intention was to rise to support Mr. Kukovich's position to vote against the recommittal motion, because like just about every member in this hall, we need to provide and believe that we need to provide the help for our volunteer fire companies.

But I wondered if I could just ask Mr. O'Brien just a few brief questions.

The SPEAKER pro tempore. The gentleman, Mr. O'Brien, indicates that he will consent to interrogation. The gentleman is in order and may proceed.

Mr. TANGRETTI. Mr. Speaker, I wonder if the chairman of the Veterans Affairs and Emergency Preparedness Committee would inform the House of his timing with respect to when he would like to bring this back to the floor.

Mr. O'BRIEN. Well, I cannot give you a definite time. There are eight substantive amendments here, and it is my intention to review the content of each of those amendments and work through the committee process as soon as possible.

Mr. TANGRETTI. There is not a way you could quantify for the House then, is there?

Mr. O'BRIEN. I hope to have a bill that we can vote on before the enactment of a budget this June.

Mr. TANGRETTI. Thank you, Mr. Speaker.

On the motion.

The SPEAKER pro tempore. On the motion, the gentleman is in order

Mr. TANGRETTI. I, like Representative Kukovich, although I respect and admire Mr. O'Brien very much in his efforts and as chairman of that committee, I am concerned that we are going to lose the momentum on this.

I have been talking to my fire departments about this; they are excited about it. Just by coincidence, yesterday at the Forbes Road Volunteer Fire Department, I attended a spaghetti dinner for \$5 a ticket, my wife and I; a week's worth of preparation; members of the auxiliary of that fire department working from about 6 o'clock in the morning until 8 o'clock last night for the purposes of raising money for one payment for their truck that is due of about \$3,000; a \$210,000 piece of equipment. Maybe a few years ago that would

have been adequate for the cost of vehicles, but anymore, it just is not enough.

And I appreciate Mr. O'Brien's concerns about the amendments, but I am really concerned that we are going to lose the opportunity and the momentum with respect to this. I think we ought to do it now. Let us deal with these amendments; let us deal with the bill; let us get on with it. These people need our help and they need it now, and I would ask that we not recommit this bill. Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. O'Brien, for the second time.

Mr. O'BRIEN. Thank you, Mr. Speaker.

My fear is that if we leave this bill out of the control of the House, that we lose control of the negotiations on this bill. The Fire Commissioner, Dave Smith, has been traveling along with my staff person, Rick O'Leary, to every county in the Commonwealth of Pennsylvania, and with that, they have issued a questionnaire, and in that questionnaire one of the questions involves, what do they need in the way of services? We have various responses from virtually every county in the Commonwealth, and it is for those purposes that we want to recommit this bill.

It is my intention not to lose control of this bill by sending it over to the Senate. I want to maintain control of this bill and these issues so that we have a product that we can bring before this House that will represent a resolution to the many issues that are brought forth in this questionnaire. Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Kukovich.

Mr. KUKOVICH. Thank you, Mr. Speaker.

I understand the prime sponsor's concern about losing control. However, we do not lose control by keeping the bill on the calendar. Who loses control are volunteer fire departments and the people.

Mr. O'Brien has done a lot of work in trying to come up with some compromise amendments. I think for the most part, they are all agreed to; I think he has done a good job. I would suggest if further negotiations are needed because of the Governor's Office, that is fine. Let us maybe table the bill. We can keep it on the calendar. I am not saying we vote it today; I am saying we do not recommit it. If we do that, I am suggesting, no matter how well intentioned Mr. O'Brien is, if the administration feels that this money – and quite frankly, it is a drop in the bucket compared to the overall budget but is almost a lifeline to a number of volunteer fire companies out there – if we recommit this, the odds go up dramatically that that lifeline to volunteer fire companies is cut off.

I am suggesting, let us keep this bill alive. Let us allow Mr. O'Brien and the House to negotiate with the Governor. Let us keep the bill available for a vote, either on the calendar or on the tabled bill calendar. Let us vote against recommittal. Thank you.

Mr. Speaker, on page 5 of the legislation, lines 10 through 16 which speak to the issue of single prime contractors for modular units which may be installed at a Department of Corrections or juvenile facility, concerning those lines, Mr. Speaker, am I to understand that the single prime contractor would be putting together prefabricated modular units as opposed to modular units that would require electrical or plumbing work be done on the site?

Mr. Speaker, do you understand my question?

Mr. BAKER. Would you repeat that question, please?

Mr. BELFANTI. Mr. Speaker, there are certain modular units that come prefabricated completely where the electrical wiring and the plumbing are simply coupled together when you put together the various units that comprise the modular facility. However, there are other modular units which require extensive wiring or plumbing onsite to be performed by a licensed or certified plumber or electrician. So the types of units that you are talking about in this legislation I would assume are those that are fully prefabricated modular housing units. Would that be correct?

Mr. BAKER. That is correct.

Mr. BELFANTI. Thank you, Mr. Speaker.

If that is the case, we have no objections to this legislation.
