Mr. RAMOS. Thank you, Mr. Speaker.

Thank you for allowing me time in our schedule to honor and pay tribute to Officer Jose M. Ortiz and his family here today.

It is only fitting that we honor this fine public servant who was a respected and outstanding police officer, who died recently in the line of duty in Philadelphia.

Here with me this afternoon, as my guests, are his widow, Theresa; father-in-law, Thomas McMann; sisters, Naomi and Maribel Ortiz; partner, police officer Ron Gardner; police officer Victor Fontane; Lieutenant Bachmyer; and Capt. Tony Boyle, commander of the 25th Police District in North Philadelphia. I would like to welcome them to the House, and I appreciate your taking the time for coming here.

Not only was his death a loss to this family, but to the community and the Philadelphia Police Department. Although he was only 29 years old when he died, he had the respect of his colleagues and the community he served.

## **OCTOBER 10**

Officer Ortiz grew up in the same community that he patrolled and served, a community of neighbors who helped him develop the compassionate caring and determined strength and confidence he would need later on to be their protector; a neighborhood he would continue to be a part of even during his off-duty hours by taking part in community events and doing volunteer work. He was a generous and loving man.

The words included in the resolution we are to consider today are words and descriptions from friends, family, and coworkers that surfaced during the period of mourning. They are sincere and true, just like Jose M. Ortiz.

When I mentioned his compassion and generosity, it was with a sense of admiration, for even in his death he continued dedicating his life to serving others by being an organ donor. He never stopped giving.

I want to thank the family of Officer Ortiz for giving us this outstanding public servant who paid the highest price in life by giving his in the course of serving and protecting others.

I ask the House to join me in recognizing this exceptional young officer for his dedication, commitment, and in remembering and honoring his life. Thank you very much.

The SPEAKER. On the question of the adoption of the resolution, the Chair recognizes the gentleman, Mr. Perzel.

Mr. Speaker, police officers go to work every single day of their lives knowing that something could happen. They put their lives on the line to protect each and every citizen of the Commonwealth of Pennsylvania. Officer Ortiz was a great public servant and an outstanding police officer. His loss will be felt by the entire community, not just by those people in Philadelphia but by the entire Commonwealth of Pennsylvania.

I wished I had known the officer better; I did not have that opportunity to know him, but I thank him for everything he did for all of us in Pennsylvania.

Mr. Speaker, Officer Jose Ortiz was one of the finest people and one of the finest police officers Philadelphia ever had. He gave his life every single day of it in order to make his community a much better community, a much safer community. He was an outstanding role model throughout his entire life; he was an outstanding role model when he died and became an organ donor. He will be deeply missed by all who knew him and by all who read of the outstanding example he was throughout his entire life.

We are deeply saddened. The Ortiz family and all his friends in the community and the police force have all of our prayers and hopes. Thank you.

And I just want to assure each and every member in the House that the words that you have heard today are not idle words and they are not words that just come without a lot of sincerity. Jose Ortiz was the type of police officer that each and every one of you would want to be guarding your home at night.

Ms. ORTIZ. Good afternoon, everyone. My name is Naomi Ortiz. I am Officer Ortiz's sister. I would like to say thank you on behalf of the Ortiz family. Thank you for your prayers in a time of mourning. My brother was everything to me, and he was a great officer, and I will miss him dearly. But I know that God likes good angels; he does not like crooked or ugly, so I know he is watching me right now.

So thank you, thank you so much for your prayers.

#### Mr. PHILLIPS called up HR 592, PN 4036, entitled:

A Resolution honoring the 225th anniversary of the United States Marine Corps on November 10, 2000.

On the question, Will the House adopt the resolution?

The SPEAKER. The Chair recognizes the gentleman, Mr. Phillips. The gentleman will yield.

The House will come to order.

Mr. Phillips.

Mr. PHILLIPS. Thank you, Mr. Speaker.

"The Few, The Proud, The Marines": that is what the recruiting slogan says, and that very nicely describes those who serve and have served our country so valiantly as members of the United States Marine Corps. They are few in number compared to other services, they are very proud, and above all, they will always be Marines.

There are a number of our House members who have served in the corps, and as such, we are happy to be sponsors of this resolution calling attention to honoring the Marines on the occasion of their 225th anniversary. I would also like to thank the other members of the House who have sponsored the resolution.

It was on November 10 in 1775 that the Continental Congress, meeting in Philadelphia, passed a resolution stating that "two battalions of Marines be raised" for service as landing forces with the fleet. That was the beginning of a long and proud tradition.

Following the Revolutionary War, Marines went into action in war with France. They landed in Santo Domingo, and they also took part in the operations against the Barbary pirates along the "shores of Tripoli."

During the Mexican War in the mid-1800s, Marines seized enemy seaports on both the Gulf and Pacific coasts. A battalion of Marines joined General Scott's army at Puebla and fought all the way to the "Halls of Montezuma," Mexico City.

Marines have distinguished themselves in battles and skirmishes here at home and throughout the world. During the Civil War, a battalion fought at Bull Run, and other units saw action blockading at Cape Hatteras, New Orleans, Charleston, and Fort Fisher.

The SPEAKER. The gentleman will yield.

Conferences on the floor, please break up. Ladies.

Mr. PHILLIPS. In the Spanish-American War in 1898, Marines performed with valor in Cuba, Puerto Rico, Guam, and the Philippines.

During World War I, our Marines distinguished themselves on the battlefields of France. The Fourth Marine Brigade earned the title of "Devil Dogs" for their heroic actions.

In World War II the exploits of the corps became etched in our minds as we heard of such faraway places as Guadalcanal, Bougainville, Tarawa, Saipan, Okinawa, and Iwo Jima. Units of the Marines took an active part in postwar occupations of Japan. In September of 1950 the Marines were called upon to land at Inchon in Korea and again proved the doctrine of amphibious assault was still viable and necessary. Following the recapture of Seoul, Marines advanced to the Chosen Reservoir only to find the Chinese Communists had entered the war. After years of offensives, counteroffensives, and endless episodes of trench warfare followed by occupation duty, the last Marine ground troops were withdrawn from Korea in March of 1955. More than 25,000 Marines were killed or wounded during the Korean War.

In later years the landing of the 9th Marine Expeditionary Brigade at Da Nang was the beginning of a large-scale Marine involvement in Vietnam.

Marines were there in Grenada and Panama, and in August of 1990 the Iraqi invasion in Kuwait would lead to the largest deployment of Marine Corps forces since World War II. In more recent years the Marine Corps units have been sent to several African nations, including Liberia, the Central African Republic, Zaire, and others, to provide security and aid in the evacuation of American citizens.

Humanitarian disaster relief operations have been conducted by Marines in Kenya and in the Central American nations of Honduras, Nicaragua, El Salvador, and Guatemala.

In this new millennium the Marine Corps is continuing its tradition of innovation to meet the challenges of our new century.

Today's Marine Corps stands ready to continue the proud tradition established by those who so valiantly fought and died in the many battles over the past 225 years. Combining that long and proud heritage of faithful service to the nation with the resolve to face tomorrow's challenges will continue to keep the United States Marine Corps the best of best. Truly they are "The Few, The Proud, The Marines."

Thank you very much, Mr. Speaker.

I just wanted to thank Merle for sponsoring the resolution. Although I never served in harm's way as Representative Tigue, Representative Belfanti, and others in this room, I think as you do, sir, as a former Marine, that this is a special resolution. And I did not want the moment to evaporate without sharing 30 seconds more on what it means to us in this chamber, because I think whether it is Representative Krebs or the Speaker, myself, Mr. Readshaw, Mr. Belfanti, Mr. Tigue, and so forth – and Merle, of course, for sponsoring it – it adds a little special aspect to our service in this body that is indicative of the magic of being in that fraternity.

So on the 225th birthday of the United States Marine Corps, I also wanted to take the microphone for 1 minute and laud the corps and ask that the adoption be unanimous, because this is a fundamental and inherent part of the fabric of our national heritage. Thank you, Mr. Speaker.

Members, please come to order. Please take your seats.

Mr. Tangretti.

Mr. TANGRETTI. Thank you, Mr. Speaker.

Mr. Speaker, I rise today to offer HR 600, along with Representative Casorio, honoring a resident of Westmoreland County and a volunteer firefighter who earlier this summer heroically gave his life to save the lives of his family.

Jack Gazalie died on August 3 when fire broke out at his home in Jeannette, Representative Casorio's district. Before succumbing to the smoke, however, Mr. Gazalie bravely rescued his own mother and daughter from the flames.

For 20 years Mr. Gazalie was a member of the Adamsburg Volunteer Fire Department, which is in my legislative district. His actions on August 3 were clearly instinctual as a family member and a longtime firefighter, but that makes those actions no less heroic.

The outpouring of sympathy and sorrow that was evident at his funeral showed that Jack Gazalie was not just a heroic firefighter but a heroic family man and community member. Hundreds came to pay their respects to a man they described as someone who truly loved being a firefighter, but more importantly, truly loved people. One of his fellow employees at the Westmoreland County 911 Dispatch Center described Jack Gazalie as a man with a million friends and a heart of gold, a man who would have done anything for anybody.

Truly Jack Gazalie's death in August was a tragedy, but it is clear that his life was a celebration – a celebration of love, of family, dedication to community, and sacrifice for others. His life and his death also remind us of the tremendous responsibility that our volunteer firefighters assume when they accept the role of protectors of the property and lives of their loved ones and neighbors. Jack Gazalie accepted that role and for 20 years fulfilled it in a way that made his family, friends, neighbors, and fellow firefighters extremely proud. I am sure that his final act, though tragic and mourned by all who knew him, also made them even more proud.

I know that I am proud today to ask for your support in honoring Jack Gazalie for a lifetime of dedication and sacrifice to his family as a son and a father, the 20 years of dedication and sacrifice to his community as a volunteer firefighter, and the final sacrifice that he made doing his duty to save the family he loved.

Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman from Westmoreland County, Mr. Casorio.

Mr. CASORIO. Thank you, Mr. Speaker.

I rise in support with Representative Tangretti of HR 600.

HR 600, Mr. Speaker, honors the passing and the life of Jack Gazalie. Jack was not only a firefighter in the city of Jeannette area in Representative Tangretti's district in Adamsburg but a resident of Jeannette City and a member for years, Mr. Speaker, of the Jeannette Auxiliary Police. Mr. Gazalie, through his actions, has shown all of us what it is to be a volunteer firefighter, a volunteer auxiliary police officer.

Mr. Speaker, Mr. Gazalie did what all of us hopefully would do, and that is risk our lives for our family members – for our daughters, for our mothers. Mr. Gazalie's actions that very early morning in the city of Jeannette on Clay Avenue are something that should be recognized throughout this Commonwealth, not only in Representative Tangretti's legislative district but in my legislative district.

Mr. Speaker, I urge the members of this House to adopt unanimously HR 600, which honors the life and death of a fine man, a member of the Jeannette Auxiliary Police and of the Adamsburg Volunteer Fire Department – Jack Gazalie.

(c) Admissibility of court determination.-If the court determines that the plaintiff has established that there is a substantial likelihood that the plaintiff will prevail on the claim, neither that determination nor the fact of that determination shall be admissible in evidence at any later stage of the case, and no burden of proof or degree of proof otherwise applicable shall be affected by that determination.

(d) Intervention.-The government agency involved in the furtherance of a person's right of petition or free speech under the Constitution of the United States or the Constitution of Pennsylvania in 2000

(f) Abuse of legal process.—In addition to other costs or remedies allowed by general rule or statute, in any administrative or judicial proceeding related to the enforcement or implementation of environmental law or regulation, the agency or court may award costs, including reasonable attorney fees, if the agency or court determines that an action, appeal, claim, motion or pleading is frivolous or taken solely for delay or that the conduct of a party or counsel is dilatory or vexatious.

(g) Definitions.—As used in this section, the following words and phrases shall have the meanings given to them in this subsection:

"Act in furtherance of a person's right of petition or free speech under the United States Constitution or the Constitution of Pennsylvania in connection with a public issue." The SPEAKER pro tempore. On that question, the Chair recognizes the gentleman from Clearfield County, Mr. George.

Mr. GEORGE. Mr. Speaker, I hope this is an agreed-to amendment.

Mr. Speaker, some might ask why I continue to bring up this anti-SLAPP (Strategic Lawsuits Against Public Participation) legislation. In the Pittsburgh area right now, there have been a multitude of lawsuits against individuals who attempt to stand up and protect their persons and property. Mr. Speaker, the Pittsburgh Post-Gazette described a \$7-million lawsuit that was filed against 17 different groups and people because they contacted their local government against a planned development. So the problem exists, and it exists in Pennsylvania, the home of our Bill of Rights.

Mr. Speaker, my amendment provides for qualified immunity for citizens who participate in matters of public concern. This version of the anti-SLAPP, Mr. Speaker, was passed unanimously in the House last April in the form of HB 393. In the meantime, the Senate has amended the bill beyond recognition, and maybe it is not their constituents that are being faced with lawsuits, Mr. Speaker, but it is your constituents and mine. With your help, I would like to send this bill over to the Senate as a clear message that the House will not stand for it drastically changing our unanimously passed bills.

I would like to take a minute to explain the amendment. Under my amendment a citizen would be immune unless a communication is not material or relevant to the enforcement or implementation of the environmental law or regulation, and was knowingly false when it was made, was rendered with reckless disregard to the truth or falsity of the statement when made, or represented a wrongful use of process or abuse of process. My amendment also allows for a SLAPP suit to be dismissed on a preliminary objection and provides for an associated stay on discovery.

Because the success of protecting citizens from SLAPP suits depends largely on the manner in which the legislation is implemented, I have also included a preamble that does the following: defines Strategic Lawsuits Against Public Participation; two, explains the need for anti-SLAPP; and three, outlines the procedure whereby the General Assembly, Mr. Speaker, intends civil immunity to be raised and resolved in court, including that no issues be reserved for further discovery – for example, by preliminary objection in conjunction with the stay of discovery.

### <u>(a) Immunity –</u>

(1) A person who acts in furtherance of the person's right of petition or free speech under the Constitution of the United States or the Constitution of Pennsylvania in connection with an issue related to enforcement or implementation of environmental law or regulation shall be immune from civil liability in any action except where the communication to the government agency is not genuinely aimed at procuring a favorable governmental action, result or outcome.

(2) A communication is not genuinely aimed at procuring a favorable governmental action, result or outcome if it:

(i) is not material or relevant to the enforcement or implementation of environmental law or regulation;

(ii) was knowingly false when made;

(iii) was rendered with reckless disregard as to the truth or falsity of the statement when made; or

(iv) represented a wrongful use of process or abuse of process.

(b) Stay of discovery.-The court shall stay all discovery proceedings in the action upon the filing of preliminary objections for legal insufficiency of a pleading or other appropriate motion on the basis of immunity, provided, however, that the court, on motion and after a hearing and for good cause shown, may order that specified discovery be conducted. The stay of discovery shall remain in effect until notice of the entry of the order ruling on the preliminary objections or on another appropriate motion.

(c) Admissibility of court determination.—If the court determines that the plaintiff has established that there is a substantial likelihood that the plaintiff will prevail on the claim, neither that determination nor the fact of that determination shall be admissible in evidence at any later stage of the case, and no burden of proof or degree of proof otherwise applicable shall be affected by that determination.

(d) Intervention.—The government agency involved in the furtherance of a person's right of petition or free speech under the Constitution of the United States or the Constitution of Pennsylvania in connection with a public issue may intervene or otherwise participate as an amicus curiae in the action involving public petition and participation.

(e) Legal protections of defendants.-Nothing in this section shall be construed to limit any constitutional, statutory or common-law protections of defendants to actions involving public petition and participation.

(f) Abuse of legal process. In addition to other costs or remedies allowed by general rule or statute, in any administrative or judicial proceeding related to the enforcement or implementation of environmental law or regulation, the agency or court may award costs, including reasonable attorney fees, if the agency or court determines that an action, appeal, claim, motion or pleading is frivolous or taken solely for delay or that the conduct of a party or counsel is dilatory or vexatious.

(g) Definitions.—As used in this section, the following words and phrases shall have the meanings given to them in this subsection:

"Act in furtherance of a person's right of petition or free speech under the United States Constitution or the Constitution of Pennsylvania in connection with a public issue." Any written or oral statement or writing made before a legislative, executive or judicial proceeding, or any other official proceeding authorized by law; any written or oral statement or writing made in connection with an issue under consideration or review by a legislative, executive or judicial body, or any other official proceeding authorized by law; any written or oral statement or writing made in a place open to the public or a public forum in connection with an issue of public interest; or any written or oral statement or writing made to a government agency in connection with the implementation and enforcement of environmental law and regulations. "Enforcement of environmental law and regulations." Any activity related to the identification and elimination of violations of environmental laws and regulations, including investigations of alleged violations, inspections of activities subject to regulation under environmental law and regulations and responses taken to produce correction of the violations.

"Government agency." The Federal Government, the Commonwealth and all of its departments, commissions, boards, agencies and authorities, and all political subdivisions and their authorities.

<u>"Implementation of environmental law and regulations." Any</u> activity related to the development and administration of environmental programs developed under environmental law and regulations.

(b) Membership.-The committee shall consist of 15 members:

Section 322. Powers and duties of committee.

Section 3121 (relating to rape).

[(2)] (3) To perform those functions related to the direct approval and disbursement of financial assistance in an advisory capacity only. The committee shall have the opportunity to review and comment on applications other than applications for claims for compensation pursuant to sections 702 and 706 within 30 days after receipt of the application from the commission.

[(3)] (4) To advise the commission on the definition, development and correlation of programs and projects and the establishment of priorities for direct victims' services and compensation.

[(4)] (5) To develop standards, methods and procedures for evaluating and monitoring direct victims' services.

[(5)] (6) Upon request, to provide assistance and advice to the commission on any other matters relating to direct victims' services and compensation.

[(6)] (7) To receive staff support from the commission and the bureau in order to adequately perform the duties provided for in this section.

(b) The results of the study, including the recommendations of the Legislative Budget and Finance Committee, shall be completed and made available to the General Assembly six months after the effective date of this section.

Amend Sec. 4, page 13, line 1, by striking out "4" and inserting -5

On the question, Will the House agree to the amendment?

The SPEAKER pro tempore. On that question, the Chair recognizes the gentleman from Delaware County, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

What this amendment would do would be to direct the Legislative Budget and Finance Committee to conduct a 6-month study of the Turnpike Commission focusing in on a number of points. The first point would be whether the public would be better served by consolidating the Turnpike Commission into the Department of Transportation. The second point would examine competitive bidding with regard to bond contracts. The third point would deal with whether patronage should be eliminated as the method for awarding turnpike jobs as opposed to civil service appointments, and the fourth would relate to its contracting procedures.

Mr. Speaker, it seems to me that this study would give us some guidance in seeing whether the public would be better served here. The turnpike has a long history of problems. In fact, Governor Shapp back in 1972 recommended abolishing the Turnpike Commission. Governor Thornburgh, he was quoted in an Inquirer article several years ago saying that his fondest hope was to get rid of the Turnpike Commission as it serves no purpose. That was Governor Thornburgh's remarks back in 1997. I think that same Inquirer article quoted a ranking member of our own Transportation Committee as calling the Turnpike Commission a playground for the Senate.

Various studies have shown that the turnpike, the hiring of the turnpike, it is over staffed; the tolls are over priced. And I think that this is an issue that perhaps the House is not ready to deal with this session, but I think as we look to reform this system, this study, which would be completed in 6 months, sometime next spring, would put us on good footing to revisit this issue.

So I would ask that the members of this House at least consider a study commission and would ask for an affirmative vote. Thank you.

The SPEAKER pro tempore. On the amendment, the Chair recognizes the gentleman from Blair County, Mr. Geist.

Mr. GEIST. Thank you very much, Mr. Speaker.

We have had tremendous pressure from the people down east for E-ZPass. Representative McGill, Representative Bard, and many members of our committee, we have been down. We have toured that site; we have toured the sites. We know that these things are extremely necessary.

Also, Mr. Speaker, a study of this nature would take us into the next term of the General Assembly. This is a very timely piece of legislation. It is a piece of legislation that needs passed now, and I would oppose the amendment.

What we have are newspaper accounts and opinions of the advocates of various sides, but we are not the decision-making body and we ought not to be making judgments, in my opinion, that assume that we are the decision-making body, and therefore, the wording of paragraph (6) on page 2, in my judgment, really ought to be changed.

However, you know, on the whole I agree with the resolution and would urge support, and I would hope, though, the people who come up with these resolutions would give time for input of members before we have such resolutions in the future.

### **REMARKS SUBMITTED FOR THE RECORD**

Mr. O'BRIEN submitted the following remarks for the Legislative Journal:

I am here to announce the release of the Joint State Government Commission's report on biomedical research in Pennsylvania.

Two years ago, I sponsored a House resolution that directed the Joint State Government Commission to set up a working group to assess the level of biomedical research being conducted by the Commonwealth's universities and teaching hospitals, and to make specific recommendations as to how we can ensure the growth of biomedical research in Pennsylvania.

The working group was composed of individuals with expertise in biomedical research, health care, economic development, and higher education. They took a critical look at the state of biomedical research in this State, and they recommended some strategic policy actions that would help Pennsylvania maintain its status as a leader in biomedical research.

This report, which I will present to the Speaker of the House, is the end result of that working group's efforts.

I want to thank all of the professionals who devoted their time and talent to this study. I would especially like to thank the Joint State Government Commission for facilitating this project, and David Hostetter, executive director of the Joint State Government Committee, for leading the working group and heading up the drafting of this report.

Recent advances in biomedical research have changed our understanding of the life sciences and have opened the door to new ways to prevent, treat, and cure disease. New drugs and therapies have been extremely successful in treating AIDS (acquired immune deficiency syndrome), cancer, strokes, and heart attacks, as well as other diseases.

But the best may be yet to come. The future will likely produce even more profound advancements, leading to untold benefits in the human condition.

We are living in an era that is being called "The Age of Biology." In the years to come, biotechnology as a growth industry will be rivaled only by that of information technology.

That is why Pennsylvania must not just maintain its competitive edge in this field, it must strengthen it. The Commonwealth is poised to be a leader in biomedical science and research in the coming years, but we must take action now to ensure that eventuality.

The goal for Pennsylvania should be to solidify its position in the upper echelon of academic biomedical research and to prepare the Commonwealth to compete aggressively in this quickly evolving area that has the potential to improve the lives of so many of our citizens.

This report will not simply be allowed to gather dust. Rather, I will ask the working group's members to reconvene as a group to formulate the next steps to be taken to implement the recommendations of the report.

We will look at ways to support the research infrastructure at our research institutions in a way that promotes the goals of the report, and we will welcome other "champions" to join with us.

Many of these will come from the private and philanthropic sectors: Pharmaceutical companies, foundations, et cetera, will be approached to foster strong alliances to push this agenda forward.
