Mr. Speaker, I would like to submit some remarks for the record

Mr. McCALL submitted the following remarks for the Legislative Journal:

With only a miner's lamp to guide them, generations of coal miners tunneled into the earth to retrieve the fuel we needed to operate our industries and to heat our homes.

Pennsylvania's coal miners became the catalyst for the American Industrial Revolution, even as they performed one of the most difficult and dangerous jobs available. It is only fitting that the nation recognizes our coal miners, both past and present.

In 1996 and in 2000 and 2001, I contacted the Citizens' Stamp Advisory Committee to recommend a coal miners' postal stamp as part of its "America at Work" series. The series will highlight various occupations in the labor workforce that contributed to the development of the United States.

My legislative district in Carbon County is the heart of the anthracite coal region and holds great historic significance in the discovery of anthracite coal in 1754.

Mining anthracite profoundly affected the location, output, technology, and organization of American industry and rail transportation. It was individual coal miners who played an undeniably important role in the new economy, while at the same time working in harsh and unsafe conditions.

Earlier this year, I introduced HR 121 that would memorialize the United States Postal Service to issue a Coal Miners' Postal Stamp. Today I ask your support.

Children at Edward Mackin Elementary School in the Wilkes-Barre Area School District have been busy in their classrooms with this stamp project. In addition to writing letters to various people, organizations, and Congressman Kanjorski, even Governor Ridge, they have posted an online petition that has already received 7,300 signatures.

These children represent so much — they are the children and grandchildren of present and former coal miners and they are the catalyst for future economic development. I hope to be able to call them later and tell them that the House of Representatives supports their goals as much as they do.

Our coal miners have toiled to help build this country. It is only fitting that they have a commemorative stamp recognizing their great achievements.
