BILL ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 928**, **PN 2778**, entitled:

An Act amending the act of May 21, 1943 (P.L.571, No.254), known as The Fourth to Eighth Class County Assessment Law, further providing for subjects of taxation enumerated.

On the question,

Will the House agree to the bill on third consideration?

Mr. ROBERTS offered the following amendment No. A3903:

Amend Title, page 1, line 23, by removing the period after "enumerated" and inserting

; requiring counties to establish assessment guidelines and grading processes; and providing for penalties.

Amend Bill, page 3, by inserting between lines 13 and 14 Section 2. The act is amended by adding an article to read:

ARTICLE III-A ASSESSMENT UNIFORMITY

Section 301-A. Uniform assessment required.

Assessments of real estate shall be performed uniformly throughout a county.

Section 302-A. Assessment guidelines and grading process.

(a) Establishment.-

(1) Each county shall establish uniform reassessment guidelines, procedures, grading processes, rates, systems and methodologies for use throughout the county. The county may have the reassessment guidelines, procedures, grading processes, rates, systems and methodologies prepared by its reassessment contractor for approval by the county.

(2) Each time a county undertakes a countywide reassessment, the prior assessment guidelines, procedures, grading processes, rates, systems and methodologies shall be updated, revised or replaced by new assessment guidelines, procedures, grading processes, rates, systems and methodologies.

Section 303-A. Format.

New reassessment guidelines, procedures, grading processes, rates, systems and methodologies shall be in a complete self-contained written narrative format. The narrative shall completely describe the valuation procedures, grading processes, rates, systems and methodologies used by the county or reassessment company.

Section 304-A. Availability to the public.

The reassessment guidelines, procedures, grading processes, rates, systems and methodologies shall be kept on file in the county assessment office and at the headquarters of the reassessment contractor, if any, until the next county assessment is certified by the county commissioners. The reassessment guidelines, procedures, grading processes, rates, systems and methodologies shall be made available at cost.

Section 305-A. Prerequisite study and public notice.

Sixty days prior to the certification of the reassessment of the county by the county commissioners, the county assessment office or the reassessment company shall publish the results of a study to determine the accuracy of the reassessment. This study shall include, but is not limited to, a common level ratio study and co-efficient of dispersion study using the sales data from the year prior to the reassessment. Any study conducted under this section shall be completed using the State Tax Equalization Board procedures and rules. Further studies shall be completed as to types of real estate including residential, commercial and industrial, agricultural and vacant land, with each category further stratified by value. In each category, a co-efficient of dispersion equal to 15% shall be required as the minimum level of overall accuracy for adoption of the reassessment. Studies shall be made available to the public without charge, upon completion. Copies may be made available at cost. Section 306-A. Required information.

<u>Each reassessment record shall include the following information:</u>

- (1) The name of the county.
- (2) The name, address and telephone number of the reassessment contractor, if any.
 - (3) The name of the county assessment supervisor.
- (4) The name of the certified Pennsylvania evaluator, license number and signature of the person who performed the reassessment and whether the person was employed by the county or the reassessment contractor.
- history, sales history and a complete description of the valuation approaches, methods and calculations used to determine the assessment referencing the procedures shown in section 302-A(a).

Section 307-A. Review and certification.

Each reassessment valuation shall be reviewed and certified at a minimum by a licensed certified Pennsylvania evaluator. In the event

that the individual reviewing and placing the final value on a property is a general appraiser or a residential appraiser, that individual shall be equally bound by the standards set forth under this article as well as the Uniform Standards of Professional Appraisal Practice. Each county chief assessor, reassessment or mass appraisal company shall be equally responsible and liable for the acts and actions of its employees to fully comply with this act and the Uniform Standards of Professional Appraisal Practice.

Section 308-A. Real estate appraiser license.

A reassessment or mass appraisal company operating in this Commonwealth shall be required to obtain a license from the State Board of Certified Real Estate Appraisers before conducting business in this Commonwealth.

Section 309-A. Penalties.

The State Board of Certified Real Estate Appraisers shall prepare a schedule of penalties, including license revocation, for failing to comply with this act and shall, within three months of the effective date of this act, publish the schedule in the Pennsylvania Bulletin. Prosecutions for violations under this act shall be subject to the rules and regulations established by the board.

We have to give tax credits for conservation. We have to pass green energy bills, but the State has to join with other States who have taken this issue head-on. We have to first say the words "global warming." We need our new Governor to recognize that he needs to take leadership on this issue. Our neighboring States of New York and New Jersey have done this. New England States have joined together. They have formed a coalition to deal with this issue. Fully 19 other States have had some greenhouse gas action plan, and we as a State need to do this ourselves.

I am withdrawing this amendment today in the spirit of cooperation because I have been requested to do so, but I think it is an issue that we have to give more attention to and it is an issue that I hope we can, as the weeks progress, start to deal with in a serious manner.

BILL ON CONCURRENCE IN SENATE AMENDMENTS

The House proceeded to consideration of concurrence in Senate amendments to **HB 1603**, **PN 2743**, entitled:

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, providing for unlawful carrying of paintball guns and markers in vehicle on a highway.

On the question,

Will the House concur in Senate amendments?

PARLIAMENTARY INQUIRY

The SPEAKER. Mr. Belfanti, did you desire recognition on this question of concurrence? We have a note that you wanted to be recognized.

Mr. BELFANTI. Yes. Thank you, Mr. Speaker.

As some of the members in the chamber are aware, I have a minority interest in a company that operates a commercial paintball field, and I have had the opportunity to shoot some of my colleagues up there on occasion, and it has been a lot of fun doing that. The bill before us exempts commercial paintball fields. In that regard, I wanted to pose a parliamentary inquiry to ensure that I could not only vote on this legislation without there being a conflict of interest but perhaps also engage in a short debate for the record with the maker of the bill, Mr. Staback.

The SPEAKER. There is no conflict in your case. This bill applies to all enterprises similar to the one that you have described, and it is not peculiar to you or your own enterprise. So yes, you may feel free to vote on it. I am not so sure that I am prepared to say that you are free to continue shooting our members.

Mr. BELFANTI. It is all in fun, Mr. Speaker.

The SPEAKER. That does not matter – paint is paint. If you want to paint, come on down to my house and I will give you something to paint.

Mr. BELFANTI. Well, it is colored vegetable oil.

The SPEAKER. The gentleman is recognized on the question.

Mr. BELFANTI. Thank you, Mr. Speaker.

The Senate amended the legislation to-

The SPEAKER. The gentleman will yield.

Mr. Staback, are you prepared to stand for interrogation?

Mr. STABACK. Yes, Mr. Speaker.

Mr. BELFANTI. Thank you, Mr. Speaker.

The bill as it returned on concurrence was amended by the Senate with simply the word "highway." The legislation before us has been requested by various segments of the law enforcement community for years to stop the vandalism, because these paintball guns are available in Wal-Marts and Kmarts for \$50, and it is very easy for youngsters to buy them and shoot their buddies off their bicycles and shoot at people's picture windows. So the law enforcement community has been clamoring for some tool to be able to ensure that these paintball markers, as we call them, can be transported without being able to be discharged out of a moving vehicle.

The language "highway" in the legislation caused us a bit of concern, because we thought that perhaps that would limit the scope of this bill to just the State Police and what we all consider to be highways, and the township roads, borough roads, and other public thoroughways might not be covered, and so the local law enforcement officials would not have that tool. I am asking the gentleman, Mr. Staback, if the word "highway" applies to local roads within boroughs and townships and counties, et cetera.

Mr. STABACK. Thank you, Mr. Speaker.

Mr. Speaker, when the Senate in fact did amend 1603 with the term "highway," they neglected to offer a definition as well. As a result, and under the rules of statutory construction, the definition of a "highway" found under general provisions of Title 1 would then apply, and that definition reads as follows: "A way or place of whatever nature open to the use of the public as a matter of right for purposes of vehicular traffic." Mr. Speaker, in my view, all public roads open to vehicle traffic would be affected, including borough roads, township roads, city roads, U.S. highways, State highways.

Mr. BELFANTI. Thank you, Mr. Speaker.

Mr. Speaker, if I could rise in support of the legislation.

This bill is not only—

The SPEAKER. The gentleman is recognized on final passage.

Mr. BELFANTI. Thank you, Mr. Speaker.

This bill is not only the product of a lot of work involving all levels of the law enforcement community, but it is strongly supported by the paintball industry, which is one of the fastest growing team sports in the world. And the major magazines that exist that cater to paintballers all support this legislation, and I am asking that my colleagues support Representative Staback's bill, HB 1603, on concurrence.

The SPEAKER. The Chair thanks the gentleman.

On the question of concurrence, Mr. Staback.

Mr. STABACK. On final passage, Mr. Speaker.

The SPEAKER. It is concurrence in Senate amendments.

Mr. STABACK. Okay. Mr. Speaker, HB 1603 is intended to stop the irresponsible acts of individuals who would use paintball guns not only to damage and vandalize personal property but also to assault people by pelting them with paintballs while they innocently walk down a sidewalk, walk down a street, or simply stand on a street corner. There should be no room in our society for this kind of behavior.

The bill, Mr. Speaker, has the support of the NRA (National Rifle Association), the Pennsylvania State Police, the Fraternal Order of Police, as well as the entire paintball industry.

I believe that the bill is a commonsense proposal that will help curtail what I perceive to be an ongoing problem in the Commonwealth, and with that said, Mr. Speaker, I would respectfully ask for a "yes" vote on concurrence.

On the question,

Will the House adopt the resolution?

The SPEAKER. May I have the attention of the House, please?

We from time to time pass resolutions of a congratulatory nature. This one that is before us now, I think, is more than just a simple, everyday, run-of-the-mill resolution. It is one that I know Mr. Herman desires recognition, rightfully, and all of Pennsylvania is very proud to recognize this particular individual.

Mr. Herman.

Mr. HERMAN. Thank you very much, Mr. Speaker.

This beautiful and prestigious October 30 being my 45th birthday, I am compelled—

The SPEAKER. That is not what I had in mind.

Mr. HERMAN. —I am compelled to rise and address the members of the House of Representatives to laud one of Pennsylvania's favorite sons.

It has been my honor for the past 19 years to have as one of my constituents Joseph V. Paterno, who has done something that no other person in intercollegiate football has done. As many of you know, this past weekend Coach Paterno and his feared Nittany Lions bested the alma mater of Representative Marsico's and Representative Robinson's Ohio State Buckeyes to garnish his 324th career win at Beaver Stadium.

I think what is most remarkable is not that Joe Paterno stands alone in being the winningest football coach in Division I-A football in NCAA (National Collegiate Athletic Association) history but the manner in which he has done that. In this day and age, Mr. Speaker, when so many coaches and players in college sports are lured away by big money, since 1966 Coach Joe Paterno has accumulated all of his 324 victories at the Pennsylvania State University.

He cannot be here today because obviously he is coaching this week, but perhaps after the football season we can bring him down here to the State Capitol and honor him in an appropriate manner. But I think if he were here, Mr. Speaker, he would certainly give great credit to his assistant coaches and the players and the people who have been so supportive of him, and also give, I think, some appreciation to the members of the General Assembly who have supported the Pennsylvania State University for many years.

Those of you who know Coach Paterno and have been following his career know that he is a very unassuming, unpretentious man. He is one also that, as you know, puts academics first ahead of college wins or winning on game day. His program has never, ever been in violation or in trouble with the NCAA. He has a program that we can all stand very proud of in the way he has done his program and also the way he has won.

He and his wife, Sue, are very much academically minded. They care foremost about the players they have and make sure that they get their degree. They alone have donated millions of their own salaries to Penn State to enhance the learning opportunity at the Pattee Library.

And, Mr. Speaker, what is not in this resolution we are about to pass is, I want to read into the record that according to his career, he has produced 20 first-team Academic All-Americans, 14 National Football Foundation and Hall of Fame Scholar-Athletes, and 16 NCAA post-graduate scholarship winners. He is a winner on the gridiron, but more importantly, he is someone who recognizes that student athletes are there to learn and they are winners when they get their degree and go out in society and become productive citizens for Pennsylvania and for the nation.

It is for this reason, Mr. Speaker, that I ask the members of the House of Representatives to unanimously pass HR 345 congratulating Penn State head coach Joe Paterno on reaching his 324th Division I-A victory in football. He now stands alone as being the winningest football coach in college football history.

Thank you, Mr. Speaker.

The SPEAKER. The gentleman, Mr. Daley.

Mr. DALEY. Thank you, Mr. Speaker.

I was hesitant to rise on this resolution, but I need to share some things with the members of the General Assembly about Joe Paterno. My father and Joe Paterno coached several years together when I was about 10 years old, and they had a camp at Kiski. My father played for the University of Pittsburgh, of course everyone knows Joe played for Brown, and my father was an assistant with Joe as a scout several years ago. And I knew Joe Paterno as a little boy growing up as a young teenager, and he would stay at our house on several occasions when he was scouting, and the Joe Paterno that you see today some 40 years later or 35 years later is absolutely the same Joe Paterno that I knew as a 12-year-old child. Let me just share one real quick story with you.

About a month ago we had a staffer that works for the Department of Agriculture, that her father was fatally ill and would like the opportunity to meet Joe Paterno; he is a lifelong supporter of Penn State and went to all the games. I called Joe Paterno up, even in the midst of a very, very busy season, and asked him if he would do a favor for me, if he could take time in his day, if I could arrange to bring that gentleman, that

was not a constituent of mine but I knew the staffer very well, as many of you know, to have her father meet Joe Paterno as sort of a make-a-wish opportunity. About a week ago Joe called me and he said, bring him up. Joe took time from his busy schedule. Even though all these things are going on regarding his season and with him riding the record, Joe took time out of his day to spend a half hour talking to this man as a request. This is indeed the Joe Paterno that I knew as a 12-year-old boy; this is indeed the Joe Paterno that is one of the greatest men that I have ever had the opportunity to know in my life, and what a great honor for him and Pennsylvania.

Thank you very much, Mr. Speaker.
