Does the gentleman, Mr. Wansacz, desire recognition? The Chair recognizes the gentleman, Mr. Wansacz.

Mr. WANSACZ. Mr. Speaker, HB 936 would exclude the first \$700,000 of the value of a farm or closely held family business from the inheritance tax when the business or property is transferred to another family member.

Mr. Speaker, this legislation is badly needed, and I ask my colleagues to vote in favor of this legislation.

Thank you, Mr. Speaker.

The SPEAKER pro tempore. On that question, the Chair recognizes the gentleman from Northampton County, Mr. Grucela. Will the gentleman suspend for a moment?

Members, please take your seats.

The gentleman, Mr. Grucela.

Mr. GRUCELA. Thank you, Mr. Speaker.

Mr. Speaker, this bill is something we have talked about several times about the inheritance tax, and this is very, very important, especially to the farmers and especially to the small family farmers.

Many times we talk about the best way to preserve farmland is to preserve the farmer. This bill goes a long way in accomplishing that goal. So I would ask the members to support HB 936.

Mr. GABIG. Mr. Speaker, I wonder if the bill includes unincorporated small businesses in this bill.

Mr. WANSACZ. I am sorry. I had a hard time hearing you.

The SPEAKER pro tempore. Members, please take your seats. Will the House please come to order. The gentlemen are having difficulty hearing each other. The conference in the area of the Democrat floor leader will please break up.

Mr. GABIG. Mr. Speaker, I wonder if the definition of "closely held business" includes an unincorporated small business in this bill.

Mr. WANSACZ. No, it does not.

Mr. GABIG. Mr. Speaker, I wonder if the bill implicates the uniformity clause of the Constitution if it does not include unincorporated small businesses.

Mr. WANSACZ. Mr. Speaker, I did have an amendment to correct it, but when the changes came yesterday on the amendment to the printer's number, it would make that amendment out of order to bring in sole proprietorships, partnerships, S corporations.

Mr. GABIG. Mr. Speaker, I wonder if there is a plan to make that correction sometime during the course of this day or—

Mr. WANSACZ. I plan on sending over a letter to the Senate with an amendment to ask them to please put this in.

Mr. GABIG. Okay. Thank you, Mr. Speaker.

That is all the questions I have.

The SPEAKER pro tempore. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Lawrence County, Mr. Sainato.

Mr. SAINATO. Thank you, Mr. Speaker.

I rise also to support this bill.

Will the House agree to the amendment?

The SPEAKER. On the question of the adoption of the Vitali amendment, the gentleman, Mr. Vitali, is recognized. Will the gentleman yield.

The gentleman, Mr. Vitali, has been recognized. He is entitled to the attention of the House. Conferences in the vicinity of the minority leader's desk, please break up. Conferences on the side aisle, please break up.

Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

What this bill simply does is require a study, simply a study with regard to the turnpike, Pennsylvania Turnpike. The purpose of this study, and it would be a study by the Legislative Budget and Finance Committee, which is known for both its impartiality and its expertise, and the point of the study would be to examine the Pennsylvania Turnpike to see if it would make sense to consolidate it into the Pennsylvania Department of Transportation. It does not require that to happen. It simply examines whether this might be something for us to consider in the future.

The purpose of this study is to answer some questions that have been raised. Questions have been raised with regard to the tolls motorists pay traveling through Pennsylvania with regard to other States.

The SPEAKER. Will the gentleman yield.

Please, members, please take your seats. Staff personnel not engaged in this bill, please be seated.

Mr. Vitali, I apologize.

Mr. VITALI. Thank you, Mr. Speaker.

Some of the questions that have been raised are, are our tolls where they should be? A study which goes back a couple of years suggests that our tolls are the second highest in the nation. I do not know why that is. I am not sure whether there are good reasons for that, but that is something a study could tell us. We do not want our citizens, our constituents, paying more than they should be.

Another issue is, are we efficiently using our personnel? Again, questions have been raised, admittedly the information is a little dated now, but that assertion was there are more workers per mile on our turnpike than there should be, than there are on other Department of Transportation highways.

Another issue has been raised with regard to the practice of patronage, and the suggestion has been made that perhaps some patronage jobs on the turnpike should be civil service jobs. That is just a question that we should be examining.

Another aspect of this deals with the competitive bidding of turnpike bonds. Maybe we can save our taxpayers and our motorists money by competitive bidding.

To be clear, I am not saying any of these assertions are true or not true. All I am saying is we study many things in this legislature to make intelligent decisions, and this vote, by authorizing this study, would just give us the basis, once that study is complete, to deal with this issue intelligently.

So I would ask for an affirmative vote. Thank you.

The SPEAKER. The gentleman, Mr. Sainato.

Mr. SAINATO. Thank you, Mr. Speaker.

Could I ask if the maker of the amendment would stand for interrogation?

The SPEAKER. The gentleman agrees to stand for interrogation. You may begin.

Mr. SAINATO. Mr. Speaker, under your proposal here, would this study determine what the rates— Would it study the turnpike rates at this point?

Mr. VITALI. It would be a comprehensive study which would deal with the feasibility of consolidating the turnpike with PENNDOT, patronage, contracting procedures, bond bidding, and those are the four things enumerated in the amendment. I would suspect that it could be expanded if it were appropriate. Mr. SAINATO. Okay, Mr. Speaker. I mean, I am looking at the amendment, and I think we have a real problem right now with the Turnpike Commission with unfair, unequal tolls throughout the system, when you have the extensions which are being charged two and a half times the turnpike rate and the main line being charged a different rate. I mean, I have been calling for turnpike equalization for 6 years now, and I am just wondering if this amendment somehow would look at these toll rates where there is discrimination.

Mr. VITALI. Well, clearly, clearly, when you are examining whether the employment practices, if there is too much employment, lowering that could lower cost in tolls. With regard to bond bidding, if you are paying inflated prices, clearly lowering that. I think perhaps it is getting at what you are suggesting in an indirect way, by looking at the practices that inflate the costs.

Mr. SAINATO. Okay. Thank you, Mr. Speaker, for your information.

I would just like to speak on the amendment.

The SPEAKER. The gentleman is in order.

Mr. SAINATO. Listening to the maker of the amendment, I am going to support his amendment.

My concern is the turnpike toll rates, which, in my opinion, are too high, especially on the extensions of the turnpike. They are two and a half times what the normal turnpike rate is, and if this amendment and this study that he is asking for would determine these toll rates, I am going to support this, because we need to do something. We need equality. Discrimination is wrong, discrimination is wrong on anything, and it is wrong on the turnpike.

So I am going to support this amendment, Mr. Speaker. Thank you.

The SPEAKER. On the question of the adoption of the Vitali amendment, Mr. Trello.

Mr. TRELLO. Mr. Speaker, I traveled the turnpike for the past 27 years, and whenever there is ice and snow on the ground, I know if I get to the turnpike I am going to make it to Harrisburg, because it is very well taken care of. Now, I do not know about the tolls; I have not received one complaint from any of my constituents that the tolls are too high. I travel 230 miles without one red light, and it is worth the \$6.95 that I pay when I come to the turnpike.

And furthermore, PENNDOT has 42,000 miles of highway to take care of. I think they have enough to do. I think we should let well enough alone, and I oppose this amendment, and I encourage everybody to vote "no," because the turnpike system is well and functioning well. Thank you.

The SPEAKER. The gentleman, Mr. Michlovic.

Mr. MICHLOVIC. Thank you, Mr. Speaker.

I, too, am going to oppose the Vitali amendment. There are some of us that are still looking for our sections of the turnpike projects to be built, and those of us in the Mon Valley have been for a long time urging the turnpike to complete its work on the environmental impact study and get moving with that very important highway. We will take an additional fee on our highway if we can get it built. At least some of my other colleagues that spoke prior to me have a highway already built. We are still looking to get that highway, and the revenues that are projected for the turnpike across the Commonwealth and in the various sections where they have added new highways are all part of the calculations for the projections on our highway. in any way interfere with various bond ratings and councils across the Commonwealth that might lead to a conclusion that, no, we do not have enough money to build the Mon-Fayette Expressway. So I am going to oppose the Vitali amendment, because all it would do is add more confusion to the revenue picture of the turnpike, and I ask my colleagues to oppose the Vitali amendment as well.

[(d) Off-highway recreational vehicles.-

(1) When the tax imposed by this chapter has been paid on fuel used in off-highway recreational vehicles within this Commonwealth, an amount equal to the revenue generated by the tax, but not derived therefrom, may be appropriated through the General Fund to the Department of Conservation and Natural Resources. It is the intent of this chapter that all proceeds from the tax paid on fuel used in off-highway recreational vehicles within this Commonwealth be paid without diminution of the Motor License Fund.

(2) The Department of Conservation and Natural Resources shall biennially calculate the amount of liquid fuel consumed by off-highway recreational vehicles and furnish information relating to its calculations and data as may be required by the Appropriations Committee of the Senate and the Appropriations Committee of the House of Representatives.

(3) The General Assembly shall review the fuel consumption calculations of the Department of Conservation and Natural Resources to determine the amount of liquid fuels tax paid on liquid fuels consumed in the propulsion of off-highway recreational vehicles in this Commonwealth and may annually appropriate to the Department of Conservation and Natural Resources the amount so determined.

(d.1) Motorized recreational vehicles.—An amount equal to 50% of the tax imposed by section 9004(a) (relating to imposition of tax, exemptions and deductions) on fuel consumed in the operation of motorized recreational vehicles within this Commonwealth, but not to exceed \$1,000,000, shall be refunded out of the Liquid Fuels Tax Fund to the Department of Conservation and Natural Resources in the following manner:

(1) There is hereby established a special nonlapsing restricted receipts account in the State Treasury to be known as the Recreational Trails Trust Fund.

(2) One-half of the tax revenues, not to exceed \$1,000,000, generated by the tax imposed by section 9004(a) on fuel used in motorized recreational vehicles used within this Commonwealth, as determined by the Department of Conservation and Natural Resources, shall be annually refunded to the department through the Recreational Trails Trust Fund.

(3) All moneys in the fund are hereby appropriated on a continuing nonlapsing basis to the Department of Conservation and Natural Resources for the activities referred to in paragraph (5).

(4) All interest earned by the fund and refunds or repayments shall be credited to the fund and are hereby appropriated in the same manner as paragraph (3).

(5) All money in the fund shall be used by the Department of Conservation and Natural Resources in accordance with the recommendations of the Snowmobile and ATV Advisory Committee for the acquisition, creation and maintenance of trails used by motorized recreational vehicles and for enforcement in State forests and State parks. 1

The SPEAKER. The Chair turns to House calendar supplemental D, HB 1219 on concurrence in Senate amendments as amended.

Mr. Freeman, I saw you rise and Mr. Vitali rise, and I thought something is wrong, and you are right. The bill is not in the system at the moment.

For what purpose does the gentleman, Mr. Freeman, rise?

Mr. FREEMAN. Thank you, Mr. Speaker.

Mr. Speaker, if I could also address the House on the subject of HB 1219 when it finally comes up on the computer.

The SPEAKER. That would be appropriate.

Mr. FREEMAN. Thank you, Mr. Speaker.

The SPEAKER. The House will stand at ease. We are waiting for HB 1219 to be reprinted. The House will stand at ease.

BILL ON CONCURRENCE IN SENATE AMENDMENTS AS AMENDED

The House proceeded to consideration of concurrence in Senate amendments to the following HB 1219, PN 3066, as further amended by the House Rules Committee:

An Act amending the act of July 31, 1968 (P.L.805, No.247). known as the Pennsylvania Municipalities Planning Code, further providing for planning commission, for zoning ordinance amendments, for procedure for landowner curative amendments, for certain findings, for hearings and for governing body's functions.

On the auestion.

Will the House concur in Senate amendments as amended by the Rules Committee?

The SPEAKER. I am advised that this bill is on the system.

Will the members check the system and see if HB 1219 is on your system. Everyone in front of the Speaker has it on their computers. It is necessary to key the bill in yourselves; it will not come up automatically. Now, I know that is a terrible burden.

Mr. Freeman.

Mr. FREEMAN. Thank you, Mr. Speaker.

I appreciate you making sure that we had it on our screens.

Mr. Speaker, I want to first commend a few members-

The SPEAKER. The gentleman will yield.

Please. This is the next to the last bill.

Mr. Freeman.

Mr. FREEMAN. Thank you, Mr. Speaker.

Mr. Speaker, I first want to commend a number of members on the other side of the aisle - Representatives Hennessey, Harper, and Watson in particular - who I know worked very diligently to try and craft better language in this bill. The handiwork they did on behalf of this legislation did improve it from what originally came over from the Senate and placed in a few more safeguards that make it better than what it was initially. That being said, however, I am still going to vote "no" on this proposal.

I believe we are faced here with a proposal where we are being asked to fix something that really is not broken. There are only a handful of communities which have experienced situations where developers' proposals have lingered for a long time without either approval or denial of those developmental proposals. It really is an issue that is confined primarily to the high-growth areas of our State, and the reason those development proposals have not met with approval or denial is because of the fact that they are being put forward in high-growth areas where planning departments, where local supervisors, are overwhelmed by the pace of development.

The idea of setting up, as this legislation does, an instance where we would have a deemed approval, even with the various safeguards which my colleagues very ably put into the bill, I think stands the planning process on its head and is a disservice not only towards good planning in this Commonwealth but a disservice also to the local elected officials whom we entrust with the task of reviewing development plans and ensuring that what is being proposed is appropriate under their zoning ordinance and their comprehensive plan and, most importantly, fits the needs and look of their community. I do not think we should be taking that power away from them, and even with the safeguards, again, that my colleagues fought to put into this bill, we are better off staying with the current status quo system, because with that system we do not really force the hands of local officials. We do not force the issue where an issue is deemed approved as it would exist under this legislation.

The SPEAKER. Please. The Chair is having difficulty hearing the gentleman and I am sure that is true of a number of others. We will close down shortly, but at the moment, Mr. Freeman has the floor.

Mr. Freeman.

Mr. FREEMAN. Thank you, Mr. Speaker.

I believe we do not need to put in place in this Commonwealth a structure where we set the stage for plans being deemed approved without the municipality acting upon them. To do so I think opens up a Pandora's box of problems in those high-growth municipalities that are forced to grapple with the problems of sprawl, and as such I would urge the membership, despite the good work done, again, by the colleagues on the other side of the aisle, I would urge the membership to vote "no" on this. Let us not try and fix something that is not broke. Let us leave that authority in the hands of our local officials as we do now under the current MPC (Municipalities Planning Code).

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

On the question of concurrence, Mr. Hennessey.

Mr. HENNESSEY. Thank you, Mr. Speaker.

Just a point of correction, Mr. Speaker.

The current bill, HB 1219, even as it has been amended, does not change existing law with regard to deemed approvals and deemed denials. It lets current law stay exactly as it is. What it does do is set some time limits for the presentation of an opponent's case. It takes curatives out of the current legislation and leaves them as they are presently.

So I think it is important for the House to understand that this does not change the existing law with regard to deemed approvals or deemed denials. We may want to visit that in the future, but this law, this proposal, does not make any change in the deemed approval-deemed denial status quo. Thank you.

The SPEAKER. On the question of concurrence, Mr. Freeman for the second time.

Mr. FREEMAN. Thank you, Mr. Speaker.

I will not belabor the point. I realize the hour is late and the members are anxious to move on with the calendar. Just as a point of clarification, however, it is my understanding that although it does not alter dramatically the deemed approval process, the current status quo does hold out an option in terms of the way in which the hearing process works at the local level, which does actually give a lot more leeway to local officials dealing with the deemed approval process. Because of the hearing process, the way you can set up a hearing, you can avoid the haphazard approach to planning that can occur with the current deemed approval language. We are changing that, and I want to make it clear to the members, so that the deemed approval process will come to the fore where before it could be held back through hearing processes in terms of how they were called.

Now, again I commend the gentleman, Mr. Hennessey, and the others on the other side of the aisle that crafted some more safeguards into it. They made a better bill out of what was coming over from the Senate. But in my opinion, I think we are better off with the current status quo. This issue, this issue has come up within the Local Government Committee. Our Townships Subcommittee has done yeoman's work on trying to find compromise language. I do not think it is appropriate at the eleventh hour of this year of the session to settle on a proposal that really does deserve more attention, more time, and more study.

So I would again urge the members to vote "no." Keep the status quo, and let us address this issue in the coming session next year.

The SPEAKER. The Chair thanks the gentleman.
