The SPEAKER. Prior to session, I had an opportunity to join with these gentlemen, welcoming them to Pennsylvania. They are here for several more days, although today they are returning to Philadelphia, and I am not sure just what their travel plans are after that. I know Cleveland.

But they told me that yesterday they were privileged, is the way they put it, to watch the Super Bowl with a group of people who were entertaining them down in Philadelphia. They had some big Super Bowl party there with 60 people. So I can imagine what that experience was like if they have never had an athletic event such as our Super Bowl Sunday. The event is as much an event in the kitchens of the Commonwealth and the nation as it is on the field of play, and I suspect that both took place yesterday.

Welcome again, and we hope you will return time and time again. If any of you would like to meet with these gentlemen, feel free to walk over and chat with them. They are very, very nice people.

The president of the Groundhog Club, Bill Cooper, has been telling people that Groundhog Day is for fun, is fun for no good reason, and I think that is really what it was about. We had about 40,000 people up at Gobbler's Knob. Punxsutawney is a town of a little over $6,000,6,500$ people. So we had 40,000 people up there to see Punxsy Phil come out.

> I bin sleepin', bin noddin', bin living better than Bin Laden.
> I only come out to eat and have fun
> My Groundhog Day job is to study the sun.
> The sky is light, the signal is strong,
> My shadow I see,
> So winter will be
> Six more weeks long.

Look out the window and you will see the snow. Actually, I kind of modified that this year. I said it will be 6 weeks long since we really have not had much winter up until now.

Thank you, Mr. Speaker, for your recognition.
The SPEAKER. The Chair thanks the gentleman.
It is my understanding that the gentleman, Mr. Barley, from the county of Lancaster, has some statement to make along the same lines.

Mr. BARLEY. Well, thank you, Mr. Speaker.
This is always a challenge, because the groundhog from southern Lancaster County, Octorara Orphie, has never been the feature in a movie. So we are at a disadvantage when it comes to the attention that this impostor in Punxsutawney always is able to garner.

But the question I have for Punxsutawney Phil, I was reading, I believe it was in the Pittsburgh Gazette, that it was his intention to forecast the winner of the Super Bowl, and I do not know what happened. He, like, backed away from that. I did not see him making his projection. So I am asking publicly, and maybe the gentleman from Jefferson will be able to explain to us sometime why we did not see that. My guess, he would have been held accountable. That was a definite forecast that we would have been able to determine whether he was right or wrong.

## STATEMENT BY MR. LAWLESS

The SPEAKER. Mr. Lawless, I apologize for the delay.
Mr. LAWLESS. Thank you, Mr. Speaker.
Mr. Speaker, as promised, I will rise every day to fight for Erin's Law, 4-year-old Erin, who sits in a duPont Hospital after a kidney transplant.

We passed this legislation, which would eliminate or help to eliminate E. coli bacteria disease with our young people in this State, back in June in this General Assembly. However, it sits in the Senate. Once again this weekend I was addressed by a Senator who told me it will go nowhere because my name is on that bill.

Mr. Speaker, as politics are played with Senator Jubelirer and Senator Waugh, Senator Waugh recently reported in a news article. That news article stated Senator Waugh claims some in the agriculture community have concerns about the cost of my bill. If he is so worried about cost, what have 4-year-old Erin Jacobs' costs been since she was infected by E. coli at a petting zoo? What dollar figure does the Senator place on the loss of her kidneys? How many bucks are three-quarters of a colon going for these days? That is not to mention the pain, the expenses of 10 operations in 15 months. What will the cost be for the next child who has to fight for life because of Senator Waugh's political spite of me?

Both Senator Waugh and Senator pro tem/Lieutenant Governor - and whatever other position he may hold - Jubelirer claim there is opposition to the Erin's Law bill somewhere out there in the agriculture community, but they never have said who has the questions and what the questions are. Mr. Speaker, I have to this date not received one letter or correspondence since this bill passed in June opposing such legislation from either a group, organization, or even a person.

Highly respected Republican Secretary of Agriculture Sam Hayes gave us input on the bill more than a year ago and worked with us until we reached what were reasonable protections for both the people who display the animals and the children and adults who come in contact with them. There were not any nagging questions when the House unanimously passed this bill last June. If Senator Waugh knows of legitimate concerns about the legislation, why has he not scheduled hearings on them? After all, he is the Senate Agriculture and Rural Affairs Committee chairman.

Pennsylvania is one of just two States in this nation that does not have E. coli safeguards. If Senators Waugh and Jubelirer want vengeance on me because of my outspoken and maverick ways, that is fine with me; I can take it. But for God's sake, why do they have to risk the health and lives of Pennsylvania's children to get the pound of flesh they lust for me? By holding Erin's Law captive, the pound of flesh will not come from me; it will come many times over from future victims of E . coli infection in Pennsylvania. Do these Senators, Waugh and Jubelirer, have any sense of decency as a 4 -year-old sits in quarantine in a duPont Hospital?

Her father contacted me late last week as he got out of the hospital after giving Erin one of his kidneys. Rick Jacobs has made this an issue. He will come to the Capitol as soon as he is healthy. I will have him sit on this floor so the people in this House can see the pain and suffering that a parent has gone through, and yet the Republican side of this aisle, as well as the Senate, has done nothing to save and preserve the health and welfare of the children of Pennsylvania.

Thank you, Mr. Speaker.
The SPEAKER. The Chair thanks the gentleman.
