MEMORIAL SERVICE FOR HON. LEROY M. ZIMMERMAN

The SPEAKER pro tempore. The members will please take their seats. We are about to begin our memorial service for Representative Leroy Zimmerman.

Last December we were all shocked to learn of the untimely death of our friend and colleague, Representative Leroy Zimmerman. His death is a loss not only to the members of this House but to the citizens of the 99th Legislative District in Lancaster County. We are all deeply saddened by the loss of Leroy, and we mourn his loss.

Today, as is our custom here in the House, we will reflect for a few minutes and conduct a memorial service and reflect on Leroy's contributions to the Commonwealth.

COMMONWEALTH OF PENNSYLVANIA THE HOUSE OF REPRESENTATIVES

RESOLUTION

WHEREAS, It is with deepest regrets that the House of Representatives of Pennsylvania notes that the Honorable Leroy M. Zimmerman, a member of the House of Representatives serving the 99th Legislative District, passed away at the age of sixty-nine: and

WHEREAS. Representative Zimmerman built a reputation as a successful businessman on his family's turkey farm. He was a member and past president of the Lancaster Poultry Association and a member of the Pennsylvania Poultry Federation, the Pennsylvania Farmers' Association and the Northeastern Poultry Council. He served as a member of the Poultry Science Council of The Pennsylvania State University in 1980, a Director of the National Turkey Federation and President of the Turkey Council in 1982; and

WHEREAS, Representative Zimmerman had been elected to five terms in the House of Representatives of Pennsylvania. He was an East Earl Township Republican Committeeman from 1982 to 1994 and a member of the Lancaster County Republican Advisory Committee in 1985. In 1985, he was named Eastern Lancaster County Republican of the Year. Representative Zimmerman was also actively involved in the New Holland Rotary Club as a member and past president and the Forest Hills Mennonite Church in Leola as a member; now therefore be it

RESOLVED, That the House of Representatives of the Commonwealth of Pennsylvania note with great sadness the passing of the Honorable Leroy M. Zimmerman; extend heartfelt condolences to his wife Bonita Roth Zimmerman; and daughter, Monica; and be it further

REMARKS BY SPEAKER PRO TEMPORE

The SPEAKER pro tempore. The passing of a friend is also and always a painful experience, but we also feel a special sense of loss when we lose a colleague here in the House of Representatives.

Leroy Zimmerman was a good man. He was our friend, and he was a member of this General Assembly's family.

For those of you who knew Leroy as I did – we came into the House as freshmen together – you knew a man who was a quiet but effective leader; you knew a man who loved Lancaster County and wanted to do the best for its citizens; you knew a man who was a devoted husband to his wife, Bonnie, for 42 years; you knew a man who was a caring father to his daughter, Monica, and Leroy would often speak of her, and he would light up with that easy, smooth smile of his when he talked about her.

Members of the House and members of the communities in his legislative district and indeed in Lancaster County as a whole would look to him at times for his wise counsel and sage advice.

Although he was quiet and did not speak often on the floor, his influence was obvious to all of us who knew him. Members often chatted with him, leaning on his experience and his soothing demeanor, especially on those issues which were near and dear to his heart: agriculture, tourism, fishing, and hunting.

He was a man who was easily approachable because of that straightforward way that he would always deal with you. He never got wrapped up in the world, the complex world, of Harrisburg, and he certainly never got wrapped up in the trappings of Harrisburg. He always remained true to his upbringing, and he always retained his excellent horse sense.

As he sat at his desk right back there, he did more listening than talking, and that sometimes is unusual for the members of the House on the floor, and it is rare, but then again, Leroy Zimmerman was a rare individual. When he had an idea on a topic, he would be sure to let you know what that idea was, and you would be sure to listen because of the type of man that he was.

His mind was always working. He always extended a helping hand to anyone who had a question that needed answered, and he was always generous with his time. Leroy would take time to talk to you, to listen to you, and to spend a few quiet moments.

Leroy's style did not even change on our stressful days and our long nights together. He remained a calming influence amidst what sometimes is a very chaotic legislative process. Leroy was the same man always that his constituents first elected, and he worked tirelessly for those constituents throughout his 8 years in office.

There is a lot worth remembering about Leroy Zimmerman. Let us never forget him, his smile, his special brand of leadership, and his counsel he offered to so many of us through his 8 years here.

When it is all said and done, when you die, what remains is your reputation. Were you fair? Were you honest? Were you thoughtful? Were you considerate? Leroy Zimmerman was all these things and much, much more.

Bonnie and Monica, we are so pleased to have known him, and we will miss him. We mourn his passing, but we thank God for his life.

God bless you, Leroy. May you rest in peace.

REMARKS BY MAJORITY LEADER

The SPEAKER pro tempore. The Chair now recognizes the majority leader, the gentleman from Philadelphia, Mr. Perzel, for remarks.

Mr. PERZEL. Thank you, Mr. Speaker.

Mr. Speaker, Leroy Zimmerman was one of those special people that you are glad to have met and privileged to have worked with. He was a quiet man, as we all know; a quiet leader.

Public service meant something to Mr. Zimmerman. He felt it was an honor, a privilege, and frankly, he thought of it as a duty. Since 1966, in one capacity or another, he served the people of his own township, East Earl, and all of Lancaster County.

For nearly four decades, Leroy Zimmerman was a tireless advocate for his constituents. He understood the challenges of farmers in today's world and fought on their behalf. Leroy Zimmerman excelled in all his endeavors. As a farmer, a turkey farmer to be precise, he headed up Zimmerman Turkey Farm since 1964. He was active in the Poultry Association and the agriculture groups in the local area.

As Chairman Bunt can attest, he was one of the top qualified members of the House Agriculture and Rural Affairs Committee. He rarely spoke in caucus meetings or on the floor of this House, but when he did rise, the room usually became quiet because something heartfelt and reverent was about to be said.

When he had a real issue or something that was major to him or controversial or something that he really was a little concerned about, he would stop by and actually talk to me privately so that he would not have to be talking or discussing his feelings with the other members, and I will never forget those times that we spent together.

That was the way that this man was. He was a quiet man, as I said; a quiet leader. He possessed a gentle firmness, dignity, and thoroughness that reflected his approach to life in general.

Bonnie Zimmerman, last week would have marked your 43d wedding anniversary. That in itself says something extremely important about this man and about you. I know you are proud of him, and I know that you are as proud of him as we were, and we know that, Monica, you were also proud of Leroy Zimmerman.

Representative Leroy Zimmerman of the 99th Legislative District in Lancaster County was my friend, and I will miss him. May God bless Leroy Zimmerman.

REMARKS BY DEMOCRATIC LEADER

The SPEAKER pro tempore. The Chair now recognizes the Democratic leader, Mr. DeWeese, for remarks.

Mr. DeWEESE. Thank you, Mr. Speaker.

To the friends and family, especially, and to my colleagues, and with a special note to former Representative Gibson Armstrong, former Representatives Strittmatter and Schuler and Wenger, all of whom launched their careers in this room as part of the Lancaster County delegation, I am glad to see you gentlemen in our midst. I think it punctuates the remarks that have already been offered.

The theologian Dwight Morrow once observed that there are two kinds of people in the world: those who make things happen and those who take the credit. Obviously, the Speaker's comment and those that followed by Mr. Perzel buttress the fact that in his quiet, steady, stable manner, our colleague made things happen without overly taking the credit.

The manners – there is no better word for the ethos that Leroy exemplified – but the manners that he radiated are so much a part of the warp and woof of Pennsylvania's political fabric. William Penn was a nice guy – solid, earthy, agriculturally inspired, farsighted, familial, decent man – and what a tradition that this House can enjoy and reflect upon when we think that our colleague from Lancaster County, where most all of the folks seem wholesome and high-minded and decent – a little too conservative for me, but they usually won the fights, and I usually lost the fights – but what a tradition Pennsylvania has and what an exemplary manifestation of those long years of

continuity and respect and solidity in our General Assembly, and Leroy evinced that kind of personal character.

We have other men who are on the wall and women who have come before us in this Assembly, and the names would go on and on, but I have one other name of a very quiet, solid, contributing Pennsylvanian, and his name was George Catlett Marshall – general of the armies, World War II; born in Uniontown, in Larry Roberts' district, right between DeWeese and Shaner's districts – who went on to fame and high involvement but was, as his biographer used to observe, one of the most introspective and low-key and solid participants on the grand stage.

So you do not have to have a great deal of pyrotechnics and bluster that sometimes affects us, many of us. He was rare; he was rare, probably in that 10-percent cohort of folks that everybody liked – everybody liked.

In summation and in conclusion, Mr. Speaker, the great Irish playwright William Butler Yeats had a wonderfully piquant observation that I think is appropriate to proffer at this moment. He said that it is impossible to perfect both the life and the work. When I think of that, I think of my father and I think of Bill Clinton. Bill Clinton perfected the work, but my father perfected the life, and Leroy perfected the life.

In the words of Shakespeare, he developed with all of us in this room an indissoluble tie, forever knit. We will miss our colleague. Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman.

REMARKS BY MR. SCHULER

The SPEAKER pro tempore. The family has requested that former member, former Representative Jere Schuler be permitted to offer remarks.

Therefore, the Chair requests that the gentleman, Mr. Schuler, come up to the reading clerk's podium.

Mr. SCHULER. Thank you very much, Mr. Speaker, for the opportunity to be here today to render a few remarks about our colleague and fellow legislator, Leroy Zimmerman.

I would like to thank both sides of the aisle, the majority leader and the minority leader, for their fine remarks about our friend.

Mrs. Zimmerman and family, our condolences to you, and to the friends of Leroy Zimmerman for being here today, we thank you for your attendance.

I have been asked by the family, as has been mentioned by the Speaker, to make a few comments. My comments about Representative Zimmerman will be about our friend, not as a legislator.

When I left the floor of the House here on Thanksgiving morning, I never expected my first time back would be to come today and speak at Leroy's memorial service.

I met Leroy 20 years ago. I was running for the 43d District in Lancaster County, and it was a very tough battle, but one of my advisers told me, "The man you want to see in the 43d is down in East Earl Township, and his name is Leroy Zimmerman. Go talk to him. He is the man." So I go down and I talk to Leroy for quite a few days in fact, and finally Leroy gave me his support, and that began a 20-year friendship. It was a few years later, when reapportionment occurred and Representative Scheetz had retired, that Leroy called me and told me he was interested in joining the Lancaster delegation here in Harrisburg, and of course, he did win the election, and he joined us and became a very contributing member to our House of Representatives.

Leroy and I had many discussions on the floor, and I know the new members, you probably will have some of those, too, when they are trying to gather those votes for the budget. And many times back in our seat we would discuss many issues, from religion to education. You name it; we would discuss it. And through those discussions, I got to understand Leroy Zimmerman and what he stood for.

And what I found was that Leroy Zimmerman had a great deal of faith and religious principles. He practiced these principles in the community in Lancaster and also here in the House of Representatives. He was a loving husband, which has already been said, but he was a loving husband and a loving father to Monica. And, Monica, let me tell you this: In those discussions that we had, he always spoke so highly of you and was so proud of your achievements. Monica is now on the teaching staff at Temple University. And he was so proud of you, Monica, and I just want you to know that, and I am sure you knew that also.

As has also already been mentioned, Leroy was a quiet man; he was a humble man; he was a gentle man. He was not interested in a great deal of publicity. He was not interested in all those things dealing with the legislature as far as recognition goes. When I said something to him about it, he just looked at me and said, and I quote, "I'm not interested in all that. I'm just doing my job." And that was Leroy Zimmerman.

Leroy was dedicated to helping his constituents. I know many times he would come on the floor, usually on a Monday afternoon when we were going into session, and he would come in and he would be very frustrated, and I would say, "What's wrong, Leroy?" "Well, I can't help this constituent; I can't do something for this individual." And he took it very to the heart. He was very concerned about his constituents back home and the fact that he was not able to give them any help. Now, we will never know how many men and women, children, Leroy had helped as a legislator here in Harrisburg.

As has been also mentioned, Leroy was a very successful businessman and farmer, and because of his agricultural background, he was a strong believer in the family farm and spoke very highly and voted many times in support of farmland preservation.

And most of all, Leroy was a gentleman. He was respectful to all, regardless of their station in life. He was a very, very humble man but a very respectful man to all that he had to deal with.

The Representative's contributions to community, to Lancaster County and the Commonwealth, and to the Lancaster delegation will be long remembered. The 99th District and the Lancaster delegation have lost a champion.

Just to give you one little story: As we were getting near the end of the session and before Leroy became ill, we were seated back there one afternoon, and he said, "Well, now, Schuler, since you're retiring, I want your seat," and I was seated where the gentlelady from Lancaster, Mrs. True, is now seated, and I said, "Well, Leroy, there's no special power in this seat." He said, "Yeah; I know that. I'm just getting tired of crawling over people, so I want the end seat."

Well, this was not to be, but today, Leroy, you have the best seat in the house.

Thank you for coming.

Mr. FAIRCHILD. Thank you, Mr. Speaker.

First, I would like to commend you on your kind words, along with the majority and minority leaders, about our fallen comrade. He was one heck of a guy.

The reason I have requested to address the General Assembly is tomorrow you should receive – or today – in your mail a report called "The Cost of a Clean Bay." It is a short summary of an awful lot of work on behalf of the staff of the Chesapeake Bay Commission, and if you live in the Susquehanna watershed or a whole bunch of other watersheds, you realize just how big of a portion of the State the Chesapeake Bay watershed intakes.

The reason we felt it was necessary to make sure that every member gets it is it kind of points out the commitments made by past Governors to clean up and delist the Chesapeake Bay from the impaired waters list by the year 2010.

The bottom line is that a lot of people had a lot of ideas how to get it done, but no one had actually cost it out, a fiscal analysis, on a project of this magnitude. To my knowledge and to a lot of people involved in this, from the Federal government down to the State governments, it is probably one of the largest projects that has ever been fiscally costed out. You will see that to get to where the bay needs to be by the year 2010, it is going to cost over \$19 billion.

We knew it would not be a pretty picture, but I would like to thank not only the members in Pennsylvania of the Chesapeake Bay Commission but also the members of Maryland and Virginia who graciously followed my lead. I was chairman of the commission last year, and I hope you enjoy and at least take the time to leaf through, and perhaps as we go forward in the future, we should do a little more fiscal reality when it comes to finding out just how we do programs and how much we are going to spend on them. Finally, I am not advocating that we spend one penny less. This will just certainly serve as where we need to go fiscally to protect our environment that we love so much.

Much to my amazement, he knew who I was and knew that I had worked in that restaurant, told me people that I worked with, told me who my parents were, told me who my neighbors were, told me different things that were going on that I had to recall 30 years back. That was the kind of person that Leroy was. He was truly a Representative that knew his constituents on a personal basis and I think should be remembered for that and will be missed in that community.
