Mr. Speaker, this amendment, briefly, would do two things.

First off, in addition to this committee holding hearings to study the feasibility of merging the Game Commission with the Fish and Boat Commission, it would also be able to entertain other options, like perhaps some sort of a merger or reconsolidation or reorganization involving these two agencies as well as perhaps DCNR (Department of Conservation and Natural Resources). But I did not want to have any limit on any of the range of options that this committee could be taking testimony on. So that is the first thing that the resolution would do, would be to broaden the scope of the hearings.

Secondly, Mr. Speaker, it would be to give a little direction to the committee hearings insofar as both of these wildlife management agencies in our Commonwealth are underfunded and have tens of millions of dollars of backlog of infrastructure needs. I think it is time that we study the options of funding for these two agencies, which are wholly supported by sportsmen's license dollars. I think it is time that we study ways that we could use perhaps some General Fund or other public revenue sources to support these two wildlife management agencies.

So it would give some definition to the study and broaden the scope at the same time, and I would urge the members' affirmative support. Thank you.
