I had filed three amendments which I will be withdrawing now, but before I did, I wanted to make a couple of comments.

All three of these amendments deal with the issue of resort-type development in Pennsylvania State parks. Specifically, they deal with allowing things like hotel-type facilities, ski lodges, golf courses, conference centers,

tennis courts in State parks, in our State park system. Many of you will remember that we fought this battle in 1996 and 1997 when there was an effort by development interests to put this type of, in my view, inappropriate development in our State parks and forests, but Secretary Oliver and Governor Ridge simply did not allow it. Unfortunately, the Rendell administration has taken a different approach, and again our State parks are threatened with this resort-type development.

I feel and I think about 70 percent of Pennsylvanians, according to polling which has been done over the years, oppose things like ski lodges, golf courses, and other resorts in our State parks and forests. Right now there are a number of projects, such as in Prince Gallitzin and elsewhere, which, unless the public and the legislature become aware of it and take steps to stop it, will come to fruition.

The purpose of my filing of amendments and speaking out today is to begin to try to increase public awareness of this, again, this type of encroachment in our State parks and forests, but I will withdraw my amendments today.

Section 1. Title 42 of the Pennsylvania Consolidated Statutes is amended by adding a section to read:

§ 1725.5. Municipal police start-up fee.

(a) Imposition of municipal police start-up fee.—A person who is placed on probation without verdict pursuant to section 17 of the act of April 14, 1972 (P.L.233, No.64), known as The Controlled Substance, Drug, Device and Cosmetic Act, or who receives Accelerated Rehabilitative Disposition or who pleads guilty to or nolo contendere to or who is convicted of a crime as defined in 18 Pa.C.S. § 106 (relating to classes of offenses) or 75 Pa.C.S. § 3731 (relating to driving under influence of alcohol or controlled substance) or 3735 (relating to homicide by vehicle while driving under influence) or a violation of The Controlled Substance, Drug, Device and Cosmetic Act shall, in addition to any fines, penalties or costs, in every case be sentenced to pay a municipal police start-up fee.

- (b) Amount of municipal police start-up fee.—Where, in accordance with subsection (a), probation is imposed, a plea is entered, or conviction obtained for a felony, the fee shall be \$50; and where, in accordance with subsection (a), probation is imposed, a plea is entered, or conviction is obtained for misdemeanor, the fee shall be \$25.
- (c) Disposition of municipal police start-up fee.—The municipal police start-up fee shall be paid into a special nonlapsing fund of the State Treasury, which is hereby established and shall be known as the Municipal Police Start-up Fee Fund. Money in the Municipal Police Start-up Fee Fund is hereby appropriated to the Department of Community and Economic Development and shall be used solely for providing grants to municipalities which do not have a municipal police department, do not participate in a regional police department, and do not purchase police services from another municipal or regional entity, which grants are to be used for the purpose of providing start-up or seed money to qualifying municipalities that wish to establish a municipal police department, join a regional police department, or purchase police services from another municipal or regional entity.

(d) Other laws.—The municipal police start-up fee shall be imposed notwithstanding any other provision of law to the contrary.

Mr. TANGRETTI. Thank you, Mr. Speaker.

Mr. Speaker, a number of months and even years ago, we did a study through the Local Government Commission and the House Democratic Policy Committee even before that relative to local municipal police departments and their lack of funding opportunities and the fact that property taxes that support municipal governments are not significant enough to help municipal police departments, and further, those communities who had to abandon police departments or, further, those who wanted to create new police departments had a woeful inadequacy relative to the numbers of funds available to them.

As a result of looking into this whole process, it was recommended that we provide a direct source of funding for that purpose. This amendment A0481 does that by providing fines, assessments, of \$50 on felony convictions and \$25 on misdemeanor convictions that would go into a restricted account in the Treasurer's Office for the purpose specifically to provide funding for startup police departments, regional police department discussions, and the like.

I would ask the members of the House to support this amendment.

Mr. ALLEN. For legislative intent, can you describe to me where the sales can take place and specifically where the sales can take place in this amendment?

Mr. FREEMAN. Yes, Mr. Speaker.

Mr. Speaker, the change that we are making with this amendment would allow breweries to be able to sell at the brewery a size of beer in the quantity of a half-gallon or a growler container. Under current law, they can only sell at the brewery either by the case or by a gallon jug container. As a result, oftentimes when tourists come through at the end of the tour, people would like to purchase some of the beer, but to take a whole gallon container home means the beer gets flat before the container is finished. The half-growler is a more practical size.

I want to make it clear, under legislative intent and for the information of the House, this does not in any way apply to beer distributors. They are still required to sell by the case. We are not touching that provision of the Liquor Code. But this would make it more convenient for breweries, particularly microbreweries, to be able to sell a smaller quantity of beer without having to sell a large jug container, gallon jug container.

The amendment was requested by a small microbrewery in my district, Weyerbacher's, who have experienced the fact that people do want to take some of their beer home after going through a tour of their facility but the gallon jug is just simply too large a size.

Section 406. Sales by Liquor Licensees; Restrictions.-(a) (1) Every hotel, restaurant or club liquor licensee may sell liquor and malt or brewed beverages by the glass, open bottle or other container, and in any mixture, for consumption only in that part of the hotel or restaurant habitually used for the serving of food to guests or patrons, or in a bowling alley that is immediately adjacent to and under the same roof as a restaurant [when no minors are present, unless minors who are present are under proper supervision as defined in section 493, in the bowling alley], and in the case of hotels, to guests, and in the case of clubs, to members, in their private rooms in the hotel or club. No club licensee nor its officers, servants, agents or employes, other than one holding a catering license, shall sell any liquor or malt or brewed beverages to any person except a member of the club. The holder of a restaurant license located in a hotel may sell liquor or malt or brewed beverages for consumption in that part of the restaurant habitually used for the serving of meals to patrons and also to guests in private guest rooms in the hotel. For the purpose of this paragraph, any person who is an active member of another club which is chartered by the same state or national organization shall have the same rights and privileges as members of the particular club. For the purpose of this paragraph, any person who is an active member of any volunteer firefighting company, association or group of this Commonwealth, whether incorporated or unincorporated, shall upon the approval of any club composed of volunteer firemen licensed under this act, have the same social rights and privileges as members of such licensed club. For the purposes of this paragraph, the term "active member" shall not include a social member. Any club licensee which is either an incorporated unit of a national veterans' organization or an affiliated organization as defined in section 461.1 shall be permitted to sell liquor or malt or brewed beverages to any active member of another unit which is chartered by the same national veterans' organization or to any member of a nationally chartered auxiliary associated with the same national veterans' organization.

(b) No retail dispenser shall sell any malt or brewed beverages for consumption on the licensed premises except in a room or rooms or place on the licensed premises at all times accessible to the use and accommodation of the general public, but this section shall not be interpreted to prohibit a retail dispenser from selling malt or brewed beverages in a hotel or club house in any room of such hotel or club house occupied by a bona fide registered guest or member entitled to purchase the same or to prohibit a retail dispenser from selling malt or brewed beverages in a bowling alley [when no minors are present, unless minors who are present are under proper supervision as defined in section 493,] where the licensed premises and bowling alley are immediately adjacent and under the same roof.

Section 491. Unlawful Acts Relative to Liquor, Alcohol and Liquor Licensees.-

It shall be unlawful-

* * *

(6) Sales by Restaurant and Hotel Liquor Licensees. For any restaurant or hotel licensee, his servants, agents or employes, to sell any liquor or malt or brewed beverages for consumption on the licensed premises except in a room or rooms or place on the licensed premises at all times accessible to the use and accommodation of the general public, but this section shall not be interpreted to prohibit a restaurant liquor licensee from providing private affairs the primary function of which is for catering only to weddings or special occasions arranged twenty-four hours in advance, nor to prohibit a hotel licensee, or a restaurant licensee when the restaurant is located in a hotel, from selling liquor or malt or brewed beverages in any room of such hotel occupied by a bona fide guest or to prohibit a restaurant licensee from selling liquor or malt or brewed beverages in a bowling alley [when no minors are present] where the restaurant and bowling alley are immediately adjacent and under the same roof.

you are not, and then it also tightens up the language on intent so that people cannot accidentally have something in their purse or carry-on, you know, knowing that they had their manicure scissors in their purse but not intending to sneak it through the security system.

So this tries to tighten up the intent language and also make one consistent list of sharp objects, and I would appreciate an affirmative vote.
