OWEN J. ROBERTS HIGH SCHOOL GIRLS SOCCER TEAM PRESENTED

The SPEAKER. The Chair would like to bring up to the rostrum Representative Tim Hennessey and Representative Curt Schroder for the purpose of a citation.

Would the House please come to order. These gentlemen deserve your undivided attention.

Mr. HENNESSEY. Thank you, Mr. Speaker.

Ladies and gentlemen of the House, I am pleased to have join us today the girls soccer team from Owen J. Roberts School District in northern Chester County. Curt Schroder and I invited them here today to celebrate their accomplishment in winning the State Class AAA soccer championship.

The girls soccer program at Owen J. Roberts is only 7 years old, but over those years they have compiled a very impressive record of 138 wins, 31 losses, and 6 ties. This year's team posted a school record of 24 wins, 3 losses, and a single tie. In early November they beat a very dangerous team from Butler, Pennsylvania, by a score of 1 to nothing, a real nail-biter.

Owen J. Roberts has a long history of accomplishment and competitiveness in football and basketball and field hockey and other sports and also in academic competitions, but this was the very first State championship ever garnered by the Owen J. Roberts School District.

The SPEAKER. On that question, the Chair recognizes the gentleman, Mr. McGill.

Mr. McGILL. Thank you, Mr. Speaker.

Mr. Speaker, HR 411 is asking the Department of Homeland Security and the Federal Aviation Administration to look at the TFRs, the temporary flight restrictions, that go into place whenever the President or the Vice President move around. When they move into Pennsylvania, as they did in Pittsburgh last week, there is some 30-nautical-mile radius around the President, which basically shuts down general aviation, and because of that, we are asking for your support.

GUESTS INTRODUCED

Mr. McGILL. And I am happy to report to you today that we have Mr. Phil Boyer. If you would please stand, Mr. Boyer. Phil Boyer is the president of AOPA, which is Aircraft Owners and Pilots Association, along with Keith Holt, who works with him.

AOPA has been a wonderful organization that has pushed general aviation forward in the United States, not only in the Commonwealth of Pennsylvania, and we are thrilled that they would come here today for the vote on this resolution so that they can take this information back to Washington and work with the congressional people and the Department of Homeland Security as well as the Federal Aviation Administration to try and help us in reducing the temporary flight restrictions.

The term includes, but shall not be limited to, termination of the carrying of gas, oil or oil product, sewage or water through an underground pipe or the carrying of electric or communication service through an underground conductor, pipe or structure. The term shall not be construed as including any other steps necessary to repair and remedy the bona fide emergency.

It does not authorize the contractor to proceed with making permanent repairs, but in cases of an emergency that threatens life or body, this will take care of a problem that was identified in the bill early on.

I would like to thank the sponsor of the bill, Representative Fichter; the Pennsylvania Association of Plumbing, Heating, and Cooling Contractors; the Attorney General's Office; the Pennsylvania Utility Contractors Association; and staff for working to resolve this issue.
