It is with a great deal of sadness and yet a great deal of pride that I stand here as a Representative for Kimberly Voelz. Kimberly was born in Monroe Township in Cumberland County. As a matter of fact, when my wife, Donna, and I moved into our second house, her parents, Floyd and Carol, lived just

around the orner, six houses away. That was 1976, the year that Kimberly was born.

She was always a dedicated, unusual individual in that she always was so enthusiastic in her pursuits. She had to do something special and go that extra step, and that was part of her life. She graduated from Trinity High School in Cumberland County, and she loved showing horses and was very good at it, but it was not enough. Then she wanted to get into barrel racing, and she was such a topnotch competitor that she competed right here at our Farm Show specials in January of each year.

She moved on to more challenging pursuits in that she joined the United States Army, but rather than being a routine soldier, as many of us were, she chose to go to the Explosive Ordnance Disposal School. She was the only female in that school, and out of the dozens of people that participated and entered the school, less than a half dozen, I understand, graduated. That is where she met her husband, Max, her husband of 4 years.

Kimberly was clearly recognized as one of the best in her field in the United States Army. She was the first female soldier from Pennsylvania to die in Iraq. She will be missed by many and be remembered by many of us who respect her as well.

I know her parents well, and I will be proud on behalf of the House of Representatives to present a copy of this resolution to her husband, Max Voelz, and to her parents, Floyd and Carol Fahnestock.
