## COUNCIL ROCK SOUTH HIGH SCHOOL GIRLS SOCCER TEAM PRESENTED

Mr. PETRI. Thank you, Mr. Speaker.

Good morning.

It gives me immense pleasure to welcome to the House chamber the PIAA spring girls soccer champions, the Golden Hawks of Council Rock South. Before you are team captains Amanda Allessio and Kim Hickey, and Coach Dunn, and assistant coach Christian Slota.

State champions in the AAA division, this amazing team enjoyed an undefeated season and is ranked third in the nation. The champion of this division has come from Bucks County 10 of the last 12 years; quite a feat.

Team members as a unit and individuals have stacked up accolades over the season and since winning the championship. Standing before you today at the back of the House floor is nearly the entirety of the Suburban One American Conference Liberty Division team. Also here is the Philadelphia Inquirer Southeast Pennsylvania Player of the Year, a member of the Pennsylvania all-State girls soccer team, the Pennsylvania Gatorade Player of the Year, Amanda Allessio. Another winner, Whitney Weinraub, who received Philadelphia Inquirer Rookie of the Year and Bucks County Courier Times Player of the Year. There are also several other award winners on the team.

## **REMARKS SUBMITTED FOR THE RECORD**

Mrs. WATSON submitted the following remarks for the Legislative Journal:

Keeping our skies safer is the intent of the legislation contained in HB 2664. Pennsylvania is one of only three States in the nation that has no law defining and criminalizing flying an aircraft while impaired by alcohol or drugs.

This legislation closes the loophole in State law that does not criminally punish pilots who fly while impaired. With this bill, pilots or members of a flight crew would be prohibited from operating or servicing an aircraft when their blood-alcohol content is 0.02 percent or higher. This standard would apply for any reading within 8 or fewer hours before a flight. Included in this bill are penalties and required evaluation and treatment for substance abuse.

Flying while impaired is a serious risk to public safety. Pilots who drink and then fly are jeopardizing their safety, the safety of their passengers, and the safety of countless people in their flight path.

I respectfully request an affirmative vote for HB 2664.

## STATEMENT BY MR. ROBERTS

The SPEAKER pro tempore. The gentleman, Mr. Roberts, is recognized.

Mr. ROBERTS. Thank you, Mr. Speaker.

I had an amendment for the bill that just passed, and in fact I have another amendment that is identical, but I wanted to make some comments on this legislation.

In Fayette County, we have the Fayette Area Coordinated Transportation department, also known as FACT. FACT provides transportation to thousands of people every month, which includes many, many senior citizens, and I am happy to say that our transportation program has been a tremendous success.

Our transportation program, FACT, has been funded as a 3-year demonstration project. Unfortunately, that project has ended and the funding will soon go away. The amendment that I had to this bill would have provided money to continue funding our FACT program, which will in fact continue providing transportation for our constituents, which is a very valuable service, and I was hoping that today my amendments would pass and we would get the project funded.

After all, we talk a lot about mass transportation here-Mr. Speaker, could we have just a little bit of order, please?

The SPEAKER pro tempore. The gentleman is entirely correct. There is too much noise on the floor. Members, please take your seats. The gentleman is entitled to be heard.

Mr. ROBERTS. After all, we talk a lot about mass transportation here, and we provide a significant amount of money for mass transportation projects across the State. Unfortunately, Fayette County's mass transit program does not qualify for the funding that we have been providing to others because it is a relatively new system, and because it is a new system, it was not included in the initial legislation that provided funding, and my amendment was designed to correct that problem.

Now, Fayette County's transportation project meets all the requirements of a class 3 urban transit system, and it is just as deserving to be funded as are the other transit systems across Pennsylvania. Now, there are currently 19 other class 3 transit systems, and they receive about \$23.5 million annually. If my amendments were to pass today, Fayette County would qualify for approximately \$600,000. But the kicker is that the funding for Fayette County would have to come out of the same pot of money that is now being used for the other class 3s. That means that the other 19 class 3 transit systems would have to give up some of their funding in order to fund Fayette County, and I am sure that is not something that my colleagues representing those areas would like to see happen. And I do not want to do that, but I am also concerned about losing the transportation program that my constituents so richly deserve, because we have come to depend on our little buses that travel around the county, and I do not want to lose them.

Now, I have been advised that we will soon be addressing this issue with other legislation, which in fact includes the language of my amendment, and hopefully the funding that Fayette County so richly deserves will be approved with the coming legislation. So I look forward to working with all of you on this project, and perhaps we can find a reasonable and acceptable solution to this situation. Mr. Speaker, that is why I withdrew my amendment on this bill that just passed, and, Mr. Speaker, I have an amendment for HB 2498, which I am also going to withdraw at this time.

Notwithstanding any of the provisions of this chapter or any law to the contrary, neither the department nor any other department or agency of the Commonwealth shall continue or implement any vehicle emission inspection program until the following occurs:

(1) The Environmental Protection Agency approves and issues rules and regulations for the use and implementation of on-board vehicle emission diagnostic testing systems that can provide less expensive and more convenient exhaust checks.

(2) A joint department and Department of Environmental Protection emission inspection policy review panel issues findings and recommendations for the use and implementation in this Commonwealth of on-board vehicle emission diagnostic testing systems to the Transportation Committee of the Senate and the Transportation Committee of the House of Representatives. Any vehicle emission program currently in effect shall cease immediately until legislative action can occur to implement such findings and recommendations. Amend Sec. 2, page 1, line 17, by striking out "2" and inserting

Mr. Speaker, those of us in the western part of this State and the eastern part of this State have been subjected to this test for, quite frankly, too many years. Now the central part of the State has been subjected to this onerous test, Mr. Speaker, and they are feeling the pain as well.

Mr. Speaker, we have been dealing with this issue since 1996 before I came into office with the Envirotest debacle, and again, my amendment, Mr. Speaker, calls for an immediate moratorium so that we can do further studies on the vehicle auto emissions testing program, and I would ask for an affirmative vote.

Thank you, Mr. Speaker. The SPEAKER. The Chair thanks the gentleman.

Mr. GEIST. Thank you very much, Mr. Speaker.

Mr. Speaker, we need to address amendment 2544 and we need to do that in short order, so I ask the members, please, to vote against the motion to table; bring the amendment to the floor; we will discuss the merits of the amendment; and then we will vote "yes" or "no." That is the procedure of the House,

and that is the process that we should be going through, Mr. Speaker.
