BILL ON CONCURRENCE IN SENATE AMENDMENTS AS AMENDED

The House proceeded to consideration of concurrence in Senate amendments to the following **HB 147**, **PN 4323**, as further amended by the House Rules Committee:

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, authorizing a film production tax credit; and providing for the powers and duties of the Department of Community and Economic Development and the Department of Revenue.

On the question,

Will the House concur in Senate amendments as amended by the Rules Committee?

The SPEAKER. It is moved by the gentleman, Mr. Stevenson, that the House do concur in the amendments.

The gentleman, Mr. Samuelson.

Mr. SAMUELSON. Thank you.

I would like to interrogate Mr. Stevenson on this bill.

The SPEAKER. The gentleman, Mr. Stevenson, indicates he will stand for interrogation. The gentleman, Mr. Samuelson, is in order and may proceed.

Mr. SAMUELSON. Thank you.

I am just looking for an explanation of what the Senate amendments were. I remember we considered this bill last November. How did this change?

Mr. T. STEVENSON. Mr. Speaker, the Senate felt that it was a violation, I believe, of the interstate commerce clause to

have two requirements in the bill that we approved, so we just deleted them; the Senate deleted them. Those requirements were requiring 50 percent of the below-the-line hires come from Pennsylvania residents and at least 50 percent of the filming days are done in Pennsylvania.

But what they did, they strengthened the bill in a way, and they are requiring at least 60 percent of the production expenses be done in Pennsylvania to qualify for the tax credit. So they have strengthened the bill, and you know, I feel they have weakened the bill, but they feel it is a violation of the interstate commerce clause.

Mr. SAMUELSON. Would this bill apply to both movies and television productions?

Mr. T. STEVENSON. Yes, Mr. Speaker. It applies to all feature film, television series, and television series of 15 minutes or more in length that are intended for a national audience.

Mr. SAMUELSON. In the news recently, there has been some discussion of MTV bringing the show "Real World" to the city of Philadelphia. Would they qualify for this tax credit to produce the "Real World" show on MTV?

Mr. T. STEVENSON. If that is longer than 15 minutes, it would qualify as a TV series.

Mr. SAMUELSON. Thank you, Mr. Speaker.

BILL ON CONCURRENCE IN SENATE AMENDMENTS

The House proceeded to consideration of concurrence in Senate amendments to **HB 2472, PN 4320,** entitled:

An Act amending he act of February 9, 1999 (P.L.1, No.1), known as the Capital Facilities Debt Enabling Act, adding and amending definitions; and further providing for borrowing limitations, for bond terms and conditions, for the Capital Debt Fund, for registration of bonds, for appropriation for and limitation on redevelopment assistance capital projects and for funding and administration of redevelopment assistance capital projects.

On the question,

Will the House concur in Senate amendments?

The SPEAKER. It is moved by the gentleman, Mr. Evans, that the House do concur in those amendments, and on that question, the Chair recognizes the gentleman, Mr. Eachus.

Mr. EACHUS. Thank you, Mr. Speaker.

Once again I would like to refer members to page 16 of this bill on concurrence, referring to costs, sections (c) and (d). Those would be lines 19 through 26. Mr. Speaker, I am concerned that the removal of professional services and the proportional requirements for State and non-State share within this language inserted just 40 minutes ago in the Senate could have a deleterious effect on prevailing wage.

Mr. Speaker, I truly believe that redevelopment assistance projects are fundamentally design and construction projects, and there should never be a situation where tax-exempt bond projects are used for either soft money and/or land acquisition.

Mr. Speaker, if the legislative intent of this language is to circumvent current prevailing wage laws and allow for some scheme to be able to purchase land and avoid construction costs associated with prevailing wage, it would be deeply concerning to many of our workers and construction trade workers around the Commonwealth, and I wanted to make sure I made that clear for the record this evening.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Beaver, Mr. Veon.

Mr. VEON. Thank you, Mr. Speaker.

Mr. Speaker, I would join with the gentleman in expressing tremendous concern about this provision that he articulated in this law, and there is no question in my mind that this is a sneak attack by the Republican members of the State Senate on the prevailing wage law. I do not think it is any secret that over the last 3 or 4 months there had been an effort to try to get this administration to back away from strict adherence and strict enforcement of the prevailing wage law, and for many of us who have been strong advocates of that law for many, many years, this provision raises great concern.

And as the gentleman described, if you look at those sections in this law, in my judgment, it is clearly an attempt, clearly an attempt, to circumvent, to allow for the circumvention of the prevailing wage law, and the section would allow that circumvention by allowing the State money that would be provided by the redevelopment assistance bill that will pass this House in a few moments to be used for soft costs, such as design, professional services, and land, and separate those soft costs out using State money for the soft costs, and then take the private money also involved in that project for the construction and, in my judgment at least, attempt to allow the private money applied for construction to then be non-prevailing-wage project.

Mr. Speaker, I just want to make it clear that I am going to vote for this bill, but I am going to work very hard with the Secretary of Labor and Industry, the officials in the Department of Labor and Industry, with the Governor himself, with the staff in the Governor's Office, to do everything possible to make sure that everybody involved understands that redevelopment assistance program is a program that fundamentally is a design and construction program, and you should not be allowed to lay off all of the State costs on the soft side simply as a way to circumvent the prevailing wage law, and if that effort and attempt is made, then I know that I will be back in this legislature very quickly to try to make sure that that cannot happen under Pennsylvania State law.

Mr. Speaker, with those concerns expressed, I do recognize that there is a tremendous amount of money involved here for capital projects, and I am going to vote for this bill and encourage you to do the same.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

I had an amendment filed to HB 2472. I am wondering if there is any way that I could offer that amendment, quickly.

The SPEAKER. It is our understanding, Ms. Bard, that your amendment was drawn to a prior printer's number. It would necessitate you sending it up to the Reference Bureau and having it redrafted.

I am sorry, and plus you would have to suspend the rules, and I do not think the crowd out there is of a mind to do that for you.

Ms. BARD. We could suspend the rules? I am sorry. I did not hear you, Mr. Speaker.

The SPEAKER. I am not so sure that the crowd out there is of a mind to suspend the rules for you, but you could try it.

Ms. BARD. Thank you, Mr. Speaker.

This amendment would continue the procedures that have been followed recently in State government where State buildings are green certified to meet LEED (Leadership in Energy and Environmental Design) standards, and this amendment would require that of expenditures of State moneys.

The SPEAKER. Maybe I did not say what I should have properly.

First off, your amendment is drafted to the wrong printer's number. You would have to get it drafted to the correct

printer's number, 4320, and even if you have done that, you would have to suspend the rules to get that amendment to be brought up immediately.

Ms. BARD. All right. Thank you, Mr. Speaker.

Given the lateness of the hour and the indulgence of the members, I will forgo this and hopefully have an opportunity in the future.

Bills numbered and entitled as follows having been prepared for presentation to the Governor, and the same being correct, the titles were publicly read as follows:

HB 564, PN 4325

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, further providing for background checks of prospective employees; providing for optometric externs; further providing for management information reports, for reports to the Secretary of Education, for withholding of State appropriations, for delinquent taxes and appointment of collector, for power of board of school directors to reopen certain budgets, for referendum or public hearing required prior to construction or lease and for school police officers; providing for attendance at schools for the performing arts; further providing for cost of tuition and maintenance of certain exceptional children in approved institutions and for actual cost of tuition and maintenance of certain exceptional children in chartered schools for the sight and hearing impaired; providing for agreements with institutions of higher education; further providing for firefighter and emergency services training and for educational assistance program; adding provisions relating to character education program; establishing the Pennsylvania Athletic Oversight Committee; further providing for powers of charter schools, for charter school facilities, for causes for nonrenewal or termination of charter, for education empowerment districts, for mandate waiver program, for limitations on education empowerment districts and for election or appointment and term and organization of boards of trustees of community colleges; providing for Community College Nonmandated Capital Restricted Account; further providing for Board of Governors of the State System of Higher Education, for educational improvement tax credit, for small district assistance and for temporary special aid to school districts; providing for basic education funding for 2003-2004 school year and for payments on account of Limited English Proficiency programs; and further providing for payments to intermediate units, for special education payments to school districts, for Commonwealth reimbursements for charter schools and cyber charter schools and for Pennsylvania Accountability grants.

HB 2579, PN 4326

An Act to provide from the General Fund for the expenses of the Executive, Legislative and Judicial Departments of the Commonwealth, the public debt and for the public schools for the fiscal year July 1, 2004, to June 30, 2005, for certain institutions and organizations, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2004; to provide appropriations from the State Lottery Fund, the Energy Conservation and Assistance Fund, the Hazardous Material Response Fund, The State Stores Fund, the Milk Marketing Fund, the Home Investment Trust Fund, the Emergency Medical Services Operating Fund, the Tuition Payment Fund, the Banking Department Fund, the Firearm Records Check Fund, the Ben Franklin Technology Development Authority Fund, the Tobacco Settlement Fund, the Health Care Provider Retention Account and the Alternative Fuels Incentive Grant Fund to the Executive Department; to provide appropriations from the Judicial Computer System Augmentation Account to the Judicial Department for the fiscal year July 1, 2004, to June 30, 2005; to provide appropriations from the Motor License Fund for the fiscal year July 1, 2004, to June 30, 2005, for the proper operation of the several departments of the Commonwealth and the Pennsylvania State Police authorized to spend Motor License Fund moneys; to provide for the appropriation of Federal funds to the Executive Department of the Commonwealth and for the establishment of restricted receipt accounts for the fiscal year July 1, 2004, to June 30, 2005, and for the payment of bills remaining unpaid at the close of the fiscal year ending June 30, 2004; to provide for the additional appropriation of Federal and State funds from the General Fund, for the Executive and the Legislative Departments of the Commonwealth for the fiscal year July 1, 2003, to June 30, 2004, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2003.
