One of the things that is special about these girls is that many of them have played field hockey together since they were in second or third grade with the Rec Commission's team called the Weed Whackers. I want to tell you a little bit about the outstanding accomplishments of some of these team members before I let them go.

This year's senior captain is Kelly Fitzpatrick. She set two new State scoring records for most goals in one season – the number is 66 – and the most goals scored in a career, 155, which is outstanding work on the field.

Four of our seniors this year were named to high school All-Americans; again, the first team, Kelly Fitzpatrick and Brooke Hoffsmith; and the second team, Amy Bonenberger and Brianna Davies.

On that question, the Chair recognizes the gentleman, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

Would the maker of the bill stand for brief interrogation?

The SPEAKER. The gentleman, Mr. Kenney, indicates he will stand. The gentleman is in order and may proceed.

Mr. VITALI. Could we initially have a brief explanation of this bill?

Mr. KENNEY. Yes. Thank you, Mr. Speaker.

This bill creates the community Mental Health and Mental Retardation Program Services and Support Act within the Department of Public Welfare. The reason for the legislation is, working with groups throughout Pennsylvania, Arc (Advocacy & Resources for Citizens), Vision for EQuality, the Rehabilitation Facilities, organizations that are caring for our most vulnerable citizens, the mentally retarded and those with mental health, they wanted some assurances that every year they were not fighting to keep the funding they already had. And so what we propose is, not only with that funding that the previous year provided them, that we did not every budget season have to negotiate for a cost-of-living agreement; that this would be in place; every budget cycle this would be automatic.

Mr. VITALI. Okay. So this would be— For example, in the past several years, how much of an automatic cost increase would this have been?

Mr. KENNEY. As you know, the past couple years we have negotiated for about a 2-percent cost of living, and that was just simply through budget negotiations. So we have not guaranteed anything in this going forward.

Mr. VITALI. But if your legislation is in effect, I am trying to get a sense for how much would this yield to this particular line item every year. I am trying to get a sense for what we are guaranteeing.

Mr. KENNEY. I do not have the number to provide you. We are asking that it be indexed based on the Home Health Agency Market Basket Index, which is published by the Federal Register, but I am sorry, I do not have the dollar figure for you.

Mr. VITALI. Okay. And could you outline again what particular line item of the budget would be guaranteed this cost-of-living increase?

Mr. KENNEY. Within the Department of Public Welfare, the community MH/MR (mental health/mental retardation) programs budget line.

Mr. VITALI. Now, is there a reason for treating this particular line item different from, you know, the thousands—

Mr. KENNEY. Yeah.

Mr. VITALI. —of other line items in the budget? Why should this particular program get an automatic cost-of-living increase as opposed to all the other worthwhile programs in the budget?

Mr. KENNEY. There are other programs that are guaranteed increases that are already within the department. What we were trying to do is, as you know, this is a very vulnerable population, very difficult to maintain a work force, you know, in this environment, and as we continue to move to community services, moving these residents into the community programs, we thought it important that we assure that that work force can have some assurances that there will be adequate funding, you know, to address the concerns of the growing population of individuals with these disabilities.

Mr. VITALI. I just want to get it out now. It is my understanding that the Rendell administration opposes this bill. That is what was referenced in caucus. I just wanted to check that information.

Mr. KENNEY. This bill was before the Health and Human Services Committee. I have not heard that they oppose it. I know who supports it; as I said, the MH/MR program administrators, the Pennsylvania Association of Rehabilitation Facilities, the Pennsylvania Community Providers Association, the Mental Health Association of Pennsylvania, the Vision for EQuality, the Arc of Pennsylvania, but to answer your question—

Mr. VITALI. Please.

Mr. KENNEY. —I do not know where the Rendell administration stands.

Mr. VITALI. Okay. Thank you.

Mr. KENNEY. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Surra.

Mr. SURRA. Thank you, Mr. Speaker.

And I rise to support the Kenney legislation. Many of us, for a long time, have been trying to help give a little pay increase to our MH and MR providers and work force across the Commonwealth, but I just cannot sit here without saying something to remind this House of the hypocrisy that exists. The administration opposes this measure because it is going to be an increase in cost, and again, the only criticism I have of this legislation is, we should be doing this with the budget. We should not be passing the budget before we even have budget hearings.

Ask yourself this: How does this fit in with a cap spending limit on State government? How does this fit in with the Taxpayer's Bill of Rights that was all across our newspapers that was supported by many members in this body? It is a good program; something we have all supported; very necessary. But those two lines do not go in the same direction, Mr. Speaker, and I just want to point that out. Every day it is the same story. You cannot be for cutting taxes, capping growth, and increasing spending. Now, if we could print money like Washington, maybe we could be about that, but we cannot here in Pennsylvania. We have to have a balanced budget.

I just left a great press conference for a great organization, the Big Brothers and Big Sisters program, and we are going to work to try to put a \$5 million line item to make sure that that program is properly funded, and that program has great results. How does that fit into the Taxpayer's Bill of Rights scenario? So as we vote on these things and as we all stand up and pontificate, just keep that in mind.

LEAVE OF ABSENCE

The SPEAKER. The Chair returns to leaves of absence. The minority whip requests a leave of absence for the remainder of the week for the gentleman from Philadelphia, Mr. BLACKWELL. Without objection, that leave will be granted.

CONSIDERATION OF HB 1813 CONTINUED

The SPEAKER. The Chair recognizes the gentleman, Mr. Cappelli.

Mr. CAPPELLI. Thank you, Mr. Speaker.

Would the gentleman from Philadelphia stand for brief interrogation?

The SPEAKER. The gentleman is in order and may proceed.

Mr. CAPPELLI. Thank you, Mr. Speaker.

Mr. Speaker, do you have any figures or numbers on the number of community-based direct-care workers who are employed across the Commonwealth contractually through service agencies in counties?

Mr. KENNEY. No, I do not have those numbers.

Mr. CAPPELLI. Do you have any figures on the number of community-based MH/MR residents who have been transitioned back home and are residing in these community-based group homes?

Mr. KENNEY. Mr. Speaker, if you would just give me a second, we will look those up.

Mr. CAPPELLI. Thank you, Mr. Speaker.

Mr. KENNEY. Mr. Speaker, 208,000 people with mental illness are being served in community settings, with 2,256 patients still receiving care in 10 State facilities; 90,815 people with mental retardation are being served in community settings, with 1,473 residents still living in 6 State institutions. The community-based MH/MR services are now provided by a \$3 billion State and federally funded service system.

Mr. CAPPELLI. Thank you, Mr. Speaker.

So we have roughly 260,000 citizens being served in the community vis-à-vis community-based residential settings versus less than 5,000 being served through State hospitals and intermediate-care facilities. Is that accurate?

Mr. KENNEY. It is closer to 300,000 in the community and a little less than 5,000 in State institutions.

Mr. CAPPELLI. Thank you, Mr. Speaker.

Mr. Speaker, do you happen to know the average, statewide average hourly rate for a community-based direct-care worker in Pennsylvania?

Mr. KENNEY. The latest figures we have are, they make about \$8 and hour, about \$15,000 a year.

Mr. CAPPELLI. Would you know the, Mr. Speaker, would you know the average hourly wage or annual salary of their State Department of Welfare counterpart?

Mr. KENNEY. It is about twice the amount, about a little over \$15 an hour, which equates to double that salary.

Mr. CAPPELLI. Thank you, Mr. Speaker. That is very close to the figures that I have.

Lastly, Mr. Speaker, are you aware or do you have a percentage relative to the turnover rate annually for community-based direct-care workers?

Mr. KENNEY. Presently the latest figure we have on turnover is around 42 percent.

Mr. CAPPELLI. Thank you, Mr. Speaker. That concludes my interrogation.

If I could speak on the bill?

The SPEAKER. The gentleman is in order.

Mr. CAPPELLI. Thank you, Mr. Speaker.

I strongly rise in support of HB 1813 and want to commend Chairman Kenney for his leadership on this issue. We have fought mightily, since I arrived here in 2001, with three different administrations, two Republican and one Democrat, to try and provide these professionals, these men and women who work and have dedicated themselves to attendant care 24 hours a day, 7 days a week, in service to some of our most vulnerable citizens. And I firmly contend and have made this clear to Secretary Richman that if any department in this Commonwealth needs to prioritize its fiscal plan annually, it is the Department of Public Welfare.

Too many citizens who cannot take care of themselves are being left by the wayside. Those who suffer from mental health and mental retardation obviously cannot care for themselves, and when we are providing an average hourly rate of a mere \$8 an hour to men and women who are nutritionists, who are nurses, who are physical therapists, who are true professional attendants, this type of recompense, it is no wonder we are seeing the horrendous turnover rate annually of some 40 to 42 percent.

Mr. Speaker, I would ask that we support HB 1813 to ensure that the 260-plus-thousand citizens in this State who depend on quality care and their families can be assured of that care through a livable wage that the Kenney bill represents.

I thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Nailor.

Mr. NAILOR. Thank you very much, Mr. Speaker.

Clearly, there has been a trend in Pennsylvania to close our State facilities and to move these patients back into the community-based homes. The last couple of years for mental retardation, I know there have been increases of about 2 percent, but prior to that, I believe for the previous 3 years, there was nothing whatsoever given for the increased costs for providing these services for these very vulnerable people in our community.

These are citizens that, through no fault of their own, face some very serious challenges that many of us do not want to identify, we do not want to hear about; we just want to leave it alone and let it go away. But the State government does have a responsibility here, and I think this bill, HB 1813, addresses some of those responsibilities and commitments that State government should make.

Again, they are individuals who depend on us. Their families depend on us. They cannot turn this off at 4:30, their serious challenges, and they cannot take a weekend off. These families and these individuals and those that provide those services that we expect from them for these very vulnerable individuals do this on a daily basis, and I think as a State government we have a commitment, and I openly support HB 1813.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Petrone.

Mr. PETRONE. Thank you, Mr. Speaker.

Mr. Speaker, I rise in support of the Kenney legislation, and I commend Representative Kenney for pointing out a critical problem in this Commonwealth with the care of these people who so badly need help.

I have worked on legislation for loan forgiveness for MH/MR workers for 10 years. I have HB 49 in the Senate, which we pray will get action in this year, but I commend Representative Kenney and ask for everybody to support the bill and the needs of the people that are affected by this.

If they go back to the classroom and teach for more than a year, whether it be an emergency or whatever the purpose would be, then they would have to get into the procedure of certification, professional development, like any other teacher would, but if they are not going to teach, they do not have to go through the 180 hours of professional development.

So the teachers groups and the school boards I think agree on this now, and I am hoping that the legislature will concur with Representative Saylor in his legislation that we had worked on in our committee.
