STATEMENT BY MAJORITY LEADER

The SPEAKER. We are about to begin a very important day. Would the members please take their seats.

The Chair at this time recognizes the majority leader, the gentleman from Jefferson, Mr. Smith.

Mr. S. SMITH. Thank you, Mr. Speaker.

Mr. Speaker, as we move into the course of business today, I am going to make two motions that will allow us to proceed into, to resolve into the Committee of the Whole. Prior to actually making those motions, Mr. Speaker, I just wanted to share a couple comments about what we are dealing with here today.

Clearly, one of the most basic functions of government, one of the core functions that we all agree on, is protecting our communities, ensuring the safety of citizens, and that is really what we need to focus on today in this proposed Committee of the Whole. We will be sharing ideas, hopeful legislative solutions, aimed at stopping the wave of illegal activity and cold-blooded atrocities in various parts of this Commonwealth.

In the not too distant past, a police officer in Reading was killed; a State trooper in western Pennsylvania was shot and killed. It seems there are almost daily homicides in the city of Philadelphia. These, Mr. Speaker, are symptoms of a great problem we have within our community, within our society, and something that all of us, not just us sitting in this room today as the House of Representatives within the legislative branch, but us in the context of local authorities, Federal authorities, State authorities, that all of us must join together in trying to deal with.

It concerns me, Mr. Speaker, that in spite of this, that the city of Philadelphia has reduced their police force by more than 600 officers in the past 3 years. It concerns me, Mr. Speaker, that for some, the sole focus is to limit guns for everyone. I do not believe that is the answer. That is my personal opinion, and I have stated that on the record before.

To put some of those thoughts into perspective, Mr. Speaker, I wanted to just read into the record a letter I received from – an unsolicited; just one of those letters we get – it is from an individual named Tom. He happens to be from the city of Philadelphia, and it was dated September 22, 2006.

"On Tuesday September 26, 2006 Mayor Street will visit Harrisburg along with others demanding gun control, not people control. Some of these people are there because the notoriety's they will receive may help them gain offices they seek. Other for the same notorieties so they may continue to feed at the public..." trough "through government grants.

"But first let me tell you about me. I'm a 64-year-old black male who is a law-abiding citizen born and raised in Philadelphia. I have been shot at six times while on the job, I have a nephew, a police officer whose been shot, and a great nephew shot, luckily they both survived. I had two friends shot and killed during armed robberies, one at 58th at Whibby, and one at 50th at Woodland, so I know a little something about violence.

"There have been 280 people killed in Philadelphia so far this year and all the media and the various groups against this and that can say is blame the NRA, blame the hunters, blame the beer belly gun nuts and blame Harrisburg."

Parenthetically, some of us resemble that "beer belly gun nuts" statement. Back to this letter from Tom.

"But the Mayor, the politicians and the various groups against and for that and this are not addressing the real problems.

"No, I'm not talking about schools and jobs etc. We all know that's a problem and it will take dollars to fix. As Dwight Evan once said, no one wants to ask the taxpayer to pay higher taxes to fix this situation.

"I'm talking about illegal guns sold on the street and nothing is done. Drugs sold on almost every street and little is done. New guns laws is not going to have an impact on these crime in our state when over 99% of crimes committed are done with illegal guns by people who can not legally buy a gun. Ask Mayor Street and the others on Tuesday, or asked the Representatives from Philadelphia what actions have been taken against straw-gun purchases. Ask what charges have been filed in cases involving guns brought from Lou Pawn shop in Upper Darby used in crimes in Philadelphia.

"The NRA, Hunters, and red neck beer bellies are not given these criminals these guns so what is the city doing about those who are?

"Unlike the people who will holler and scream on Tuesday, I hope that you and the other state leaders will make decisions that will have a real impact on what's happening on the streets of our state. Go after the criminals that make our streets unsafe by selling drugs and illegal guns. Please share this with your co-Representatives.

I would note, Mr. Speaker, that he made reference in his letter to Lou's Pawn Shop, and I am informed, Mr. Speaker, that the Feds at the end of July have shut down this shop. They have cases pending, and I think that the point is very clear.

RULE 42 SUSPENDED

Mr. S. SMITH. It is time for us to act, Mr. Speaker, but the answers lie with prevention, enforcement, and sentencing and punishment. Mr. Speaker, this is an important subject we are about to discuss, and therefore, Mr. Speaker, I move that the portion of House rule 42 which provides that the Speaker shall leave the Chair after the formation of the Committee of the Whole be suspended so that the Speaker can continue to preside during such portions of the Committee of the Whole as he deems appropriate.

The SPEAKER. The Chair thanks the gentleman.

On the question,

Will the House agree to the motion?

The SPEAKER. The Chair recognizes the gentleman, Mr. Evans.

Mr. D. EVANS. Thank you, Mr. Speaker.

Mr. Speaker, I rise to support the majority leader in the motion that he is making, but I would also like to add some comments. Is that appropriate, Mr. Speaker?

The SPEAKER. The gentleman is in order.

Mr. D. EVANS. Thank you.

Mr. Speaker, I would like to first applaud the majority leader for the willingness on his part to have this type of discussion. I have talked to the majority leader personally and I have talked to him publicly about the need to have this discussion. I have said to him that we have not had this type of discussion in almost 11 years, and since that 11 years, there have been a lot of things that have occurred throughout the Commonwealth of Pennsylvania, and in those things that have occurred throughout the Commonwealth of Pennsylvania, it is, in my view, a responsibility that we all have to try to address these issues.

I believe, Mr. Speaker, that the primary responsibility of government is to ensure that safety and security is provided to the citizens of this State. I would like to repeat that. I believe, Mr. Speaker, that the primary responsibility is for safety and security of the people of the Commonwealth of Pennsylvania. If we look at the statistics, Mr. Speaker, it is clear to me that we have not been addressing that particular issue.

It is strange, Mr. Speaker, that as we look around in our various communities, it may be in Punxsutawney, may be in Williamsport, may be in Reading or Pittsburgh or York or Erie, or wherever it may be, we have a problem. Now, Mr. Speaker, we did not create this particular problem; we did not create this particular problem, but I do believe we have a responsibility to attempt to address this problem. I do not believe, Mr. Speaker, that we solely in this building can resolve that problem. I believe that families, I believe that churches, I believe that local community-based organizations, and people themselves have a part to play in attempting to reduce this particular problem we have.

I also believe, Mr. Speaker, that this is an epidemic, that although people will show you statistical information in terms of what is occurring, it is clear, Mr. Speaker, that we cannot hide bodies. If we look at statistical information, Franklin and Marshall, just the other day, Duquesne University, just the other day, if you look at the events that are occurring, we need to ask ourselves some serious questions as why is this happening.

Now, I have some ideas, like all of you have some ideas, and I believe we should talk about everything. I believe that everything should be on the table. The gentleman read a letter, but I will not read this letter to you, but it is a letter that says, "Fight Crime: Invest in Kids," and it is from – you probably have received it – it is from the various commissioners and district attorneys, and it lays out, Mr. Speaker, very specifically – and I will give this for the record – it lays out a strategy for fighting crime and violence.

I also have a letter here from the district attorney of Philadelphia County. I would like to provide that for the record, because that district attorney, in my view, and the Fight Crime: Invest in Kids basically are looking at a comprehensive approach. Anyone who knows, who attempts to deal with this particular issue, this issue will not be solved, whether we meet today or tomorrow, in one session. It will require short-term strategies and long-term strategies. It will require Republican strategies and Democratic strategies. It will require all of these different kinds of strategies, but what I hope, Mr. Speaker, is that we keep our minds open, that we really listen to each other, not as we sometimes have done in the past, but we really listen to each other, that we try not in any way to question anybody's motives or anybody's intent when they offer a particular proposal. Because a person puts a particular proposal on the table, it is not something that we suddenly say, they do not get it.

I would hope that the majority leader in terms of the things that he has expressed, that there is the willingness, that we all are open to recognize that we have a primary responsibility to provide safety and security, that we need not to take that lightly, that we need no longer to continue to suddenly say to ourselves, well, that is happening over here; it is not happening here, and I should not be concerned about it.

I have gone through the entire 110 proposals that we had, and there are some very good proposals in this package, and they come from both sides. So I think we should all be open to have this dialogue and discussion where we are not going to try to hide and face up to the fact that we have a problem and we have a responsibility to try to address that problem.

So, Mr. Speaker, I stand to support the majority leader in having this Committee of the Whole so we can have this discussion to try to make sure that every borough, every township, and every community is safe.

Thank you, Mr. Speaker.

STATEMENT BY MAJORITY LEADER

The SPEAKER. The Chair recognizes the gentleman from Jefferson, the majority leader, Mr. Smith.

Mr. S. SMITH. Thank you, Mr. Speaker.

As I prepare to make the second motion that actually resolves us into the Committee of the Whole – and within this motion you will hear a couple of time limits – I simply want to make a point before I make the motion, Mr. Speaker, that each of you have on your desk or have been provided with a binder with the summaries of the issues that are going to be provided, or be presented today, and there is a lot here.

Obviously, we do not have the luxury of talking about all of these issues in the greatest of detail, nor should we in this setting. This should be a setting where we talk about, you know, kind of the concept. Some of them are simple; some of them may be a little more complex. But I guess what I am saying, Mr. Speaker, is, while the motion will provide a time limit, I am asking you to be cognizant of those that might be behind you. There is an overall time limit on the length of the Committee of the Whole, and that if you are at the end of the line, I do not want people to feel that they are being shortchanged. So while there is a time limit being proposed, please try to be mindful that there are a lot of other members who may be coming behind you that would like to have a couple minutes to present their ideas and concepts on this, or during the course of this Committee of the Whole.

HOUSE RESOLVED ITSELF INTO A COMMITTEE OF THE WHOLE

Mr. S. SMITH. Mr. THOMAS. So, Mr. Speaker, is it my understanding that the two leaders are prepared to extend the time based on how this turns out?

The SPEAKER. If necessary, they will discuss it.

Mr. THOMAS. Okay, Mr. Speaker, because I think it is important for the record to reflect that it is almost myopic for us to think that we can deal with this problem in 1 day, and we all agree that it is a problem that has different faces to it. It is not just about law enforcement. It has to be about jobs and training; it has to be about family support; it has to be about strengthening the community. So it has more than one face to it, and it would be wrong for us to even try and resolve it today.
