I am here today to ask this House, this Assembly, to vote for HB 1795, which would designate the Powell Avenue Bridge in Millcreek Township, Erie County, as the S. Sgt. Jeremy R. Horton Memorial Bridge.

Staff Sergeant Horton was born 16 June 1979 to Timothy Horton of Fairview, Pennsylvania, and Gretchen S. Wittenburg Horton Miller of Millcreek, Pennsylvania, whom I became acquainted with through the American Legion Post 773, where she belongs to the American Legion Riders.

After graduating high school in 1997—

The SPEAKER. The gentleman will suspend.

Members will take their seats. Members will hold their conversations to a minimum.

Mr. HORNAMAN. After graduating high school in 1997, Jeremy enlisted in the U.S. Army as an infantryman. After basic training, AIT (advanced individual training), and airborne school at Fort Benning, he was assigned to Fort Bragg and married his high school sweetheart, Cristie Schock. He then proceeded to serve as a SAW (squad automatic weapon) gunner, a grenadier, and a fire team leader in the 2d Battalion, 504th Parachute Infantry Regiment, known as the "Devils in Baggy Pants."

Jeremy Horton was promoted to staff sergeant in March 2003 and deployed with the 2d Brigade, 1st Armored Division, to Iraq for Operation Iraqi Freedom. He joined Bravo Company, 2d Battalion, 6th Infantry, in June of that year, serving initially in the commander's personal security detachment before being selected as the 1st Platoon's weapons squad leader. His element operated in the Jisr Diyala sector and secured the Tuwaytha Nuclear Research Facility. In October he volunteered to be alpha section leader, commanding his first Bradley fighting vehicle.

You are probably waiting to hear a tale of an intense fire fight in which Staff Sergeant Horton sacrificed his life while saving the lives of all of his men. I do not have a story like that. Staff Sergeant Horton died near Al Iskandariyah, Iraq, when an improvised vehicle-borne explosive device did explode on May 21, 2004, while his convoy was stopped for another roadside bomb. But was Jeremy a hero? You better believe it. Like so many other young men, Jeremy volunteered and served his country well, believing in his call to duty. He was posthumously awarded the Bronze Star and Purple Heart.

Please join me in honoring this fine young patriot by voting for this legislation to name the Powell Avenue Bridge in his honor. Thank you.
