RESOLUTION PURSUANT TO RULE 35

Ms. McILVAINE SMITH called up HR 5, PN 21, entitled:

A Resolution designating October 3, 2007, as "Change a Light, Change the World Day" in Pennsylvania.

On the question,

Will the House adopt the resolution?

The SPEAKER pro tempore. On the resolution, the Chair recognizes the gentlelady, Representative McIlvaine Smith.

Ms. McILVAINE SMITH. Thank you, Madam Speaker.

Today House Democrats are taking the lead in making the State Capitol more energy-efficient. It has often been said that the journey of a thousand miles begins with a single step. What little step are you willing to take to help protect our environment and conserve our energy supplies?

Our journey to wean Pennsylvania off of oil from the Middle East and put us at the forefront of renewable, sustainable power began last week when we opened our special session on energy. Today I am asking my fellow House members to take another step towards our goal, a small step to be sure, but I think an important step. Today is the kickoff for the 2007 "Change a Light, Change the World" campaign by ENERGY STAR, a bright idea for cutting energy use and saving the environment.

All we are asked to do is change one light bulb in our home or office to an ENERGY STAR qualified compact fluorescent light bulb. No excuse for not doing that. On your desks you will find your own qualified fluorescent light bulb, and I want to add that no taxpayer money was used to purchase these light bulbs. They came out of my own pocket. It is a gift from me to you, a gift that I hope will help wean you off of ordinary light and encourage you to use these energy-efficient fluorescent bulbs.

I am also offering HR 5, which I hope all of you will support, to encourage all Pennsylvanians to get involved in the "Change a Light, Change the World" campaign and take the pledge to change just one light with a qualified compact fluorescent light bulb.

This little light bulb is a powerhouse in helping to save energy. It uses about 75 percent less energy than standard incandescent bulbs and lasts up to 10 times longer. It saves about \$30 in electricity costs over its lifetime and produces about 75 percent less heat than regular light bulbs. So it is safer to use and can cut energy costs associated with home and office cooling.

If every American home replaced just one light bulb with an ENERGY STAR qualified bulb, we would save energy enough to light more than 3 million homes for a year, we would save more than \$600 million in annual energy costs, and we would cut greenhouse gases equivalent to the emissions of more than 800,000 cars.

Our journey to make Pennsylvania more energy independent and wean this State off of oil from the Middle East will be a journey of many little steps like the one I am asking you to take right now.
