ALLAN McCUSKER INTRODUCED

The SPEAKER pro tempore. Members, kindly take your seats. We have a solemn and reverent moment that we are going to be recognizing here.

Representative George and Representative Conklin both seek recognition over this matter. So, members, kindly take your seats. Clear the aisles. Staff, please be seated.

Mr. George.

Mr. GEORGE. Thank you, Mr. Speaker.

Mr. Speaker, we would be much obliged if you would recognize me at session's start. If now is appropriate, we would like to recognize Allan McCusker of Clearfield County. He is the widower of Marilyn McCusker, the first woman miner killed in a deep-mine accident in the United States. Representative Conklin also would hope to be able to make a few remarks, and I await your agreement.

The SPEAKER pro tempore. The gentleman is in order and may proceed.

Mr. GEORGE. Thank you, Mr. Speaker.

Representative Scott Conklin and I are proud to introduce to you a gentleman from Clearfield County, namely Allan McCusker, who is in the chamber today.

On October 2, 1979, Mr. McCusker's wife, Marilyn, was the first woman coal miner to lose her life in a United States deep-mine accident. She was 35 years old. But the story is much more than just the ending; it is about determination, hardship, and the indomitable human spirit.

Mrs. McCusker had almost 2 years' mining experience, including as a roof-bolter helper. She became a miner because the pay was better than what the local garment factories were paying. Despite her experience and determination, Mrs. McCusker and two other women, Mary Louise Carson and Bernice Dombroski, were forced to file a Federal

sex discrimination lawsuit to be able to work in the mine. It took years, but they won their lawsuit, and by 1983, almost 34,000 women were working in the mines in this great country of ours. But in October of 1979, Mrs. McCusker, working as a roof bolter, began to leave the Rushton Mine in Centre County because she noticed that the roof was giving way. The roof fell before she could leave, pinning her under a huge slab. Investigators cited the mine operator's failure to support a weak section with temporary roof supports until permanent supports could be installed. It was a lapse in safety, a compromise, that cost Marilyn McCusker her life and Allan McCusker his wife.

Through all the reports through all the years, the families' dignity and determination shine through all of this.

Would the members please stand and join us in welcoming Mr. McCusker into this body.

And now, Mr. Speaker, with your permission, if I may turn this podium over to my young colleague, Representative Conklin, who will continue.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman, Mr. Conklin.

Mr. CONKLIN. Thank you, Mr. Speaker. Thank you, Chairman George.

I think it is very important today as we take up SB 949, the Senate bill that will give safety to miners throughout Pennsylvania, I think it is more important though that we recognize someone who has not been forgotten, Marilyn McCusker, and I think that we should all together put a face on not only that name that was lost that day in the mines but also look at the faces of the individual families that are left behind when they lose a loved one when they go into the mines for no other reason, as Mrs. McCusker did, to make more money to support her family.

So I would like to thank the members today for allowing us to take this time. I would like to thank Allan McCusker for coming down today and honoring us with his presence. But most of all, I would like to thank and worship the memory of his wife, for she was the trailblazer that not only brought women into that workplace but also gave us a reason to do what we are doing today.

Thank you, members. Thank you, Mr. Speaker.

Ladies and gentlemen of the House, it gives me great honor today to welcome a young woman who, through her own personal growth and perseverance, has risen to a level of excellence few achieve. A resident of the Broomall section of Marple Township in Delaware County, Pennsylvania, a graduate student of the University of Pennsylvania's Fels School of Government, I would like to introduce Miss Pennsylvania 2007, Miss Rachel Brooks.

Also with Rachel is her proud mother, Julia Brooks. Julia, please rise.

Throughout the Miss Pennsylvania competition, Miss Brooks has clearly demonstrated a determination and drive to succeed that few young women possess. She is indeed a worthy ambassador of the Commonwealth of Pennsylvania.

Her humanitarian mission is to be commended. Miss Brooks, who has personal experience with autism, ran on the platform of "Autism Awareness: Unlocking the Mystery." She plans to pursue a career in public service and private consulting. She is currently on leave as a research analyst with an economic consulting firm in Philadelphia.

As Miss Pennsylvania, Miss Brooks won a \$7,000 scholarship and had the opportunity to represent the Commonwealth in the 2008 Miss America Pageant in Las Vegas, which she did with distinction.

Please join me again in congratulating Rachel Brooks on achieving the title of Miss Pennsylvania 2007 and her excellent volunteer work on behalf of those afflicted with autism.

Ladies and gentlemen, Miss Pennsylvania.

Miss BROOKS. Well, thank you so much to Representative Adolph for how he has been a tireless advocate for all of us in our part of Delaware County here in Harrisburg. And I would also like to say a thank you to each and every one of you who are here, who are a part of this legislative body, for passing, unanimously, HB 1150, the bill that, hopefully if your colleagues in the Senate pass that through as well, will provide health insurance coverage in the private sector for so many of the young people in the State of Pennsylvania who are affected and afflicted with autism.

I have a younger brother. His name is Brandon, and he was diagnosed with autism before the age of 2. He is 19 now and doing very well, but he is one of the thousands of children who will be impacted by HB 1150. So I thank you all so much for being our advocates.

And I would like to give a special thank-you also – I do not know if he is still here – but to Speaker O'Brien. As all of you know, he has just been a tireless advocate for all of us in the

autism community. I have literally crisscrossed the State, been everywhere from Meadville to Media and everywhere in between, and have crossed his path at every point. If I am at an autism-related event, whether it is fundraising or an advocacy event, he has always been there and has been our champion, and so I thank him so much for that.

But I also ask that you remember, health care is only one piece of the autism puzzle. As you are advocating for education and health care and for housing and employment, please remember our community, as well, so that folks with autism, whether they are children or adults, can participate in all the promises that we have for all Pennsylvanians.

So thank you, again, and please continue to support the autism community.

Carly is a member of the National Honor Society; she is on the honor roll and will attend Syracuse University next fall where she will study education. Her biggest interest outside of school and sports is Camp Bournelyf, a nonprofit camp for mentally challenged kids. Carly donates time as a camp counselor, and her dedication to the camp will be felt for years to come; for her senior project, she and a friend organized an auction for the camp, raising over \$5,000. The camp will make the auction an annual event.

Our four young men are all members of the West Chester Henderson High School Boys Swim Team.

Andrew Fink, a senior, was named an All-American 16 times in individual and relay swimming events. He won a gold medal in the 100-yard freestyle, a silver in the 200-yard freestyle, and was named Swimmer of the Year by the daily local news. Andrew is a history buff and looks forward to continuing his academic and athletic career at North Carolina State University in the fall, where he will major in history and pursue a teaching career, and what an inspiring teacher you will make, Andrew.

Dave Baldino, a junior, qualified for a junior national event and received an All-Area Honorable Mention for swimming. In addition to being an accomplished swimmer, Dave is also an honor roll student involved in several community service organizations, is the lead singer in a reggae/rock band, and is pondering attending a military academy. He attended the last Super Bowl as an avid New York Giants fan, but do not worry, Dave, we will not hold that against you.

David McCormick is a sophomore, and sports is in his blood – literally. His dad, Ken McCormick, is the athletic director of Henderson High School. His mom also works there, so David, I am sure, is always on his best behavior. David started swimming at age 6. He won the Lynne Hamelton Outstanding Eighth Grade Health Student at Peirce Middle School, qualified for two junior national events, is an honor roll student, and is ranked 32d in his sophomore class of 340 students.

Andrew Kosic is a freshman whose journey to this point today really illustrates overcoming one's fears. When he started swimming at age 7, he hated putting his face in the water. Today, Andrew is nationally ranked in USS swimming (United States Swimming) in the 13-to-14 age group for 50-yard freestyle and won numerous awards for USS Club Team and Summer Swim Club. He qualified for five junior national events, is an All-Area First Team in swimming, and won the Lynne Hamelton Outstanding Eighth Grade Health Student at Peirce Middle School. Not bad for a kid who did not want to get his face wet.

Collectively, these young men won gold medals in two relay events – the 200-yard freestyle relay and the 400-yard freestyle relay at the Class AAA State Swimming and Diving Championships. Their time in the 400-yard freestyle relay was the seventh fastest in the nation during the 2007-2008 season.

Joining our athletes are athletic director Ken McCormick, who is in the back; swim team coach Jeff Bott; assistant swim team coach Kim Lewis; and indoor track coach Bill Lott. Please join me in applauding the athletic accomplishments of these students and honoring them for living their lives in such a way as to be an inspiration to all of us.

THE SPEAKER (DENNIS M. O'BRIEN) PRESIDING

The SPEAKER. The Chair recognizes Representative Reichley on the motion to suspend.

Mr. REICHLEY. Thank you, Mr. Speaker.

The SPEAKER. If the gentleman will suspend for one moment.

The Chair will ask all members to take their seats. Conferences in the rear, in the well, and in the side aisles and center aisle will break up immediately. Members will take their seats

The Chair thanks the members. Representative Reichley is in order and may proceed.

Mr. REICHLEY. Thank you, Mr. Speaker, for gaining the members' attention.

Mr. Speaker, during the course of our debate last week on SB 1278, it became obvious there were very relevant concerns about the source of the, supposedly, federally mandated collection fee that must be associated with support payments. Representative Harper felt very strongly that this should not come from the custodial parent as the bill is currently drafted. Representative Maher brought out the fact that, in fact, the Federal legislation allows the State to choose from either the custodial parent, the noncustodial parent, or the State finances.

As we have that third possibility, I am asking the members to at least suspend the rules to consider allowing an amendment to the language of the bill as it is to switch the source of collection of that \$25 mandated fee from the custodial parent, by and large the mother, in most cases, to the noncustodial parent, the parent who is actually paying the support.

I was at a rally earlier today, along with Representative McIlvaine Smith, in support of a COLA (cost-of-living adjustment) for mental health and mental retardation workers. There are numerous causes that many of the members of the House and the Senate are going to be advocating for, which will cost at least the \$2 million that would be saved by the imposition of this fee on the noncustodial parent.

So I am asking for the willingness and consideration of the members to at least suspend the rules so we can debate this and shift the collection source from the party which is the most able to pay, that being the noncustodial parent, the person paying the child support in the first place.

Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes the majority whip, on behalf of the majority leader.

Mr. McCALL. Thank you, Mr. Speaker.

Mr. Speaker, this is an extremely important bill. The Federal government has written to us, has called us, and asked us to immediately act on legislation or we jeopardize \$800 million in Federal reimbursement.

I would simply say we need to put this bill on the Governor's desk, and I would ask that we do not suspend the rules and that we immediately move to get this bill, on third consideration, passed and on the Governor's desk.

So I would ask the members to vote "no" on the suspension of the rules.

The SPEAKER. The Chair will remind the members, this motion is debatable by the majority and minority leaders and the maker of the motion.

Representative Smith.

Mr. S. SMITH. Thank you, Mr. Speaker.

Mr. Speaker, I would urge the members to support the suspension of the rules. Elements of this bill have been debated previously, and while no one disagrees that there is some level of urgency for implementing this legislation to comply with changes at the Federal level, it is interesting that that sense of urgency was not expressed by the administration when they delayed notifying the legislature – notifying us – of the need for

It seems apparent that this has been known to some people for quite some time, yet it was really only brought to the attention of the legislature, at least to my knowledge, just maybe in the last month and a half to 2 months. So when you are talking about moving legislation that is sensitive and impacts people in the way that this legislation potentially does, some good and some bad, Mr. Speaker, I do not disagree that there is a sense of urgency for moving this.

However, the fact that the administration waited to try to apply the crisis of time, that we had to have this done by a month or so ago, which we have already missed that deadline – this House had passed legislation in time for that deadline; it was not acted on – the fact is, we have already missed the deadline. The fact is, we are moving forward on legislation that will address the concerns that are put forth by the Federal government. Whether this becomes law today or tomorrow, though, Mr. Speaker, is not going to change those facts. We have already missed that deadline. If we were going to be subject to some sanction by the Federal government, we are already subject to it and just have not felt the pain.

We are moving forward; that is clear. The record shows that. I think that the compromise embodied in this amendment is practical and worthwhile and would urge the members to support the motion to suspend. Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes Representative Reichley for the second time.

Mr. REICHLEY. Thank you, Mr. Speaker.

Just to amplify upon the remarks of the gentleman from Jefferson, the members of the House did not create the imperative that this legislation be passed; that is of the administration's doing. They dragged their feet for months and months. This has been something which was made evident to the administration some time ago.

A bill was passed – Representative Caltagirone's bill – was passed in this chamber, I think more than 2 months ago, and then we recessed without any further action. It is sitting in the Senate. That bill could be taken up by the Senate, but I think, based upon the level of commentary last week when this bill was debated, the members have an opportunity to be able to say to their constituents, we are not taking the \$25 from those people who are the least able to afford it. We are not going to deprive money that we want to put into COLAs for MH/MR (mental health/mental retardation) workers or other kinds of programs which we feel valuable in the State budget. This is a responsible way of addressing the concerns of the Federal government, doing it in a timely fashion. The world will not fall apart if we do not move to final passage on the bill as it is written today. I think the members should be sensible in looking at what the true source of the funds is – that is, the noncustodial parent, the person paying the support – and have that person be assessed with a \$25 fee, not the mothers, primarily, of the children, who are the ones trying to get by, sometimes on very limited support.

If the noncustodial parent is not paying the support, how do you then say to these same people, we want the \$25 from you even though you did not get the support? So I think the members really have a very clear and easy choice here: Vote to suspend the rules so you can move forward on this amendment, and move that forward so the administration can take the responsible step.

Thank you, Mr. Speaker.

The SPEAKER. On the motion to suspend, Representative McCall.

Mr. McCALL. Very briefly, Mr. Speaker.

Mr. Speaker, we have been put on notice by the Federal government that we have to act. The reality is that we had this debate on this legislation last week or 2 weeks ago, and the Senate sent over a bill, without the amendments that you are trying to include in this legislation, because they fully understand the importance of getting this bill to the Governor's desk and acted upon.

And with all due respect, the reality is that our staff has been meeting – including the Republican staff – has been meeting and has met with the administration, as early as September 2007, explaining the urgency and the need to get this legislation passed, not only on this issue but a myriad of other issues relative to the Department of Public Welfare and what their needs are in this budget.

But the reality is that, specifically, this bill was talked about in 2007, September 2007, its importance and its need to pass this General Assembly so this State does not lose \$800 million in reimbursement, so we are not sanctioned. As a matter of fact, if we do not do it now, we are going to start losing our monthly payments right now. March 31 was the actual deadline that we faced.

Mr. Speaker, it is important. The Senate, understanding and realizing the importance, sent this bill over unamended so we could send it right to the Governor. I would urge the members to vote "no" on the suspension of the rules.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

(Bill analysis was read.)

The SPEAKER. The question is, shall the bill pass finally?

The Chair recognizes Representative Harper.

Ms. HARPER. Thank you, Mr. Speaker.

Well, it is indeed unfortunate that we did not go with the suggestion made on the floor last week by Representative Thomas to amend the bill, but since we did not, I am forced to remind my colleagues what it is we are voting on today.

If you have signed a taxpayer pledge not to raise taxes or enact new taxes, you should vote "no" on this bill, because it is a new tax on moms and children receiving child support.

Mr. Speaker, am I in order to speak on the bill?

The SPEAKER. The lady was recognized to speak on the bill.

If the lady will suspend for one moment.

Ms. HARPER. Thank you.

The SPEAKER. The Chair will ask the members to please reduce the noise level. The noise level is entirely too loud. The Chair will ask members to take their seats. The lady is entitled to be heard.

Representative Harper.

Ms. HARPER. Thank you, Mr. Speaker.

And with all due respect to my colleagues on the other side of the aisle, the House has already passed a bill by a near perfect majority which does not contain the fee but which does meet all of the Federal requirements. That bill is sitting in the Senate. The Senate could vote that bill this afternoon and send it to the Governor's desk.

I would also remind my colleagues that Pennsylvania receives, from the Federal government, \$175 million from the Federal government to collect child support. The fee raises between \$2 million and \$3 million. There is no reason to take this fee out of the child support that children are receiving; we can take this fee from the money that the Federal government sends to us. There is no reason to enact a new tax on mothers and children, and I would urge my colleagues to vote "no." We can comply with the Federal government's requirements by asking the Senate to pass the House version of this bill, which we passed before the March 31 deadline.

I would also like to remind my colleagues that the cost of this bill, the \$2 1/2 million, can easily be borne by the Commonwealth's money from the Federal government or perhaps some other source. Our budget this year will be \$27 billion; that is \$27 billion with a "b." Two and a half million dollars is a significant sum, but it is not a significant sum when compared to our total budget. In fact, it is not even a significant sum when compared to the amount of money we have set aside last year and this year for the film industry. We have \$70 million for the film industry, and we cannot spare \$2 1/2 million for children receiving child support? These children are not getting a government benefit like the film industry. This is money from their own parents. We are taking it from them.

This morning on my way to the Capitol, I had to fill up my car. It cost me more than \$25. What is \$25 worth to you? What is it worth to a mother struggling to provide for children? We have 169,000 families who will be affected by this bill – 169,000 mothers, 169,000 fathers – and with an average of 2 children per family, about a million Pennsylvanians affected by the vote you are about to take.

I would urge you to vote "no," to understand what you are doing, to realize that the bill that takes care of this problem has been sitting in the Senate for weeks now. You do not have to take this from mothers and children.

Now, Mr. Speaker, I would like to direct my remarks to anyone in the hall who is a mother, anyone in the hall who has a mother, anyone in the hall who sent a sappy card to somebody praising mothers. I want you to think about what you are doing today to mothers. You do not need to do this to mothers. Please vote "no" on this bill.

Thank you very much, Mr. Speaker.

The previous language has asserted that this would be within 2 hours, and it is our contention and the perspective of our brothers and sisters in the United Mine Workers that it should happen immediately, not within 2 hours. The metaphor that was used in some of our dialogues, historically, was that an airplane pilot would take a very, very aggressive view of his or her aircraft immediately, not 2 hours into the flight.

Now, whether that metaphor is satisfactory to some of the men and women in this room or not, it makes perfect sense that these trailing cables be inspected immediately at the commencement of the shift. Therefore, that is the motivation behind this amendment.

The SPEAKER. Donovan, on behalf of the General Assembly, we recognize that you are a great individual, an upstanding citizen, but more importantly, I think it is important for us to recognize athletes who give back and participate in identifying, passionately, causes that they are for, so they can

rally the citizenry around that cause. So, Donovan, thank you for not only what do you as an individual and what you do for the Philadelphia Eagles but also for advancing these important health-care issues. Thank you very much.

For what purpose does the gentleman, Representative Solobay, rise? There is only one team in order today, the Chair will remind the members.

Mr. SOLOBAY. Thank you, Mr. Speaker.

But just to correct the record, if I may. I believe you said the Philadelphia Eagles' next Super Bowl quarterback; you got to win one first before you can have a next one, Mr. Speaker.

The SPEAKER. The gentleman is out of order, and the Chair will instruct the Parliamentarian to strike that from the record. We have serious business we have to get back to now.

THE SPEAKER PRO TEMPORE (JOSEPH A. PETRARCA) PRESIDING

CONSIDERATION OF SB 949 CONTINUED

The SPEAKER pro tempore. Returning to SB 949.

On the question recurring,

Will the House agree to the bill on second consideration as amended?

Mr. **HUTCHINSON** offered the following amendment No. **A06681:**

Amend Sec. 104, page 18, lines 4 and 5, by striking out all of said lines

On the question,

Will the House agree to the amendment?

AMENDMENT WITHDRAWN

The SPEAKER pro tempore. Representative Hutchinson.

Mr. HUTCHINSON. Mr. Speaker, I would like to withdraw that amendment.

The SPEAKER pro tempore. The Chair thanks the gentleman.

Mr. HUTCHINSON. And my other amendments.

On the question recurring,

Will the House agree to the bill on second consideration as amended?

Mr. **REED** offered the following amendment No. **A06682:**

Amend Sec. 108, page 29, line 16, by striking out "(A) FREQUENCY AND PURPOSE.—"

Amend Sec. 108, page 30, lines 5 through 25, by striking out all of said lines

On the question,

Will the House agree to the amendment?

AMENDMENT WITHDRAWN

The SPEAKER pro tempore. On the amendment, the Chair recognizes Representative Reed.

Mr. REED. Mr. Speaker, I would like to withdraw amendment A06682, but I would still, at the appropriate time, like to offer amendment A06729.

The SPEAKER pro tempore. This would be that time, Representative.

On the question recurring,

Will the House agree to the bill on second consideration as amended?

Mr. **REED** offered the following amendment No. **A06729:**

Amend Sec. 108, page 30, line 18, by striking out "CONCERNING HEALTH AND SAFETY AT THE MINE." and inserting

from the same mine concerning health and safety.

Amend Sec. 108, page 30, lines 22 through 25, by striking out "FOR PURPOSES OF THIS SUBSECTION, THE" in line 22 and all of lines 23 through 25

On the question,

Will the House agree to the amendment?

The SPEAKER pro tempore. Representative Reed.

Mr. REED. Thank you very much, Mr. Speaker.

Today truly is a landmark day in Pennsylvania, as we look to move forward with the revised and updated mine safety law, which will help to put our miners into a more safe environment in their workplace.

This amendment is quite simple and looks to enhance those safety efforts. When an inspector goes into a mine, they are afforded the opportunity to be escorted through that mine with a representative of the miners. This amendment would, quite simply, make sure that that miner's representative actually is a miner from the mine that they are inspecting.

The entire purpose of this amendment is to make sure that the miner's representative is familiar with the mine that they are taking the inspector around in and familiar with the different tunnels and different atmosphere and environment within the mine that the mine inspectors intend to make safe for all of the miners within that environment. I would ask for your support.

The SPEAKER pro tempore. The Chair thanks the gentleman.

The Chair recognizes the majority leader, Mr. DeWeese.

Mr. DeWEESE. Thank you, Mr. Speaker.

I would respectfully oppose the gentleman's amendment. I do not believe it does what he wants it to do. The amendment is not necessary and really does not accomplish what the sponsor intends. The amendment states that the department shall meet with no fewer than two miners from the same mine concerning health and safety when there is no authorized representative of the miners.

The current language, Mr. Speaker, of SB 949, approved by the Environmental Resources and Energy

Committee chaired by Bud George, already establishes that the department meet with no fewer than two miners concerning the health and safety of the mine. SB 949 does not, repeat, does not require or suggest that the department meet with the miners who are not employed at the mine. The purpose of meeting with miners when there is not an authorized representative of the miners is to allow miners to discuss any concerns they may

have with the DEP (Department of Environmental Protection) mine inspector.

I would argue that the gentleman's effort does not accomplish what he wants to accomplish, and it is with that perspective that I would ask for a negative vote.

The SPEAKER pro tempore. The minority leader, Representative Smith.

Mr. S. SMITH. Thank you, Mr. Speaker.

I would urge the members to support this amendment. I think the comments just made by the majority leader were a little bit circular in their argument in that the bill, as it is currently before us, would allow someone from a competing mine to have access on a walk-through with the inspector. I find that, Mr. Speaker, to be a little bit odd and not necessary.

The fact is, the people that are working in these deep mines – mines are very peculiar places to work. They are places that are unique to each other; in other words, they are not all the same. The purpose for this element of the law, this section of the law, obviously, is to allow an employee of the mine to be along with the inspector not only just for familiarity of what is going on, but also to help point out and respond to any of the issues, whether they just be solely on the safety side of things or others to allow for a line of communication and explanation of what is actually taking place at that particular point in the mine.

I think the problem here, Mr. Speaker, is that in anybody's given mind, to suggest that a miner, an employee of a competing company, should have that type of access is a little bit confounding to me. I believe the Reed amendment that is before us is there simply to clarify the fact that the mining employees – as opposed to the mining company management – that the mining company employees do have access to the inspector, do have time with the inspector as they are going through the mine but that that should not be open to just anybody who happens to be a miner somewhere in Pennsylvania.

I would urge the members, Mr. Speaker, to support this amendment. Clearly, if the majority leader is correct in his general assessment, there is clearly nothing about this amendment that takes away from the purpose of the bill or the intent of the bill. It just clarifies that the miner shall be an employee of that particular mine under inspection. I think it is a good amendment, Mr. Speaker, and urge the members to support it.

Thank you.

Mr. DeWEESE. Mr. Speaker?

The SPEAKER pro tempore. The Chair thanks the gentleman.

Representative DeWeese.

Mr. DeWEESE. The walkaround rights that we are asking for in this amendment are a part of the West Virginia coal-mining scene. The walkaround rights that we are discussing in this amendment are a part of the Federal coal-mining law. The amendment says, and I quote, "Where there is no authorized representative of the miners, the department shall meet with no fewer than two miners..." from the same mine "...concerning health and safety...."

The amendment does not even say anything about the walkaround rights. So ostensibly, they could have a meeting in the bathhouse or they could have a meeting at the conference table in the mine foreman's office, and they would not be walking through the mine. So the honorable gentleman, I believe, if he is trying to do what I think he is trying to do,

needs different language. This amendment does not do what the honorable gentleman wants to do. In fact, it would vitiate the dynamics of the proposal that miners be walking with inspectors in all of these different mine settings.

So I again, respectfully, would ask for a negative vote.

The SPEAKER pro tempore. The Chair thanks the gentleman.

Representative Pyle.

Mr. PYLE. Will the maker of the amendment please stand for interrogation?

The SPEAKER pro tempore. The gentleman indicates that he will.

Mr. PYLE. Thank you, Mr. Speaker.

Mr. Speaker, I have a question. How does this amendment address the quote, unquote, "walking-around rights"?

Mr. REED. Mr. Speaker, this amendment would actually not impact walkaround rights and the ability to have a miner's representative joining with the mine inspector during the inspection of the mine. In fact, this amendment does two very clear and two very distinct things: The first part of the amendment, which amends section 108, page 30, line 18, strikes out, quote, unquote, "concerning health and safety at the mine," and instead inserts "from the same mine concerning health and safety," which ensures that the miner's representative is actually an employee at that mine, which ensures that the miner's representative has actually been in that mine that they are supposed to tour the inspector through.

The second part of this amendment removes the reference to Federal statute, and by removing the reference to Federal statute, it then reverts back to the first part of SB 949. I will quote for you, on page 17 of this proposal, line 17, where we define "Representative of the miners" to be, "A miner employed at the mine who is authorized by a vote of two or more miners working at the same mine to perform the duties specified in this act." So what we are doing, there is a loophole in the Federal statute that could allow an outside miner to be taking the inspector around a mine they have never been in. By referencing the first part of SB 949 that was put forward by House Republicans, by House Democrats, by Senate Democrats, by Senate Republicans, by the DEP, by the administration, by representatives of the UMWA (United Mine Workers of America) and the Coal Association – they drafted that definition of a miner's representative.

We are going to ensure that that definition stands and there is no ambiguous interpretation of that definition by referencing Federal statute. So what we are actually ensuring is that the person who is afforded the walkaround rights, elected by the miners to be their representative, has actually been in that mine before. Let us be clear: If we are going to have an inspector traveling around these mines with the miner's representative, the safest and most appropriate way to do it is to provide complete clarity in this law that ensures that that miner has actually been in that mine before.

Mr. PYLE. Thank you, Mr. Speaker.

On the amendment, Mr. Speaker.

The SPEAKER pro tempore. The gentleman is in order.

Mr. PYLE. I am somewhat familiar with the geology of the Pennsylvania Commonwealth – a subject I taught for 13 years in our high school. It barely addresses the issue that the geology varies greatly in each of the corners of the State and the midstate. Mr. Speaker, I would think the Reed amendment would go a long way to assuring that each one of these

individual mines is being inspected by a person familiar with it, a.k.a. a localized miner from that individual operation.

It would seem both safer and more expedient for the sake of the mine inspectors for us to support the Reed amendment. Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman.

On the amendment, the Chair recognizes Representative George.

Mr. GEORGE. Thank you, Mr. Speaker.

Mr. Speaker, in no way do I intend to stand here and attempt to impugn any of those who have spoken or the maker of this amendment, and I believe that we all, no matter what we believe, we cherish the human life and what we can do to make their daily usage safe. Now, we can talk about many things, and it seems like maybe being a little older and working in a mine and seeing all the changes that have come by in 50 years and then recognizing, for some reason, that yet not enough has been done.

There should be no reason, there should be no cost prohibited, there should be no usage of influence that would change that. I insist, as the gentleman, Mr. DeWeese, has argued, that we are second to West Virginia, who has been, over the years, notorious in their lackluster means, but yet we fall behind them. What I am saying is that we should not, whether it is our spouse or our children or our parents or what, or who we are or where we are from, should we not be able to do what is best so that these miners, when they leave home in the morning, they return home at night immediately after the shift, not in a box a couple of hours later.

I am saying this amendment allows a company to be able to gain the matter of influence and be able to influence greatly some safety matter. I do not think that any of those who have spoken for this bill are not well meaning. I just insist, if it is your son, your daughter, your parent, you could not go to bed at night thinking that you did something to eliminate the possibility that you have saved that life, and I urge those members to make this personal, to believe this is we, ourselves, our families that are asking to go the whole way.

This harms nobody. That is the nice thing about the bill, but an amendment could, in some way. For that gentleman who provides this bill to insist that a man must be familiar, a man who has experience in the mining is familiar with a mine operation no matter which gob or which cavern that he is in, and so I say, without being personal or without being vindictive, this is not what we want to do with this bill. I ask us to vote "no" on this amendment. Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes Representative Daley.

Mr. DALEY. Thank you, Mr. Speaker.

As a grandson of coal miners, as a son of coal miners, as a legislator that represents a district that is peppered with coal miners, in both Washington and Fayette County, I think it is a great day in Pennsylvania that we are looking to protect the lives of coal miners throughout our State. Coal has played a dominant role in the economy of Pennsylvania and America, and without the coal miners of western Pennsylvania and central Pennsylvania and northeastern Pennsylvania, World War II would not have turned out the way it had.

The coal miners of western Pennsylvania and central Pennsylvania, as well as northeastern Pennsylvania, mined the anthracite coal that ran New York City and ran all the

shipbuilding that was going on, all the ships that were built with the munitions – that was created by the coal from western and central Pennsylvania.

Mr. Speaker, this is a great time in the lives of Pennsylvania coal miners, where we in the legislature take time to say, it is time that we really protect the rights and the health and safety of coal miners. I do not know how many of you have ever been down in a coal mine. I chaired the Coal Caucus for 16 years. We went down a wildcat mine in an anthracite region; in an open strip mine in an anthracite region; we were up in Representative Bud George's district for an open mine; we were down in the coal mines, 600 feet below southwestern Pennsylvania, where they had continuous miners and longwall miners that mine more coal in one day than a coal mine used to mine in a year.

And it is so important that we, as legislators, recognize how important the lives of coal miners are, like the Robena Mine, which had a disaster when I was a young man in seventh grade, and many men never came out of that mine that day. Then Marianna, Pennsylvania, in the early 1900s had a disaster where over 100 people were killed. Now, of course, we pay attention because of Quecreek and what goes on in West Virginia.

Coal was the driving factor of America. The companies and the miners have worked together for many years to make coal competitive with the rest of the natural resources in our country. This amendment does not accomplish it. In all respect to Mr. Reed, who I have tremendous respect for, it does not accomplish his intent. This amendment is not necessary. I ask that you vote "no," with all due respect to Mr. Reed.

But I want you to think about the health, safety, and welfare of the coal miners and their families and their children that attend the schools of Pennsylvania, that we have to protect their lives; it is absolutely paramount. Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman.

Representative Mahoney.

Mr. MAHONEY. Mr. Speaker, as a former coal miner in 1979, I went into the coal mines at the age of 21 years old. I might look a little big to be in the mines, but I did the job. It is a tough job to do. We have not addressed this problem since 1961. We need to address this problem because coal is our future; our future is coal. I want to tell you a little bit of a story about safety in the coal mines.

In 1980 I was coming out of the coal mine, we were coming out the main haulage—

The SPEAKER pro tempore. Will the gentleman suspend. Will the House please come to order and give the gentleman the courtesy of being heard. Members please take their seats.

Representative Mahoney.

Mr. MAHONEY. In 1980, when the shift was over, we were coming out the main haulage, and there was a fall in the main haulage. There were 22 of us trapped in the mine for 4 hours. We had to walk approximately 2 miles to an air shaft. We had to walk through water up to our chins. I believe it is time, and I know it is time, and I think this bill does address most of the problems in the coal mine for safety.

We need to make the miners feel safe underground, because coal is the future. It is going to be the future, and that is why I oppose this amendment. I think this bill needs to go for a vote now. Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman.

Are there any other members seeking recognition? The minority leader, Representative Smith.

Mr. S. SMITH. Thank you, Mr. Speaker.

Mr. Speaker, with all due respect to the issue before us, there is no one here that does not believe that the core of this bill, that the bulk of this bill is not something that is necessary. It is probably something that is a little bit overdue, but there have been a lot of people who put a lot of work into this bill, negotiating it between the various parties that are affected, from the mining companies to the labor side, to the environmental regulators, to those that deal with the safety side of it from DEP.

Mr. Speaker, we are very much in support of this legislation. The Reed amendment before us, Mr. Speaker, has to do with one small section of this bill. It has to do with who is permitted to walk around the mine when the inspectors – who are outsiders, those are the regulators – when they are in the mine. That is what it has to do with.

I believe, Mr. Speaker, that the men and women that are working in a particular mine are the people who have the most vested interest in that mine being safe. They are the people who are in that mine virtually every day. They are the ones who should be part of that inspection, as opposed to someone from another mine somewhere else in Pennsylvania.

Therefore, Mr. Speaker, I do not believe that this amendment does anything to reduce the safety value that is composed in this legislation. I think it ensures, Mr. Speaker, that those miners that are directly affected, whose livelihoods are taken out of that particular mine, are the individuals that should be allowed and afforded and guaranteed the opportunity to walk around with the inspectors.

That is the core of what this amendment does, Mr. Speaker. It does not reduce the overall effect of this legislation. It does not diminish it in any way. It merely protects that the men and women that are working in a mine get to decide who among them is going to walk with those inspectors, and that, I think, Mr. Speaker, is an improvement to this bill and something that we can all support. Thank you, Mr. Speaker.

The SPEAKER pro tempore. Representative DeWeese.

Mr. DeWEESE. Thank you, Mr. Speaker.

If the Reed amendment is adopted, people who work underground under collective-bargaining agreements will not have the same dynamics as they do under the bill that was brought forward from Chairman George's committee with an overwhelming vote. Two people at a mine could bring a person in to walk around with the inspector. In the words of the gentleman's amendment, 50 percent of the mine would have to decide upon a person to walk around with the inspector, and everybody motivated by the most minimal amount of common sense will agree that it would be almost impossible in a nonunion mine for over half of the workers there to agree on who was going to do the walking-around inspection.

So suddenly, the gentleman's proposal, I think, inures to the detriment of the United Mine Workers and all who work underground under collective-bargaining agreements. To the best of my knowledge, that is only the United Mine Workers, but it is not accidental that the UMWA opposes the gentleman's language. It is not accidental that many of his Republican colleagues helped as the bill came out of committee, and I would like to have it looking like it came out of committee, not the way it would be altered by my honorable friend with his amendment.

I, again, for the third time, respectfully and politely, would request a negative vote.

The SPEAKER pro tempore. The Chair thanks the gentleman.

For the second time, Representative Reed on the amendment. Mr. REED. Mr. Speaker, as we look at this issue, everyone is exactly right that it is time for Pennsylvania to come out of the Dark Ages when it comes to mine safety and our mine-safety statutes. I guess where we differ in opinions is that some of us have used this opportunity to debate whether you are for mine safety or against mine safety. That is not the debate before us today. The debate before us today is, what is the appropriate way to ensure that mine safety is at the forefront?

Some of us have looked at this issue in a number of different ways that are somewhat, in my opinion, inaccurate. This amendment is very simple. It actually ensures that the person leading a mine inspector through a mine has actually been in that mine. And when you think of it commonsense-wise, when your first priority is safety, why would you send a miner into a mine they have never been in, leading an inspector? You are putting that first miner's life in danger; you are putting that inspector's life in danger, before you have even started the inspection.

If you truly care about mine safety, what you need to do is begin with the folks inspecting the mines and the miner who is actually going to be taking them around. No miner's life should be more valuable than another miner's life, and that begins by ensuring that they actually have knowledge of where they are going in any given mine. This amendment does it. This amendment ensures that they are qualified and knowledgeable on where they are leading the inspector. Any evidence to the contrary is a vote against mine safety – putting a miner's life in danger, putting an inspector's life in danger, for no good purpose.

Mr. Speaker, I would ask for support of this amendment. Let us care about every single miner, not just the miners that we choose to. Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman.

On the question recurring, Will the House agree to the amendment?

The House proceeded to third consideration of **HB 1439**, **PN 2483**, entitled:

An Act amending the act of May 21, 1943 (P.L.571, No.254), known as The Fourth to Eighth Class and Selective County Assessment Law, further providing for appeals by municipalities.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER pro tempore. This bill has been considered on three different days and agreed to and is now on final passage.

(Bill analysis was read.)

The SPEAKER pro tempore. The question is, shall the bill pass finally?

The Chair recognizes the gentleman, Representative Seip. Mr. SEIP. Thank you, Mr. Speaker.

Mr. Speaker, HB 1439 will remedy a glitch that presently exists in the county tax code. This glitch creates an inequity in law that results in many people being treated differently in the Commonwealth. According to current law, people who have identical homes on identical lots of identical sizes, within the same school district, possibly right next door to each other, may be taxed at different rates. They may be taxed at different rates because of this technical glitch which allows spot appeals to occur.

Spot appeals, basically, are the same thing as a spot assessment. We all know that spot assessments are illegal and are not allowed under current law. However, spot appeals are allowable and continue as I speak. This practice occurs when an existing home is sold. The new owner may be singled out for an incredible tax increase if the district feels that they can siphon off enough money from the new owners through a spot appeal, while leaving other homes at the existing lower rate that everyone else pays – even those with identical homes, and again, possibly right next door to the one getting spot appealed.

Mr. Speaker, this is clearly not fair and was never intended to occur. Last year in Schuylkill County, there were 1500 appeals made. One hundred and sixty-eight were initiated by the property owners. The remaining 1332 appeals were almost exclusively initiated by the school district.

Mr. Speaker, I have folks in my district, retirees, that wanted to downsize. They wanted a smaller home, similar home on a smaller lot so that they could reduce their financial obligations. The result was a spot appeal. That spot appeal increased their taxes and caused them more financial hardship.

The SPEAKER pro tempore. Will the gentleman suspend. Will the House please come to order and show the gentleman courtesy.

Representative Seip.

Mr. SEIP. Thank you, Mr. Speaker.

Mr. Speaker, this type of inequity cannot continue. Let us not allow the school districts to just cherry-pick properties that they wish to raise taxes on. Let us return to a system where everybody is taxed the same by fixing this egregious glitch in the law. Also, if this practice of spot assessment is allowed to continue, it will only serve to discourage home buying. It will shun new people from wanting to move into our communities, and it will also serve to stifle economic development in our Commonwealth, which will only further burden the remaining taxpayers.

Mr. Speaker, this travesty is not just limited to homes. My fine colleague from Berks County, the gentleman that represents the Kutztown area, had a farm that was purchased and spot appealed. The result was a three-times-the-prior-rate increase in their taxes. It was over \$20,000 of an increase for that particular farm. We should be encouraging people to continue to farm. That is why the Farm Bureau and the Grange have supported this legislation. The realtors also support this legislation.

Mr. Speaker, I implore all of my colleagues to vote in favor of fairness and in favor of the taxpayers. I would encourage an affirmative vote on HB 1439. Thank you, Mr. Speaker.
