A Resolution designating the month of April 2009 as "Celiac Disease Awareness Month" in Pennsylvania.

On the question, Will the House adopt the resolution?

Mr. DALLY. Thank you, Mr. Speaker.

As is the case with much of the legislation we consider here, the idea to introduce a resolution to designate April as Celiac Disease Awareness Month was brought to me by a constituent. I had never heard the term "celiac disease" until I was contacted by Geoffrey Roche about introducing a resolution.

Celiac disease damages the small intestine and interferes with the absorption of nutrients from food. People who have this disease cannot tolerate gluten, a protein in wheat, rye, and barley. Gluten is found mainly in foods, but can also be found in products such as medicines, vitamins, and lip balms. Researchers have determined that celiac disease is a genetic or inherited condition. In some cases, it becomes active or is triggered by events such as surgery, pregnancy, childbirth, viral infection, or severe emotional stress.

One reason it is important to increase public awareness about this disease is that roughly one out of every 133 Americans has it, but 97 percent of them remain undiagnosed. This means that almost 3 million Americans have the disease, but only about 100,000 are aware of it. Left untreated, people with celiac disease can develop further complications such as other autoimmune diseases, osteoporosis, thyroid disease, and cancer.

I urge the members and those who might be watching on PCN (Pennsylvania Cable Network) to visit the National Foundation of Celiac Awareness Web site to learn more about this disease.

Thank you, Mr. Speaker, and I urge the members to vote affirmatively on HR 153. Thank you.

These women paved the way for others, like me, to not only have a voice through my vote in elections, but also to be able to hold elected office. When I look around this magnificent chamber, I am elated to see so many women participating in Pennsylvania State government. I want to thank you for having the courage to put yourselves out there to serve your communities and our Commonwealth. I believe Abigail Adams and the many women who fought for equal rights for women would be proud to see how far we have come. Thank you.

Today I stand before the chamber to present a resolution that designates March 2009 as Women's History Month in Pennsylvania, and I would like to, at this time, ask all of the ladies of the chamber to please come and stand with us.

This resolution serves to both honor and educate. It honors women of achievement in Pennsylvania and across the nation and to again bring their names to public notice so that the knowledge of their struggle continues to be passed on.

Crystal Bird Fauset and Jeannette Rankin were among the first fruits of a long struggle for political rights of women, a struggle that, as indicated by the ratio of male to female in this chamber, remains to be truly fulfilled. The torch has been passed to our generation of American women. Inspired by the courageous pioneers who came before me, I proudly honor their legacy. Today I stand here among the ranks of these great women legislators of this chamber. To my female colleagues in the Pennsylvania legislative General Assembly, today I honor you.

Women of strength, vision, and character have long influenced our country by contributing their time, effort, and wisdom to improve our government and communities, our school and religious institutions, our businesses and military, and the arts and sciences. And so, I implore you vote "yes" on this resolution.

A recent Kaiser poll reported that 29 percent of the females in America have said they have been pressured or coerced to engage in sexual activity they did not want. A 2001 article in the Journal of the American Medical Association reported that violent dating relationships in adolescence can have serious implications for victims. These implications include being at a higher risk for substance abuse, eating disorders, suicide, and adult revictimization.

Mr. Speaker, despite these statistics, a 2004 article in Women's Health magazine reported that 81 percent of parents

surveyed across America believe dating violence is not an issue at all. Given those facts, Mr. Speaker, it is clear that we must do all we can in our Commonwealth and across the nation to raise the collective awareness of sexual violence.

Mr. Speaker, I therefore respectfully urge my colleagues to join me in supporting this resolution. Thank you, Mr. Speaker.
