Mr. FRANKEL. Thank you, Mr. Speaker.

Today I have the privilege of calling up HR 394 to honor Pittsburgh Steelers' Chairman Dan Rooney, who on Thursday, June 25, 2009, was confirmed by the United States Senate to serve as our country's next Ambassador to Ireland. Dan Rooney is known throughout the United States and Ireland not only as the chairman of one of the NFL's (National Football League's) most successful franchises, but also as a man who has dedicated his time and energy to countless philanthropic causes.

In 1976, Dan Rooney cofounded the American Ireland Fund, an organization which to date has raised more than \$300 million for peace and education programs in Ireland. Dan later founded the annual prize for Irish literature in 1987 and cofounded the Ireland Institute of Pittsburgh in 1989. In 1993, the Rooney Fellowship was created to honor Dan's generosity and charitable works.

In March of 2009, Dan was nominated to serve as Ambassador to Ireland by President Barack Obama, who said, quote, "I am honored and grateful that such a dedicated and accomplished individual has agreed to serve as the representative of the United States to the Irish people. Dan Rooney is an unwavering supporter of Irish peace, culture, and education, and I have every confidence that he...will ensure America's continued close and unique partnership with Ireland in the years ahead."

In order to serve our country, Dan Rooney will relinquish his position with the Pittsburgh Steelers, a team which has won a record six Super Bowls, the most recent win coming in Super Bowl XLIII against the overmatched Arizona Cardinals in February of this year.

So as our friend Dan Rooney begins his new career as the United States Ambassador to Ireland, I hope we can all take a moment to congratulate him on his appointment and wish him the best of luck in his new career, and I would ask for your affirmative vote on HR 394. Thank you, Mr. Speaker.
