#### SB 66, PN 197

An Act amending the act of June 27, 1996 (P.L.403, No.58), known as the Community and Economic Development Enhancement Act, codifying the State Tax Equalization Board into the act; further providing for creation of board, for membership, for general powers and duties and for common level ratio; providing for publication of information by board funding contingency; and making a related repeal.

The SPEAKER. If I could have the members' attention, I would appreciate it. Clear the aisles, and I appreciate the members taking their seats. I would appreciate if the members would kindly take their seats.

We have a few other guests that are with us today, and I think they warrant our undivided attention. I appreciate the members' attention.

Located to the left of the rostrum, I would like to welcome a number of guests of Representative Aument, Representative Miccarelli, and Representative Murt, who are here in recognition of the 10th anniversary of Operation Iraqi Freedom. From the Pennsylvania National Guard are Brigadier General Gronski, Command Sergeant Major Kepner, and Captain Perino. Will those gentlemen please rise. Welcome to the hall of the House. Thank you for your service.

Along with them is 1st Lt. Jordan Frain. He is here as a guest of Representative Miccarelli. He is a veteran of the Battle of Fallujah and a recipient of the Bronze Star for Valor and the Purple Heart, and he is also Representative Miccarelli's commanding officer. I have got some things in common with you on that one. Welcome to the hall of the House, and thank you for your service.

Also located to the left of the rostrum are Barb and Jack Benard, the parents of fallen Iraq War veteran Sfc. Brent Adams. Welcome to the hall of the House. Thank you for your service.

And Barb Benard is obviously a Gold Star Mother. She is joined by a group of additional Gold Star Mothers who are sitting in the rear of the House, and they are all mothers of fallen Iraq War veterans. Will our additional Gold Star Mothers please rise. Thank you for your sacrifice.

# **STATEMENT BY MR. AUMENT**

The SPEAKER. I would like to recognize the gentleman from Lancaster, Mr. Aument, for further comments relative to the resolution just adopted and the special guests that we have with us that I just introduced. The gentleman is in order.

Mr. AUMENT. Thank you, Mr. Speaker.

Today we pause to remember the 10th anniversary of the start of Operation Iraqi Freedom. It is right for us as a Commonwealth to recall all those from each branch of the military who answered the call to serve during these last 10 years. We remember all who served today, but especially the more than 200 sons and daughters of Pennsylvania who paid the ultimate sacrifice and gave that last full measure of devotion. The freedoms we cherish come at a very high price.

Ten years ago I was a young junior captain serving with the 1st Battalion, 8th Infantry Regiment of the 4th Infantry Division. As I reflect back, I think of the men and women with whom I had the honor of serving. I leave other conversations and judgments to the historians. The soldiers of the 1st Battalion, 8th Infantry, came from diverse backgrounds. Many began their service prior to September the 11, 2001, and they joined for many reasons: College money; some for job training; some because they thought they would enjoy the adventure; a desire to serve; some to be challenged in a unique way; some, perhaps, just for something to do. Many others joined after September 11. They felt a unique call to serve after our homeland came under attack. Some even left high-paying careers to enlist. This diverse group came together and they became my family, my friends, my brothers.

Today I remember them, and, Mr. Speaker, I wish I could name them all, but I want to name for the record those who did not come home, those who did not enjoy a reunion with their families as I did, those who did not marry or start a family, those who did not have the opportunity to serve here as we do. I remember S. Sgt. Dale Panchot, Capt. Eric Paliwoda, Sgt. Gordon Misner, S. Sgt. Curtis Howard - all of the 1st Battalion, 8th Infantry Regiment. May God continue to bless their families and grant them a peace that only He can give.

I pray that same prayer for the Gold Star Mothers and the families who are here with us today. The families of Sfc. Brent Adams, Spc. Ross E. Vogel - today, today would have been Specialist Vogel's 31st birthday - LCpl. Nicholas Morrison, Spc. Martin W. Kondor, S. Sgt. Kimberly Ann Voelz. Will their families please rise again. Thank you.

Today I also remember others who still bear the wounds of battle - some seen and many unseen. It is a remarkable thing, the responsibility this country places on the shoulders of its youth and how well they perform. It is right that we pause, reflect, and here renew our mission to selflessly serve in the light of their inspirational and sacrificial service.

# STATEMENT BY MR. MICCARELLI

The SPEAKER. The Speaker recognizes the gentleman from Delaware County, Mr. Miccarelli.

Mr. MICCARELLI. Thank you, Mr. Speaker.

And I believe this may mark the first occasion in the history of our House where a member has honored a person who just months ago put a member in the hospital. I always knew Lt. Jordan Frain, my commanding officer, was a tough guy, but until our unit boxing training, I did not really understand the power that he had until I was hit with a right hook. And while waiting for those x rays, I wrote a different set of remarks about Lieutenant Frain, but I have decided to go ahead with my original remarks.

I started by saying that I always knew he was tough, but I refer to a toughness that is more moral in nature than it is physical. Toughness and the will to stand and to fight has always been part of the 28th Infantry Division's mission. During World War I, the actions of our unit led General Pershing to say, these "...are not soldiers!" these are "...men of iron!" giving us our nickname, "The Iron Division." During the war in Iraq, that name was reaffirmed.

I would like to take a moment to discuss two cases during the war in Iraq where men wearing the keystone on their shoulder decided to stand and fight.

Lt. Jordan Frain is not only my sparring partner, and a good one at that, but he is my commanding officer. He served in Iraq in 2004 as a gunner with the 18th Airborne Corps. In 2004 Lieutenant Frain's gun truck was ambushed by at least four men with AK-47s and grenades. The enemy vehicle opened fire on Lieutenant Frain's truck, mortally wounding his platoon sergeant and seriously wounding another soldier. Lieutenant Frain was then blown from the Humvee with a grenade. Although concussed from the grenade and bleeding badly from shrapnel wounds, he secured a rifle and killed remaining enemy personnel and held off others until reinforcements arrived. For his bravery, he was awarded the Bronze Star for Valor, and for his wounds he was awarded the Purple Heart.

There are many similar tales of heroism like the one I have just described by my commanding officer, but that was not the end of the war in Iraq for Lieutenant Frain. His unit was sent to Fallujah, and then they were sent to Sadr City. He was wounded two more times during operations in those cities. But rather than accept two more Purple Hearts, he declined them. He refused them so he could stay with his unit. He decided to stay and fight.

One of our other guests here today is General Gronski, and I am not sure if General Gronski remembers the first time I met him was on a place called Observation Post 293 in Ramadi, Iraq, in 2006. General Gronski came to Observation Point 293 to assess battle damage and the current conditions after a brutal attack on our outpost. Just days before, a coordinated attack killed two members of the small team that we had served with. They were Marine Corps Capt. Brian Letendre and Army Sgt. Joe Proctor.

When the enemy attacked OP 293 on May 3, 2006, their intent was not to harass us and leave. Their intent was not to kill one or two soldiers and use it for propaganda. Their intent was to completely destroy that observation point and kill everyone in it.

The attack began with mortar rounds, rocket-propelled grenades, direct automatic weapons fire. Our troops fought back valiantly until a truck bomb packed with 300 pounds of explosives breached the gate and made its run for the main body of troops on the observation point. Before it could get there, Sergeant Proctor shot and killed the driver. He shot and killed the driver of a dump truck packed with explosives that was bearing down on him. As soon as he killed the driver, the truck detonated, killing Sergeant Proctor. He had the option to run, but he stood and fought, because that is his job.

A group of us from the team arrived shortly after at the scene, after the attack, to find some of the Iraqi soldiers jumping on trucks in an attempt to flee, assuming that the post would be abandoned since it was largely destroyed. Our Marine Corps 1st Sgt. Craig Cressman ordered them back off the truck and back into the fight. In true Iron Division fashion, retreat was not what our brigade commander had in mind.

We rebuilt Observation Point 293 and a small group of us defended it. While the OP was strategically important, it was little more than a blown-out storage facility that we used to conduct patrols. There were several more attempts by the insurgents to drive us from that point, but armed with the knowledge that our brothers in arms had paid in blood for that ground, we made certain that all of those attacks failed. When General Gronski came out to Observation Point 293, he told us to stand and fight, and we had planned to do nothing less.

Today Lt. Jordan Frain is the rear detachment commander of A-1-104th Cavalry in Philadelphia. He continues to serve in the Pennsylvania National Guard despite his injuries.

Today General Gronski is the commanding general of the 28th Infantry Division. He continues to serve with the unenviable task of knowing that he may again have to send his soldiers into harm's way.

And while Sgt. Joe Proctor was killed that day in Ramadi, his service is not over either. After word of his father's death was given to his family, Joey Proctor, Joe's son, went right down and joined the National Guard.

Proctor and men like him still serve us every day. They remind us that when faced with the option to fight or run, the choice should always be clear. These soldiers serve as a reminder that it is not the length of our lives, it is not the amount of money we have made, or the power that we accrue that matters. What matters is that when it is all said and done, will those that you leave behind be proud of you? Will they say you stood up in the face of adversity? Will they say that you were a devoted citizen to your Commonwealth and to your country?

Mr. Speaker, I submit to you these heroes who would say they were just doing their jobs. I would say that they have inspired us all.

### STATEMENT BY MR. MURT

The SPEAKER. The Speaker recognizes the gentleman from Montgomery County, Mr. Murt.

Mr. MURT. Thank you, Mr. Speaker.

Early in 2003, I was serving as an Army reservist and I was called to active duty, ordered to Fort Drum to prepare for

deployment. We were pretty sure we were going to be sent to Iraq, although we were praying that would not be the case. And we trained up at Fort Drum for a few weeks, and subsequent to that, we were deployed to Iraq. I served in Iraq for 14 months with the 4th Infantry Division, the same unit as Representative Aument was serving with.

Today we recall Operation Iraqi Freedom and recognize the men and women across Pennsylvania who served our nation with great courage and bravery.

The war in Iraq was different. It was the first one fought not just by regular component military personnel but with significant numbers of our National Guardsmen and reservists. These brave patriots from across Pennsylvania, from towns big and small, from Chichester to Erie, answered the call of duty. These men and women left their jobs, their homes, their families, much like the minutemen from the Revolutionary War, to serve our nation and to defend freedom.

The debate continues about the war in Iraq, but regardless of anyone's belief as to the war in Iraq, we all have an ongoing duty to care for our veterans and their families. As lawmakers, we have a responsibility in this chamber to help provide housing, health care, jobs, and the sense of security that comes from knowing that a grateful nation cares and appreciates their service.

Many of our veterans from the war in Iraq, and from all the wars, continue to suffer from post-traumatic stress disorder, traumatic brain injuries, and from illnesses related to exposure to various chemical elements on the modern-day battlefield. We owe these men and women the best health care that money can buy and a sincere commitment to their welfare and to that of their families.

Let us as lawmakers rededicate our energies to providing the programs and services that our veterans not only need but have earned. Let us support programs both at the State and Federal level that will help our military make the transition to civilian life, and that includes helping them rebuild careers that ended with their deployment. They have secured our freedoms. They deserve our help in rebuilding their lives.

Mr. Speaker, I had planned to offer this amendment, A679. However, it came to my attention that there was a mistake in the

drafting of the amendment. This mistake runs counteractive to what I wanted to do as far as the death tax. Unfortunately, this amendment was submitted on time. I am going to withdraw it, and I would like to say that I have a replacement amendment which I would like to offer, but I am going to withdraw that too. But I just want to bring it to the attention of the members what this amendment does.

I commend the maker of HB 659 and what he is doing, but I think it is time for the House to address the issue as a whole. We have been chipping away – and that is what my other amendment does – we have been chipping away at the death tax for small businesses. We did it for the farm community. Today we are doing it for children with 659, but I think we need to do it for the average worker out there because of the fact, he is really getting hit twice on this issue. The fact is that God forbid when some parent dies or something, and we know that they could pass that on at 4 percent; with siblings, it is 12 percent. When you start taking that, and with the low rate of returns they are getting on their investment, it certainly does not make sense that we continue to utilize this death tax, especially when they were fighting in Washington to get rid of the death tax, the exemption was \$2 million.

So I would hope that, I would like to work with the chairman of the Finance Committee to see how we can phase this out over a period of time. And if I remember right, I think that it was one of the Governor's commitments to phase out and do away with the inheritance tax. This session here, I think, would be an opportunity for us to do that.

So, Mr. Speaker, I want to thank you, and I want to thank the House for listening to my explanation on this. I will be withdrawing both amendments. Thank you very much.
