CONDOLENCE RESOLUTION

WHEREAS, The House of Representatives of Pennsylvania wishes to honor the memory of the Honorable Raphael J. Musto, a former member of the Senate of Pennsylvania who served the 14th Senatorial District and who passed away at the age of eighty-five on April 24, 2014; and

WHEREAS, Born in Pittston, Mr. Musto was the son of the late Rose Frushon Musto and the Honorable James Musto. A graduate of Pittston Township High School and King's College, he served this country with honor and distinction as a member of the United States Army during the Korean War from 1951 to 1953. Mr. Musto began his legislative career in 1971, when he was elected to fill his late father's unexpired term in the House of Representatives of Pennsylvania. He served four more consecutive terms in the 118th Legislative District

prior to winning a special election in the 11th Congressional District of the United States Congress in 1980. Mr. Musto was elected to the Senate of Pennsylvania in 1982, and he represented the 14th Senatorial District for twenty-eight years until his retirement in 2010; and

WHEREAS, A dedicated legislator, Mr. Musto was instrumental in crafting one of the first clean air bills in the country, and he advocated for education and the rights of individuals who are disabled. A member of Saint Joseph Marello Parish and the Pittston Township Fire Department, he was the catalyst behind the Luzerne County Grandparents Raising Grandchildren program; now therefore be it

RESOLVED, That the House of Representatives of the Commonwealth of Pennsylvania proclaim with enduring sorrow the passing of the Honorable Raphael J. Musto; and extend heartfelt condolences to his wife, Frances Panzetta Musto; sons, James and Ray, Jr.; daughter, Fran Drozda; eight grandchildren; one great-grandchild; and many other family members and friends; and be it further

REMARKS BY MR. CARROLL

The SPEAKER. The Speaker recognizes the gentleman, Mr. Carroll.

Mr. CARROLL. Thank you, Mr. Speaker.

Mr. Speaker, today I rise to offer this condolence resolution honoring the life of former Representative Ray Musto, and I thank the members for their unanimous support of the resolution.

As the reading clerk just outlined, Ray was born in 1929 in Pittston, Pennsylvania. He was one of eight children and the son of James Musto and Rose Frushon Musto.

Ray was inspired by the work of his father, who served in this chamber for 21 years. Ray attended public schools, as was mentioned, and graduated from Pittston Township High School in 1946. He served in the U.S. Army during the Korean era in Germany, and he was the de facto head of the family while his father was here in Harrisburg and helped run Musto's Market in Pittston Township before he decided to follow in his father's footsteps and enter politics.

As an early campaign brochure outlined, Ray was an accomplished butcher; according to early campaign information, he would tend to the store's meat counter while his

father was here in Harrisburg. He would take grocery orders over the phone and chat with customers about the events of the day and then deliver their orders.

Ray simultaneously served as the chief dispatcher, driver, and firefighter for the township fire department, which had headquarters next to the family store. The department did not have a telephone, so local residents would develop the habit of calling the store and reporting the fire to Ray.

After several years of attending night classes while raising a family of four with his wife, Fran, Ray graduated from King's College in Wilkes-Barre with a bachelor of science degree in accounting in 1971, and he later received a doctorate of letters and degrees from King's and Wilkes, both in Wilkes-Barre.

When his father, a 21-year State Representative, James, died in 1971, Ray won a special election to fill his seat. He was elected to a full term in '72 and reelected three times, serving 8 years, and was succeeded by Representative Tom Tigue, who is with us here today.

He focused heavily on constituent services, walking coal miners through the process of receiving black lung benefits. That had been a program pushed by his father, a former coal miner, during his 21 years as a State Representative.

In 1980 Ray was victorious in a special election to the U.S. House of Representatives and proudly represented Pennsylvania's 11th Congressional District in Washington. Ray was then elected to the State Senate in 1982, representing the 14th Senatorial District, which included portions of Luzerne and Monroe Counties, and he was reelected to the Senate six times. He served as the Senate Democratic caucus secretary from '97 to 2004. He also served as the Democratic chair of the Environmental Resources and Energy Committee and the Senate's Local Government Committee.

He was the past cochair of the Council of State Governments, Eastern Regional Council, which encompasses 11 States, 5 Canadian Provinces, Puerto Rico, and the Virgin Islands, and I know Ray was very active with that organization and was thrilled to be an active participant.

He was a renowned strategist here in Harrisburg and worked across party lines and cosponsoring all sorts of legislation, especially related to the environment, and his list of accomplishments in that arena are lengthy. Just a few notes, the Hazardous Sites Cleanup Act, the Air Pollution Control Act, the land recycling program all are in existence because of Ray's advocacy.

He had many other legislative accomplishments, including the rights of the disabled, which was an inherent arena that was important to Ray, and also the Fair Education Act, which was an effort to try and prohibit discrimination due to physical disabilities.

With us today are Ray's beloved wife, Frances Panzetta Musto, and their four children – James and his wife, Mary; Ray and his wife, Karen; Michael and his wife, Laurine; and Fran and her husband, Dave – all in the well to the left of the Speaker, if you would not mind a round of applause.

Ray and Fran celebrated their 61st wedding anniversary on April 6, and they have seven grandchildren as well.

As was mentioned, Ray was a devout member of St. Joseph Marello Parish in Pittston, former Mount Carmel parish; he was fourth-degree Knight of Columbus; charter member of the Pittston Township Lions Club; and a life member of the Pittston

Township Fire Department, as well as a member of the Sons of Italy. And Ray, unfortunately, passed away April 24, 2014, spending his last days at home surrounded by his family and enjoying one last Easter celebration together.

In addition to the family that I just introduced a moment ago, there are many other members of the Musto family, family friends, former staff members, as well as Representative Tigue behind the rail in the back of the House, and I thank them for their dedication to the Senator through the years, their love of the Senator through the years, and we appreciate their presence today.

And I can tell you, Mr. Speaker, dating back to Ray's father, the Carroll and the Musto families have been associated in many ways, ranging from my grandfather's service as a county commissioner in Luzerne County during Ray's father's career here in Harrisburg to Ray's brother, Girard, and my father and their paralleled careers with the Pittston Area School District; and then Ray's niece, Jackie, marrying my cousin, Tim; and now me holding the seat that Ray once held here in the 118th District.

Mr. Speaker, I can tell you that Ray Musto was a larger-thanlife figure in our community, and his untimely passing ends a public service career that positively impacted thousands of citizens and has dramatically improved our community.

Thank you, Mr. Speaker.

STATEMENT BY MR. GROVE

The SPEAKER. The Speaker recognizes the gentleman from York County, Mr. Grove, under unanimous consent relative to one of the resolutions just adopted.

Mr. GROVE. Thank you, Mr. Speaker.

I rise this morning to mark the 250th anniversary of Dover Borough in York County. This community was founded in 1764 and was laid out by Jacob Joner. In fact, Dover was commonly known as Joner's town for around half a century after its founding. The community's name was officially changed to Dover after the founding of its Post Office in 1815.

Dover has a long and vibrant history, which includes a direct connection to the Civil War and the Battle of Gettysburg. As part of the Gettysburg campaign on June 27, 1863, Confederate soldiers arrived in Dover and stayed for a short time before returning to Carlisle. Confederate soldiers, including the cavalry of Jeb Stuart, returned on the first day of battle, July 1. Stuart's forces numbered nearly 6,000 men. Stuart lingered in Dover

through the evening of the battle's second day, July 2. During this time he was cut off from communications with Gen. Robert E. Lee, and some experts say that had he arrived at the battle earlier, the tide may have been turned against the Union Army.

In 1864, 150 years ago, Dover had a population of around 500 people. Since then the borough has grown to be the home of more than 2,000 residents. I can personally attest that it is a wonderful place to live and raise a family, with a great appreciation for its history and an eye toward its future.

I want to thank all those who have come before us and those who are still working to make Dover what it is today. I would also like to thank Dover Borough Mayor Richard Pope and his wife for joining us today.

Mr. CLYMER. Thank you, Mr. Speaker.

Mr. Speaker, I know that this bill is well intended by the sponsor. However, I find myself asking this question: Why do we want to give volunteer fire companies a club liquor license that will allow them to be open 24 hours a day, 7 days a week, 52 weeks a year?

Mr. Speaker, we know that alcohol addiction is a serious problem in our society, so why are we allowing this product to be available at our volunteer fire companies? How will it impact on those individuals who are in the fire company who are recovering from alcohol? Is this going to be a problem? What about the junior volunteers? Is that going to be a problem for them? Are they going to be served alcohol? Will parents want their children, their teenagers to be part of an organization where there is the possibility to secure alcohol?

And, Mr. Speaker, in the past and certainly in the future, we kind of look upon our volunteer fire companies as role models, as individuals that do a wonderful service for the communities in which we live, and I do not see this as part of that special role model that volunteer fire companies have.

If the volunteer fire companies want to have alcohol, special permits are available to them, and then who will have the oversight? Who is going to go in there and check to make certain that the underage are not drinking?

And then, Mr. Speaker, will there be an increase in insurance rates to the fire companies because now they are serving alcohol?

Auxiliary members can participate as well. So will this mean a rise, an increase, in members of the auxiliary to join because now alcohol is available? What will be the result if a fire company, say within a community, in close communities where several may say on principle we do not want to get involved but others say we will have this liquor license? Will that drive people from one organization to another? Will people want to become part of an auxiliary if there is no alcohol license?

Mr. Speaker, I recently attended a 3-hour conference on the serious problems of alcohol and drug addiction at the Penn Foundation in my district. It was sponsored by the Bucks County Drug & Alcohol Commission and Drexel University School of Public Health, and this was certainly a major issue that we considered. It was alcohol misuse and drug prescription misuse.

So, Mr. Speaker, based on those comments, I would ask for "no" vote.

REMARKS SUBMITTED FOR THE RECORD

Mr. BIZZARRO submitted the following remarks for the Legislative Journal:

Thank you, Mr. Speaker.

Today I stand in support of HB 2310, which I am proud to cosponsor. This important piece of legislation would authorize the State Department of General Services (DGS) to grant and convey Washington Monument Park, Judson House, and Fort LeBoeuf Museum in Waterford to the Fort LeBoeuf Historical Society.

These properties all hold special, historical significance to Waterford residents and to Erie Countians in general. Washington Monument Park is rumored to be the home to the only statue of George Washington in Pennsylvania depicting the first President in a British military uniform. Judson House is named after Amos Judson, who ordered the construction of the house in the early 19th century. The house, which has been converted into a museum, is open for tours and features a plethora of historical items, as well as a library. Fort LeBoeuf Museum occupies the site of the original French fort built in 1753. The museum holds exhibits on Native Americans who inhabited the area as well as the British and French fur trade.

At a time when so many individuals are focused on looking ahead to the future, it is increasingly important to remember and preserve our past, including these meaningful monuments in the great northwestern part of our State. I am pleased that HB 2310 would give the historical society the rightful authority to carry on its important preservation work in addition to providing future generations the opportunity to learn about Erie County's storied heritage.

Additionally, I am proud that this particular issue is being addressed after so many people have advocated for so long for the historical society to take over ownership. I had introduced three separate bills to achieve this important goal, as DGS had advised me to do, so I am pleased to see Rep. Curt Sonney's piece of legislation finally receive State House approval.

Though I will be sorry to see Waterford leave the 3d Legislative District due to redistricting, I am confident the historical society will continue to preserve these sites in an upstanding manner. I hope Rep. Sonney, who will be Waterford's new State Representative beginning December 1, also continues to fight for preservation of Erie County's many historical sites.

Thank you to my colleagues for their support of HB 2310, and thank you, Mr. Speaker.

The board shall permit private third-party providers of alcohol training to modify the order in which the content of the Bureau of Alcohol Education's standard curriculum is presented so long as the material is taught.

BILL ON CONCURRENCE IN SENATE AMENDMENTS

The House proceeded to consideration of concurrence in Senate amendments to **HB 1424, PN 3712,** entitled:

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in terms and courses of study, providing for Holocaust, genocide and human rights violations instruction.

On the question,

Will the House concur in Senate amendments?

The SPEAKER. Moved by the gentleman, Mr. Clymer, that the House concur in the amendments inserted by the Senate.

The Speaker recognizes the gentleman, Mr. Clymer, for a brief description of Senate amendments.

Mr. CLYMER. Thank you, Mr. Speaker.

I am not sure how brief, but I will try to put everything into proper context.

I urge my colleagues to vote in favor of concurrence in Senate amendments.

This product before the chamber is the result of negotiations and agreement between interested parties between the House and Senate.

As a student of history, I am very pleased that the General Assembly has the opportunity in cooperation with our school districts and other public school entities to ensure our students are steeped in the causes of the Holocaust and other genocidal and human rights violations and their tragic outcomes. The last century in particular witnessed a killing of 6 million people of Jewish descent and millions of other citizens around the world, needlessly and tragically put to death. This bill encourages instruction – a point I know is important to my colleagues – and provides public school entities with model curriculum, guidelines, and teacher training if instruction is offered.

A comprehensive study by the State Board of Education following the 2016-17 school year will review data from each public school entity on whether they offer instruction and the

quality of that instruction. If less than 90 percent of the Commonwealth's public school entities are offering instruction, the State board will then be required to promulgate a regulation to require this instruction.

As I said, this bill is a compromise which I believe is in keeping with the desire of this chamber, not to foist further unfunded mandates on our schools. It is a compact with our schools that we believe they already are teaching the students the lessons of the Holocaust and of genocide and human rights violations and do not need Harrisburg to tell them to do so.

Mr. Speaker, I may be proven wrong by the State board study, but I have faith in the quality of education occurring within our public schools. Further, a safety net will be in place through the authority that we have granted the State board. Our children will be taught so that we and future generations never forget.

I urge a positive vote. This has the support of the Pennsylvania Jewish Coalition, and it came to us from the Senate with a 49-to-0 vote. Thank you, Mr. Speaker.

The SPEAKER. The question is, will the House concur in the amendments inserted by the Senate?

On that question, the Speaker recognizes the gentleman from Allegheny County, Mr. Frankel.

Mr. FRANKEL. Thank you, Mr. Speaker.

I rise in support of the concurrence vote on HB 1424.

As my colleague and the prime sponsor from Bucks County said, the bill before us today is a reasonable compromise and it represents a collaborative effort that will guarantee that future generations of Pennsylvanians will never forget the atrocities of the Holocaust. They will learn that systemic hatred and bigotry – sponsored hatred and bigotry can translate into mass murder and the attempted extermination of entire groups of people.

HB 1424 may not go quite as far as mandating Holocaust education at this time, but it does require our State's Department of Education to create a curriculum on Holocaust education and to offer training to educators who will then be able to take this curriculum into classrooms throughout the State.

Mr. Speaker, the legislation also includes a study to be conducted 2 years from now that will show us which districts across Pennsylvania are utilizing this curriculum and free training in Holocaust education, and if that study shows that less than 90 percent of school districts are offering Holocaust education in their classrooms, the State will require all school districts to offer the curriculum.

I would like to thank all the legislators and advocates who worked tirelessly to make this compromise come to fruition. HB 1424 is supported, as the Representative from Bucks said, by the Pennsylvania Jewish Coalition and by every single Jewish federation throughout the State.

This is a historic moment for those of us who strongly believe that we must never forget the Holocaust, nor stop telling its stories and drawing lessons from those stories.

I urge all of my colleagues to concur in Senate amendments to HB 1424. Thank you, Mr. Speaker.

This piece of legislation does not represent 100 percent of what I wanted and what some advocates wanted, but it represents literally 90 percent of it. I believe that is an honorable compromise.

I just also want to say to those from in and around my district who are survivors of the Holocaust, who actually came to the State Capitol to petition their government, to lobby their Representatives, because they felt so deeply that their voices needed to be heard, for them this is a proud moment and shows that every once in a while a representative democracy can work.

I urge all members to vote and to pass this unanimously. Thank you.

The SPEAKER. The question is, will the House concur in the amendments inserted by the Senate?

On that question, the Speaker recognizes the gentleman from Philadelphia County, Mr. Cohen.

Mr. COHEN. Thank you, Mr. Speaker.

I, too, support this legislation, and I commend Representative Boyle, Representative Clymer, other members of the House and Senate who worked on this legislation.

Mr. Speaker, is there anything in this bill that stops Holocaust education from occurring in the year 2014 or 2015?

Mr. CLYMER. No. They can start to teach in the next school year, beginning in September.

Mr. COHEN. Thank you, Mr. Speaker.

That is what I thought the answer would be.

I think this is an excellent bill. I commend everybody involved in it and urge unanimous passage.

The SPEAKER. The question is, will the House concur in the amendments inserted by the Senate?

On that question, the Speaker recognizes the gentleman from Allegheny County, Mr. Turzai.

Mr. TURZAI. Thank you very much, Mr. Speaker.

I rise in support of HB 1424, and I applaud the outstanding work by the prime sponsor and the chair of the House Education Committee.

Iraq is crumbling. A new caliphate seems to be in the making. The brutality and total disregard for human life is appalling. In today's newspapers we saw ISIL bragging about the murder of Iraqi troops. The threat of ISIL cannot be underestimated.

They have singled out the United States as one of their avowed enemies. One of the reasons for HR 794 that we passed several weeks ago was to prevent the further reductions of our military forces. Make no mistake, we need to protect ourselves.

The other enemy mentioned by ISIL is the nation of Israel. Mr. Speaker, there is always that possibility that this radical terrorist group will attempt a strike at Israel. A reason for HB 1424, which we just passed, is so that future generations of Americans learn about the Holocaust and its devastation on the Jewish race.

As a reminder, in the 1930s few were willing to speak out against the atrocities by the Nazi regime against European Jews. Today I believe Israel is in imminent threat and danger from these radical jihadists, and hopefully, this administration will recognize this impending danger and give the support and solidarity which we should to our Israel ally.

HB 1424 is a reminder to future generations that never again will we tolerate such atrocities to be committed against a race of people because of their religious identity.

Mr. Speaker, the question begs itself, will Israel allies provide assistance if and when a military situation should occur that would demand a positive response from America or will "never again" be just meaningless words as Israel becomes a nation isolated, an island unto itself?

STATEMENT BY MRS. DEAN

Mrs. DEAN. Thank you, Mr. Speaker.

I appreciate the opportunity to address my colleagues pursuant to rule 17 of the operating rules of the House of Representatives.

I rise once again, like I did in October, on the issue of Medicaid expansion.

Six months have passed since Medicaid expansion has taken effect in our country but not in our State. Twenty-six States are benefiting from the Affordable Care Act, allowing them to cover their most vulnerable working populations. These are mothers and fathers, sons and daughters, students, employees, Americans who simply need medical coverage but who simply cannot afford it.

Here in our Commonwealth we have gone 6 months without covering 500,000 of our own, our most vulnerable residents, including nearly 30,000 veterans. Meanwhile, our Federal tax dollars in Pennsylvania are being used in other States to cover their people while our citizens and members wait.

Governor Corbett continues to pursue his own plan and thinks he is getting close, which means at least another 6 months without coverage for half a million Pennsylvanians. I urge the Governor to please opt in now; sign that single piece of paper that will mean immediate health-care coverage to the 500,000 Pennsylvanians who are in the cold and waiting. Get them coverage now while you continue to pursue the waivers of the Medicaid program. It is the right thing to do. It is the human thing to do. It is also the economically and fiscally sound thing to do.

On my Web site I have a running calculator of the Federal funds that we have forfeited by Governor Corbett's refusal to expand Medicaid. Today, conservatively, we are exceeding the \$1.2 billion mark. That is \$5,000 a minute, \$7 million a day.

And if Governor Corbett fears that the Federal government will not live up to its promise to support Medicaid at the levels promised, I will be the first to stand with him when we say we pull away from it.

So in the absence of Governor Corbett's action, we here in the House are taking action. Two weeks ago the House Human Services Committee passed HB 1492 out of our committee. The Bucks County chairman's bill aims to legislatively expand Medicaid in Pennsylvania. That bill currently sits in the House Rules Committee.

Therefore, Mr. Speaker, I respectfully request that our majority leader and the Speaker bring the bill up for a vote. This issue deserves consideration by this body. Pennsylvania deserves Medicaid expansion. It is the right thing to do. Thank you, Mr. Speaker.

Their Healthy PA, we think, is an outstanding approach toward both Medicaid expansion but also reforming the system so that it provides necessary services but also makes sure that there are needed reforms.

There is no doubt that the Governor and his Secretary are working very diligently with the Obama administration to make sure that we move in a positive direction that has the needed reforms.
