I will be submitting my remarks for the record. Thank you.

Mr. MATZIE submitted the following remarks for the Legislative Journal:

Thank you, Mr. Speaker.

Bordeaux, Burgundy, Tuscany, Napa Valley, and Pennsylvania. It might surprise some of you to learn that these locations have at least one thing in common - high-quality wines and wineries.

The Commonwealth currently has at least 280 wine grape growers working more than 13,000 acres of grape farms and supplying more than 180 licensed wineries. Pennsylvania's varied climate and well-drained soil allow for a diverse wine region. From Lake Erie to Brandywine Valley, from the Southwest Passage Trail below Pittsburgh to the Endless Mountain north of Wilkes-Barre, great wine is being made by talented craftsmen in every corner of our State.

The wineries take a quality ingredient grown right here in Pennsylvania to produce a wide array of wine varietals that will be enjoyed by adults in and around Pennsylvania. Each year these wineries attract 1.2 million visitors and bring an estimated \$222 million in tourism expenditures, but this is not the only way the Pennsylvania wine industry helps stimulate the regional economy.

Our State's wine industry is credited with creating over 8,600 jobs with a total payroll of \$401 million. And according to a study commissioned by the Pennsylvania Winery Association, the production of grapes for wines and juices contributes a total of approximately \$1.9 billion to the State economy annually. This vital component of our regional economy comprises the fourth largest producer of wine grapes in the nation, and the reputation of the State's wineries and the wine they produce has been on the rise.

Thank you all for your support of this resolution, and thank you, Mr. Speaker.

Code Green: First Responders Suicide Prevention and Awareness Month is what HR 512 encompasses. A local tragedy prompted the resolution.

Our Bucks County communities lost an incredible young man, George Redner III, this summer. He was the beloved son of Jackie and George Redner, Jr., and had four brothers – Joshua, Joseph, Nicholas, and Austin. He worked tirelessly throughout Bucks County, New Jersey, and even South Carolina as both a firefighter and an EMT (emergency medical technician). He strived to help others through the worst of catastrophes and tragedies. George, whose life was devoted to serving others, took his life August 1. He was 27.

HR 512 aims to shed light on the psychological issues that first responders face through the Code Green Campaign. Code Green, available online at codegreencampaign.org, has two main goals: raising awareness of mental health issues, substance abuse, and suicide among first responders; and secondly, providing education to first responders on how to care for themselves and recognize issues in their peers. It gives first responders an outlet to talk about their mental health issues anonymously. It tells our hometown heroes that it is okay to hurt and that seeking support is a sign of strength and not of weakness. Code Green also bolsters educational resources for first responders and agencies through courses like first responder peer support training and mental health first aid.

The Code Green Campaign is but a year old. It was founded by EMS (emergency medical services) professionals alarmed about the high rate of suicide among first responders and the lack of discussion about mental health in general.

I just want to say on a personal note, I have known Jackie and her family for years. We did business with her parents. We are all saddened by this, and I hope this brings some awareness to this issue. Thank you.

STATEMENT BY MR. FARRY

The SPEAKER. Representative Frank Farry is recognized on unanimous consent.

Mr. FARRY. I want to thank Representative Davis for bringing this issue to light.

As a fellow Bucks County emergency responder and a friend of George's parents, it has been a very trying time in our Bucks County emergency services community.

I want to bring to light that the sacrifices the men and women in our military have made have really opened the door to have discussions about such issues as PTSD (post-traumatic stress disorder), which many emergency responders suffer from as well. In working with the Redner family, we are working on developing programs so our emergency responders have their resources, and hopefully we can take the programs we are developing in Bucks County and move them statewide. The Redners, it is very important to them. As they said to me, George spent his whole life as an EMT and as a firefighter, and he was actually scheduled to start in the Philadelphia Fire Academy in January. They said that he spent his whole life trying to help people, and then this tragedy happened.

Well, we made a promise to them that George's death will not be in vain, because he will continue to help people by spreading the word about the mental illness and the stress and strain on our emergency responders, and the programs we are going to develop because of this incident will truly be difference makers.

So down the road we will have some information for you as to what we have developed in Bucks County, and I ask you to join us in helping to spread it statewide. Thank you.

Section 1. Section 2 of the act of December 4, 1996 (P.L.911, No.147), known as the Telemarketer Registration Act, is amended by adding a definition to read:

Section 2. Definitions.

The following words and phrases when used in this act shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"Robocall." A telephone solicitation call made to a large number of people, using a computerized autodialer, to deliver a prerecorded telemarketing message. * * *

Section 2. Section 5(a)(2) of the act is amended and the section

is amended by adding a paragraph to read: Section 5. Unlawful acts and penalties.

* * *

(a) Acts enumerated.–The following acts are prohibited:

(2) Initiating an outbound telephone call, including a robocall, to a person when that person previously has stated that he or she does not wish to receive an outbound telephone call made by or on behalf of the seller whose goods or services are being offered. A seller or telemarketer will not be liable for violating the provisions of this paragraph if:

(i) he has established and implemented written procedures to comply with this paragraph;

(ii) he has trained his personnel in the procedures;

(iii) the seller or the telemarketer acting on behalf of the seller has maintained and recorded lists of persons who may not be contacted; and

(iv) any subsequent call is the result of error.

* * *

* * *

(10) Conducting telemarketing on a legal holiday.

Section 3. Section 5.2(c) and (j) of the act, amended September 12, 2003 (P.L.105, No.22), are amended and the section is amended by adding a subsection to read:

Amend Bill, page 2, by inserting between lines 12 and 13

(j) Identification.–No telemarketer shall fail to provide a residential or wireless telephone subscriber with the name of the caller, the name of the person or entity on whose behalf the call is being made and, upon request, a telephone number or address at which the person or entity may be contacted. If a telemarketer makes a solicitation using [an artificial or prerecorded voice message transmitted by an autodialer or prerecorded message player which placed the telephone solicitation call] <u>a robocall</u>, the telephone number may not be a 900 number or any other number for which charges exceed local or long-distance transmission charges.

* * *

(l) Robocall requirements.-

(1) A telemarketer or telemarketing business that uses robocalls:

(i) Shall establish a procedure, consistent with the requirements under subparagraph (ii), for a called person to opt out of receiving future telephone solicitation calls from that telemarketer or telemarketing business and be immediately taken off the telemarketer's call list.

(ii) Shall provide notice to a called number, at the beginning of the call, stating how a called person can opt out of receiving future telephone solicitation calls from that telemarketer or telemarketing business. Immediate opt out shall be available through an automated, interactive voice-activated or key pressactivated opt-out mechanism for the called person to make a do-not-call request, including brief explanatory instructions on how to use the opt out mechanism, within two seconds of disclosing the name of the caller and the name of the person or entity on whose behalf the call is being made. The called person shall be able to opt out throughout the duration of the call.

(iii) May not require a called person's written consent as a condition to opt out of future telemarketing calls.

(iv) May not consider the action of opting out as the creation of an established business relationship.
(2) When a robocall is left on an answering machine or a

voice mail service, the message must provide a toll-free telephone number that enables the called person to call back at a later time and connect directly to the automated, interactive voice-activated or key press-activated opt-out mechanism and

I rise in opposition to HB 123. I would first like to salute the maker of the bill for her efforts in this regard. I think the intent of the bill is good, which is to make sure that victims are compensated when they have suffered a wrong and to make sure the court is compensated with regard to court costs. That is a good goal. I do think this bill has some unintended consequences, and that is why I oppose it.

I think first and foremost this bill provides a disincentive to family members who may want to post bail on behalf of their, perhaps, ne'er-do-well son who perhaps has given them trouble throughout their lives. I think if a mom or a grandmom posts bail for their son who has given them heartache all their lives, they should not have to risk losing that bail, and I think that is exactly what this bill does.

I think the second problem with this bail, in addition to making innocent people like a mom or a grandmom or a brother have to pay for something they had no responsibility for whatsoever, I think the second thing it could do would be to inadvertently increase costs to taxpayers, because the problem is, if a person in jail cannot get bail, they continue to sit in jail, and that could increase court costs, costs of incarceration, which are very expensive.

I just want to read a little bit from a letter from a group called Decarcerate PA that is also in opposition to this bill. This is their letter dated September 29, 2015. This is from Decarcerate PA: "To the Pennsylvania House of Representatives: We are writing to voice our strong opposition to HB123...." I am going to quote bits and pieces, not the whole letter. "This bill

dis-incentivizes families and friends from supporting their loved ones.... This bill also would have the unintended consequence of increasing costs to the county and state. Creating additional obstacles to paying bail means that people stay in jail longer, at a considerable cost to the taxpayer." They also raise the concern, quote, "that HB123 violates the legal purpose of bail and in fact represents an unlawful or improper taking, which would likely meet with legal challenges."

I think when we think about it – and we all want our criminal justice system to do justice, and we have to and we take a constitutional oath to presume someone arrested is presumed innocent – we all, if we find ourselves in that situation, would appreciate the constitutional right to be presumed innocent. And the purpose, when you are arrested, of sending you to jail prior to trial is not to punish you, because you have not been convicted of anything yet. People who have not been convicted should not be punished for anything. The sole purpose of bail is to compel your appearance at trial so you can stand trial. This bill—

CONSIDERATION OF HB 123 CONTINUED

The SPEAKER. Members, we have one bill left in front of us. We are going to return to HB 123.

On the question recurring, Shall the bill pass finally?

The SPEAKER. It is my understanding there are three individuals who wish to speak.

Representative Vitali, we would like to move forward. You had quite some time on this, but we will return to you first.

Then I am going to call on Representative Barbin, and then Representative Delozier, who is the maker of the bill.

At this point we would like to move with some efficiency.

Representative Vitali, the floor is yours.

Mr. VITALI. Thank you, Mr. Speaker.

I did not have too much to go, but I just want to get back to the original purpose of bail. People accused of crimes, they have been arrested, they have been incarcerated awaiting trial. They are presumed innocent. And we have taken a duty to uphold their right of that presumption of innocence, so when they are in jail, they should be presumed innocent. Now, the purpose of bail, the only purpose of bail is to let them out, and that bail money compels their appearance at trial – constitutionally innocently presumed people.

Now, if you say to a mom or a grandmom or a neighbor, "Guess what? If you post bail for this person, you are going to lose it. You are going to lose it even if he shows up for trial. You are going to lose it." That is a disincentive. That is a disincentive for a person who should be presumed innocent to

get out of jail, where he should not be if he is in fact presumed innocent.

Mr. Speaker, this bill was, I will concede, improved by the Madeleine Dean amendment by imposing an undue hardship standard for the return of bail to the mom or the grandmom. In other words, the bill as it currently reads said that if they can prove undue hardship, they can get their bail back. But they should not have to prove anything.

Mr. Speaker, let me give you an example. If my neighbor is in jail, my neighbor—

The SPEAKER. Sir, if you will suspend for just a second.

Members, members, please, if you have any conversations, please take them to the anteroom outside the chamber. Members, I would ask everybody to please give Representative Vitali the floor.

Representative Vitali.

Mr. VITALI. I just wanted to make a point, because, you know, I am anticipating the argument, "Yes, they can get the bail back if they prove undue hardship." But let me just sort of give you a little example. Let us say my neighbor is in jail on bail for a crime and he needs \$10,000 posted. I have \$10,000. You know, maybe I would consider posting bail so my neighbor can get out of jail. But if I know I am going to lose that \$10,000 if he in fact is found guilty of the vehicular accident he is involved with, I do not want to lose my \$10,000. Hey, I have another \$10,000. I have 2 or 3 more \$10,000, so it is not an undue hardship for me to lose \$10,000, but you know what? I may not put up that \$10,000 because I do not want to lose it. So that might be the difference between a person presumed innocent from getting bail or not. So this whole undue hardship provision in the Madeleine Dean amendment I do not think solves the problem.

The bottom line is, I agree with the maker of the bill that a person who puts up his own money for bail should lose it and it should go to restitution, fines, and costs, but not his mom, not his grandmom, not his brother. That is just, that is just wrong, and I do not think it really makes our system of justice any better; to the contrary, I think it makes it worse.

So I think we need to send this bill back to the drawing board. So I would urge a "no" vote.

The SPEAKER. Representative Barbin, on the bill, please.

Mr. BARBIN. Thank you, Mr. Speaker.

I rise in support of this bill as amended. This bill was amended in the Judiciary Committee to resolve the question of a third party that would place cash bail up. Again, this is cash bail, and the only time cash bail can be forfeited is if the person who is putting up the bail money has been convicted of some other offense where he has an obligation to the Commonwealth.

So what this bill says is that if you are the depositor and you are the person who is the defendant and you put up cash bail, then that money can be applied to other court-ordered obligations that you have from a criminal or delinquency matter. That means you have been convicted of another crime and you have not paid those fees. So the first part is real easy. We just did the same thing with the State tax intercept where tax refunds go to pay for other delinquencies. This bill also builds on that concept, and it has a protection that was agreed to by all members of the Judiciary Committee.

Representative Dean put an amendment up to protect the depositor who was not the defendant, and that amendment said that the court may order that deposit be applied to the defendant's other obligations. But then it is up to the judge. So

there is a protection in this bill, and the protection is the judge. Unless the judge orders that the depositor does not get the cash bail back, then the cash bail that is put up by someone else is protected.

So with those protections that were agreed to by all members of the Judiciary Committee, both Republican and Democrat, I ask my colleagues on both sides of the aisle to vote in favor of this bill.

The SPEAKER. Representative Delozier, the maker of the bill.

Ms. DELOZIER. Thank you, Mr. Speaker.

I ask for an affirmative vote for this bill. We have worked through many of the issues that deal with how our victims and those that were victims of crime can be made whole. This bill simply works that through. Those that are found guilty of a crime— And let me be clear that this is dealing with only those that have been found guilty of a crime, not those that are accused and not those that are working through the process. It is those that have been found guilty of committing a crime and have been assessed fees and restitution requirements to their victims. These dollars simply are dollars put up by themselves to get out of jail, and the thought process is that if they have the money to get out of jail, they also have the money to pay their victims back and pay the court fees.

So I ask for an affirmative vote, and I would ask for your support for this bill.
