The SPEAKER. Representative Hahn is recognized to speak on HR 518.

Ms. HAHN. Thank you, Mr. Speaker.

Mr. Speaker, I rise to thank my colleagues for their support of HR 518, which celebrates the 125th anniversary of the Daughters of the American Revolution. DAR, as it is often referred to, is a women's service organization dedicated to promoting historic preservation, education, patriotism, and honoring the patriots of the Revolutionary War.

Founded in 1890, DAR has 177,000 members in the 3,000 chapters across the country and internationally. Any woman 18 years of age or older who can prove lineal descent from a patriot of the American Revolution is eligible for membership regardless of race, religion, or ethnic background.

Its annual convention is held at the DAR Constitution Hall, which opened in Washington, DC, in 1929.

The group's projects include restoration and maintenance of historical sites; locating, restoring, and marking Revolutionary War patriot gravesites and headstones; and placing monuments around the world to memorialize people and events throughout American history.

As a proud member of the Bethlehem, Pennsylvania, chapter of the National Society Daughters of the American Revolution since 2010, I would like to introduce a representative of the Daughters of the American Revolution. As the Speaker noted before, Geraldine Falk is here. She is the regent of the Bethlehem, Pennsylvania, chapter. Please join me in welcoming her to the hall of the House. And thank you again for your support of HR 518. Thank you, Mr. Speaker.

STATEMENT BY MR. KRIEGER

The SPEAKER. Representative Tim Krieger is recognized to speak on HR 516. Representative Krieger, the floor is yours.

Mr. KRIEGER. Thank you, Mr. Speaker.

Hopefully everyone in the chamber recognizes strong families are the foundation of every safe and healthy community. Teen dating violence patterns are similar to adult domestic violence with widespread effects on individuals, families, schools, businesses, and health-care systems. Teen dating violence includes physical, emotional, and sexual assault and harassment via texting, electronic mail, or instant messaging.

At least 40 percent of our young people between 11 and 12 years of age report that their friends have been victims of verbal abuse in relationships. Among teenagers in dating relationships, 30 percent have been text-messaged up to 30 times an hour by an obsessive-compulsive partner to find out where they are, what they are doing, with whom they are with.

With all those points in mind, I rise with a heavy heart today to once again offer this resolution to designate October 6, 2015, as "Demi Brae Cuccia Day" in Pennsylvania. Demi Brae Cuccia was fatally stabbed in her Monroeville home by her ex-boyfriend on August 15, 2007. She was born August 14, 1991, and was the daughter of Gary and Jodi Cuccia, who are honoring her memory by their creation of the Demi Brae Cuccia Awareness Organization. This resolution is being offered in recognition and, most importantly, to raise awareness of the tragic impact of teen dating violence on the health and wellbeing of our families and communities.

And I would like to thank the members for their unanimous support of HR 516.

STATEMENT BY MR. SCHWEYER

The SPEAKER. Representative Schweyer is recognized to speak on HR 513.

Mr. SCHWEYER. Thank you, Mr. Speaker.

Mr. Speaker, thank you for the opportunity to address this esteemed body about HR 513, which designates this week, October 4 through October 10, as Pennsylvania Dutch or Pennsylvania Deutsch Heritage Week in our Commonwealth.

Throughout the Lehigh Valley, from which I hail, and in many other areas of our Commonwealth, we are fortunate to have as a significant part of our heritage the Pennsylvania Germans. Many of these folks arrived before 1800 for reasons so familiar to each and every immigrant group: to escape religious persecution and to seek a better life overall.

On October 6, 1683, the first major emigration of Germans to America resulted in the founding of the Borough of Germantown in Philadelphia County. From there they branched out across the State, in particular the eastern part of Pennsylvania. More commonly known as Pennsylvania Dutch or Pennsylvania Deutsch, this community is filled with people known for possessing an impressive work ethic, a strong social conscience, and a true sense of both family and community. They were farmers and laborers, entrepreneurs and clergy members, and those traits I just mentioned ensured that they would be successful and that their communities and families would thrive.

Pennsylvania Dutch heritage is inescapable in our State. One simply needs only to travel any country road through Lehigh, Northampton, Berks, Lebanon, Lancaster, and other counties and see hex signs on the side of a barn. The folk art and music is one of a kind, and their impact on our language and dialect is obvious.

At one time over one-third of Pennsylvania's population spoke Pennsylvania Dutch, which is, of course, very similar to German. Pennsylvania Germans have contributed greatly to the culture of this Commonwealth, and organizations like the Pennsylvania German Society, organized in 1891, have published a number of materials relative to the history and folklore of these proud people.

As someone who counts Pennsylvania Dutch as part of my ancestry – Mr. Speaker, my last name is Schweyer – I can tell you that we are extremely proud of our heritage but also patriotic and always have been. This is true going back to the very founding of our nation as the Pennsylvania German community was generally very supportive of the war for independence.

There is much to admire about the Pennsylvania Dutch and their impact on our Commonwealth and our nation, and the time is right to honor and reflect upon their legacy.

I thank you, Mr. Speaker, once again, for the chance to speak today, and I thank every member of the House for your affirmative vote on HR 513. Thank you.

Mr. VEREB called up HR 501, PN 2291, entitled:

A Resolution expressing profound sorrow and heartfelt condolences on the passing of Brian Kadunc and recognizing his contributions to the House of Representatives and this Commonwealth.

On the question, Will the House adopt the resolution?

The SPEAKER. The Speaker recognizes Representative Mike Vereb.

Mr. VEREB. Thank you, Mr. Speaker.

I rise today about an employee who was also a dear friend. As many of you know, Brian Kadunc, who worked with me since 2007, passed away last month. Brian had traveled through Virginia and North Carolina to tour battlefields, which was one of his hobbies. He suffered a heart attack, and after weeks of emergency medical care, he passed away.

While most people in Pennsylvania probably have never heard Brian's name, his work has directly affected them. Brian played an instrumental role in helping me to write, introduce, and eventually pass Pennsylvania's sudden cardiac arrest law. This law was the first of its kind in the entire United States. Thanks to this law, youth athletes, coaches, assistants, referees, officials now must receive training about sudden cardiac arrest. I have no doubt that Brian's work on this law will save lives in Pennsylvania.

One of the tragic ironies of Brian's passing is that it gave me an opportunity to meet his family, who lives in Chagrin Falls, Ohio. After Brian suffered his heart attack but before he passed away, I traveled several times to North Carolina to be with him and his family. I got to know his father, James; his mother, Catherine; and his sister, Melinda. We shared stories about Brian and laughed about our fond memories of him.

Mr. Speaker, I could stand here and tell you that Brian is a proud graduate of Villanova University. I could tell you he was a devoted Wildcats fan, but he would never turn down a Temple Owl's ticket either. I could tell you Brian served as an employee of the House for 10 years. But these simple facts do not convey the true essence of Brian. To truly know Brian, you had to see him smile.

Now, as many of you know, our former Speaker, Sam Smith, was from Punxsutawney, and I think everyone, at least in my caucus, knows Sam did not go a day without a good ribbing from me or some type of practical joke. I met with my coach, Leader Dermody, for our softball game from last year and I informed him that a groundhog would be showing up at the softball game to terrorize Sam, who was coaching the other team. Now, Brian was not in that groundhog costume and nor was I, but the reaction to that groundhog was watching Brian in the dugout seeing his creative prank work to, one more time, give a shot to Sam that said that would be his last softball game with us.

The essence of Brian Kadunc was simple. He operated in the background, but his efforts produced results. He was quick to laugh and went out of his way to make others laugh with him.

Mr. Speaker, Brian was taken from all of us far sooner than any of us would have liked at age 38. However, we are grateful for the time we enjoyed with him and the impact he had on all of our lives.

Mr. **BIZZARRO** offered the following amendment No. **A03452:**

Amend Bill, page 1, line 6, by inserting after "COURTS" and for veteran and service member courts

Amend Bill, page 6, by inserting between lines 8 and 9 <u>§ 918. Veteran and service member courts.</u>

(a) Establishment.—The president judge of each court of common pleas shall establish, in consultation with the district attorney of the county, a veteran and service member court for veterans and service members charged with a misdemeanor or felony offense, other than a crime of violence. The court shall be established using available funds.

(b) Joint court.–Two or more president judges may jointly form a veteran and service member court, in consultation with the district attorney from each county represented by the joint court.

(c) Discretion of president judge.—At the discretion of the president judge, the court shall be either a separate court or problem-solving court, within the court of common pleas.

(d) Local rules.—The court shall adopt local rules for the administration of the court and its related treatment services. The local rules must be consistent with this section and the rules established by the Supreme Court of Pennsylvania.

(e) Existing courts.—If a court of common pleas has an existing veteran and service member court before the effective date of this section, the veteran and service member court shall continue and is not subject to this section.

(f) Eligibility.-A defendant is eligible for participation in a court if:

(1) the defendant agrees to plead guilty to the charges; (2) the prosecutor consents to the defendant's participation; and (3) the court finds that the defendant:

(i) is a veteran or current member of the United States Armed Forces, including the reserves, National Guard or State guard; and (ii) suffers from a brain injury, mental illness or

mental disorder, including post-traumatic stress disorder, that:

(A) resulted from the defendant's military service in a combat zone or other similar hazardous duty area; and

(B) materially affected the defendant's criminal conduct at issue in the case.

(g) Exclusion.–A defendant shall be excluded from a court if any of the following apply:

(1) The crime committed is a crime of violence.

(2) The defendant does not demonstrate a willingness to participate in a treatment program.

(3) The defendant previously participated in or was discharged from a veteran and service member court.

(h) Verification.–Proof of matters described in subsections (f) and (g) may be submitted to the court in which the criminal case is

pending in a form the court determines to be appropriate, including:

(1) a military service or medical record;

(2) a previous determination of a disability by a veterans' organization or by the United States Department of Veterans Affairs;

(3) testimony or an affidavit of other veterans or service members; and

(4) a prior determination of eligibility for benefits by a State or county veterans' office.

The court's findings must accompany a docketed case.

(i) Procedure.-The following apply:

(1) The court shall order the defendant to submit to a mental health and drug and alcohol screening and assessment through the United States Department of Veterans Affairs or the department. A report based on the mental health and drug and alcohol screening and assessment shall be submitted to the court and shall include treatments and rehabilitative interventions for the defendant for consideration by the court or correctional programs. A mental health and drug and alcohol screening and assessment may not be ordered if the court finds that the defendant has undergone a screening and assessment within the previous 60 days.

(2) The court shall inform the defendant that, if the defendant fails to meet the conditions of the court, eligibility to participate in the court shall be revoked and the defendant shall be sentenced as provided under the law.

(3) The defendant shall execute a written agreement with the court as to his participation in the court and shall agree to the terms and conditions of the court, including the possibility of sanctions or incarceration for failing to abide by or comply with the terms of the court.

(4) In addition to any other conditions authorized under law, the court shall order the defendant to complete the treatment recommendations. A failure by the defendant to complete the treatment recommendations may result in the defendant's being charged with sanctions, removal from the court and incarceration.

(j) Mental health and substance abuse treatment.—The following apply:

(1) The court shall collaborate with a network of substance abuse treatment programs representing a continuum of graduated substance abuse treatment options commensurate with the needs of defendants, including programs with the United States Department of Veterans Affairs, the Commonwealth, the department and community-based programs.

(2) The court shall collaborate with a network of mental health treatment programs representing a continuum of treatment

options commensurate with the needs of the defendant and available resources, including programs with the United States Department of Veterans Affairs, the Commonwealth, the department and community-based programs.

(3) The court shall employ additional services or interventions as it deems necessary on a case-by-case basis. (k) Violations, termination and discharge.—

(1) The court shall impose reasonable sanctions under the written agreement executed under subsection (i)(3), including incarceration or dismissal of the defendant from the court, if the court finds from the evidence presented, including a report or proffer of proof, from a court professional, that the defendant:

(i) is not performing satisfactorily in the assigned treatment and rehabilitative interventions; (ii) is not benefiting from education, treatment

or rehabilitation;

(iii) engaged in criminal conduct rendering him unsuitable for the court; and

(iv) otherwise violated the terms and conditions of the court or his sentence or is unable to participate for any reason.

(2) Upon successful completion of the terms and conditions of the court, the court shall:

(i) dismiss the original charges against the defendant; and

(ii) terminate the defendant's sentence or

otherwise discharge the defendant from further

proceedings against him in the original prosecution. (1) Funding.–The following apply:

(1) A court shall collect from a participant in the court: (i) a fee of \$1,000; and

(ii) a testing, counseling and treatment fee in an amount necessary to cover the costs of testing, counseling or treatment performed or provided under the

<u>supervision of the court.</u> (2) At the discretion of the judge administering the

program, a fee collected under this section may be paid on a periodic basis or a deferred payment schedule.

(3) A fee collected under this subsection may only be used for a purpose specific to the court.

(m) Definitions.-As used in this section, the following words and phrases shall have the meanings given to them in this subsection unless the context clearly indicates otherwise:

<u>"Court." The veteran and service member court established</u> <u>under this section.</u>

<u>"Court professional." A prosecutor, defense attorney, probation</u> officer or treatment provider involved with a program supervised by the court.

"Crime of violence." An offense under any of the following:

(1) 18 Pa.C.S. § 2502 (relating to murder);

(2) 18 Pa.C.S. § 2701 (relating to simple assault);

(3) 18 Pa.C.S. § 3121 (relating to rape);

(4) 18 Pa.C.S. § 3124.1 (relating to sexual assault); and

(5) 18 Pa.C.S. § 3701 (relating to robbery).

"Department." The Department of Military and Veterans Affairs. "Service member." A person who is currently serving in the

Army, Air Force, Marines, Navy or Coast Guard on active duty or reserve status or in the National Guard.

<u>"Veteran." A person who served in the armed forces and was</u> <u>discharged or released from service under conditions that were not</u> dishonorable.

Amend Bill, page 6, line 9, by striking out "in 60 days." and inserting

as follows:

(1) This section shall take effect immediately.

(2) The addition of 42 Pa.C.S. § 918 shall take effect in 120 days.

(3) The remainder of this act shall take effect in 60 days.

BILL ON SECOND CONSIDERATION

The House proceeded to second consideration of HB 1348, PN 2260, entitled:

An Act amending Title 65 (Public Officers) of the Pennsylvania Consolidated Statutes, in lobbying disclosure, further providing for prohibited activities, for penalties and for registration fees, fund established, system and regulations.

On the question, Will the House agree to the bill on second consideration?

Mr. COHEN offered the following amendment No. A03450:

Amend Bill, page 1, line 7, by striking out "13A09(c)(1)" and inserting

13A09(a)(1) and (c)(1)

Amend Bill, page 2, by inserting between lines 5 and 6 (a) Notice of alleged noncompliance.—

(1) The commission shall issue a notice of alleged noncompliance to a person that has failed to register or report as required by this chapter. <u>The required registration and reporting</u> <u>deadlines shall be extended for the duration of any emergency</u>, <u>natural disaster or other such event that directly affects the</u> <u>person required to register or report</u>.

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Chair recognizes Representative Cohen.

Mr. COHEN. Thank you, Mr. Speaker.

The SPEAKER. Members, please give Representative Cohen your attention. All members, please take your seats. Any conversations I would request that you take to the anterooms outside the chamber. Members, please take your seats. Just wait for a second, Representative. Members, if you could please take your seats.

Representative Cohen, on the amendment.

Mr. COHEN. Thank you, Mr. Speaker.

Mr. Speaker, this underlying bill deals with fines to lobbyists who miss reporting deadlines. It significantly raises the fines. Now, the problem with this legislation is that not all organizations are equal. Some lobbying organizations have hundreds of people, and filling out a lobbyist registration form for them is a very minor task. Other lobbying organizations are much smaller. They may have only one person, and these one-person lobbying groups are vulnerable to events. Somebody may get sick, somebody may have a family emergency, and that limits their ability to comply.

Now, this issue was brought to my attention from Barry Kauffman of Common Cause. Mr. Kauffman's organization is typical of many organizations in the Commonwealth which have a small financial base and a very limited staff. Mr. Kauffman writes, "However, this bill will have unintended consequences that need to be addressed before a final committee vote is taken. Lobbying disclosure requirements, including penalties, should not act to meaningfully reduce the number or types of voices who attempt to provide opinions and ideas to legislators and other policymakers. The increase in fines for late filings will have some impact even on the multi-million...or multi-billion dollar entities that lobby state government. But they could have devastating impacts on smaller entities...which have budgets well under \$100,000 per year.

"These penalties also fail to address situations in which a small organization may have only one staff person. If that staff person has a heart attack near a filing deadline, or is on an extended leave from work due to cancer treatments, they may miss a filing deadline even though fully intended to comply. There should be a provision that permits a person or organization to request that the Secretary to grant a filing extension due to medical emergency or similar emergency...." That is what this amendment does, Mr. Speaker. It allows the required registration and reporting deadlines shall be extended for the duration of any emergency, natural disaster, or other such event that directly affects the person required to register a report. If there is any ambiguity in this legislation, that ambiguity can be dealt with by regulation, but this is an attempt to make it meaningful.

Now, Mr. Cutler has introduced his bill numerous times in the past. It has passed the House in four successive sessions and not ever passed the Senate. I believe this language will make the bill more palatable to members in the Senate, more palatable to the Governor, more palatable to the small lobbying community, and actually increase the chances for its passage.

I urge support for this amendment.

The SPEAKER. Representative Cutler.

Mr. CUTLER. Thank you, Mr. Speaker.

Mr. Speaker, while I am sympathetic to the gentleman's concerns regarding his proposed amendment, I actually have larger concerns with how the amendment is actually drafted.

When viewing the amendment, as proposed on lines 8 through 11, it reads in part, "The required registration and reporting deadlines shall be extended for the duration of any emergency, natural disaster or other such event that directly affects the person required to register or report."

Mr. Speaker, unfortunately, while all of those items are completely excusable and understandable, the way that the amendment is drafted does not give the department any discretion – it "shall be" waived.

My second concern, Mr. Speaker, is when you look at the terms "emergency, natural disaster" or the catchall at the end "other such event that directly affects the person," none of these terms are defined. I would argue, Mr. Speaker, that in actuality when this would be applied in real life, that it would actually harm and allow for any excuse to be used, because any item such as the "other such event" could be used to justify missing a filing deadline and therefore would make our current reporting and corrections system less enforceable.

Mr. Speaker, additionally, when you look at the bill as drafted and the law as it currently stands, I would argue that they already have this kind of latitude, because on page 2, line 1, the fine is listed as the "amount not to exceed," and lines 9 through 10 of the same page, "penalty not exceeding...." The judges already have discretion to levy a zero-dollar fine in an event such as the gentleman outlined.

Mr. Speaker, because of the lack of definitions and clarity in terms of what would be covered, in addition to the mandatory nature of the extension, I would respectfully request that the amendment be withdrawn. I would be happy to work on some alternate language as it heads to the Senate, but absent that, I would request a "no" vote. Thank you.

The SPEAKER. On that question, the Chair recognizes Representative Daley. Please hold, Representative.

Members, please take your seats. Representative Daley, the floor is yours.

Ms. DALEY. Thank you, Mr. Speaker.

So I introduced amendment A03464 to HB 1348, and

I introduced the amendment because of concerns for unintended consequences related to the dollar levels and the reporting requirements. So I am not looking to excuse any lobbyist or to treat any lobbyist differently, but I think we all understand that some lobbyists have very large budgets and some have smaller budgets.

I would like to just ask, Mr. Speaker, how the maker of this bill would see his bill without the amendment affecting the smaller lobbyists with smaller budgets.

The SPEAKER. Representative Daley, you want to interrogate the maker?

Ms. DALEY. Yes. Thank you.

The SPEAKER. He is agreeable to that.

Ms. DALEY. Thank you.

Mr. CUTLER. Thank you, Mr. Speaker.

Mr. Speaker, I would argue that there is actually more discretion in the bill as currently drafted. Referencing the comments from the last amendment debate, in each case, it is an amount not to exceed the \$4,000 or not to exceed the \$50 for the first 10 days. So again, I believe that they would have broader discretion under the bill as drafted, whereas when you look at the amendment as drafted, picking the \$100,000 budget, that would actually limit judicial discretion. We want to give them as much discretion as possible in cases like this, quite frankly, to address both the filing concerns as well as the issues that the prior gentleman raised. My fear would be that, as drafted, it would actually limit the ability to scale the fine to the related offense.

Ms. DALEY. Thank you. Thank you, Mr. Speaker.

So I would stand by this amendment and I would just ask that you consider the unintended consequences of passing this bill.

We all know that lobbyists come in all sizes, large and small, and the lobbying disclosure requirements, including penalties, should not act to meaningfully reduce the number or types of voices who attempt to provide opinions and ideas to legislators and other policymakers.

So I would ask for an affirmative vote on this amendment. Thank you.

The SPEAKER. Thank you.

Representative Cutler, on the amendment, sir.

Mr. CUTLER. Thank you, Mr. Speaker.

Mr. Speaker, I appreciate the gentlelady's concerns that she raises and the disparate impact that this could have on a variety of organizations. However, as I expressed during the

OCTOBER 6

interrogation, I personally believe that we have ultimate judicial discretion now based on the current fine structure and we are only looking to utilize that same discretion to the extent with the new fines.

Additionally, Mr. Speaker, I think it is of greater concern that in terms of the budget, in terms of the \$100,000 budget and the smaller organizations or even volunteer organizations, one of the fundamental problems that we would have in implementation of this amendment in the real world would be the fact that their budgets are not currently a reportable item, so you would add to the reporting requirements. The next question, naturally, is, what items would fall into the budget if they have multiple principals? Is it the aggregate budget or only the budget for the related item that they are lobbying on?

Unfortunately, while I understand the gentlelady's concerns, I think that this amendment would, one, remove judicial discretion, and two, further complicate the nature of reporting. I think that the foundation of our system is the equality of all in regards to the law, and therefore, I would urge a "no" vote on this amendment and we should treat everyone equally. Thank you.

REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. Representative Godshall is recognized on unanimous consent.

Mr. GODSHALL. Thank you, Mr. Speaker.

I have some comments that I would like to submit for the record, please. Thank you.

The SPEAKER. Thank you, sir. They will be accepted.

Mr. GODSHALL submitted the following remarks for the Legislative Journal:

HB 46 creates a freestanding act which allows the Department of Human Services to conduct unannounced inspections of both child day-care centers and family day-care centers. This would bring the State into compliance with the new child care and development block grant reauthorization which also requires annual and unannounced inspections. Further, this act would license family day-care centers, which are only currently required to register with the department.

Research has shown that unannounced inspections, or the availability of unannounced inspections, results in much stricter compliance with the health and safety regulations for day-care facilities. There are already 25 States which require unannounced inspections of all day-care facilities, although all States will be required to do so in order to keep the child-care subsidy funds.

Finally, this act will require the department to conduct an inspection of the day-care facility within 24 hours of a complaint which alleges a serious or immediate risk to the health or safety of a child, or after a serious injury or death of a child.

Please join me in protecting the Commonwealth's children with this commonsense and necessary piece of legislation.
