The House proceeded to second consideration of **SB 286**, **PN 1437**, entitled:

An Act amending the act of June 12, 1931 (P.L.575, No.200), entitled "An act providing for joint action by Pennsylvania and New Jersey in the development of the ports on the lower Delaware River, and the improvement of the facilities for transportation across the river; authorizing the Governor, for these purposes, to enter into an agreement with New Jersey; creating The Delaware River Joint Commission and specifying the powers and duties thereof, including the power to finance projects by the issuance of revenue bonds; transferring to the new commission all the powers of the Delaware River Bridge Joint Commission; and making an appropriation," further providing for the Delaware River Joint Commission, for composition, for employees, for financing and for executive sessions; providing for majority approval and contract procedures; further providing for report; providing for conflicts of interest, for master plan and creating the Port Authority Transit Corporation Commuter's Council; further providing for definitions; authorizing the Governor to apply for approval; prohibiting the entrance into a compact until passage of a similar act; and making editorial changes.

Amend Bill, page 29, lines 26 through 28, by striking out ". subject to" in line 26, all of line 27 and "Senate," in line 28

Amend Bill, page 38, lines 9 through 14, by striking out all of said lines and inserting

Section 6. This act shall take effect immediately.

Mr. CARROLL. Thank you, Mr. Speaker.

Mr. Speaker, this amendment removes the confirmation requirement that was included in the bill. It seems to me that the amendment is self-explanatory, so I will see if there is any other commentary. Thank you.

The SPEAKER. My apologies.

Obviously, Chairman Keller is the chair of the Transportation Committee, the minority chair. Representative Carroll, who spoke on Representative Keller's behalf, is the minority chair for Agriculture.

Does anybody else wish to speak on amendment 4560?

Chairman John Taylor of Philadelphia County. John.

Mr. TAYLOR. Thank you, Mr. Speaker.

Mr. Speaker, this amendment contradicts what we did in committee with this legislation to make sure there is a Senate confirmation process on appointments onto that board. We delayed the action in deference to the Governor's opinion on this, but just delayed it to 2018. That is how the bill reads currently. This amendment would strip it completely, and I would ask for a "no" vote.

The SPEAKER. Representative Carroll, for the second time. Mr. CARROLL. Thank you, Mr. Speaker.

Mr. Speaker, again, it seems to me at least that with the advent of the new administration, there is a heightened desire to advance in a direction of confirmation that I did not see in this building during the past 4 years, and it does not seem to me to be a coincidence. So I think that considering the current administration, I would like to have them treated in the same way that the past administration was treated with respect to confirmation requirements, not just for this appointment, but for other appointments.

So for that reason, Mr. Speaker, in the interest of consistency, I would ask for a "yes" vote on the amendment. Thank you so much.

STATEMENT BY MR. JOZWIAK

The SPEAKER. Representative Barry Jozwiak is recognized on unanimous consent. He will be speaking on HB 1154, which has already passed.

Members, please take your seats. Please take your seats.

Mr. JOZWIAK. Thank you, Mr. Speaker.

Good afternoon, Mr. Speaker, and I would like to ask Representative Dom Costa if he would come down here with me, please. I just want to make a comment.

Last week a Pennsylvania State trooper was shot in Philadelphia on the Vine Street Expressway after a traffic stop was initiated. If you remember, the trooper approached the vehicle and there were four occupants in the car. After some conversation, the trooper suspected there were drugs in the car, some drug activity. The driver of the car speeds away and a pursuit begins. The fleeing vehicle crashes into a school bus and both vehicles burst into flames. Fortunately, the school bus was not occupied by any children.

The driver of the car exits the vehicle and begins shooting at the trooper, hitting him in the shoulder. The trooper returned fire. Three of the fleeing occupants were apprehended immediately, with the fourth apprehended a few days later.

But I wanted to bring to your attention the reason for the traffic stop. It was an expired registration plate.

I just wanted to thank all my colleagues on both sides of the aisle for your wisdom in passing HB 1154 last June in this House. That legislation was prime-sponsored by Representative Dom Costa and myself for the purpose of repealing a portion of the transportation bill allowing registration stickers to continue being displayed on the license plates. We advised that this is a tool for police to have probable cause in order to stop vehicles and discover additional violations of the law.

And actually, the State Police have a program called Looking Beyond the Plate, indicating that the troopers are supposed to look for additional violations of law or criminal activity that may be afoot, and in this case it was. In this case the driver of the car that was stopped for the expired registration sticker was 17 years old and had a handgun and was willing to shoot at the police.

Keeping the registration stickers on the license plates showed you in real life how something as simple as a registration sticker helps protect the public and allows the police to do their job. This traffic stop removed a dangerous person with a handgun and his accomplices off the streets of Philadelphia, and who knows what other crimes this person may have committed or would have committed in the future.

I am asking all of my colleagues to pray for Trooper Patrick Casey for a full and speedy recovery from the injuries he received. And today I have to tell you, this is my first time at this podium, but I am proud to be a part of this chamber for having done the right thing in passing HB 1154 last June. I encourage the Senate to do the same very soon. I also encourage the Governor to sign the bill as soon as it reaches his desk.

I would like to ask Representative Costa if he wants to make a few comments.

The SPEAKER. Please suspend for a second.

I would just like to reiterate the comments of my colleague and pray for a speedy recovery for Trooper Casey. I mean, let us face it, little things matter a lot, and when a little thing like that little sticker came up and this House was made aware of it, you folks responded to that call to support our law enforcement. It is a little thing, and I would like to commend the administration because they are working with us for alternatives in the future. But until alternatives, a better alternative is available, we have to stay with that. We have to support our law enforcement.

Again, thank you, and let us all pray for Trooper Casey's full and immediate recovery. Thank you very much.
