HR 711 recognizes today, March 21, 2016, as "World Down Syndrome Day" in Pennsylvania. It is my hope that we recognize the abilities of individuals with Down syndrome and value their meaningful role they play in our society.

Mr. MARSHALL submitted the following remarks for the Legislative Journal:

HR 711 recognizes today, March 21, 2016, as "World Down Syndrome Day" in Pennsylvania. Down syndrome, a genetic condition, occurs in approximately 1 in every 800 births and impacts the lives of people in all ethnic, religious, and socioeconomic groups.

While people with Down syndrome are at a higher risk for various conditions, such as congenital heart defects, respiratory problems, and thyroid issues, advances in treatments have enabled them to lead healthy and longer lives. In 1983 the life expectancy for people with Down syndrome was 25 years of age. Today it is 60 years of age.

Over recent years it has become increasingly clear just how important early intervention, appropriate speech, physical and occupational therapies, and quality education programs are for people with Down syndrome to not only adapt in life but to thrive in life.

The date for World Down Syndrome Day, the 21st day of the third month of the year, was selected to signify the uniqueness of the triplication of the 21st chromosome. For those of us who have had the pleasure and the privilege of having these individuals in our lives, we know just how much joy that uniqueness can bring.

With each passing year, it is my hope that we continue to make medical advancements to improve the quality of life for people with Down syndrome. It is also my hope that we, as a society, learn even more how to value the important, meaningful, and irreplaceable role these smart and capable individuals can play in our society and that we all play a better role in encouraging them to follow their dreams.

I ask for your support of HR 711. Thank you.

STATEMENT BY MR. STEPHENS

The SPEAKER. Representative Stephens, on HR 743.

Mr. STEPHENS. Thank you, Mr. Speaker.

Mr. Speaker, HR 743 designates the month of March as "Keith Valley Challenge Month" in the Commonwealth of Pennsylvania, and I just wanted to share with the members a little bit of history regarding this particular initiative undertaken in my hometown, in Horsham, Pennsylvania, by my alma mater, actually, the students at the Keith Valley Middle School.

Back in 1977 an eighth grade boy, unfortunately, died because of a serious heart defect, and his classmates, eighth graders, back in 1977, decided they were going to play floor hockey and go out and try to solicit some donations to help St. Christopher's Children's Hospital, who had helped this little boy. Over the last 40 years the eighth grade classes at Keith Valley Middle School have continued this tradition, and over the last 40 years they have collected and donated over \$1 million by playing floor hockey overnight at Keith Valley Middle School.

So, Mr. Speaker, it is my honor and privilege to have introduced this resolution. I want to thank the members for supporting it and designating March as "Keith Valley Challenge Month" in the Commonwealth of Pennsylvania. Thank you very much, Mr. Speaker.

I know Russ Faber, the former Chief Clerk of the Senate; former State Representative and one of our distinguished employees at BMC, Pete Wambach; Jim Walsh, formerly of the Legislative Reference Bureau, they are all here. Please stand if you do not mind.

And Alexis's current staff are all seated in the rear of the House. Would you please stand. We want to pay you special attention. Thank you for serving so well.

Mr. Speaker, as you noted, I am joined by my friend and colleague, Representative Greg Rothman. We are joint sponsors of this resolution.

HR 755 recognizes and honors a highly regarded member of our legislative family here in Harrisburg, Alexis Brown, Comptroller of the Pennsylvania House of Representatives. Alexis is retiring, as was mentioned, after 41 years of service with the House, 19 of those years being as Comptroller for this institution.

Alexis was chosen to be Comptroller of the House on October 20, 1997, and as the Speaker has mentioned, served in various other capacities prior to that time: data analyst for the Legislative Data Processing Center, assistant personnel supervisor for the Chief Clerk's Office, management systems director for the Bipartisan Management Committee, and payroll assistant for the Comptroller's Office before assuming the position of Comptroller of this House.

As management systems director of the BMC, she oversaw the installation of our current air-blown fiber optic infrastructure that is used here in the Capitol Complex. And as Comptroller she was instrumental in developing the Legislative Financial System, the Travel Expense System, and the Legislative Payroll System, all of which are currently utilized by members and staff here in the House.

As the House's chief fiscal officer and watchdog, she has worked diligently to ensure that the House's expense system is in full compliance with IRS (Internal Revenue Service) regulations and with the laws of the Commonwealth of Pennsylvania.

In the course of her duties, she has always conducted herself in the most professional manner and has displayed the highest level of integrity in carrying out her responsibilities, yet she has also always been very personable and approachable to members and staff alike, and has demonstrated time and again a willingness to assist us and to provide proper guidance on the way to comply with our expenses and our requirements. Alexis Brown has been a dedicated and trustworthy employee of the House, and we are extremely grateful for her service to this institution.

Mr. SIMMONS called up HR 740, PN 2998, entitled:

A Resolution honoring the life of Charles "Chuck" Philip Bednarik, Hall of Fame center and linebacker for the Philadelphia Eagles, and expressing condolences upon his passing.

On the question, Will the House adopt the resolution?

The SPEAKER. Representative Simmons, you are recognized, sir.

Mr. SIMMONS. Thank you, Mr. Speaker.

I rise this afternoon to honor the life of one of the truly great sports legends here in the Commonwealth of Pennsylvania, Charles "Chuck" Bednarik, who unfortunately left us exactly 1 year ago at the age of 89 today.

As many of you know, Mr. Bednarik was a Hall of Fame center and linebacker with the Philadelphia Eagles. He played a franchise-record 14 seasons, from 1949 to 1962, and helped the team win two NFL (National Football League) championships.

The SPEAKER. Please, sir, just suspend for a second.

Members, I realize we have much to do today, but we are honoring a hero, a significant individual from our Commonwealth who passed away. I would ask for your attention with respect to Representative Justin Simmons' remarks. If we could all please take our seats, and if the conversations could just go to the anterooms.

Representative Simmons, please. I apologize for interrupting. Mr. SIMMONS. Thank you, Mr. Speaker.

He played a franchise-record 14 seasons, from 1949 to 1962, and helped the team win two NFL championships, in 1949 and 1960. To the chagrin of many Eagles fans, including myself, the Philadelphia Eagles have still not won a championship since that time

"Concrete Charlie," as he was known, was a devastating tackler and the last full-time, two-way player in the NFL - a 60-minute man. His skills were on full display before a nationally televised audience in the 1960 title game against the Green Bay Packers when he played nearly every minute on both offense and defense. Then at the end of the game as running back Jim Taylor headed for the end zone, Mr. Bednarik preserved the victory by tackling Taylor and staying on top of him as the clock ran out.

Mr. Bednarik had another famous tackle during the 1960 season when he stopped Frank Gifford of the New York Giants, who took 18 months to recover from the ferocious hit. When asked about it sometime later, "Concrete Charlie" said, "It's like the New York press wanted me to apologize for hitting Gifford. They came to me after the game and said, 'Did you know Frank is hurt?' I said I didn't know but it was a clean shot

and that's part of the game. They carried Frank off on a stretcher but I was in another world. I was busy celebrating the win. I played to win and so did Frank, that's why we're in the Hall of Fame. You don't hear him whining about it. He says I hit him with a clean shot and that's the truth."

He goes on to say, "I sent a basket of flowers and a letter to Frank in the hospital. I told him I'd pray for him. I'm a good Catholic but I'm also a football player. When I was on the field, I knocked the hell out of people, but that's the name of the game."

Charles Philip Bednarik was born on May 1, 1925, in Bethlehem, Pennsylvania. After playing high school football, he joined the United States Army Air Corps and flew 30 bombing missions over Europe in World War II as a gunner on a B-24 Liberator. Mr. Bednarik earned the Air Medal with four oak leaf clusters and five battle stars for his courageous military service.

When he returned home to the Lehigh Valley, Mr. Bednarik decided to get an education. He played college football at the University of Pennsylvania and was a two-time All-American. He also earned the Maxwell Award as the nation's most outstanding college player.

Mr. Bednarik went on to be the first overall pick in the 1948 NFL draft by the Philadelphia Eagles. His number 60 is one of only 9 numbers to be retired by the Philadelphia Eagles.

Mr. Bednarik is survived by his wife of 67 years, Emma; and their five daughters, Charlene, Donna, Carol, Pam, and Jackie. We are honored that all of them are here to join us today, along with his other family members. Unfortunately, his wife was not able to join us today.

I would now ask that Donna, Charlene, and his granddaughter, Jennifer, who are seated to the left of the rostrum, and the rest of the family in the back of the chamber to please rise and accept our sincere condolences on the passing of a great Pennsylvanian and Philadelphia Eagles icon whose life we are celebrating today.

In addition to being an outstanding football player, Mr. Bednarik was a wonderful family man who loved and appreciated the people of the Lehigh Valley. Mr. Bednarik spent the last 35 years of his life in Coopersburg. As he once put it in an interview, "I never forgot my roots and my friends, and I wanted to be back home with them."

Mr. Speaker, I ask that all members join me in honoring Chuck Bednarik by voting in support of HR 740.

Perhaps in my position, it should be the other way around, but I find that often it is that staff, which is part of our family, that inspires me to be better in my position, and I am sure many of us feel the same way.

So thank you for your support, for your prayers, and for your thoughts. Once again, I am reminded as I see so many of you that we know that darkness will eventually be overcome by light, and many of us in this room, as we celebrate Holy Week, understand that death is not the final answer, and I am eternally grateful for that.
